## Residents, City Life and owners clash

The building, which contains 98 units of affordable housing, has come under scrutiny because of what some residents and City Life Vida Urbana call unfair practices. According to City Life and several residents, there have

## WRNC to vote on Roxbury Prep

While the site for the proposed 562-student Roxbury Prep High School is technically in Roslindale, the West Roxbury Neighborhood Council (WRNC) plans to take a vote to support or oppose the project at its upcoming June meeting, scheduled for the 25th.

At last week's WRNC meeting, members debated whether or not to take the vote, but decided to table it until more council members were available.

"We were going to stay away from this because it was Roslindale," said WRNC Chair Larry Costello. "There were community meetings

# Affordable housing, community outreach concerns for 43 Lochdale Rd.

More than 15 residents came out on a rainy Monday night, May 28, to demand more affordable housing at the proposed housing development at 43 Lochdale Rd., in the heart of the Archdale neighborhood, at a meeting at the BCYF Menino Center on Brookway Rd.

The public also asked about outreach to the neighborhood, which is comprised primarily of people of color and people who are non-English speakers, who will be impacted by the project.

A public meeting was originally scheduled on Apr. 22. However, there was confusion with the development team on the date, and they did not attend the meeting. Residents, however, stayed at that time to express concerns about the need for more affordable housing. They also were pleased about the installation of outlets for electric cars and places for bicycle storage.

"I'll take the rap for that," attorney George Morancy said during the introduction. He explained that he had thought the meeting was the following day.

He also noted that the development has scaled back from a previous version when there were 42 apartments and five stories.

The proposed multi-family building would be a four-story, 36-unit apartment complex half a mile from Forest Hills. It would occupy a currently vacant lot totaling 22,500 square feet off of Washington St. The building would include five affordable units.

Each floor will have one one-bedroom unit, ten two-bedroom units and one two-bedroom-plus-study unit. The building would include two elevators.

The project includes two parcels with one full parcel on Lochdale Rd. The second parcel, which faces Washington St., would be subdivided into two lots. The building would fill most of the two lots, with space for frontage. This would be where residents enter the building.

Entrance to the garage would be through Kitson Rd., a private way. There would be 46 parking spaces in the garage, a bicycle storage room and a loading dock. There are 1.4 parking spaces per unit, although the zoning code requires 1.5.

"The loading dock only means that there is a space for when tenants are moving in and out of the building," explained architect David Freed.

If approved, construction is estimated to begin in the fourth quarter of 2019, with completion in early 2021. The cost is estimated at \$7 million. The project would employ 45 people.

"The building being 40 feet tall is not dramatically out of context with the neighborhood," Morancy said. It would be only slightly taller than the surrounding triple-deckers, but requires variances because of the height and because it is on land zoned for industrial use.

Community beautification and other amenities were included in the plans. The front of the building will be set back nine feet from the lot line to allow for a planting bed and tree planters, as well as a wider sidewalk.

On Kitson St., the building is set back 19 feet from the lot line to encourage pedestrian and bicycle traffic. Also, there will be a new walkway and bike path to connect to the bike path off of Arboretum St. This will be part of the city's Complete Streets program.

The number of parking spaces was the first concern brought to the developers. Some ideas included uncoupling the spaces and making them available for rent; designating some for Zipcar and car sharing; or doing away with some spaces to

create more affordable housing units.

"It may turn out that we have a surplus of spaces, but I think we are playing that by ear," Morancy said. "There is potential for car sharing. There tends to be preferences on both sides, but it's a flexible site."

He added that, after a year or two, it would be easier to "determine the dynamics" of the site.

Members of Walk UP Roslindale advocated for the parking space ratio to be closer to 1.1 to encourage use of the MBTA, bikes and walking.

"Understood," Morancy said. "This proposal has evolved to where we are now. My clients are committed to that."

"I think that, if the project is less than one-half mile from Forest Hills, to couple them to the units makes no sense," Alan Wright said. "If you reduce the parking spaces, you can add more affordable units."

Wright also advocated for solar panels to allow for the use of green energy and questioned if the building would be LEED platinum status. It would meet LEED silver status.

Karen Kirchoff, of Roslindale is for Everyone (RISE), also demanded more affordable units.

"I think you need to take a more complex look at the community, she said. "This building is for people who make 70 percent of the AMI (average median income) for affordable units. But the BPDA's own statistics show that many of Roslindale's residents here make less than \$50,000. That represents 2,000 people."

"If this building is for those who already live here, it is just not accessible," she continued. "I think anything you could do to increase affordable housing would be great, because this is just not enough."

Alex Nedel said he was concerned about the meeting policy and how much outreach was done to the Latino community who live in Archdale.

"When I look at all the people at this meeting, every single one of them is white," he said. "And when I look at those slides with the people at the building, all of them are white. But in the gym across the hall, there is not one white person in there."

"I am offended by that," Morancy said, noting that one of the women in the slide was a woman of color.

Nedel also mentioned that the comment period ends on June 3, six days after the meeting. He asked if outreach could be done in Spanish or other languages.



# Editorial

## This and that...

Some potentially controversial, and perhaps awkward, conversations, were emerging from City Hall this week (and we don't refer to YET ANOTHER plan to make the off-putting brutalist architecture greener and more visitor friendly).

As we were going to press, the Boston City Council was preparing for a hearing to assess whether to take up on a proposal by councilors Matt O'Malley and Lydia Edwards that would help provide freely available female hygiene products (yes, by that we mean menstruation supplies) in school, library, community center, and municipal women's rooms.

The idea is not an entirely new one. Brookline already does it. Also, a non-profit organization, Catie's Closet, helps keep a couple of dozen schools stocked with supplies.

Foolish arguments will likely be triggered by the proposal. Some will invariably yell about tax dollars and why they should not shoulder this cost. They need to be quiet, lest they want a counter effort to strip public bathrooms of toilet paper.

Facts are facts. With young girls reaching puberty at increasingly younger ages, having available products can save them embarrassment. The cost is also negligible when compared to the hardship some families face, or the distractions that come with a fast-approaching biological emergency.

There are many who love to purport to know what women should do with their own bodies. It is high time we support them when facing the unwelcomed biological imperatives that rely on no one's permission.

### WHAT WILL THE FLOATS LOOK LIKE?

As we recall, years ago and with an ill-fated attempt at Swiftian satire, we pitched the idea of a Heterosexual Pride Parade. The idea, and please believe us in that there were no unsavory prejudices at play, was merely our venting about less-desirable aspects of Pride events each June, and other cultural events in the city.

At the time, we were put off by the fact that throughout the year, Boston's gay community has distinguished itself as an important part of the community fabric, only to damage those societal gains with bacchanalian behaviors on parade day. The argument extrapolated to the St. Patrick's Day parade (a de facto celebration of homophobia, fighting, and public intoxication), and Caribbean festivals that might alternately be billed as a "gun pride" celebrations.

Our call for an alternate parade was intended to underscore these concerns in one of the most absurd ways possible.

Well, now, apparently a group of men are aiming to hold just that sort of event on city streets in August. The joke, never funny to start with, is now just disgusting.

This is exactly the sort of bro-dude, Barstool Sports-reading, strip club under-tipping, fedora-wearing misogyny and homophobia that has no place in our city. We were once properly chastised for our stupid "joke". Those who are serious about this are themselves walking punchlines. The city may not be able to legally bar the parade, but we the people can certainly mock it and its caveman organizers.

# You think things are bad now


Anti-Catholicism, on the rise now because of the clerical scandals vis a vis ephebophilia (which word is more accurate than pedophilia because the former involves crimes against pubescents), does not compare to what President Kennedy encountered in West Virginia and other southern states when he ran for president. And even this papism of the 1950's pales in comparison to the anti-Irish, and hence anti-Catholic, sentiment that prevailed in Boston in 1834.

Let's step back from that year and view the Boston Fire Department (and countless other municipal, suburban, and rural) fire departments as they fight fires today. It seems that they are always in doubt as to whether a burning building is ever truly vacant: from a layman's perspective, they risk serious injury, if not death, when they enter seemingly empty edifices already seriously aflame, just in case an unknown resident or homeless person might be inside; they clamber courageously upon smoking rooftops to vent the fire to minimize damage to the building.

Such an approach to firefighting did not exist with the BFD on a summer night 185 years ago when the Ursuline Sisters convent in Charlestown was ablaze. Thomas O'Connor, the late renowned historian from South Boston who taught for decades at Boston College, describes an attack of about 45 workingmen who smashed their way into the convent; they allowed the nuns and their students to flee but set fire to the building. A large crowd of people stood by, including fire companies who also merely stood around and watched the conflagration destroy the entire Catholic structure.

It can be argued that the firefighters of the pre-Civil War era did not have the protective gear that they have today, nor did they have the hoses for knocking down the blaze from a safe distance (obviously there were no hydrants). But based on the all-pervasive anti-Catholic sentiment so prevalent at the time, it would not be surprising if the firefighters were under orders not to knock down the blaze, lest the Catholic school be spared.

It's just incomprehensible

now to imagine fire officials, so consumed with personal prejudice, to discourage their underlings not to do their best to stifle a fire, the opposite of which is so dramatically done daily around the city, highlighted by their combined efforts in a nine-alarm inferno several months ago at East Boston's New England Casket Company.

### CITY OF THE RICH AND POOR

It seems that too often both our print and broadcast media sources gives us news of yet another large residential project being okayed by the Boston Planning and Development Agency. All over East Boston, where I live, more and more housing starts are plopping down. If there's a piece of vacant land it doesn't stay empty for long, and this is happening in every neighborhood of this city.

All over my neighborhood, thanks to the large scale development of the East Boston waterfront and Jeffries Point, homes are being scooped up and turned into high-end housing. There seems to be no end in sight. The largest development idea is a 165 unit devel-

opment on Bremen Street, not far from the MBTA Airport station on the Blue Line.

Over the past couple of years, Bremen Street looks like ground zero for aggressive housing proposals. I wonder what affect all this will have on nearby residents. Three families are turning into multi-family units. More cars, more congestion and higher rents for new structures and higher rents for nearby folks.

How much more developed will Eastie become? Do we just keep endlessly increasing the neighborhood population? Also, one would think all these new housing should mean more revenue for the City of Boston and higher assessments for small property owners. The only winners in this story are developers and City Hall. Everyone else gets negatively im-

pacted.

Officials from City Hall always talks about plans to increase affordable housing. City Hall talks about things like the 2030 plan. I am worried about East Boston in 2030, but I am more concerned about East Boston today, tomorrow and next year. What happens when folks get displaced here because of this ongoing over-development of many Boston neighborhoods? Where do folks priced out go? Chelsea is doing the same thing as East Boston. Where can you go to hide from high-end over-development?

Boston City Hall needs to take a closer look across the whole city and start to tame development before we become a city of only the very rich or very poor.

"Outreach can be done in other languages by request," BPDA project manager Aisling Kerr said.

"I would like to make that request," Nedel said. "And I would like to ask that the comment period be extended."

Kerr said that she would accept comments after the June 3 deadline. Nedel offered to flier the neighborhood with information in Spanish.

"I really think it's not fair," Nedel said after the meeting. "The BPDA's own letter on Article 80 talks about a process that is inclusive. I didn't see that here."

"Many of the folks here don't feel empowered to advocate in this way," added Donna Parker. "It's a challenge for them. And many have different levels of reading comprehension."

Matt Lawlor of Walk UP Roslindale echoed RISE's stance on affordable housing and parking.

"I would be disappointed to hear that this proposal is set in stone," he said. "You can expect letters from Walk UP Roslindale and from RISE."

"A call is being made," Lawlor added. "You can expect this to happen more regularly, so be ready."

about this all the time... We stayed away from it, and then at a couple of meetings people wanted the WRNC to weigh in."

Members agreed that since the project was right up against the WRNC's borders, it would be appropriate for them to have a position on the project, especially since any issues with the project if it moves forward would affect the West Roxbury community.

"I think it's actually impacting West Roxbury more than Roslindale, so I don't think it's out of line for us to take a position," said Vice Chair Stephen Smith.

Costello said he and several other members of the WRNC have been following the project very closely. Costello added he's been able to take a look at the traffic study provided by the Roxbury Prep development team, and said he thought it showed a very small increase in traffic.

"If you believe the traffic study, it's really not an issue," he said.

Costello said there was some confusion among the community as to the traffic study. He said originally, the study was done with traffic counts that did not take into

account proposed and approved residential development projects in the area. Then, due to resident input, the Roxbury Prep development team did the traffic study with the proposed residential development. Costello said some residents confused the two studies, but said Roxbury Prep's actual impact, according to the study, would be very small since the development team has stated numerous times that they will require their students to take public transit.

WRNC member Tony Sarufim said he felt any impact on the West Roxbury Parkway could be a serious issue.

"Maybe it's not so bad for Belgrade to Forest Hills, because of the way they're counting them but the West Roxbury Parkway? I Couldn't drive on it at all today, everything is always jammed."

Sarufim also pointed out that because of pedestrians crossing the street on an increased basis, traffic will be stopped more frequently, as on Belgrade there are no crosswalk signals.

"At Holy Name you have to stop for pedestrians. I mean you have no choice and that traffic, it doesn't move at all,"

he said.

Also discussed at the meeting were slight changes to the proposed 27 single-family homes proposed for the Willet Street Extension. O'Neill and Associates Representative Chris Tracy went over the changes proposed by his client, CAD Development.

"The bones of the project are still the same," he said.

Tracy said they would be donating \$20,000 for traffic improvements in the area, which he said would be mostly striping and stop signs. The new plan will also include 66,000 square feet of open space and an entrance to the public trails at the Roxbury Latin campus.

"We're creating a public

easement access path for dog walkers and folks who want to walk in the woods and the Roxbury Latin folks are aware of it," he said. "Residents are welcome to walk in these woods."

Tracy also said while they will not be allowing vehicular access to Washington Street, they are working with the developer at 4945 Washington St. to extend sidewalk access.

The WRNC also heard from the Blue Bikes Team, which is hosting an open house on June 6 at the Boston Centers for Youth and Families Menino Center in Roslindale from 6:30 p.m. to 8:30 p.m. Blue Bikes Representatives Kim Foltz and Jen-

nifer Rowe went over proposed locations for the Blue Bike stations, which include the Anawan Avenue/Belgrade Avenue intersection directly adjacent to Roxbury Prep. WRNC members agreed that might be helpful for students to commute to the school.

Other notable possible locations included but were not limited to the Parkway YMCA, Spring Street at Powell Street, Railroad Street at Willow Street and Washington Street at Metropolitan Avenue. The pair said there will likely be further expansions in the Parkway, as the idea is to create a network in which no Boston resident is more than a 10-minute walk from a Blue Bike Station.

The 26th annual Corrib Classic 5K and Kids Fun Run attracted thousands of residents and out-of-town runners on Sunday.

The race was set up more than a quarter-century ago to benefit the Corrib Charitable Trust, which has now raised more than \$1.4 million for local causes.

"I just want to say thank you on behalf of my family and my fellow board members on the Corrib Charitable Trust," said Tony Bligh of the Corrib. "This is such a great day and have fun!"

Boston Mayor Marty Walsh also spoke while the thousands of racers limbered up for the event.

"I'm not going to talk long, you didn't come here to listen to speeches, but I want to thank the Bligh family and the Corrib and all they do," he said. "Today is a great day for West Roxbury and the money that's raised today goes right back to the community so I want to thank them for their generosity over the years and years and years they've been doing this."

Walsh also acknowledged fellow public officials at the race, including runners District 6 City Councilor Matt O'Malley and State Rep. Edward Copping.

"Also my favorite Rush in West Roxbury is here, (State Sen.) Michael Rush's mother Jenny Rush is here today," he said. "And I want to say thank you to the Lord of Mayor of West Roxbury, Richie Gormley. I don't know though, his race shirt has his name on the back so I don't know if he's going to run for mayor in the next couple of years, but we'll keep an eye on him. Have a great day today!"

Emcee Thomas Doherty opened the ceremony before the race began.

"It's race day everybody!" he said. "It's been 26 years, and this great annual event run by the Corrib Charitable Trust has raised over \$1.4 million... We'd like to thank all of our supporters because without your support this would not happen. We'd also like to reach out to the Cooperative Bank, helping us by being the patron saint of our race and all the support they give the day of the race."

Doherty also gave a special shout out to race co-founder Marty Bligh.

"Yesterday was his birthday so give it up for Marty Bligh!" he said.

been retaliatory rent increases after residents brought up issues such as mold, pests and parking restrictions.

Resident Bruce Green said he became aware of City Life when they were passing out fliers to inform residents of their mission to help residents fight unfair evictions and housing practices. He said he was issued an eviction notice after discussing income issues with management and has been fighting it for almost year now.

“I thought it was all just me, but when I started going out and canvassing and hearing all the problems everyone else was having in this complex, I said it isn’t me, it’s them,” he said. They don’t repair the apartments. The apartments have rats, roaches, mold, and then they want to raise your rent every year. They have hardly done anything to my apartment since I moved in here two-and-a-half years ago. Oh, they did do something. They replaced my on/off switch for my light... And when I first moved in, December of 2016 I had no heat because they didn’t change the filter in the furnace. Because they didn’t change the filter in my unit,

there was no ventilation. I put my bed in the middle of my living room and I heated my space with the oven. I know it’s dangerous, but it’s better than freezing.”

According to a letter dated March 31, 2019, written by City Life and signed by more than 50 residents, several rent increases at the building have been reported at \$700 a month. The letter states that these increases and eviction notices are retaliatory to residents who are asking for “basic repairs and services,” and demands that these practices cease. The letter also demands that all dangerous conditions in the apartments be fixed. The letter also asks that the Low-Income Tax Credit (LIHTC) payment standard requires rent increases only go up 3 percent each year.

Lincoln Ave. Partner and CEO Zachary Ulman said they have received the letter and responded.

“We wrote a letter to every resident and we addressed a handful of their concerns,” he said.

Ulman said Lincoln has never and never will “raise rents in a retaliatory manner.” He said he does not believe the \$700 a month rent increase

accusations.

“Our rents are governed by (the Federal Housing and Urban Development Department [HUD]), and HUD sets what our maximum rents are,” he said. “The maximum increase in Massachusetts, I believe, was 9 percent. I just don’t see a world in which that would translate to \$700 within a year. I believe our highest year-over-year increase we saw when I reviewed this with my team yesterday was \$200... Our rental increases are regulated by HUD and by state and local laws, and so with the average rent in Stony Brook, \$700 would be an over 50 percent year-over-year increase in rent, so it’s hard for me to see how that could have happened.”

Ulman said, as an example of how a \$700 increase could occur, is if a resident’s income increased to a point where they are no longer subsidized. However, he did not have a specific example of that in Stony Brook. He did say he wants to work with residents to fix any ongoing concerns like the reported mold and pest issues.

“We have high expectations on what we expect from our units and, if that story is

true (the \$700 increase), we would like to work with the tenant to address it,” he said. “Our property management team Sawyer (Realty Holdings) is on site and we encourage all residents to call the office, get a ticket submitted and we’ll work diligently to work through these.”

Lincoln Ave bought the property from Sawyer last May, but Sawyer still manages the property. Ulman said they have had dealings with dishonest property management companies in the past – the company owns properties in Florida, Texas, Nevada, Washington State, Maryland and Boston (with the majority being located in Florida, according to the company’s website) – but he doesn’t see that with Sawyer, and said he does not believe there is a disconnect between the owners and the management.

“It certainly could be possible, but we’ve been in pretty close communication with

Sawyer and I think they’re, as far as we can tell, operating in good faith and are taking care of things in a timely manner,” he said. “It would be surprising to me because we’re not the type of owners who buy a property, sit on it for 12 years, totally outsource property management and don’t pay attention... We’ve had other property management companies that we’ve had issues with that we spotted early on... There’s nothing that would lead me to believe that Sawyer is not operating in good faith.”

Resident Skyndy Suffrin said she disagreed, and spoke to the majority Haitian population of the building in Haitian Creole to the residents during the protest.

“We should be united and come together,” she said. “Together we will fight better.”

Sawyer did not respond to a request for comment before the Bulletin’s deadline.



consisting of residential, office, restaurant, fitness and retail uses, including a new building grocery store, and a one-acre public open space.

Michael Sinatra, project manager for the Boston Planning & Development Agency (BPDA), opened the meeting with an overview of the project process so far and turned the meeting over to John Twohig and Mike Barelli from New England Development which was involved in bringing the current Stop and Shop to Allston 30 years ago.

Barelli reviewed the project which includes roadways, parkways, connections with the T and pedestrian walkways. David Manfredi, an architect for the project, emphasized efforts to bring a city neighborhood feel to the site. "What we're talking about tonight are four sites, three on the north, one on the south. We are trying to create blocks that are walkable," said Manfredi, including connecting Everett Street and Guest Street. "What it's really doing is making the connection through the current Stop and Shop parking lot. There will be one acre of open green space. It is designed to be a neighborhood amenity." The Stop and Shop Building A would have five levels of housing added, Building B would have retail at the base and office space, Building C would be a combination of retail space and 396 units with parking spaces for 204 cars, Building D would include retail space and 306 residential units with parking spaces for 203 cars. "We want these blocks to be active on all sides. What this is about is mixed use, said Manfredi.

The developers highlighted how they had incorporated feedback from previous public

meetings and now included 115 affordable residences and over 110 ownership residences. They noted the current benefits of the plan as providing significant up-front infrastructure improvements totaling \$20 million; a unified street grid; a transportation network; new green space; and a flagship Stop & Shop with indoor parking and loading.

An estimated 20 people stood in line to comment, with all but one, highly critical of the current plan. Anger over increased traffic, density, lack of more affordable housing and not enough green space dominated the remarks.

Jane McHale asked, "Why is this so big? It is so impacting to transportation, which is poor. This does not do us a service in terms of our quality of living. The mayor says we need more housing. We need more affordable housing."

She went on to add, "Maybe you can help the city of Boston with its problem—traffic, access roads, affordability, and greenspace. This is much too big."

Barelli said he had heard a lot about affordability and is working to increase it and is committed to the green space remaining on the site through perpetuity. Audience members remained unconvinced. One complained, "This amount of green space is actually an insult. We need way more green space here."

A local small business owner noted, "Ever since they opened Boston Landing, parking has been hell. You are taking a hellish parking situation and making it a lot, lot worse." Another said, "You are going to destroy this neighborhood and

create a second downtown."

Local Brighton resident Kevin M. Carragee read a list of problems he and others have with the plan.

"We want the public space publicly owned. There is no commitment by the MBTA to improve transportation to the site."

Carragee, a neighborhood resident since 1989, spoke about projects that had been stopped in the past due to neighborhood opposition. He praised the strength of community power and hoped the same kind of passion could be rallied to stop this development.

"People get ready, there's a train comin', you don't need no baggage, you just get on board," he added, quoting the 1960s Curtis Mayfield song.

"This should be a place we're all excited about," said another neighbor, pointing out that no one has spoken up to that point in support of the development in its present form.

A speaker who had been a graduate architectural student complained that there was no real physical model of the development to show citizens what it would truly look like. "It's like asking us to judge the Mueller report from Barr's four-page report," said the speaker. Another noted that no elected officials were present for all open question portion of the neighbor questions/comments. "I feel our voices are not heard. We are not being listened to."

The next meeting for the project will be the Impact Advisory Group (IAG) on June 12 at WGBH.

# Mayor addresses Hyde Park Board of Trade meeting

A Hyde Park Board of Trade (HPBOT) meeting took place on Tuesday, May 28 at the Fairmount Grille. The room was completely filled with residents, eager to listen to guest speaker Mayor Marty Walsh.

Walsh opened his speech by thanking Councilor Tim McCarthy for his service and dedication to Hyde Park. “He has brought a lot of reason to the city of Boston and Hyde Park, so I want to thank him,” Walsh stated.

Walsh discussed the need for housing and development in Boston. He explained that when he became Mayor in 2014, his administration inherited a housing crisis. So he released Housing a Changing City: Boston 2030, a comprehensive housing plan designed to address the housing needs of Boston’s growing population. In 2018, a planned assessment found that Boston’s population was growing faster than anticipated, with 759,000 residents expected to live in Boston in 2030. The administration wants to help create 69,000 new units of housing at a variety of income levels across the City, including nearly 16,000 new units of income-restricted housing that will bring Boston’s total number of income-restricted units to 70,000 by 2030.

Walsh explained that when he first entered office, areas such as Copley, Back Bay, South Boston, and Beacon Hill were the focus of housing development. Many parts of

Dorchester, Mattapan, Roxbury, and Hyde Park were being overlooked. “We want to do Boston 2030 without gentrification and displacement,” remarked Walsh. “We do not want to lose the people who grew up here and built the community.”

“We have a couple of proposals in Hyde Park that are big, but if we truly want to continue to grow as a city, we have to have an honest conversation with each other about where we are in economic development,” Walsh stated. “I’m not looking to change the community, what I’m looking for is to make sure we support our businesses, support our main streets, and having people in our community supporting what we have. If we don’t do something about [the housing shortage] we won’t be able to.” Walsh remarked that there needs to be more honest conversations about development during community meetings.

Scott Batey, HPBOT President, opened the meeting by discussing a recently published study focused on newly diverse communities in Boston. The study, titled Changing Faces of Greater Boston, is collaboration between Boston Indicators, the UMass Donahue Institute, and the four free-standing research institutes at UMass Boston dedicated to the major communities of color and faculty from UMass Boston’s McCormack Graduate School. The report discusses a regional analysis, newly diverse communities in Boston, and Asian Americans, African Americans, Native Americans, and Latinos in

Greater Boston.

A section titled Newly Diverse Communities in Greater Boston highlighted the growing Latino and African American populations in Hyde Park. The study shows that Hyde Park has gotten much more diverse since 1990. From 1990 to 2016, the Latino population in Hyde Park grew by 428%, while the African American population grew by 112%. In 2016, Hyde Park became the third most diverse neighborhood in Boston.

Batey explained that community groups, such as the HPBOT, are critical when creating an inclusive community because it helps neighborhoods reflect and make sure “everyone is invited to the table”. The next HPBOT meeting will take place on June 25 at the Fairmount Grille. An election of officers will be held at that meeting.
