Wandering up Walter St., one would eventually reach the gate to the Arnold Arboretum. But you don't have to go there to enjoy nature's splendor.

A walk through the side streets to Selwyn St. or Hazelmere Rd. will take you to the Roslindale Wetlands Urban Wild, where about two dozen volunteers gathered Saturday morning, May 11, donning saws, rakes, cutters

and smiles.

The City of Boston's Greenovate Boston initiative, the Environmental Department and the Parks and Recreation Department coordinated the three-hour cleanup. They were joined by members of the Roslindale Wetlands Task Force and neighbors concerned about protecting this little-known natural resource.

"Most people have no idea that it is here," said Janet Forrester of the Roslindale Wetlands Task Force, a subcommittee of the Longfellow

Area Neighborhood Association (LANA). "You can't see it from Walter or Weld Streets. Most of it belongs to the City, but some belongs to the Department of Conservation and Recreation (DCR)."

She described how the task force is not only trying to maintain the wetlands by freeing the area of debris and non-indigenous plants, but also from development. For more information, go to <https://sites.google.com/site/UrbanWild>

## MHC discusses dispensary, Blue Bikes

Silver Therapeutics promises \$10k



About 30 residents came to the Mount Hope Canterbury meeting to hear from Silver Therapeutics and its proposal for a dispensary.

The Mount Hope Canterbury Neighborhood Association (MHC) heard a presentation on Thursday, May 9 by Silver Therapeutics about a new cannabis recreational and medical dispensary slated for 717 American Legion Highway.

The proponents increased the facility's slated parking to 22 spaces, and the project also includes a greenhouse and a lot of modern architecture at the current site of City Farm Greenhouse and Nursery. But those weren't the items that got residents' attention.

Silver Therapeutics said they promised to donate \$10,000 a year for as long as the business exists there to the MHC. Owners Josh Silver and Brandon McKee said they want to pro-

vide safety enhancements and investments that benefit the surrounding communities, and they would also attend MHC neighborhood meetings as stakeholders.

"If you guys had come back here and you were not putting profit sharing on the table I would have known you were full of (it)," said one resident at the meeting.

The presentation also included the addition of local cannabis entrepreneurs Sieh and Leah Samura, who had originally proposed a cannabis research, development and manufacturing cannabis site at 612 Hyde Park Ave. in Roslindale. The pair said they joined up with Silver Therapeutics after they both realized they had the same goals in terms of social

## DCR reopens Kelley Field House

After a \$1.2 million renovation, the Department of Conservation and Recreation (DCR) officially reopened the Kelley Field House in Hyde Park on Friday.

The ribbon-cutting was sparsely-attended, presumably due to the rain. DCR Commissioner Leo Roy came to speak during the event and said the department has been looking to invest in Hyde Park, and this is the first step in the completion of that goal.

"There's nothing I like better than coming to Hyde Park and cutting ribbons," he said. "This is something that we've been doing for the last several

## New construction for domestic violence housing under way

It looks like a typical corner-lot apartment building in Egleston Square; a long, four-story brick building broken up with bays, generous windows and wide cornice. The first floor is welcoming with open glass picture windows for offices, day care and entrances. It's called Westminster House.

But what architect Kitty Ryan of The Narrow Gate Architecture has created is a comfortable,

32-unit home for domestic violence victims developed by The Elizabeth Stone House (ESH) at 3012 Washington Street at Westminster Avenue.

Construction began in April and ESH Director of Development Jim May is relieved. "It's been a long time coming," he told the residents at the May 6 meeting of the Egleston Square Neighborhood Association.

## Brighton does spring cleaning with Love Your Block event

Early Saturday morning, Brighton residents gathered together to clean up the streets during the The Love Your Block Spring Cleanup Day project.

Everyone was out bright and early at 9 a.m. in front of Corrib Pub & Restaurant on 396 Market St.

People from all over the neighborhood came together to do some spring cleaning to make their community stronger and more presentable. Police officers, union workers, and neighbors came together on this day for a common goal.

"The most basic goal is to pick up all of the trash and street litter that gets revealed when the snow melts" said Brighton Main Streets Executive Director Liz Sullivan. The secondary goal, she said, is to "bring neighbors together, enjoy the weather on a nice day, and show residents and businesses that people care."

Sullivan pointed out that often the weather impacts how many volunteers would show up. Luckily, May 11th, started with a sunny morning.

By promoting for a specific day to clean, it allows cleaning the community to be more efficient.

"It's a resident community-driven event that the city supports by promoting it as one day where everyone can do it together. And it also consolidates the load on public works, so if it's all happening on one day it's so much more efficient for them to come and pick up everybody's trash" Sullivan said.

Public Works employees drive around Brighton picking up trash that was swept in recyclable garbage bags. Police officers also stopped by to talk

to residents and enjoy the event.

"I think today turned out really well. It's great to see regular folks take time out their Saturday to contribute to the neighborhood and help with the cleanup... it's great to see that people care about the neighborhood" said Mayor's Office of Neighborhood Services Allston Brighton representative Conor Newman.

Some people said they heard about the event in different ways.

"Some folks that didn't know about the event just signed up and now they are connecting with people and getting involved in the neighborhood" said Newman when asked how this event is able to bring the community together. Newman said he hopes to see more events like this one.

"Our mission objective is to beautify the place so that people can enjoy it" said Brighton Main Streets President, Chris Parisi.

He said he also appreciated all of the volunteer efforts that were given, including the Spaulding Rehabilitation Network who brought others to attend.

"We do this a couple times a year. We're trying to drive businesses, we have vacancies and we're trying to fill them. Trying to keep the folks who're here to keep them here and make Brighton a destination place."

In addition to appearance, volunteers planted new tulips and other plants around the city. Food and refreshments were also provided to volunteers and to anybody who walked by. Officers on bikes, runners, and people walking

# East River Street Neighborhood Association discusses 64 Poydras St.

The East River Street Neighborhood Association met on May 13th at 912 River St. Topics of discussion included the new Goodwill opening on 892 River Street, 15 proposed residential units on Poydras Street, and information regarding programs for aging adults.

Thomas Piatt of Piatt Associates Architecture gave the neighborhood association a presentation on his proposal for 15 residential units on 64 Poydras Street. The building would include three stories with five units per floor, large windows to provide light, super-insulated energy efficient units, energy efficiency and sustainability, solar panels, private garden patios for five units, shared yard space, in unit washer and dryers, bicycle parking and 1.5 spaces of parking per unit.

The feedback from the neighborhood association was mostly positive. One neighbor raised traffic concerns.

“How much will the units sell for?” Questioned one neighbor.

Piatt explained that the units will be priced between \$325,000 and \$335,000. Piatt

James Harder, the Director of Communications for Goodwill Massachusetts, was present at the neighborhood meeting. He explained that the new Goodwill Store and donation center in Hyde Park, which is located at 892 River Street, will be opening in late June or early July. Harder remarked that the Hyde Park store will have a modern design.

“Goodwill is slowly undergoing new branding,” he stated. Harder explained that people will be able to drive up to the donation center to drop off their used goods. The new Hyde Park store is the 12th Goodwill in the Greater Boston area. “Hopefully we will see you all shopping and donating!” Harder exclaimed.

The new store is hiring for full and part time positions. Those who are interested should email Karen at [krobles@goodwillmass.org](mailto:krobles@goodwillmass.org) or call 617-541-1227. Interviews will take place on May 21st, 22nd, and 23rd.

Another topic of discussion was programs for aging adults. Elsa Bengel and John Wicker from JP @ Home attended the neighborhood meeting to discuss their membership based pro-

gram of Ethos. JP @ Home is a 44-year-old non-profit dedicated to promoting the “health, independence, and dignity of older adults and persons with disabilities”.

The program is intended for middle income, older adults who reside in Jamaica Plain, Roslindale, West Roxbury, Hyde Park, Mission Hill, Roxbury, and Brookline and want to age in place. “Members subscribe to JP@Home to receive access to Ethos’ services at discounted rates and numer-

ous social, health, and wellness activities,” Bengel stated. Activities include board games, theater, reading, dining out, tai chi, tech classes, walking groups, spirituality, men’s social, and much, much more.

“It takes a village to age well,” explained Bengel. “We are here to spread the word about

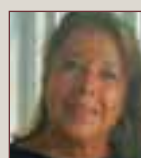

# NEEDLES AND THE DAMAGE DONE

We are out of patience.

Yes, we are fully aware of the psychological claim that drug addiction is a “disease,” especially if you broadly apply that definition.

And sure, opioids have somehow become a recent “crisis,” even though kids in Southie have been dying for years.

The “solution,” thus far, is to mollycoddle addicts while punishing or ignoring the broader citizenry. Mrs. Jones cannot get post-surgery pain killers, you know, because some goon in Charlestown is nicking grandma’s stash from the medicine cabinet.

Did we mention that we were out of patience?

Let’s refer to last week’s Bulletin to elaborate on our frustration.

Reporter Jeff Sullivan wrote: “During last week’s Boston City Council Meeting, At-Large City Councilor Annissa Essaibi-George introduced a new citywide ordinance to help residents safely dispose of needles and sharps.”

Sure. Fine. Adding some Sharps containers to the public landscape may be necessary, albeit a wrong-message and eyesore.

The ordinance would establish the Sharps Stewardship Program (SSP), and would, if enacted, require a manufacturer of sharps and needles sold in the city to be subject to several regulations.

Here is the problem. Very few will use them.

“We know the City of Boston and the Boston Public Health Commission (BPHC) have collected hundreds of thousands of needles, and that does not measure the countless needles that we know are ending up in household trash,” Essaibi-George said. “We’ve got not only an opioid crisis and substance use disorders that are contributing to the improper disposal of needles, but we also have those dealing with chronic illnesses and those with substance abuse disorders with needles ending up in household waste.”

Never mind “household waste.” Many of these needles are just carelessly dropped to the ground, playgrounds and schools alike, even if a container is nearby.

So, given this addict laziness, how will this help: “The ordinance states that the manufacturer may include a collection system of two disposal methods, which may include a mail-back program with prepaid postage, collection kiosks, drop-off day events at locations in the city or in-home disposal methods that render a product safe from misuse and comply with applicable city, state and federal laws and regulations.”

“Most of the needles that were collected last week during our needle take back day involved our residents who are unable to dispose of their needles due to the expense of disposal,” she said. “It is important and critical that our pharmacies play a role in the life cycle of our needles and proper disposal,” the Councilor added.

Pro Tip: pharmacies are not the ones sharing needles with heroin addicts.

Essaibi-George added that larger pharmacies would be required to participate in needle take back programs, “but she added that there are concerns that such requirements may negatively impact some of the city’s smaller pharmacies.”

Great, so let CVS and Walgreens subsidize an equal source of an already specious claim.

Break out the pitchforks. What we need is a strict, arrestable penalty for those who wantonly and carelessly dispose of needles. Use DNA testing if necessary. Lock these idiots up and let a jail cell become their rehab spa.

“Oh, boo hoo, the poor victims of addiction.”

Let’s see those crocodile tears if YOUR kid steps on a junkie’s needle.

## Suggestions for improving 2019 life

Some things are a notch or two above common sense, but they still deserve scrutiny. They may be common sense to many of us but they need explaining to other people. Consider the following:

All sorts of safety requirements are now incorporated into playground design. The seesaws of yesteryear seem to be forbidden altogether. But swings still present a common danger to youngsters walking in the area: they don’t have any idea of how wide an arc that a swing-rider will carve out. Could not red lines be drawn that indicate to such walkers that a danger zone exists?

When the Ryder Cup came to The Country Club a number of years ago, asphalt on nearby rotaries had white lines drawn on them to indicate lanes. Could not the same measure be done today for all our roundabouts to indicate which lanes are for exiting?

The gentle speed bumps that now exist in Brookline to slow down vehicular traffic

need to be replicated elsewhere. Granted that the fear exists that they may cause a motorist to lose control, but properly spaced signage may prevent this. As for snow plows, hmmm.

Radar-based signage that indicates speed need is already enhanced—but not that commonly—with a flashing bright indicator below when the maximum speed is exceeded. The upgrade, needing to be more widespread, will really grab a motorist’s attention.

Single stream recycling, as with the blue 96-gallon bins in Boston, does NOT process plastic bags, such as CVS, Glad, etc. These need to be brought separately to Roche Brothers, Lowe’s, or other stores. The inclusion of plastic bags slows down recycling conveyor belts. China is already refusing much of our recyclables, as it is “contaminated” by other products contained herein.

### All babies have the same rights

To the Editor:

Babies are babies, no matter where, when, or why they are born. Yet right now, Massachusetts Democrats want babies born during failed post-24 week abortion procedures to be denied medical treatment.

A bill gaining traction among the Radical Left on Beacon Hill would remove the requirement to have lifesaving equipment available in rooms where late-term abortions are performed. The babies born during failed procedures would simply be left

to die.

The twin bills introduced on Beacon Hill in the Senate (S. 1209) and in the House (H. 3320) would establish a two-class system where some babies are given medical care and others are left to die.

This should not be a partisan issue. In fact, 75 percent of Americans believe that a baby who survives a failed abortion should be given the same medical treatment as any other baby born prematurely at the same age.

The Radical Left, under this bill, also want to repeal parental

consent requirements for minors between the ages of 12 and 17 who are considering having an abortion. The proposed legislation would also repeal the law requiring late-term abortions to be conducted in hospitals.

A baby’s right to life and medical care does not change because it was born in an abortion clinic instead of a delivery room. Massachusetts law as it currently exists requires medical care to be administered to babies no matter where, when, or why they are born.

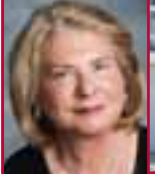

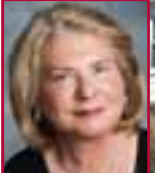

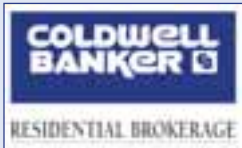

That's why we've also scheduled road improvements for Bellevue Street as part of our Roadway Reconstruction Program.

We believe that funding equitable and accessible community spaces is critical in keeping Boston not only a beautiful city, but also an open and welcoming one. That's why we're investing \$1.36 million to improve the baseball and softball fields in the Hynes Playground. We're also investing \$300,000 to design play lot improvements, pathway repavement, and installation of modular bathroom facilities at Millennium Park. We're also continuing to invest over \$6.3 million to upgrade park

lights across the city, including new field lights at Billing's Field.

In Hyde Park, we're making investments across a wide range of projects, including parks and open space, streets and transportation, our schools' infrastructure, and our delivery of City services.

In Hyde Park, the environment and accessible, open spaces for families, neighbors and the community are key investments. That's why we're putting \$7 million into equitable and accessible open spaces and parks in Hyde Park, including \$1 million for play lot upgrades in Stonehill and Amatucci Playgrounds, and \$640,000 for trail improvements and wetland restoration at the Sherrin Woods Urban Wild so residents can continue to enjoy these spaces in the coming years.

We're continuing to invest in the George Wright Clubhouse, this time allocating \$1.4 million to upgrade building systems and the construct of an accessible bathroom. We're investing an additional \$200,000 yearly to the George Wright Golf Course to improve drainage, paving, and other areas. We believe that funding community spaces is crucial to keeping Boston not only a beautiful city, but also an open and welcoming one.

Also, we're allocating much of

our budget to infrastructure and transportation efforts in order to make navigating Boston safe, reliable, and equitable. We're putting \$4 million towards improvements to the Dana Avenue Bridge, including replacing the bridge superstructure and repairing bridge abutments.

\$2.9 million will be distributed for designs to improve traffic patterns and ease congestion on the Father Hart Bridge. This will go towards installing new traffic signals at the intersections of Milton Street at Neponset Valley Parkway, Milton Street at Hyde Park Avenue, and Neponset Valley Parkway and Hyde Park Avenue at Wolcott Square. Additionally, it will support the installation of wheelchair ramps, new crosswalks and bicycle accommodations.

We've also funded a number of longer-term projects designed to create growth and opportunity in each neighborhood long after the initial investment. These account for the requests of the neighborhood's residents and prepare Boston for the coming years.

With an eye towards the future, we're investing heavily in high-quality public libraries to better serve residents. That's why we're making a \$300,000 investment for improvements at the Hyde Park Branch of the Boston Public Library to repair interior finishes and prevent future water infiltration.

Now that we've submitted Boston's budget, where do we go from here? First, to the City Council, where it will be reviewed and adjusted as necessary. After it's gone through that process and secured approval, it will go into effect, starting in July 2020 and running throughout the next 12 months. We hope you will continue to provide your valuable input on what we as a city can do to raise up your community. 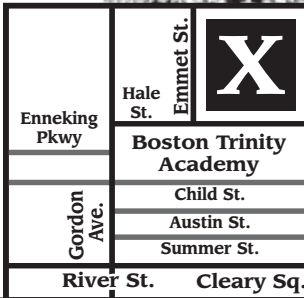

years. Do you realize that in the last several years, the Commonwealth of Massachusetts – the Baker Polito Administration – has invested more than \$7 million into this neighborhood. About five of it is behind us at the Bajko Rink. Improvements include improvements to the compression system and the lockers. Many of you may notice the improvements to the spray deck and the playground, which is almost \$1 million right there.”

The new field house featured an area for concessions, changing rooms and refurbished bathrooms. According to project architect Josh Cane, the field house had been in disuse for about 15 years.

Hyde Park Pop Warner Football member (and former president for about 10 years) Joe Walsh said the new field house looked great.

“When I first started the concessions used to be here,” Walsh said. “I’ve been around since 1998. That’s when my son started. It’s all about the kids; it’s what you do for them. We want to keep the kids safe, that’s our goal for them.”

Walsh said he moved up to the Hockomock Board that oversees 10 towns, but he still comes back to Kelley Field to

help out, grilling hot dogs and hamburgers for the kids. He said he uses a simple charcoal grill, and so he’s concerned about the new concession space. The new space came with gas hook ups for a frialator or a grill, but no actual cooking apparatus.

“I don’t know if it’s going to work out, because we’re responsible for buying all the equipment, and we’re in big trouble,” he said. “We’re not going to be able to afford that. It’s very expensive to run the league.”

Roy said they will be soon moving forward with other celebrations of completed projects in the neighborhood.

“Very soon we’re going to be gathering to cut the ribbon to celebrate the improvements to the playground and the hard courts at Camp Meigs Playground,” he said. “So we’re very excited about that. That’s a playground that’s well-loved by the neighborhood and really needed a face lift.”

Roy pointed out that Hyde Parkers love their parks and open space, and said DCR is responsible for much of it in the neighborhood.

“In this neighborhood, there are 540 acres roughly of open space, and that’s why you all live here because of

the greenery and open space that’s around us,” he said. “But what you probably didn’t realize is that of that 540 acres of open space, 440 of them are managed on your behalf by the DCR. This is why this partnership is so important and why the DCR is such an important part of this neighborhood.”

State Rep. Angelo Scaccia said the project had been in the pipeline for some time, but Roy was able to move it along much quicker than he and State Sen. Mike Rush had anticipated.

“This has been in disrepair for a long time,” he said. “Leo, you came and you expedited it. Mike and I had asked, and you responded immediately. This place is going to be a tremendous asset.”

Rush said that he, Scaccia and the DCR had to work together to pull off the renovation.

“This is what it’s all about right here,” he said. “As the commissioner said, it’s all about partnerships. Nothing is done by an individual, it’s about putting egos aside, digging in and getting things done and that’s what happened here today.”

October 2016 and granted zoning approval in December 2017, the BPDA community meeting was held at the Egleston Square YMCA in July 2013.

ESNA-dormant for almost a decade—had not been revived yet and this was May's first presentation to the neighborhood group.

In the six years since the BPDA, construction costs have risen from \$15 million to \$25 million.

"Yes, this is an extremely large increase over six years," May told the Bulletin. "As planning proceeded, programmatic needs increased the complexity of the building and costs went up. Costs also went up for both childcare and private consultation space. Rising costs of construction materials also had an impact."

"We bought an old abandoned warehouse," May told ESNA, "and we're building housing for the victims of domestic violence. Thirty-two units affordable at 30 percent to 50 percent area median income. We have city and state vouchers to subsidize the rents."

"We will get a huge windfall from the city in December that will subsidize rents for up to two years," he said.

"We will get \$615,000 from the Boston Continuum of Care for homeless families through DND."

"It will in part provide permanent housing as quickly as possible for survivor families. During the two years, a household is expected to see their incomes increase either through public ben-

efits or employment. The goal is housing stability for those households."

ESH is starting that right away. It will host a job fair for Westminster House at Academy Homes on June 10.

Originally built in 1925 as a garage and then an automotive dealership for Westminster Motors (now on Morrissey Blvd), it was purchased by ESH in April 2013 for \$724,000.

Part of the delay was due to soil contamination cleanup and in October 2015 the EPA granted \$200,000 to start clean-up; DEP added an additional \$65,000 later. That work didn't begin until June, 2018.

ESH was founded in 1974 to provide housing for women with mental illness, later turned to domestic violence shelter and finally transitional housing for domestic violence survivors.

Their clients are overwhelmingly poor. They come mainly from Roxbury, but also Jamaica Plain and Dorchester.

ESH is located at 8 Notre Dame Street on the edge of the Dimock Community Health Center,

"In 1987 it had outgrown its housing space," May said "and opened up a home on Sheridan Street. That had 18 beds, but it burned in August 2007 and we had to find replacement space."

3012 Washington Street was a deep, cavernous 29,000 square foot building and had been on the Problem Properties list for years.

"After we bought it we heard stories from the neighbors of

people living there in tents," May said. "So the project not only will allow Elizabeth Stone House to increase domestic violence services significantly, but it will replace an abandoned eyesore with an attractive multi-service space."

Trying to be a good neighbor, in July, 2014 ESH hired the Mayor's Mural Crew to paint colorful decorations on the building.

In addition to the apartments the building will have a licensed day care on the second floor.

"The capacity will at first be for infants and toddlers," May said. "But also after-school programs will also be available to the community. We will also have extensive space for public meetings and classes."

ES provided programs in adult education and job training and helps clients complete their GED.

"We're never going to be able to provide enough safe housing,"

May told ESNA. "In 2018, we got 9000 service calls for domestic violence from the four police precincts in our service area, E13 (Jamaica Plain) C11 (Codman Square-Dorchester) B2 and B3 (Roxbury and Mattapan). That's probably 36,000 incidents."

"So we also provide services for people not living in our housing," he said. "We will be able to increase our programming in the new building; referral services, psycho-therapy emergency financing. We have a wide range of services and expect to serve 2000 clients in one year. We only have 11 apartments in our old building [on Notre Dame St.], but most domestic violence victims don't want to leave their homes. We want to keep them in their homes."

Alvin Shiggs is co chair of ESNA.

"What are you going with that building on Notre Dame?" he

asked. "And do you have any partners?"

"It's been sold to the St Mary's Center for Women and Children," May said. "They will expand it to 14 units. All affordable. We didn't want to turn the building over to a market rate developer."

"We've worked with other non-profits," May said, "Domestic violence counseling at Dimock and Goodwill. We're always looking for opportunities to be case managers. We accompany victims to court. We give moral support. We're not lawyers."

"The entire [domestic violence] system is completely clogged," May said at the ESNA meeting. "We have no emergency space right now. The shelters keep people for two and three years. There is no place for them to go. The transitional housing list is closed. Transitional housing is becoming permanent housing."

**Ask The Doctor**

Junior Damato began servicing vehicles in 1969. He owns a 10-bay auto repair service center in Hyde Park and an 8-bay center in Middleboro. Junior is an ASE-certified Master Technician, ASE-certified L-1 and ASE-certified Natural Gas.

**To the Doctor:** The windshield wipers on my 2008 Jeep Liberty swipe on when I start the car. The intermediate wipers are always swiping – rain or shine. They quit doing that for a few weeks, but then they go back to constantly swiping across the windshield. Mechanics have looked at the issue, but can't seem to solve the problem.

**From the Doctor:** You are not alone with wiper complaints, as well as headlight and directional signal faults. The wipers work off the same multi-function switch on the steering column. Unlike the old days when you would switch on the wipers, headlights, directional signals, etc., you are asking a control module to activate the item. The switch goes through a module via a CAN BUS line – welcome to the world of electronics. The use of a factory equivalent scan tool and both Alldata and Identifix will assist the technician to the correct repair. Sometimes removing the negative battery cable for a couple of hours can cure some computer glitches – same as rebooting your phone or home computer.

**To the Doctor:** I have a 2005 Mercedes CLK320 convertible. The convertible top is broken; one of six hydraulic pistons is leaking. Because it's broken electronically, I cannot access the trunk and hydraulic reservoir. Is there any way I can open the convertible top manually? Or, is there any other solution to removing the hydro pistons for a rebuild?

**From the Doctor:** Make sure the trunk lock switch (if equipped in the glove box) is not on lock. Next, look under the rear license plate – there should be a key slot to insert the key. Remove the key from the key fob, insert it, and try turning it. This information should also be in your owner's manual. In some cases, removal of the rear inside panel can get access to the trunk to get to the trunk lock safety release.

roslwetlands/.

“This area was threatened by a developer years ago,” she said. “Now the threat is even more dangerous. In 2010 and in 2012, we had a hundred year’s flood because of climate change.”

Volunteers treaded through the mud and began digging out Japanese knotweed and garlic mustard plants, which are invasive and quickly overgrow the area.

“We already know that all the dampness causes mold,” she continued, adding that the wetlands help by managing flooding. “In turn, there will be structural damage to homes. If developers continue to build at this density, we will not only lose our natural resource but the homes will suffer damage. They cannot build near wetlands. Developers are thinking of the quick buck and not in the long term.”

In January, City Councilor at-Large Michelle Wu and District Six City Councilor Matt O’Malley refiled the Local Wetlands Protection Ordinance. It would empower the Boston Conservation Commission to require green infrastructure with new development and also to protect urban wetlands.

Greenovate Boston outreach manager David Corbie had been a volunteer for two years before assuming his role.

“Our first cleanup effort was last July, and this is our sixth in total,” he said. “We have four more scheduled for the rest of the year.”

He called the wetlands “the best-kept secret in Roslindale.”

“When you have events like this, you build up momentum, you build up community and there is instant gratification. There needs to be environmental stewardship.”

Linda Stern, who lives on Sheffield Rd., was one of the few people on the cleanup team who knew of this secret on her own. A resident for more than six years, she came upon the wetlands while walking through the neighborhood.

“I had seen some wild crocuses on Weld St., and I followed them,” she said. “Then I realized I was at the Roslindale Wetlands Urban Wild. I just felt drawn to it. I have seen ducks swimming in the pond.”

The paths, overgrown with branches, weeds and brush, were visible and walkable within an hour thanks to the efforts of the group. As if in gratitude, the sun shone brightly overhead.

“I am thrilled to be here to support the cleanup effort,” Anne Herbst said. “I serve on

the Boston Conservation Commission, and I live in Roslindale on the Hyde Park border. This area is a little hidden gem.”

Bethany Czerny, who volunteered last year, had several reasons for dedicating her time to the effort.

“I like to have a place to come to, even in an urban area, that is part of nature,” she said. “I could care for it and nurture it..”

Czerny said she loves the Arboretum as well, “but it has an institutional feel.” In contrast, “here nature is the artist,” she explained.

Amanda Forde lives nearby and decided to join the cleanup when she heard about it on Twitter.

“I can walk down here for some peace and quiet,” she said. “Don’t get me wrong. I love the Arboretum. But this feels so different.

“I don’t have a green thumb or anything, but I figured I could help,” she continued. “I didn’t know anybody. But we all started chatting, and it was a great atmosphere. It was low stress.”

The Dorchester native said she also never knew about this resource in her backyard.

“I have been here 10-plus years, and I just found out about it,” she said. “If there are more opportunities like this, just keep people informed. I’ll be back.”

There were a couple of interesting finds during the cleanup. There was a birdhouse on a pole about four feet high, which volunteers balanced against a large tree.

Then there was a burial marker in honor of “Sweet Sam,” who lived from May 13, 2004 to what appears to be January 2, 2017. The stone was visibly worn, and a second stone with similar markings was split and broken.

“The paper could have a contest about the history of Sweet Sam,” said one of the volunteers.

Nicholas Moreno, the assistant conservation agent for the City’s Environmental Department, said the event was a great success.

“I feel like most residents here have some sort of investment in the environment,” he said. “The wetlands are so important regarding climate change that people feel that sense of stewardship.”

He added that they collected between ten and 15 large bags of invasive species and compost.

“That is not including everything we cut and left in place to decompose naturally,” Moreno said.

The next local cleanup will be the Spring Stewardship Day at Allandale Woods. It will be held on Saturday, June 1 from 9 a.m. to noon. Volunteers can meet at Vincent Road and the West Roxbury Parkway Circle Trailheads at Morey Rd.

equity, and when both teams realized they would violate the half-mile separation rule of marijuana licenses imposed by the Boston Zoning Code.

The couple had already had their license hearing at the Roslindale Community Center, as required by the city and state licensing process, when Silver Therapeutics was first reaching out to the MHC on March 14. They will use the premises at 717 American Legion to develop their products, which includes lotions and salves, to be then mass produced at a different location and sold at retail spaces.

The pair has worked for social equity on cannabis and other issues for more than a decade – more than 20 years in Leah's case – and said they believe in the small local company Silver and McKee have created.

"I work in a nonprofit where I, well, one of my responsibilities is workforce readiness, where I strive to help people move forward and be better in any way possible, however that is, personally,

professionally, and that's something I'm really very passionate about," Leah said.

Residents were also concerned about traffic. Development attorney and former Boston City Councilor Mike Ross said they had conducted a traffic study in the previous months. He said the study found that the dispensary would create a 1 percent increase in traffic during the business' peak hour, but MHC member Lisa Beatman pointed out these counts do not include the projections of traffic increases from approved proposals for multi-family developments.

"There is a proposed development for 106 apartments at Walk hill and possibly 100 more units when they redevelop the Home (for Little Wanderers)," she said. "Then 60 more units proposed at Cummins and American Legion. There will be more cars and we're hoping to reduce that and have more biking."

Ross said they have increased their onsite parking and would promise not to oppose any proposal by the city to in-

stall a bike lane on their side of American Legion, which right now stops at the business as the road comes in from Franklin Park. He said they would also subsidize MBTA passes for all their employees and offer a rewards program for any customer who uses public transit, walking or biking to get to the business. He said there will also be parking for bikes.

Beatman said she wants Silver to reduce the hours of operation for the business, which is currently set at 10 a.m. to 9 p.m.

"As a community we can give strong opinions about hours of operation," she said. "My particular bent in terms of our neighborhood is this is a profit-making establishment that's going to have an impact on our geographical neighborhood."

Also presented at the meeting was potential locations in Roslindale for the Boston Transportation Department (BTD) to install Blue Bike docks. BTD Program Manager Kim Foltz gave a presentation for about five to seven stations among 12 potential locations in the Parkway. Those potential locations include the Arboretum Weld Hill Research Building, Hyde Park Avenue at Walk Hill Street, Hyde Park Avenue at Northbourne Road, American Legion Highway at Canterbury Street, Mount Hope Street at Hyde Park Avenue, Stella road at American Legion Highway, Cummins Highway at American Legion Highway, Washington Street at Metropolitan Avenue, Belgrade Avenue at Anaway Avenue, Railroad Street at Willow Street, Centre Street at the Parkway YMCA and Spring Street at Powell Street.

Foltz said the idea was to make sure that no one station is too far away from another, so that if a rider completes their trip and finds the station full, it's not the biggest inconvenience to find another. Foltz said the plan is to make sure that by 2030, no residence in the City of Boston is more than a 10-minute walk from a bike station. She said this roll out will be part of 20 new stations coming this year.

"In our neighborhood, I think we've been trapped in our cars," said Beatman. "I feel really embarrassed that I work two-and-a-half miles from here and I drive."

The BTD is hosting another meeting with the neighborhood at the Menino Center 125 Brookway Rd. on June 6 starting at 6:30 p.m. to further discuss the placement of these stations.
