LANA reviews Centre/Walter St. intersection

The Longfellow Area Neighborhood Association (LANA) met on March 9 in the Longfellow House Community Room. The agenda included the Boston Police E5 report by CSO Ed Roach, a speech by State Representative Nika Elugardo, a talk by City Councilor Matt O'Malley, and a discussion about the Centre/Walter St. intersection.

State Representative Nika Elugardo spoke addressed neighborhood concerns with members. "I give annual reports - at either the end of the year or the beginning of the year - to let folks know at all the different neighborhood associations

about our offices district priorities and what will be changing in 2020," stated Elugardo. "Last year, our district priorities were housing (in a constituent sense), public safety with an emphasis on new development and community building, and jobs for youth and the elderly."

Elugardo also discussed the legislation she has helped co-sponsor over the past year: "I co-sponsored over 435 pieces of legislation. The area where I thought there was the biggest gap was housing, so I wrote five bills on housing with help from advocates, the council, and other legislators. I filed ten other bills related to things that constituents brought up, including indigenous rights. We have also co-sponsored bills in the

area of animal rights, transportation, public safety, civil rights, and criminal justice reform."

After her speech, Elugardo responded to questions, comments and concerns from LANA members. Many board members expressed concerns with the Centre/Walter St. intersection project. Elugardo explained that "money for the project has been allocated" and is predicted to be completed around fall 2021, which she believes to be "a bit too optimistic".

One LANA member questioned why the state would set aside a certain amount of

Taft Parking Lot development a no go

In 2017, the City of Boston's Housing Innovation Lab, under the auspices of the Department of Neighborhood Development (DND), started a program to look at potential sites for development with public benefit in mind.

Most recently, the idea for a residential building placed above the public parking lot at Taft Hill Terrace in Roslindale was pitched. At a Jan. 30 meeting in Roslindale, residents were not too keen on the idea, and the city announced this week it will not be continuing with the process.

Roslindale Business Group (RBG) President and Founder John Malley said at that time

30,000 people come to Roslindale Village (nay Roslindale Square) to shop, and he said those people need parking that could be taken up by residents of a new development on the 43,000 square foot lot. The idea was to keep the public parking, but residents were not convinced that those living in the development would stay out of the lot and keep it open for business, despite its closeness to the Roslindale MBTA Commuter Rail Station.

"The efforts of the business and residential community have been successful," Malley said. "Thank you to everyone who at-

ERNA urges Burger King compromise

Burger King again was the focus of the East River Street Neighborhood Association (ERNA) meeting on Mon., March 9, with board members urging opponents to work with developer Todd Finard to compromise on what they believe is an improvement to the plaza.

Finard told the group of about 25 people that he came to "observe and answer questions" rather than give a formal presentation.

"Certainly the one thing I've learned through all of this is that I should err on the side

of caution and invite as much conversation as I possibly can," he said.

He added that he has not heard back from the Licensing Board about a date for the Burger King to go forward with its application. The Jan. 15 Licensing Board hearing was deferred after other neighborhood groups, including the Belnel Family Neighborhood Association (BFNA), said there had not been enough community outreach, and they were taken by surprise by the Burger King being built.

The BFNA is holding a

Covid cancels Boston

The COVID-19 Coronavirus has created a State of Emergency in the Commonwealth of Massachusetts, and while the big headlines of the St. Patrick's Day Parade might have hit many residents hard, there are many smaller community events that have also been canceled or postponed.

The West Roxbury Civic Improvement Association (WRCIA) announced on Tuesday night that the group's Wednesday meeting had been canceled. WRCIA President Larissa Castro said they will consider what to do at their next meeting.

"Sorry for the inconvenience but we don't want anyone to get sick," she said. "We will update when we reschedule."

West Roxbury Business and Professional Association (WRBPA) President Jim Hennigan said they are postponing the third annual Mary Mulvey Jacobson Families in Need Fundraiser at Costello's in Jamaica Plain, originally set for March 21. He said a new date will be confirmed later and all those who bought tickets for the original event will have their purchases honored.

"We're absolutely still having the event, we just figured with the uncertainty of what's been happening, we just want to be cautious," he said. "We're going to postpone this and we'll do it in

several weeks, a month, whatever. We still have the plans to do it."

Hennigan said they were expecting just a few hundred people, but with the increased reports of infection, he felt it was better to wait.

"We'll be watching what's happening," he said.

The Mount Hope Canterbury Neighborhood Association (MHC) also canceled its March 12 meeting as well. MHC Co President Lisa Beatman said they will be allowing those wishing to present to the neighborhood to send their information to her at lisabeatman@yahoo.com, and

community-wide meeting on the Shops at Riverwood, with Burger King as a focal point, on Thurs., March 19 at the Match Charter School, 100 Poydras St. in Hyde Park beginning at 6 p.m.

“My assumption is that they are going to wait until after that meeting next Thursday, and then

sometime after that, it will go to the Licensing Board,” Finard said. “So we’re in limbo.”

Burger King is finishing construction on the building now, Finard said, and is waiting to see if Zo Dhanani, the Burger King owner and operator, “would be qualified to open a restaurant.” Dhanani’s company owns and operates more than 400 Burger King and Popeye’s franchises around the country.

Sharon Liszanckie, the Executive Director of Boston Prep, the school with 700 students across the street, said that negotiations with Finard had stalled. She raised concerns that her students would eat fast food at the Burger King rather than healthful alternatives.

At a previous meeting last month, Dhanani offered to close the dining room in the morning, which Finard confirmed. Liszanckie said she wanted it closed in the afternoon at dismissal time as well, which Finard said “Burger King was unwilling to do.” Finard had offered partnering with the school on fundraising efforts for their new kitchen, where they plan to offer three healthful meals a day to their students for free.

“Our challenge is around the accessibility of fast food to young people our community,” Liszanckie said. “So doing any kind of fundraiser associated with a Burger King is less than ideal.”

She added that there seem to be two pathways: one where

people not in the room don’t want the Burger King at all and another where, because it will be here, “the school should have been part of the active dialogue,” as it was used in the marketing strategy.

Finard responded that, “on the record, the Burger King was started before the school got here.”

Finard and Liszanckie agreed that, in the future, communications could be improved.

Residents noted that there was a Dollar Tree and a pizza shop nearby where kids buy junk food. Others stressed that it is the parents’ responsibility to steer their children away from less savory food options.

“It’s not a guarantee that every Burger King will have the same food offerings,” Liszanckie responded. “I’m hoping at minimum that the healthiest menu that Burger King is able to offer will be implemented here. I don’t think I’m alone.”

Hamilton said she hoped Liszanckie would not preclude her students from getting jobs at the Burger King, because Hamilton believed they would benefit from skills in managements and food science. Liszanckie said she would not stop them from economic opportunities.

Tensions appeared to ease as all sides got to air their concerns.

“In this community, we all have to work together,” Odom said. “If kids see us fighting what we don’t want, what are we teaching our kids?”

The next meeting will be held Mon., Apr. 13 at 7 p.m. at the Perfect Dental building at 912 River St.

Council looking into preparedness amidst Covid-19 uptick

As of the date of publication, The Bulletin Newspapers can report that one resident has been confirmed to be infected with the Corona Covid-19 virus, and 92 have been confirmed statewide. The city announced it has canceled the annual St. Patrick's Day/Evacuation Day Parade in South Boston, as well as the annual St. Patrick's Day Breakfast.

The City Stated on Monday: "There is no evidence of community transmission in Boston right now. The risk remains low, but this situation is evolving rapidly and changes day to day."

So far, no one has died, but that doesn't mean the Boston City Council is not trying to get ahead of the disease. Last week, the council called for a hearing of the city's health response.

District 6 City Councilor Matt O'Malley and At-Large City Councilor Michelle Wu both sponsored the hearing. O'Malley emphasized the importance of keeping as many lines of communication open to Boston residents as possible in as many languages as possible so residents can stay informed and not panic.

"We are watching a pandemic unfold in real time," O'Malley said. "It's important for us as city officials to not create a false panic but also recognize the enormity of the pandemic that is happening... So I think it's important that we provide as much information and offer the people of Boston, the people who live and work in Boston, an opportunity to have their questions answered. To find out as much real information that is out there and be disseminated to as many people in as many languages and as many access points as humanly possible."

O'Malley said while he has faith in the local response to the contagion, the federal government's response thus far has been underwhelming.

"I take issue more with the federal government's response, which has taken this as more of an economic impact, which of course it is, than the public health risk it seriously poses," he said.

O'Malley brought up the need to have as much access

to testing materials as possible and pointed out that New York's Governor Chris Cuomo has stated that Medicaid recipients in that state would have full free access to testing materials as they become available.

"That is a vital step," O'Malley said. "Obviously when it's tested it gets managed well, and we should be doing the same thing in the Commonwealth and that's one thing I hope can come from this hearing."

He said the City needs to look at every possible way to disseminate information to help residents stay informed of where this contagion is in terms of rates of infection. He pointed out that the MBTA has announced its staff will be disinfecting its fleet and areas that are touched in stations (Charlie Card stations, railings etc.) every four hours to help reduce the risk of infection. He added they want to convene members of public safety and public health officials, as well as public event staff.

Wu said the city has been holding rallies and dine-ins at Chinese restaurants in the city to show support for residents who may be experiencing hardship due to the origin of the virus. She said they now need to focus on the response from the city if infection rates increase.

"At this point, with the encroaching number of quarantine cases and the risk that grows across this country, we have to make sure people are armed first and foremost with knowing what to do in a way

that is accurate and in a way that is empowering," she said. "Knowing the facts about when you're contagious and what to do as an individual when you might be feeling certain symptoms is crucial, and what processes and infrastructure our public health system needs to be evaluating now."

"It was really a hard decision," she said.

The West Fairmount Hill Community Group announced that its March 30 meeting is still set to occur at 7 p.m. at the Boston Police Academy on Williams St. in Hyde Park. According to the group, District

5 City Councilor Ricardo Arroyo will be stopping by, as well as the new Executive Director of the Boston Housing Authority, who is in charge of the Fairmount Housing Development. Also canceled this week, District 6 City Councilor Matt

tended the meetings, signed the petition and let your voices be heard."

Malley said residents worked tirelessly from the 1980s onward to reinvigorate Roslindale Village to what it is today and he and many other business owners felt a residential development in the area could tip the balance against local business growth.

DND stated it decided not to move forward with the plan because of concerns from the business community, but also worried about the impact of construction on the commercial district, confusion about potential co-location at the municipal lot and the loss of spaces post construction.

DND also stated that residents expressed a desire for more transportation options, more affordable housing and the co-location of small development at the site. DND stated it will still look into more housing opportunities in

Roslindale.

"The engagement around the use of the Roslindale lot has helped to inform the HHPA process and prioritization," DND staff stated in a press release. "In consultation with a number of city departments and agencies, at this time we are suspending the process for the Roslindale municipal lot while the team conducts community engagement for other public assets in different neighborhoods throughout the City. Looking for new and innovative ways to create affordable housing remains a priority for Mayor Walsh and the City will continue to explore potential spaces in Roslindale for the development of additional affordable housing in the future and look for opportunities to collaborate with neighborhood groups interested in the intersection of affordable housing creation and racial equity."

money before they decided on a design. "How can you fund a project before designing it?" asked one meeting attendee. Many members believe the intersection needs traffic signals. LANA President Sue Forti and Vice President Kathleen McCabe shared an email they wrote to Massachusetts Department of Conservation & Recreation Commissioner Jim Montgomery regarding the intersection.

"The project should be fully funded based on what is needed, and not just funds available. We are very concerned that this project be fully and adequately funded, so that it is done right with high quality design and construction benefitting the roadway and the landscape, so that it is lasting and not in need of frequent future repairs. Based on our experience, we know this is a once in a generation improvement," the letter stated. "Crosswalks and sidewalks for pedestrians' safe passage and access, including "oases" when crossing wide swaths of pavement are very much needed."

Other concerns LANA members have about the intersection include safe, separated bicycle lanes, lighting at the intersection, and a parkway quality and design.

"Signal Alternatives I and II are preferred over the roundabout/rotary option. Both signalized options could be enhanced if there was a central entry to the Sophia Snow House and Trinity Lutheran Church. We suggest that DCR work with all parties to better access management and a centralized ingress/egress to these two facilities," wrote Forti. "The Centre/Walter Street intersection is part of the parkways and abuts or is a connector to major open space areas. As such, the final design of the intersection should reflect a parkway quality and design. The plans need to have additional detail and attention to the landscape design. The analysis as conveyed in the February 13 presentation slides focused on roadway and neglected the landscape. Centre Street and Walter Street are important connectors for both people and vehicles to the Arnold Arboretum and Allendale Woods, an urban wilds in the City of Boston and part of the Charles-to-Charles Open Space Corridor connecting several DCR reservations."

City Councilor Matt O'Malley also spoke at the meeting. "I want to talk about issues we should be pushing for in the budget; I have some ideas but I want to hear some feedback

as well," he told LANA members. O'Malley explained that the city budget has three parts: education, operations, and capital.

"Legislatively, one thing I'll be focused on this year is continuing net zero carbon building. I also want to look at trash and recycling - which might not be the most exciting to talk about." He remarked that the city pays around \$120 per ton of recycling. For ten years, the city generated \$4 of revenue per ton of recycling. "There's many factors that account for that. Recycling is no longer the valuable commodity that it used to be. Secondly, the foreign markets are no longer accepting recycling at the rates they used to be," O'Malley explained.

He also remarked that Boston's recycling rates are "dismal". O'Malley believes we need to move away from single stream recycling - which was a great idea at the time", but he explained that many households in Boston don't recycle correctly and cross contaminate what goes into the bins. O'Malley believes it's time to "move away from single stream recycling" and go back to smaller bins and separate paper, plastic, and textile.

"The biggest piece in this is having curbside compost. This will be a subscription service, that hopefully by July 1st - or

fall at the latest - that every Boston resident will be able to opt into a subscription for curbside compost pick up," O'Malley explained. He also stated that composting generates revenue, and will remove a quarter of the items people put into their trash.


The meeting opened with the police report for the Longfellow area from January-March. The report included a larceny in an unlocked motor vehicle on Walter St., and two building larcenies. One of these larcenies took place at 100 Weld on Jan. 13. "Someone stole pipes and copper out of the garage at a construction job site. The victim estimates ten thousand dollars in damage," stated Roach. The report also included a residential burglary on Conway St. in February.

A few LANA members

raised the issue of construction vehicles parking on sidewalks in the neighborhood. "It's hard to be a walkable neighborhood when you have trucks on the sidewalk," one member told Roache.

The association meets in odd-numbered months on the 2nd Monday of the month from 7:00 - 9:00 pm. Meetings are open to the public and are held in the community room of the Longfellow House in Roslindale. The Longfellow Area is the section of Roslindale north of the MBTA commuter rail tracks. Its borders the commuter rail tracks to the south, Centre Street to the north, and the Arnold Arboretum to the north and east. For more information about LANA, visit

Council to look into Jackson Mann Community Center in Allston

District 9 City Councilor Liz Breadon called for a hearing at last week's regular Boston City council meeting to discuss and possibly decide

the future of the Boston Center for Youth and Families (BCYF) Jackson Mann Community Center.

"Jackson Mann is the only BCYF community center in the Allston Brighton neighborhood, with a population of

approximately 70,000 residents," she said. "This center is a critically important resource for our diverse neighborhood and has served as a community hub for educational, cultural, social and recreational programs for all ages

since 1976, when the building was built."

Breadon said that the complex, though built relatively recently compared to many public buildings, community centers and schools in Boston, is not doing great to say the least structurally.

"It is in an advanced stage of disrepair, to the extent that it needs to be demolished," she said. "The building is scheduled to close next July 2021, and that time is approaching really fast. It is vitally important that in District 9 we have a plan for the relocation of the Jackson Mann Community Center after July 2021."

The building also contains the Jackson Mann Elementary School and the Horace Mann School for the Deaf, which will also have to have their services relocated. To add on

to this, Breadon said another community resource, the Faneuil Branch of the Boston Public Library in Oak Square, will be closing around the same time.

"The Allston Brighton community wants answers about the future of both the schools, which will be addressed by the Boston Public Schools, but also the BCYF center, which plays such an important role in our neighborhood," she said. "Where will the community center be temporarily housed? Will the necessary funds be appropriated to find a temporary location to prepare and build out that venue to continue to provide these services to our community and allow the center to meet their contractual obligations for preschool and adult education classes?"

Breadon said she is also looking long term as to where the BCYF will find a new per-

Two housing developments approved

It was a “Ripleys Believe it or Not” moment at the March 4 JP zoning committee: four matters heard without one single objection.

For two of the housing developments, including the 202-unit Pine Street/ TCB supportive housing venture at 3368 Washington St., this was because behind the scenes abutter negotiations resulted

in significant design and program changes.

3371 Washington St. was formerly The Gate (long known as CoCo’s lounge) and Kevin Connors and Justin Kreger of CK Investments want to replace it with a four-story, nine-unit condominium with ground floor commercial space opposite JP Auto Plaza.

Nine units would have required CK Investments to provide one affordable unit but Connors explained this had

changed.

“Nine condominiums is a bit of a Scarlet Letter,” he said “Initially it was eight plus one commercial unit but we addressed the concerns of the abutters [213-219 Boylston St.]”

“The neighbors didn’t like the nine parking spaces in the rear. We took that out,” he said. “They didn’t like the three bedroom units. We took that out. You can’t have three bedroom units without park-

ing and keep the affordable unit.”

“The affordable unit was taken away. This is not a ploy. The economics didn’t work,” Connors said.

Committee member Lee Goodman was incredulous.

“The community negotiated you away from an afford-

able unit?” he asked.

Connors also explained that the design had changed to include more rear and side set backs, a change in the fourth floor penthouse reducing its size, and added space between his building and the barber-

manent home, and wants BCYF to start formulating and laying out a plan to that effect.

At-Large City Councilor Julia Mejia emphasized the importance of recognizing what impact this could have on the young people of Allston Brighton.

“There are a lot of young people who end up feeling the dramatic impact of being displaced when we see our schools and community centers closing and I think looking at this through a

public health lens and through the trauma that our children are experiencing when these closures do happen as part of this conversation is important,” she said.

The decision to shut down came in April of 2019 after an engineering survey on the complex. At the time, then Acting Superintendent for Boston Public Schools Laura Perille said in a letter that there is not nor has there been an immediate danger to students or residents in the building, but that “This level of

work is so extensive and time-consuming that the safest course of action, long-term, is to vacate the building.”

At the time, she said, “we have over two full years to engage in a community process to consider what options might be available to us regarding possible alternate locations for both school communities currently residing in the building, as well as the community center.”

shop at 3161 Washington St. The other balance is that the condo sale price is less expensive. “It’s more affordable now,” Connors said. “The apartments are smaller. We

hope to sell a one-bedroom for \$499,000 and two-bedroom units with 925 square feet for \$650,000.” “I don’t get it,” he said, “You lost an affordable unit. It’s a four-story building. It al-

ready was a four-story building, I’ll vote for it if you guys are happy with it.”

Baron was happy with it and Turley made a motion to approve.

“Take it with a grain of salt,” Baron said. “They’re done. They lost an affordable unit.”

The committee was happy too and voted unanimously to approve.

The harmony and goodwill prevailed as Pine Street and The Community Builders gave their presentation for 3368 Washington S., the largest supportive housing development in the city and one of the largest multi-family developments in Jamaica Plain.

JP zoning committee members rarely if ever attend BPDA Article 80 meetings on development so this was the first time they had seen this development

presented.

As The Bulletin reported, it was a year long and contentious process but the opposition was seemingly exhausted and no one spoke in opposition to the planned housing of 140 units of supportive homes and 62 income deeply affordable rental homes in a five-story building.

This was in large part because in November neighbors got Pine Street/TCB to reduce the scale from six stories to five thus eliminating 33 units of income-restricted housing. They also insisted on significant design changes.

JP zoning committee Stephen Lussier asked about the unit sizes and tenant mix; he also wanted to know what else Pine Street owned in Jamaica Plain.

Griffin explained three housing developments.

“We own the 50-unit lodging house on Green Street, The

Bowditch School,” she said. “We manage but do not own the sister Virginia Mulhern House on Creighton Street and the Francis Grady Apartments sat 461 Walnut Avenue, both owned by JPNDC.”

Committee member Peg Preble asked about the number of men and women in supportive housing.

“There’s more men in the shelter,” Griffin said, “but in supportive housing the mix is like 60 percent men and 40 percent women.”

Bob Harrington owns BMS Paper next door that he intends to develop into large-scale housing and retail. He wanted to go on record as supporting the project.

“I support the mission of Pine Street,” he said, “But we share a corner driveway and I want to make sure I have some access. We have to live with each other.”

He said there would be a site visit the next day with Pine Street.

“This is no fun, everyone’s in support,” he said, but added “this is a great statement for JP. Speaking just for myself, I’m amazed to see all this support. A lot of people opposed this but those people are not here. Others worked hard to appreciate the value of this undertaking.”

The vote was unanimous and Pine Street/TCB took that to the Zoning Board of Appeals on March 10.
