New housing planned for Brookley Road

Turris Fund Investor Jeff Glew, with real estate developer Pamela Bardhi, came to the Stonybrook Neighborhood Association May 13 monthly meeting to introduce their plan for a four-story, 45-unit apartment building at 35 Brookley Rd.,the site of Northeast Petroleum, now owned by Jerry Mello.

They're coming into a Jamaica Plain that is pushing back on housing development with effect.

Boston Community Ventures has had its housing development at 3353 Washington delayed for three years by lawsuits; it is now getting restarted and a BPDA project change meeting is scheduled for May 22.

Scott Johnson just last week withdrew his project of a 37-unit apartment building on the site of Keegan's Garage at 7 Kenton Rd that he first introduced in August. But he faced hints of a lawsuit and in January a five-page letter of complaint.

On May15, the Jamaica Plain Neighborhood Council zoning committee rejected a four-unit conversion of a house at 11 Minton St. proposed by City Realty; not for zoning reasons but for alleged wrongful business practices of tenant displacement in its rental properties

At the May 7 Zoning Board of Appeals (ZBA) meeting, the mayor's office stepped in after receiving pressure from City


Boston Haitian Parade reaches thousands

The festival was a fundraiser that benefits the Chefs Table Foundation, a "non-profit video production organization that provides educational cooking shows and offers culinary scholarships to homeless U.S. Veterans and homeless young adults".

Co-founder Carol O'Connor explained that the grilled cheese festival helps raise money for "culinary scholarships for Veterans that are in need and have a passion for culinary arts."

West Roxbury, was set up because the TV show's live audience was an almost constant sell out. Co Founder Joe Murphy has said that they basically wanted to do something good with the funds they raised, and so started the scholarship fund to do that. Now, he said they have put their first recipient through the program and are looking for more.

Many people bought tickets online, while others purchased

IF YOU BUILD IT...

Simply put, our City Hall is an ugly, off-putting barrier to our seat of local government and all the civic engagement it entails.

EVERYBODY WANTS SOME (POWER)

So, everyone wants to run for an at-large seat on Boston City Council. It is not a surprising development. Given the multitude of problems facing our city, many of these issues are inoperative for our citizenry.

There is no doubt that racial identity is a catalyst for the idea. Good. As we said earlier, a neighborhood has the right to name and identify its own community's racial and demographic identity. Electing its own representative candidates is a big step in the right direction.

Roxbury and Chinatown have no need or desire to hear about the struggles faced by Michael Flaherty as his family ponders what to do with too many cars on their property.

There are, thus far, about 65 candidates for the various posts. It truly is amazing.

Among those running are Ricardo Arroyo, the son of former Councilor Felix Arroyo, the council's first Latino member; and Maria Esdale Farrell of Hyde Park, an education advisor to McCarthy.

They, and many others, will face off against a plethora of ballot-seekers.

Choice is a very good thing; and the more the merrier. Folks need direct representation; they should get it; and they should demand it at the ballot box.

A field of candidates this large can be a confusing morass. We are confident, however, that voters are up to the challenge.



DEVELOPMENT NEEDS TO BE LOOKED AT IN TOTALITY

To the Editor:

As a resident of Hyde Park, I would like to address the proposed Residences at Readville Station. Although a proponent of reasonable mixed-use development, I do see issues with this proposal.

I am concerned about the infrastructure of Readville and Hyde Park. This development may choke the streets and further deteriorate the Father Hart Bridge. There are 305 units proposed with another approximately 500 proposed for Sprague Street, resulting in 800 potential housing units along with the additional commercial use. Additionally, with the crisis of climate change, we need a green building commitment and a move to Net Zero buildings. This proposed development needs to incorporate significant green modifications.

Residents are being asked to look at these projects one by one, instead of through a neighborhood-wide lens. We need a comprehensive planning process for Hyde Park, a vision for what we want to see in our neighborhood. Numerous variances are required for this proposal, so there must be compro-

mise with adequate community benefits offered before the community agrees to variances. The community must be fully engaged in this process and whatever is built here must meet the needs of our neighborhood.

I am also concerned about the affordability and unit mix. There is a housing crisis for working families in the city, and we need additional affordable units to address that need. I applaud Ad Meliora for including homeownership units in this proposal. However, the unit mix does not reflect the need for families given the current proposal provides studios, one and two BRs and a limited amount of three BRs.

Residents have asked the BPDA to take a few simple steps to support community involvement in the development process including a 30-day notice period for meetings and notices provided and distributed in additional languages. Can we incorporate additional notice measures into the planning process to expand community engagement for all residents?

I understand that Hyde Park must be willing to accept some new housing units and work with the BPDA to fulfill the needs of a growing city, however we must be fully engaged in a transparent process. In Hyde Park we love our "small town in a big city". We do not reject multi-family developments out of hand, but they must comport with the neighborhood. We have a way to go before this development fulfills the community's needs. Thank

Council takes aim at E-cigs



The City Council will be looking into how the city could curtail youth usage of electronic cigarettes and any potentially adverse health effects.

District 6 City Councilor Matt O'Malley called for a hearing concerning restrictions on the sales of e-cigarettes. The purpose of this hearing is to reduce health concerns for youth.

O'Malley first stated that, "Boston has successfully reduced the public health hazard

of nicotine addiction. Today, only 15 percent of Bostonians smoke."

Still, tobacco and nicotine have proven to continually be one of the major health problems in Boston and the nation, contends O'Malley. The initial purpose of e-cigarettes was to reduce the number of cigarette users in hopes of them quitting or at least reducing their risk, but the electronic cigarettes could be creating more problems on top of smoking. Known manufacturers of e-cigarettes, most well known of which the company Juul, have been accused of introducing nicotine to younger children through fruit or candy flavors and flashy advertising. According to the hearing order O'Malley introduced, "A single Juul cartridge contains as much nicotine as a pack of cigarettes."

Teen usage of e-cigarettes has drastically affected public health in a negative way. National Youth Tobacco Survey stated that "from 2017 to 2018, e-cigarette use by high school students increased 78 percent and use by middle school students increased 48 percent."

One out every five students surveyed admitted to using ecigarettes. Along with that fact, "Some studies have shown that more than 80 percent of high school seniors have tried ecigarettes at least once."

Though the initial plan for e-cigarettes was to help discourage adults from smoking, at least according to manufacturers, it had the opposite effect on youth as they smoke more e-cigarettes than adults do

"Three percent of adults use e-cigarettes, while 20 percent of high school students do," O'Malley said. ""The number of high school seniors who used e-cigarettes doubled last year, the largest one-year increase ever recorded for youth addictive substances in over four decades."

The Food and Drug Administration (FDA) plans to make new regulations concerning the usage of these harmful products by reducing the sales of the ecigarettes to adult stores only and banning certain flavors due to some hazardous chemicals that are also harmful. Still, the effectiveness of those regulations could become unsuccessful as the usage spreads significantly enough for the younger population to attain the access illegally and second-hand. Internet vendors are also easy workarounds for underage us-

The only flavors that seem to be allowed besides tobacco flavored e-cigarettes are menthol and mint. In fact, "51 percent use menthol- or mint-flavored e-cigarettes that will remain legal."

The responses to the Federal policy remains limited until the FDA officially makes the new regulations in 2021 with health evaluations. Although they are trying to make the situation with e-cigarettes less problematic, the wait for the restrictions allows people to use this opportunity to continue risk their health with these products.

The negative health effects to the public could be reduced by providing some of these products through medical use and in medical settings, satisfying many traditional cigarette users and direct sales need. To improve this action towards restrictions on e-cigarettes in Massachusetts, the Boston Public Health Commission has flavored tobacco sold only in adult stores and Somerville does the same, except they restrict all flavors. State bills are even looking to end the flavored products as well.

Ask The Doctor

Junior Damato began servicing vehicles in 1969. He owns a 10-bay auto repair service center in Hyde Park and an 8-bay center in Middleboro. Junior is an ASE-certified Master Technician, ASE-certified L-1 and ASE-certified Natural Gas

To the Doctor: I've had nothing but problems with the radio in my 2017 Chevy Suburban for the past 2 1/2 years. The radio cuts out multiple times while driving, and it's been in the shop more than five times to be fixed. But each and every time I get the truck back, the radio continues to cut out. It's frustrating that I paid \$65,000 for a vehicle and have to use my phone for music. Do you have any suggestions as to what the problem could be — and how to get it fixed?

From the Doctor: There are a few updates that are dealer downloaded for radio. The problem is the radio is not just a radio anymore, it is a computer processor. If the vehicle is still under warranty ask the dealer to exchange the radio versus just sending it out for service. This is what I would suggest. You may also want to involve customer service at Chevrolet with this problem.

To the Doctor: I have a 2009 Chevrolet Traverse and it is the most unfriendly car to do simple maintenance to, such as changing a battery, a headlight bulb or brake light. To change the battery it's under the passenger seat – it's not easy; replacing a headlight you need remove a portion of the wheel well – that's insane! And to replace a brakelight, you have to unscrew the light assembly from the outside. Has Chevy made these vehicles any easier since I bought my 2009 model?

From the Doctor: Vehicles are built in ways I do not understand. Yes, something that should be a simple maintenance item is not easy. Some vehicle headlight replacements involve removing the front bumper cover, not just the inner fender well. The rear taillight replacement involves removal of the taillight assembly on more than just your Chevrolet. I am in favor of moving the battery from the hot, under-hood temperatures to under the floor board or into the trunk. They did move the battery to left front under the computer; to replace headlights some have a removable access cover that simply is a 1/4 turn to remove.

Bike share expansion and start of 2019 bike program series announced

Mayor Martin J. Walsh today announced an additional 50 stations and 540 bikes will be added this year to Bluebikes, expanding the City's bike share infrastructure.

Boston's Bluebikes expansion will take the total of bikes in the city to 2,400 and stations to 230 by the end of 2019, marking the highest number of publicly available bikes and stations in Boston's history. An additional \$1 million of capital funding from the Mayor's proposed FY20 budget will bring bike share to parts of Boston for the first time with stations being added in Dorchester, Roslindale and West Roxbury. Tomorrow, Boston will celebrate National Bike to Work Day with an event at City Hall Plaza, which will mark the beginning of Boston's 2019 Bike Program Series, a full calendar of programming that spans from May to October.

"I am excited to be expanding our Bluebikes program to allow for even more of our residents and visitors to take advantage of our bike infrastructure, which we're continuing to prioritize by building new protected bike lanes throughout Downtown and our neighborhoods," said Mayor Walsh.

Feedback from residents and community organizations has informed the locations of the stations. New stations this year will be installed near community health centers, with financial support from Blue Cross Blue Shield of Massachusetts. City investments have brought bike share to new neighborhoods as well as added necessary capacity in job centers, commercial corridors, and high-density residential neighborhoods. For the newlyannounced expansion areas in southern Dorchester, east Roslindale, and West Roxbury, the Boston Transportation Department will be hosting the following public meetings:

- * Roslindale: June 6, 6:30 p.m., BYCF Menino, 125 Brookway Rd
- * Dorchester: June 12, 6:30 p.m., All Saints Church, 209 Ashmont St
- * West Roxbury: June 13, 6:30 p.m., BCYF Roche, 1716 Centre St

BTD is also meeting with neighborhood associations in the expansion areas of Dorchester and Roslindale. Information about the full planning process and proposed stations can be found at boston.gov/bike-share-expansion.

Blue Cross Blue Shield of Massachusetts, through its Bluebikes title sponsorship, has supported the massive expansion of the public bike share program in Boston, Brookline, Cambridge, and Somerville. This year, as the health plan enters the second year of its six-year partnership, BCBSMA is making additional investment in Boston to ensure bike share access at Community Health Centers.

Mayor Walsh's FY20 budget proposal includes a total of \$10.6 million for spending on bike infrastructure, including more than \$1 million in new funding going towards accelerating the design and construction of major bike corridors. The City's FY20-24 \$2.78 billion Capital Plan dedicates \$1.15 billion to implement the core initiatives outlined in Go Boston 2030, the City's transportation plan. Specific bike projects that will be advanced include the Southwest Corridor Extension, an on-street bike connection between the Southwest Corridor Path, Downtown and Beacon Hill; and Massachusetts Avenue between Columbia Road and Harrison Avenue.

Prior investments have advanced multiple bike lane projects that are now completed, under construction, or in design, including the South Bay Harbor

Trail, Summer Street in Fort Point, Brookline Avenue in the Longwood Medical Center, and parts of Cambridge Street in Allston.





power and have a real democracy," he said. "I and other friends of mine have talked to passersby by in Brighton and Boston, and more than 90 percent of them said it was a good idea, so I wasn't surprised. I realize though that almost everybody else might be surprised.

"After I got about 800 signatures, I started telling people that they were the 853rd person to sign or whatever it was and asked them if it surprised them and mostly they said no, it was a no brainer," he said. "Politicians and activists are probably more surprised than other people."

The petition states: "No Rich No Poor: We the undersigned joined (or are hereby joining) the Brighton Allston Community Coalition (BACC) because its goals, including adequate affordable housing and good public transportation and an end to gentrification, are part of our larger goal: removing the rich from power to have real, not fake, democracy with no rich and no poor. We hope that the BACC will declare that it also aims for this larger goal; that would make us be even more enthusiastic members of it."

?The BACC formed earlier this year to provide a strong community voice regarding affordable housing and gentrification, but Spritzler said he wanted to take it a step further and work to get at the root of the problem.

"It was easy for just me, one person to collect 1,000 signatures just in the Allston Brighton neighborhood, it was easy to do. I just showed them the statement and most people read it and asked 'Where do I sign?" he said. "I wanted the BACC to gain more enthusiastic support if they were for this larger goal and they would show members and potential future members were serious about solving the problem."

Spritzler said he believes the overarching opinion of what John Steinbeck said decades ago about why Americans can sometimes be infatuated with the rich, but he said he doesn't think the majority of Americans still feel this way.

"I think people think that most Americans think like that, that 'the poor see themselves not as an exploited proletariat but as temporarily embarrassed millionaires," he said.

He said people are coming to the realization that not everyone can become a millionaire, and that the system should reflect that. BACC cofounder Kevin Carragee said he's glad Spritzler is doing the work, but said the BACC was founded on local issues, and

he feels this is more of a national conversation.

"John's contributed to BACC over time and we certainly are thankful and appreciate his contributions, but the BACC is a far more narrowly-focused organization than the wide ranging political agenda that John and his allies advance," he said. "With that said, obviously we share certain concerns and principles about the need for more affordability and housing in our neighborhood and the desire to expand the ability of working people to live in Allston Brighton so that we don't have the displacement effects we have now."

Spritzler contends that he was able to garner so many signatures because of this national and expanded focus, and these signatures could be potential members to the BACC if the BACC expands its focus.

Spritzler added that when he started collecting signatures, the BACC Steering Committee asked him to hand out the group's mission statement, which he said he did. It read that the city should increase affordability requirements so that when the Inclusionary Development Policy is triggered by a large enough development or a development seeking zoning relief, it would require 20 percent of dwelling units constructed to be affordable (or build them somewhere else or pay the city enough to build them).

"Twenty percent? That's a good thing, it's not a bad thing at all but it doesn't solve the problem of gentrification," Spritzler said. "I think it was 2016 in Somerville, they raised the percentage from a lower percentage, and Somerville now is more gentrified than Commonwealth Magazine had a 2019 article reporting the fact that it's just continuing to be hor-

Carragee said any substantial change of the BACC's mission would have to involve a discussion by the BACC's Steering Committee and its total membership, which is hovering around 500 residents

"There would have to be a democratic process to dramatically expand BACC's mission," he said. "I would also emphasize that BACC's mission from the beginning has been development focused."

Carragee added that he will be meeting with John in the future.

Life and Rep Malia and convinced City Realty to defer its zoning date on its proposed 23-unit development at 197-201Green St. until July 9; again for alleged wrongful business practices.

"You don't want to tick off the mayor," warned zoning committee member Lee Goodman. "You'll never be able to build again."

There is some remorse.

Dave Baron, chair of the JP zoning committee, repeatedly admitted his frustration on May 15 and said displacement is often inevitable.

"[But]I don't want to defer this project," he said about 11 Minton St. "It's only four units, but we can't get a yes or no from these people[City Realty] on the provisos on tenant agreements."

Trevyn Langsford is cochair of the SNA and worries about affordability.

'I want more building, more housing," he said on May 13. "We generally need to make concessions. But how much do we give up? Do we lose affordability if we want smaller buildings?"

Turris Fund was started on Nov 28, 2018 by Glew and his partner David Mackay and they formed Brooksted LLC to develop the Mello property.

Consultant Jay Walsh said that his client does not own the property; it's under agreement. (According to Mello, the closing will happen between December 2019 and April 2020).

"We want to give something people can live with," he said. "This is a plan for a multi-family building. There's no [BPDA]filing yet. We'll do our best to make concessions if we can."

Architect Bill Mensinger showed detailed elevations and floor plans.

Mensinger showed a long building with flat face façade on Brookley Road, extending back down Stonley Road. The middle wing of apartments will be set back from Stonley. This wing will sit over ground floor parking.

"It's a four story building with 45-units of one and two bedrooms," he said. "There will be four artist live/work spaces in keeping with the JP Rox guidelines. The brick façade at the base will wrap around the building at the sidewalk. There will be Clapboard and fibre cement siding on the upper stories with some brick detailing.

"There will be 21 parking spaces inside the ground floor," Mensinger said, using stackers, a vertical mechanical system. Stacked parking is getting popular in the city. Circulation will be from Brookley to Stedman streets. Entrance to parking is

off the lobby."

This will be the third new mult-family building in that fading light industrial corner of the Stonybrook neighborhood.

Opposition was immediate from Fred Vetterlein.

"This looks like a 20-story city building on Brookley Road," he said. "This is far out of scale. We fought very hard to keep 50 Stedman down to three stories"

35 Brookley will line up with the four-story, 76 Stonley Rd. apartment building that SNA battled for over three years. Now, well underway, completion is expected this fall.

SNA co-chair Wylie Procter expressd her surprise.

"This looks like Metro Mark," she said. "It doesn't look like anything- nothing like anything that exists here now. We don't have any brick or metal screen buildings here."

"49 feet high?" she exclaimed. "This is a big cliff. You're turning the street into a wall."

Jon McCurdy, co chair of SNA, was unhappy.

"You're filling an entire block," he said. "Its just going straight up. This is the first four story building on Brookley Road."

"This will be rental, not condos," Glew said. "Although that's not a final decision. The target rents will be consistent with Metro Mark. A studio will be in the low \$2000's. We will have third party property management."

At the time of lease-up, in May 2017, a two-bedroom unit at Metro Mark was listed at \$2650 a month.

Walsh explained that the proposed building meets the JP Rox guidelines for affordability.

"We've set the units at 12% to 15% affordable," he said. "It will be a blended ami from 30 to 70 percent. We'll have better understanding when we go to the BBDA. The four artist live-work space is part of the affordability contribution. The rest will be spread out."

McCurdy said that Plan JP Rox is "just an idea."

"The Jamaica Plain Neighborhood Council requires 25% affordability," he said. Walsh tried to explain.

"It's tied to the FAR [floorarea-ratio]. I'm not entirely clear. I don't understand it. We're using the density bonus. But we can get more affordability at 19% than at 25% of 70% ami. Once we have a plan we can work on the affordability," he said. "Get the front load work done before the filing. Hopefully in less than four years."

After the development team left the building, SNA reviewed

the proposal. McCurdy was still not happy.

"There's too many units. It's too tall. It's too dense," he said. "This is typical. These guys come in with the maximum number of units. 45 units is a lot. This is double 50 Stedman. Each building sets a precedent. 76 Stonley is four stories."

Rob Coerver, co-chair of SNA, tried to be conciliatory.

"It doesn't look like any other project." he said. "What can we change productively?"

In standard operating proceedure, a 35 Brookley Rd subcommittee was created to work with Turris; seven members signed up including Proctor.

It was not assigned to the newly formed affordability subcommittee.

Asked if he would pick up Johnson's project, a local developer and property owner told The Bulletin at

"It's too much of a head-

ache with community groups," he said. "And land costs and construction costs. It's too expensive."

I was a patron of Clay Auto before it closed, which opened up this parcel at 361 Belgrade Ave, and frankly I'd be happy if they had stayed. Since something else will inevitably open there, I'd rather see a school than more apartments or stores. It is commercial land and wellsuited to a multi-story structure, and anything that goes in there will bring some level of traffic and parking. It seems a small price to pay to be able to give public school kids a better facility!

Rozzie hasn't had a public high school in decades, and now that the only public high school in West Roxbury is closing, our area deserves to have at least one option for our neighborhood kids. I appreciate the rigor and high behavioral standards that Roxbury Prep offers, so I think they would make a great neighbor and option for our kids.

It is sad to hear that Roxbury Prep has searched for years for a piece of property to develop, and that they presently make do by using two buildings, miles apart, and without basic resources like a cafeteria or gym at either location. Please support their efforts to find a permanent home for these public school students, and turn this vacant property into a beautiful school which would be an asset for the Roslindale community!
