West Roxbury Main Streets (WRMS) is bringing back the popular 2016 Celebrate Centre program on Sept. 8 this year.

WRMS Executive Director said it's one of the many initiatives they're working on right now, but said bringing the event back was definitely a priority.

"This year we're just taking over the Corey Street parking lot," she said. "It's a big party, 10 a.m. to 4 p.m., and we'll have live music the whole time, a hula hoop artist, different community groups, yard games and that kind of thing. We're just trying to get people out and welcome the fall."

A cavalcade of officials from the City of Boston and the Suffolk County Law Enforcement offices came through the city this week as part of the 35th annual National Night Out (NNO) celebration.

Boston Mayor Marty Walsh went through the city on Monday and Tuesday, passing through Roslindale and Hyde Park on Monday. He pointed out that crime in both the E-5 and E-18 Police Districts is down, and he said that is due to the work of the community and

community policing.

"I want to thank the community, the police officers and the community crime watches for all that work," he said. "That work doesn't happen in just one area, it happens with everyone working together in the neighborhoods and I want to thank you for all the work in the neighborhoods to make the neighborhoods safe."

About 20 Allston and Brighton residents came out to the Hawes Medical Building at the Brighton Marine Health Center for a Boston Planning and Development Meeting on Tuesday to discuss recent changes to the proposed building at 139-149 Washington St.

The proposal plans to build 228 total units on the site, which abuts the Cabot Cabot and Forbes' (CCF) 600-plus unit complex at St. Gabriel's. Avalon Bay representative David Gillespie said that after a Draft Impact Review Process, they have decided to reduce the size of the project and increase home ownership on the site.

The plan is to put a large horseshoe-shaped building in the front on Washington Street and extend Fidelis Way – a private street owned by the Boston Housing Authority – up to a hill where previously workers for the St. Elizabeth's Hospital parked. The plan is to put the 48 condo units (the other

180 will be rental in the horseshoe) on top of that hill in a seven-story building.

The conflict comes from a lease agreement. Currently, the construction at St. Gabriel's does not allow for anyone to access that lot. However, when it is finished, St. Elizabeth's workers could drive through the St. Gabriel's development to the parking lot. St. Elizabeth's parent company, Steward Healthcare, also has a right to lease that lot until 2022, which residents said they were worried about since the rental portion of the 139 development could come in years ahead of the homeownership portion. Allston and Brighton have some of the lowest homeownership rates in the entire City of Boston and the region as a whole.

Steward previously caused a stir in the neighborhood when it tried to purchase and use 150 spots at a parking lot near Oak Square on Washington Street, right on the border of Brighton and Newton.

Residents petitioned against this move because of the lack of public process, but there may now be some unintended consequences. It may put the 139-149 Washington St. construction process in limbo.

"That is a topic of ongoing discussion for all parties involved," Gillespie said. "This was always going to be a phased project, however conditions may change things. It could be market conditions, or it could be access, it could be a lot of things."

The condo portion of the building would be abutting the St. Gabriel property, and CBT Architects' Alfred Wojciechowski said the idea is to create an accessible area for residents of both properties. He said there would be pedestrian paths connecting them once both are finished.

"The building joins in with the CCF building, which is under construction currently, and the sidewalks continue through to the top of the hill and connect to the walkway with the CCF property," he said. "This takes the whole section of the

site and makes it publicly accessible."

Residents said they were also concerned with transient populations at the rental property. Gillespie said that Avalon Bay does not look for transient populations and has many mechanisms to dissuade students. For one thing, they don't rent to undergraduate students and they do not lease in the first week of September. He added that unlike most rentals in Allston and Brighton, they will have a management staff on site at all times to handle any issues. He said move ins will also be staggered throughout the month so that there is not a peak of move ins, like Allston Christmas.

Gillespie also said there would be a good deal of community benefits with the extension of Fidelis Way. He said since the private street is owned by the Boston Housing Authority (BHA) they will be making several upgrades to the full road there and to the green space of the community center in the BHA's Commonwealth Development.

Gillespie said they will be widening Fidelis by using 139-149 Washington's own land. There will be two-way traffic, as well as space for parking on both sides. The parking lot for the Commonwealth Development Community Center will also be widened to accommodate head-in parking in front of parallel parking (which is currently the case but requires a lot of 3-point turns from the head-in lot) and will increase the amount of green space for the community center by curling out Fidelis as it goes up the hill to the condo building.

Gillespie said both buildings will meet the 13 percent requirements for affordability, but declined to comment too much on the rates of rent and prices of the condos when everything is said and done.

The comment period for this project ends on Aug. 17. Residents can comment at the BPDA website by going to bostonplans.org/projects/development-projects/139-149-washington-street.

HITTING THE STREETS

Watching the newly appointed Police Commissioner William Gross take to the streets of Boston's neighborhoods this week, we had to pause upon hearing his commitment to "community policing." A similar promise has been made by many of his predecessors. Nothing new here. Or is there?

We don't doubt his commitment. The idea that building street-level relationships with the police officers who serve an area is a wonderful concept. Well executed, it can help reduce both violent and petty crime rates and improve an intangible, not so easily lent to metrics: engendering civilian trust and respect.

The more we thought about it, however, the more we realized that Gross has plenty of work ahead to improve the city's community policing commitment.

To start with, there is the obvious. As a man of color, fairly or not, expectations will ramp up exponentially. The presumption, and we will need to see how it plays out, is that the color of his skin will automatically break down some of the city's notorious culture barriers, infamously exhibited with the "stop snitching" mantra that even made its way onto novelty t-shirts at one point in time.

That assumption may be an obvious one, but it is nevertheless a bit unfair. The superior credentials and bottom-up experience Gross brings to the table is far more valuable than the color of his skin. Police forces, as we've seen in many recent controversies across the nation, are no longer judged on a cop-by-cop basis. They are viewed as an institution that is far more than the sum of their parts. In some parts of the country, even black officers have been accused of being racist.

Boston, fortunately, doesn't yet suffer the same issues that have gripped much of the nation, but there for the grace of God we go. No matter who takes charge of the BPD, it is important to not just maintain good community relations, but to build upon the existing base.

That is easier said than done. Gross has already faced one of those tricky dilemmas needing to be handled with great sensitivity.

Last week, two undercover police officers followed a teen, later found with a gun, into the Dewitt Center in Roxbury. Backup officers, however, were barred from entering the premises.

Gross thus far has been very careful in his reaction, and rightfully so. How can police best balance the need to protect and serve all residents, while also respecting that there may be community "safe spaces" where flashing a badge can be detrimental to winning hearts and minds.

In a city undergoing a development boom and an addiction to high-end properties, the divide between the "haves" and "have-nots" will continue to deepen. The resulting isolation, anger and despair is another of the macro issues Gross will need to deal with. Thus far, he seems to be up to the task. We wish him well.

WHY NO OUTREACH?

To the Editor:

RE: Large Project Review Requirements 361 Belgrade Avenue, Roslindale / West

Roxbury

Dear Mr. Golden:

On behalf residents of West Roxbury and Roslindale that surround Belgrade Avenue, we are AGAINST the plan for Roxbury Prep Charter High School Facility at 361 Belgrade Avenue.

This site is said to be revitalizing this under-utilized former automotive sales and services site in the Roslindale neighborhood with the construction of a new high school facility, but this is NOT an appropriate site for such a large school. This proposed building with cover 43,014 square feet of land in a part of Roslindale/West Roxbury that does not have the facilities to support such a large influx of people.

There was little to no outreach done in the neighborhoods that surround this lot, and they did not take into consideration the already congested roundabout that is right next to the police station. The current commute time to get through this bottle neck is about 15 minutes and if you add a facility that houses 860 students + 80 staff and teachers that rush hour traffic will be at a standstill.

The 2nd issue is that the MBTA commuter rail Belgrade is the smallest stop that we have on the Needham line, and it is currently not capable of handling a large amount of people nor is the MBTA capable of keeping the trains and busses running on time with their skeleton crews that are currently on the Needham line. With an additional 800 students this will overwhelm the trains, orange line and busses.

There is a proposed kiss and drop off area on Anawan Street, which also is a problem as that street cannot hold a large amount of traffic. The streets are too narrow for multiple drop offs or busses or teachers parking. It is right next to a residential apartment building and their parking also has an exit on that street which can no longer be moved.

The current enrollment of students from the Roslindale and West Roxbury neighborhoods is 3%, and it would be more advisable to put this school into a current school that is under-utilized, such as one that is in West Roxbury.

The development team did not conduct any preliminary community outreach with abutting and area residents, business owners and institutions. We feel that there is a real need to communicate with the neighborhood rather than ram a project this big into a small spot of land, at the last minute.

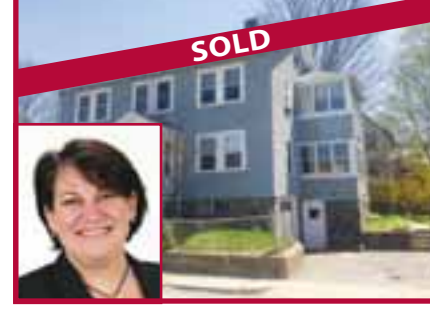

Berte, a Roslindale resident, said that the city has changed up its process in approvals. He said that now, instead of a city council hearing, any proponent for a dispensary must first get a refusal letter from Inspectional Services (a dispensary is a conditional use and therefore always requires a zoning variance), set up a community meeting with the Mayor's Office of Neighborhood Services, create a host agreement with the Office of Emerging Industries and then go through the process set up by the state's Cannabis Control Commission.

"We're just waiting on the Mayor," he said.

Berte said that once the date for the Zoning Board of Appeals hearing is set he expects to have a community meeting set up with abutters.

Berte said that they have now moved from strictly medical to medical and recreation, as a medical card would negate any benefits for veterans in the Veterans Administration healthcare system, since it's a federal system.

"We want to go into this from a medical standpoint, but a lot of us veterans will lose our VA benefits if we register under the medical program," he said. "We're trying to help certain groups, especially vets who don't want to lose their benefits, which is why we checked recreational and medical."

Some residents said they did not want a dispensary in their neighborhood as they felt it could increase crime. Some residents said they didn't want their kids exposed to marijuana either, and Berte did say they will have extreme security there. Many residents said they hadn't seen the presentation Berte did on his dispensary earlier and asked if they could see it again. HPNA president John Raymond said they would invite Berte back for the next meeting, even though the group has already voted not to oppose the dispensary.

"We've announced things in the papers and people always decide to come after the fact and register complaints when everything's been voted on," he said. "I will try to get some elected officials here, I cannot promise though because we're going into the election season."

In other news, Fairmount Hill Neighborhood Association President Joe Smith said they had a presentation from developer Milan Patel to convert a three-family house on 11 Dana Ave. to a 24-unit building, which Patel and his development attorney John Pulgini said they believe to be an as-of-right project.

"I am outraged that that kind of project is, in fact, within the zoning code," Smith said. "I am surprised by it and shocked by it and we need to do something about those kinds of zoning violations that are occurring in our town... How

much do we have to put up with in Hyde Park from North Shore developers who come in and put up developments? They think we're stupid, and they think we don't understand."

Though the project may be as-of-right – as of the date of publication no letter of intent has been filed with the Boston Planning and Development Agency (BPDA) and it is not yet known if Inspectional Services has approved any application – it does fall under the BPDA's Article 80 Small Project Review process and will require at least one community meeting and a comment period for the public to participate in. Nothing has yet been scheduled with the BPDA, but when it is, the Bulletin will have notices published.

"When these meetings come up, you have to show up," said Raymond. "You have to voice your opinion, both positive and negative."

Resident Craig Martin said he believed the developer's notion that the project will be as-of-right was in error. He said the area is zoned as a Neighborhood Shopping District 2, that was an add-on designation. He said the fact that it was an add on means it does not have the same parking requirements. At this time, the project will have a one-to-one parking ratio of 24 spaces for 24 units. Martin contended that the add-on zoning requires a two-to-one ratio.

"They're going to have to find a place for 60 cars," he said.

Urban Edge gets CPA funding for Columbus Ave. Courtyard

Since 1981, Urban Edge has preserved and built hundreds of income-based rental housing in Greater Egleston Square, but on June 20 the City Council approved a \$200,000 Community Preservation Act grant for a pocket park on Columbus Avenue.

Called Delphines Courtyard after the late Delphine Walker—an active and longtime resident of Walnut Park, it will be built on land Urban Edge has owned since 1984, long occupied by a sitting area and neighborhood garden next to the Egleston Square Branch of the Boston Public Library.

The courtyard is part of 67 Walnut Park, a four-story, thirty-two unit, fully-affordable apartment house developed by Urban Edge and designed by Prellwitz-Chillinski; construction began in January, 2018.

In the planning stages since 2015, the development abuts the branch library.

Leslie Belay is one of the leaders of the Friends of the Egleston Square branch library.

“Urban Edge came to the Friends and asked us for an endorsement [of 67 Walnut Park],” said Belay. “In the meantime we were in the process of getting a landscape design for the library grounds and we had conversations with Urban Edge about collaborating. We wanted a connecting pathway through the library to Walnut Avenue that would go through the Urban Edge property.”

“About six months ago we submitted a joint proposal with Urban Edge that would fund the pocket park and conform with the library design,” she said.

According to Belay, the Boston Public Library supported the landscape proposal but added that it intended to completely renovate the library and grounds within the next five years.

“CPA cannot fund a project that already has funding plans,” said Belay. “They don’t want their project to be dug up later on, so the Friends withdrew their proposal for a walkway.”

“We’re still partners,” Belay said of Urban Edge. “We’re neighbors and allies

and we want to be. We just hope Urban Edge’s design conforms to our permaculture and sustainable planting landscape ideas.”

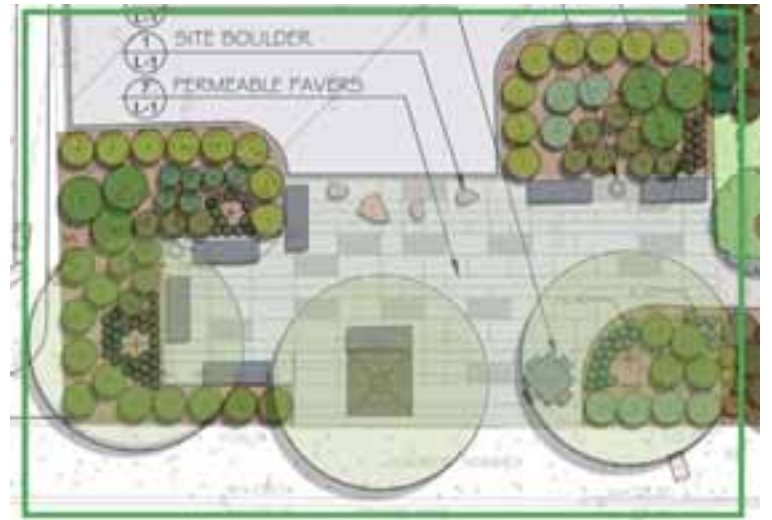
“BPL Director of Operations Patricia Foley came out two weeks ago,” Belay said. “She wanted to see what the Friends are going to do. We already have a \$20,000 Henderson grant. We’ll give it back if we have to.”

Sixty-seven Walnut Park will include a 23-space parking lot between the building and the courtyard; access to the parking will be from Columbus Avenue over a shared driveway with 2030-2040 Columbus Ave., which Urban Edge also owns.

Emily Loomis is director of Real Estate for Urban Edge.

“We’ve always had a long standing relationship with The Friends,” Loomis said. “We had already planned a courtyard; at first just a paved area with benches and trees. About 18 months ago the Friends came to us and encouraged us to incorporate the courtyard with the library landscaping using sustainable plant designs.”

“The courtyard was going

to be funded as part of 67 Walnut Park,” Loomis said,” but we ran into unexpected ledge and soil conditions and there was no room in the budget for the courtyard. Then CPA came along and we saw an opportunity.”

“Our vision is to include a pathway,” Loomis said. “Our property will not be blocked off so we can still share that connection with the library.”

“It’s a green buffer,” she said. “It’s community space for all residents to enjoy. We wanted to create an attractive space on the street. It’s a great way to use that [67 Walnut Park] development opportu-

nity. It also connects our properties [Wardman Apartments on Walnut Park and Cleaves court on Columbus Ave].

“We will own and maintain the courtyard,” she said. “The old sitting area will continue its tradition in the court too. It will not be locked.”

“The CPA funding will enable us to use permeable pavers to absorb water, sustainable plants and recycled materials for the benches and tables,” Loomis said. “Hammer and Walsh are the landscape architects.” We plan to start work on the courtyard in September,” she said.

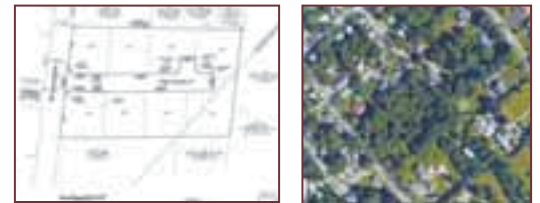

Dervan said the Emerald Society fundraisers for Cops for Kids with Cancer and dozens of other local community charities month-to-month, but he said they really wanted to have an event that emphasizes the importance the BPES feels towards the charity.

trict at large. Her daughter Jill Connolly, her sister Carol Vance and her grandson came out to accept the award in her honor, dedicated by District E-18 Community Service Captain Joseph Gillespie.

“She was president of the Hyde Park Neighborhood Association since Reagan was president,” he said. “She was awesome, she never judged anybody. She was dedicated to what she did and she single-handedly cleaned up the Neponset River. I mean every Saturday in May she’d be down there pulling out shopping carts, all kinds of trash and she invited people down. I can’t tell you what a loss it was for us in the community.”

The award for the Community Watch of the Year was given to the East River Street Neighborhood Association, and accepted by the association’s president Barbara Hamilton. She accepted the award with the group’s founder, her mother.

“I wanted to bring my mother up because she’s the one who started the ERNA,” she said. “Hyde Park is diverse and we knew it when it wasn’t. We knew it when I was the only person of color at my elementary school, the James. J. Chittick. Hyde Park has definitely changed for the better

and we appreciate that.”

NNO Roslindale Emcee Glenn Williams announced that Roslindale Village Main Streets Executive Director Alia Hamada Forest won this year’s Community Service Award for the E-5 Police District.

“I’ve been a Roslindale resident for 60-something years, and I say it all the time, if someone had told me 60 years ago there would be people lining up outside of Roslindale restaurants, I would have told them they were out of their minds,” he said. “But it’s because of the commitments of people like Alia that have brought this place into the destination that it is.”

Forest said she is just the representative of the hundreds, if not thousands, of volunteer hours that so many Roslindale residents put in to make the Village an amazing place to be.

“RVMS is nothing without the work of volunteers,” she said. “All of the events we do is because of residents and business owners who take pride in living and working here.”

Newly-appointed Boston Police Commissioner William Gross stopped at all the NNO celebrations across the city. He said he was happy to take over for former Commissioner William Evans.

“Though I’m going to have to find some civilian clothes, and I sure can’t take them from Commissioner Evans!” he said to laughter from the crowd. “I’m just so proud to serve in this capacity. I’m someone who doesn’t forget where they came from and that’s from the community. actively moving forward with our Paintbox Program, trying to identify utility boxes to paint and getting artists to paint them in the district,” she said. “We have not yet made selections for the artists, we still have one more approval step and then we have to send them to the city for approval.”

Joseph said while this is just a pilot program, they hope to extend it in the coming years.

“We’re looking forward to make that an annual initiative, eventually getting through the 20 boxes that we have along Centre Street, Spring Street and a little more off of Spring and Centre,” she said. “A couple of people when they found out we were doing it actually asked to have the boxes closest to them painted, and these were residents who reached out and said ‘this is awesome, let us know if we can add some locations.’”

While graffiti tagging is not so much of a problem in West Roxbury, Joseph said they know public art can attract it and they are working with the city to have repair teams in place should that hap-

pen.

“This would be working with the Boston Artists Commission to deal with tagging, but right now we don’t have an issue with tagging on the utility boxes,” she said. “It is something we will keep awareness about and make sure that we don’t see any issues about it, or address them when we do.”

Joseph said WRMS is also looking at other places public art could be installed.

“We’re excited to implement this as some public art and we’re looking for more opportunities for public art as we move forward,” she said.

Joseph said the WRMS is also continuing its Women’s Networking Group going on, and the group is meeting at Recreo on Aug. 15 for a coffee hour. Joseph said anyone interested in helping women’s businesses in West Roxbury can come to share ideas or learn.

“It’s not exclusive, it’s just giving more of a network for people who are looking for invites and insights from a businesswoman’s perspective, but everyone is welcome to attend,” she said.

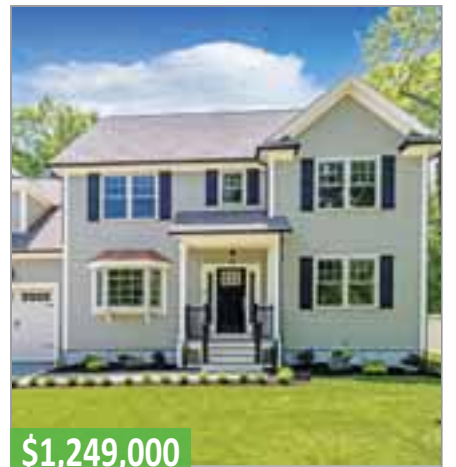

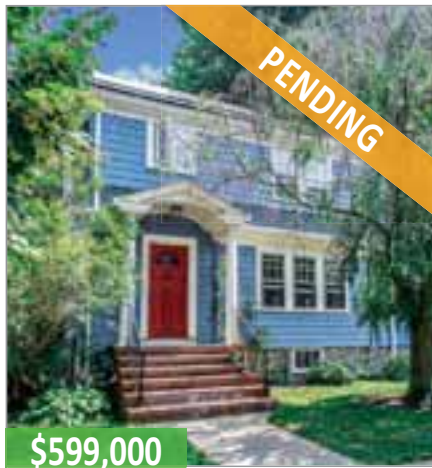
