## Lara and Arroyo out of contention in November

With all districts reporting, the City of Boston has released its unofficial results from the preliminary election for Districts 5 and 6 of the Boston City Council.

In District 6, challengers Ben Weber and William King beat out Kendra Lara in a race that saw much higher than usual turnout, with 11,748 ballots being cast.

In that race, Ben Weber received the highest number of votes with 4,951 (42.25 percent of the vote), with King behind at 4,384 (37.42 percent), and Lara coming in at 2,351 (20.06 percent).

In District 5, a total of 7,583 ballots were cast, with Enrique Peppen topping the ticket with 3,047 votes (40.42 percent of the vote), Jose Ruiz coming in at 2,302 votes (30.53 percent), incumbent Ricardo Arroyo with 1,397 votes, and Jean-Claude Sanon coming in with 766 votes (10.16 percent).

Weber took to social media to thank his voters for getting to this important step in the process.

“Thank you District 6 voters for the faith you have put in me,” he said on social media. “I am thrilled by the support we received across every neighborhood in the district. Together, we can make Boston a place where my kids and everyone’s kids want to stay and raise their own families. Onto November!”

Weber’s main talking points have been centered on schools, since he said he entered the race because of issues at his children’s Mission Hill school. He

has also worked as an attorney in cases concerning workers rights for the last decade or so.

In West Roxbury, the issue of road safety has taken up a lot of airtime particularly concerning the Centre Street redesign project, perhaps known better by many as the Centre Street Road Diet. The plan calls for the narrowing of Centre Street from four travel lanes to two and creating a central turning lane. Weber said in a recent candidates forum that he wants to make sure the design works and, if elected, will oversee how it changes safety on Centre Street.

“I want to make sure people actually stop speeding down Centre Street and people are actually able to cross the street,” he said. “I think it would be a good idea to put in a flashing sign, so when pedestrians are going to cross the drivers are alerted that they’re coming and they need to stop. I think the Road Diet is not the end. It’s going to have to be tweaked and made sure that it’s actually making the street safer, and there needs to be a review of what it’s doing.”

King said he feels more incremental changes would be preferable all around the district, not just at Centre Street.

“We need to be looking at different infrastructure changes on different roads that make sense,” he said. “Like making sure we have curb bump-outs so that seniors getting off a bus can step right onto the curb and not onto a street. Make sure we have crosswalks where we need them and make sure we have more pedestrian-controlled stoplights. I’m also a big fan of speed humps where we can put them. I understand they can cause a prob-

lem for plows but they really slow down cars, and make it safer for folks crossing streets, and our bikers too. We need to continue to look at how we make our streets safer for our more vulnerable people in the district.”

Peppen said he was honored to be chosen for the upcoming election in November.

“I am honored and beyond thankful to announce that we made top of the ticket today,” he said on social media. “Your hard work, dedication and unwavering support are what made this achievement possible. To every volunteer, every supporter, every endorser that put their trust in me—thank you, from the bottom of my heart. Above all, thank you to my family for being there with me every step of the way.”

Both Ruiz and Peppen have stated they feel development is the biggest issue in Hyde Park and Roslindale. They have said developers get away with not following the Boston Zoning Code too often. Both candidates expressed support for the city purchasing the Crane Ledge Woods from the current owner to stop the proposed development there (as did Arroyo and Sanon).

The final elections are set for November 7. In District 9, Incumbent Liz Breadon will be facing off against challenger Jacob deBlecourt. For the At-Large seats, incumbents Ruthzee Louijeune, Julia Mejia and Erin Murphy (Michael Flaherty decided not to run for reelection) will be facing off against challengers Clifton Braithwaite, Bridget Nee-Walsh, Shawn Nelson, Henry Santana and Catherine Vitale.

## LivableStreets Hosts 'Tour de Streets'

On Saturday, Sept. 9, the LivableStreets Alliance hosted its annual 'Tour de Streets' bike ride and walk to fundraise for transportation equity and access.

'Tour de Streets' started as a memorial for Robert Zeeb, a Newton public school teacher who died in a bike crash in 2009. His family partnered with LivableStreets, an advocacy organization, to host the event each year and raise awareness on street safety.

“We’re an access and equity organization, and the way we achieve those goals is by focusing on our largest shared public spaces, which are our streets,” Executive Director Stacy Thompson said. “LivableStreets focuses on Metro Boston, and we think about walking, biking, public transit, green space, land use – all of the things that contribute to a healthy system where everyone has the ability to move throughout their community in any way that they choose.”

The event started around 10:30 a.m., with participants heading up the Charles River Greenway. A group of walkers was led

by Emerald Network director Abby Jamiel, who shared about various greenspace projects in the works across Boston. Bikers then split off into two groups: a three-mile family ride and a 10-mile urban ride.

Around noon, participants made their way back toward The Speedway for hot dogs, empanadas and ice cream. Remarks were made by LivableStreets staff, which highlighted achievements the

previous year's 'Tour de Streets' fundraiser made possible.

Projects included deploying ambassadors to every Orange Line stop during the Orange Line shutdown, securing funds to advance the Greenway Project, passing an act to reduce traffic fatalities, releasing a bus report to improve the busing system, and securing funds to reduce MBTA fares for low-income Bostonians.


were made a long time ago, particularly within a racist or otherwise inequitable context."


Watertown State Representative Steven Owens was in attendance and has partnered with LivableStreets previously. Most notably their partnership led to the passing of a bill – one LivableStreets advocated for, for nine years – to reduce traffic fatalities. Representative Owens rode in the 10-mile ride, which went through his district in Cambridge and Watertown. In an impromptu speech, he said he is currently working to connect the Greenway to the Minuteman Bikeway, which will make it a commuter route.

"I think it's really important to have a network of off-road spaces for cyclists – not just for recreation, but also for commuting," Representative Owens said in an interview. "Every commuter that commutes by bike is a commuter that's not taking up space in a car. So if we're going to reduce congestion, if we're going to meet our climate goals, getting people out of cars is a great way to do that."

About 100 residents, veterans, Boston Mayor Michelle Wu and officials came out on Thursday to honor West Roxbury native Captain Thomas Gunning Kelley and to dedicate a new mural for him at the Boston Ale House on Centre Street.

Kelley is one of the few living Medal of Honor recipients. He has earned several other awards and medals, and has served as the Massachusetts Department of Veterans' Services Commissioner and as the President of the Medal of Honor Society, as well as starting several initiatives to help returning veterans from Iraqi Freedom.

Kelley said he was so grateful to his hometown for putting together the ceremony and the mural.

"Joan and I were over here the other day visiting my old stomping grounds and we decided to stick our heads into the joint next door," he said, gesturing to the Boston Ale House. # Need to back Mayor's proposal

Disappointed as I was to hear of BPS Superintendent Mary Skipper's recent on-air agreement with Cantabrigian WBUR host Jim Braude that private (=Catholic) school kids should not be allowed to attend Boston's exam schools, Mayor Wu's proposal to relocate the O'Bryant School of Math and Technology to the current site of West Roxbury High School has buoyed my spirits: truly it has significant merit.

If the transportation is in place, this is a great move not

only for Madison Park High School but also for O'Bryant, with both benefitting from additional space.

When the new draconian rules for admission to the Boston Latin School were imposed, scores of Parkway students were denied entrance to the venerable institution on Avenue Louis Pasteur: most of their parents spoke English, they did not live in public housing, most were not foster children, and they came from Catholic schools. Thus they did not receive the very

generous "bump up" in additional points that hundreds of other applying public school students had received.

Supplying almost a plurality, if not the actual plurality itself, of students to BLS under the previously fairer admission system (yes, fairer), the Parkway needs a public high school to service higher-than-average teenage students. While currently Catholic Memorial High School services such males, the area needs such a school for

girls and for boys whose families cannot afford or do not want to pay for the excellent education on Baker Street.

The scores of high achieving students from Holy Name, Sacred Heart, and St. Theresa's — now uninvited to attend BLS — need a nearby high school. If the O'Bryant is moved, watch how the quality of education at its new location will be elevated by the inclusion of such pupils.

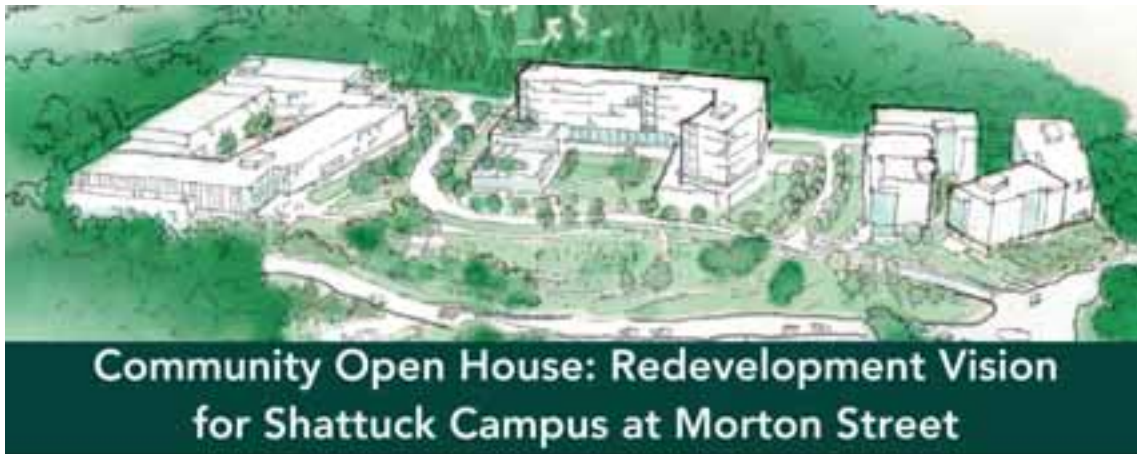
Yes, of course, there needs to be transportation in place for the current student population not living in the Parkway and for the future pupils not living here. With T buses already in place arriving at Forest Hills from Nubian Square (#42), from Mattapan Square (#30), and from Cleary Square (#50), school buses would have to leave from Forest Hills as well as a new stop on the Needham Heights purple line would have to be sited — which would have the additional benefit of serving adults working at Home Depot and to be residing in the abundant new apartments already built on the VFW and scheduled to be built on

Millennium Drive. The new railroad stop would serve students currently riding T buses into Ruggles, where they could transfer onto the Purple Line.

Yeah, students from Brighton, Allston, Charlestown, and East Boston will still have it tough: they already have long rides into Roxbury, but for more time to get to the VFW, they will have at their fingertips excellent football, baseball, and soccer fields, a 6-lane track, and a swimming pool, all of which they do not have now.

# Celebrating 300 years of Irish US contributions

The Irish Social Club is hosting a celebration of the contributions of Irish peoples and those of Irish descent for the past 300 years in the United States on Sept. 23 from 7 p.m. to midnight.

Organizer Michael Dwyer said the night will feature the story of John “Owen” O’Sullivan (no relation), who came to Massachusetts in 1723 and settled in what is now Berwick, Maine. Dwyer said John O’Sullivan came from the same area as the Fighting Sullivan brothers, whose service

and sacrifice inspired movies like “Saving Private Ryan,” “The Fighting Sullivans, and instituted new military policies to limit loss to individual families. Dwyer said O’Sullivan got his first job as a school teacher in Berwick because he submitted a rather unique job application.

“He was educated in the continent because he wouldn’t have had that opportunity under British rule in Ireland,” he said. “He was fluent in five languages, and the story goes when he applied for a school teaching job in Berwick, Maine, he applied in five different languages.”

He said O’Sullivan married Margery Brown and settled

down. He and his wife may have settled down, but his children definitely did not.

“They had five sons who fought in the American Revolution and, as the story goes, one became the governor of New Hampshire, that was John, and James became the governor of Massachusetts,” he said. “And that’s in a single generation. John Sullivan, the governor, was also a general in Washington’s army.”

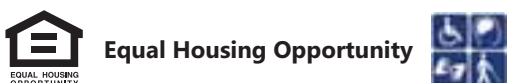

letter to (Somerville Mayor Katjana) Ballantyne over in Somerville and ask that she do the same thing so I don't have to drive all the way over here!"

Kelley grew up just a few blocks from the mural on Meredith Street and said the neighborhood helped to make him who is today.

"When I was here in West Roxbury there were only two pubs, one at Centre and Lagrange and the one that's right behind me; it was called the West Roxbury Cafe I think," he said. "Across the street right there, I worked at a fruit and vegetable store run by Richard Morris and Sons, and at Christmas time I sold Christmas trees at that parking lot right over there. It was just a grassy area at that time."

As he was speaking, a large 18-wheeler passed by with a loud engine.

"I guess that takes the place of a flyover," he said, to laughter from the crowd.

Kelley said his father was a teacher and his mother worked part-time at a card shop and lending library. He went to Boston College High School with Lord Mayor of West Roxbury Richie Gormley's older brother, William.

"Billie became a colonel in the National Guard and died very prematurely about 10 years ago. He and I and our families go back a long, long way," he said. "It's a great honor to be here and I feel very humble, but I think of other people here in West Roxbury who I knew growing up who were probably at least as, or if not more worthy than I, for this particular honor."

Kelley called out Michael Donnellan, who was also at the ceremony.

"Mike and I worked together, we went to Holy Cross together and he became the linchpin of the peace accords that brought peace to Northern Ireland," he said. "He didn't get all the credit for it, but he was a mainstay for that. Mike, you belong up here."

Kelley earned his Medal of Honor in 1969 when his command of eight river assault craft were extracting a U.S. Army company from the east bank of the Ong Muong Canal in Kien Hoa province. One of the troop carriers suffered a mechanical failure, stranding the soldiers there, and almost at the same time the enemy opened fire on the group of eight river boats from the opposite bank.

Kelley ordered his boats to form a defensive posture around the stricken vessel, with his modified LCM-6 troop transport directly in the line of fire. Despite enemy rocket fire hitting his boat and the resulting shrapnel se-

verely wounding his person, he continued to relay commands during the fight and safely extricated his command and the army soldiers.

The enemy attack halted and he was able to move his boat and all those under his command to safety. The citation reads: "His extraordinary courage under fire and his selfless devotion to duty sustain and enhance the finest traditions of the U.S. Naval Service."

Wu announced during the ceremony that Sept. 7, 2023, was officially "Captain Thomas Kelley Day" in the City of Boston.

"Public art helps us highlight the values and achievements of our communities, telling the story of sacrifices and leadership that helped form Boston's neighborhoods and our country. Commemorating Captain Tom Kelley's decades of military service adds to the fabric of West Roxbury's character," said Mayor Michelle Wu. "I'm grateful to the local artist, community members, and city departments that made this artistic vision a reality. And most of all, to Captain Kelley for his example of selfless leadership and dedicated service."

Wu added that the City of Boston will fight hard to keep Kelley's legacy here in Boston.

"We'll take full credit for your bravery and heroism, not Somerville, they had nothing to do with it!" she said to laughter from Kelley and the crowd. She took out a commemorative plaque as well. "And we will send you home with a small memento so you'll always have this in the house too."

Boston Commissioner of Veterans Services Robert Santiago said he and many other sailors before him owe him a debt of gratitude.

"As a retired Navy Sailor myself, I want to thank Tom for leading the way for us sailors who came after you, thank you very much," he said.

Richie Gormley said he had nothing but warm feelings for Kelley and his family.

"It's a great event and I've known the guy growing up," he said.

The mural depicts Kelley in front of the planned U.S.S. Thomas G. Kelley, an in-the-works Arleigh Burke-class guided missile destroyer announced earlier this year. A Harvard team led by Mark Handley presented project updates that were made after their previous meeting with the Harvard-Allston Task Force. Updates included building design changes; regulatory timelines and an Institutional Master Plan amendment; reports on shadows the housing building will cast over Smith Field

Park; and the use of public transportation (both Harvard shuttles and the MBTA bus system).

Afterwards, the Task Force was given time to ask questions. Members asked if there was enough parking for the housing building, if enough

trees would be planted, and if the theater's shows would impact local traffic.

The most common concern was the appearance of the housing building.

"I know that millions of people will travel down Western Avenue in a year, and they will see that building front and center for the next 50 or 100 years," Task Force member Tim McHale said. "Is that a building that's really architecturally snappy and really grabs the eye? I mean, I don't see it."

The architect, Dennis Vermeulen, stated that the team wanted to create a "fairly iconic shape" and that "that shape might not be for everyone." Even so, he said that the team believed the building was "good urban design."

"This is a signature building going into Barry's Corner, and for the life of me, I can't understand why anyone would be excited by its looks," Task Force member Bruce Houghton said. "How it takes into context the neighborhood of Allston is beyond me, other than that it looks like a warehouse. It's tremendously unappealing."

When questions were opened to the public, Paula Alexander also commented on the design of the building.

"We're going to end up with a park surrounded by this humongous wall of concrete," Alexander said. "To me that's disappointing to the neighborhood. We need more open space; we need more breathing space. We're just getting closed in by concrete and high-rise buildings. It's unhealthy. It doesn't make for a good community."

Another key concern was in the shadows that will be cast onto Soldier Field Park from the housing building. Handley stated that they had met with the Parks Department and "produced all of the shadow studies they've asked for." Since the previous Task Force meeting, the

Harvard team reduced the proposed height of the building by one floor in an effort to reduce shadow casting. Task Force member Cindy Marchando stated that the change "still did not satisfy the request." And in the end, Handley said, "There is no way to achieve the total mass and avoid casting shadows... We are limited in how much we can reduce [shadows] here."

Task Force members also questioned the benefit of the project to Allston residents. During their presentation, the team stated that the theater would create public retail access, partnerships with schools, and free theater tickets for Allston and Brighton residents.

Houghton questioned what benefits would be linked to the housing building; "Harvard is getting a large bulk of residential housing. Other than some free tickets, I'd like to have more clear delineation as to what the community benefits are from that building." He requested a written report of these benefits.

Task Force member Edward Kotomori expressed concern over dust from concrete and contaminated soil that would spread during the construction project.

"[Locals] need to know these things because they're the ones that are going by it, they're the ones who are going to be breathing this stuff in, and most of the time they don't realize that this can affect their health in the future," Kotomori said.

Ed LeFlore of CSL Consulting responded by offering to discuss the construction plans at the next mitigation meeting.

Handley concluded the two-and-a-half hour meeting by stating that they would continue to meet with the Task Force and reminded attendees that the last day for public comment is September 29th, which can be made at [bostonplans.org](http://bostonplans.org).

the Irish Social Club will focus on the connection between O'Sullivan, the Fighting Sullivans and many of the Irish diaspora now living in Massachusetts.

"O'Sullivan arrived in Berwick, Maine 300 years ago this year, and the five O'Sullivan brothers, who lost their lives fighting in the Second World

War, their grandparents came from the same area in Ireland as John Owen O'Sullivan in County Cork bordering County Kerry," he said. "The Beara Peninsula is the connection. And also our current Governor Maura Healy's grandfather came from the same location as well."

Dwyer said the granddaugh-

ter of the youngest Sullivan Brother, Albert Sullivan, will be coming to the event all the way from Waterloo, Iowa. He said Kelly Sullivan Loughren will speak about her experiences growing up around the story and the sacrifice that her family made a generation prior. The five brothers had their own movie made about them in 1944, as well as having two U.S. Navy warships honoring their legacy.

Dwyer said Caroline Cronin, a councilor in Cork, will also be

coming to the event.

"I would imagine that Caroline will be giving an update on the political situation in Ireland," he said.

Dwyer said it was amazing that O'Sullivan, the Sullivans and Healey all came from an area within 20 miles of each other.

"What comes to mind for me is that geography is the mother of history," he said.

Dwyer said there will also be a meet-and-greet at M.J. O'Connors at Park Plaza in the Downtown on Sept. 19 at 6 p.m.


"We have 74 people coming from Kerry and Cork, the County Councils are being represented and the mayor of each county is coming," he said. "Others coming are community leaders from West Cork and South Kerry because the Beara Peninsula straddles both counties."

Dwyer added that they are expecting City Council President Ed Flynn, as well as many other officials, to attend.

About 50 people came by to enjoy the festivities inside and out at the busy Columbus Avenue branch library.

There was face painting, a sing-along with the group Sulinta, and empanadas provided by Pikiolo, and Boston by Foot (BBF) was there coordinating oral histories.

According to Procyshyn, "BBF is working on a project where they partner with us next year on a walking tour of Egleston Square."

Chances are there won't be a 75th birthday party. A new stand-alone library is planned and \$22 million has been allocated in the city budget to build it.

According to one source, the Egleston library will close in late 2024 or early 2025 for construction to begin, but no architect has been chosen yet.

Perhaps the highlight of the summer was on Saturday, July 22, when the NAACP Day of Service came to Lawson Park ahead of the 114th NAACP convention that opened on July 26.

Egleston Square was one of four neighborhoods including Hyde Park, Dorchester and Mattapan to host the service day.

According to Egleston Main Streets director Denise Delgado, over 30 volunteers not only from Egleston but "from Boston and beyond" came out to join the Lawson Park friends and ESNA.

"The volunteers laid soil and mulch and bricks for edging and planters and paths, plus they planted bushes, shrubs and set up trellises," Delgado said.

Ericka Lawson, with her sisters Vida and Ursula, greeted the volunteers and explained for the benefit of the out-of-towners the story of Robert Lawson, who opened up his barber shop in 1967. Though he died in 2016, the shop is still going strong being run by his daughters.

Egleston House of Pizza provided the lunch.

Delgado told The Bulletin that Main Streets, ESNA and the Friend of Lawson Park coordinated the service day with the Boston NAACP.

She said ESNA and the

Friends bought tools, mulch, flowers and other supplies with a \$5,000 District Beautification grant from the city of Boston.

In its press release, the Boston NAACP announced the Day of Service in Boston's neighborhoods by reminding people that the NAACP began in this city on Feb. 9, 1912.

"The Boston branch wants to support the beautification of Boston's neighborhoods," the release read.

On August 16 Mayor Wu celebrated the long-awaited re-opening of the Walnut Avenue playground at the corner of Walnut Park.

The popular one-third acre corner playground was razed and rebuilt at a cost of \$1.2 million. Designed by landscape architects CBA (the Clara Batchelor firm) the new playground is designed with features for kids aged 5 to 12 with a spray pool, shade shelter swings and rubber surfacing for the swings and the jungle gym and slides. Eleven new trees were planted.

In June 2023, what is perhaps the most distinctive feature, the exterior fence, was repaired and repainted.

This is not just a fence; it is dotted with square hand reliefs cast from the hands of little kids, mainly from the nearby Ellis School. This was a feature from the 1991 reconstruction designed by Wallace Floyd Associates.

"The hand theme," the Parks Department press release read "is carried over through the rubber play surface."
