School Com votes to close Irving, Jackson and Timilty

In an effort to move away from middle schools, the Boston School Committee voted 5-0 with two abstentions to close the Washington Irving School in Roslindale and the James P. Timilty School in Roxbury. The Committee also voted to close the Jackson Mann School in Allston, but that was because of the buildings' structural problems rather than any kind of curriculum changes.

BPS Superintendent Brenda Cassellius said the closures of the Irving and Timilty are based around the district's desire to move away from dedicated middle schools.

"We know our performance at our middle schools is one of our biggest challenges for a whole host of reasons," said member Hardin Coleman. "This is where we are not well-organized, and as we know from the Headmaster at Boston Green (Matthew Holzer), when they ask for seventh and eighth grade-students, they

wanted those students in their building to prepare them for a high school curriculum, and that's received a lot of success. Their performance has improved because they're getting kids in those middle years and preparing them. We don't know for certain this is going to work, but I'm highly supportive of this decision to go to a grade K-6, 7-12 system so that we can address our middle school performance problems and engage kids earlier to reduce the transitions and keep them engaged."

Member Michael O'Neill harped on the problem of transitions, in that he believes too many BPS students are having to switch schools too often.

"This is a perpetuation of a policy that we as a governing body set awhile ago," he said. "We did not like that we had up to 23 grade configurations within BPS; too many transitions, too much uncertainty for parents. We heard continuously that they wanted

11 Dana Ave. case found to lack standing

The three-year saga regarding the 11 Dana Ave. housing development in Cleary Square reached its climax as a decision was issued in Suffolk Superior Court on Mon. Dec 20 that the case lacked standing.

Cross-motions filed by plaintiff Ralph Rosati, a Dana Avenue resident and member of the Hyde Park Neighborhood Association (HPNA), were denied because once the case lacks standing, his arguments are considered moot.

The case was heard on Wed, Dec. 15 by Hon. Debra A. Squires-Lee, one day after the third anniversary of the 11 Dana Ave. housing proposal being filed with the Boston Planning and Development Agency (BPDA). Rosati filed the lawsuit against the developer, HCC One Grant LLC, and the Zoning Board of Appeals (ZBA). He intended to represent himself in court but could not appear because of illness.

Squires-Lee found that Rosati did not have standing as an abutter or a

person who was directly impacted by its construction in a way that was different from the rest of the community.

"Because the case is dismissed for lack of standing, and therefore subject matter jurisdiction, I do not address the substantive issues raised in the cross motions for summary judgment," she wrote in a footnote to the decision.

"Although I appreciate, acknowledge and accept Rosati's commitment to affordable housing, matters of 'general public concern ... do not establish a plausible claim of a definite violation of a private right, property interest, or legal interest sufficient to bring' Rosati within the 'zone of standing,'" Squires-Lee wrote in her five-page decision.

Construction of the 24-unit housing development is nearly complete despite HPNA contentions that it should not have been deemed an as-of-right project by the BPDA, the Inspectional Services Department

Residents still concerned about 309 Summit

The Boston Planning and Development Agency (BPDA) hosted a virtual meeting on Mon. Dec. 13 with developers for the 309 Summit Ave. proposed 19-unit development in Brighton, and residents said they were pleased that the units will now be condominiums. However, they also wanted design modifications and better vehicular access for the moving trucks and shared ride cars that will frequent it. And a much less modern design.

Lance Campbell, BPDA senior project manager, moderated the hour-long-plus meeting. It was the second community meeting organized by the BPDA, with developers

Michael Flynn and former Boston District 8 City Councilor Josh Zakim for the community. It was attended by 17 community members, including Rep. Kevin Honan.

Proponent attorney Marc LaCasse gave a presentation on the building modifications, which were based on community feedback. He said the building currently on the site at the corner of Summit Avenue and Allston Street will be razed. The proposed four-story development would have a footprint of 5,500 square feet with a mix of unit sizes.

“The biggest change from when you have last seen this proposal is that the unit count has been reduced to 19 units,” he explained. “And in

response to a lot of comments about the type of units in the building, Josh and Michael have converted this proposal from a rental building to condominium ownership opportunity.”

On this and other development projects, Allston-Brighton residents have advocated for more units for home ownership for families. The units will be larger now that the number has been reduced. There will be eight one-bedroom units, seven two-bedroom units and four three-bedroom units “so that persons can set down their roots in the neighborhood,” according to LaCasse.

Architect Nick Griffin from Cube 3 presented the plans for the building, which will have a single



On Dec. 17, Boston Police Officer Mark Tobin and his wife Jessica were sitting on one of the benches on Centre Street in front of the Hastings Street Parking Lot

with their three children, Tommy, Anna and Donata.

A pickup truck parked nose-in to the parking space behind them then apparently jumped and damaged the brick wall separating the street from the parking lot and crashed directly on top

(ISD) and the Zoning Board of Appeals (ZBA). If the project required variances, it would have triggered an affordable housing requirement for 13 percent of the units under the city's Inclusionary Development Policy (IDP).

The other issue was that the City and the HPNA had differing interpretations of the definition of accessory parking. The entrance to the garage is at ground level and descends six feet below grade. The height of the garage is 10 feet, which HPNA

argued would place it on the first floor. The City disagreed, stressing that accessory parking is allowed if it is an accessory to the main use of the building.

HPNA previously argued the building is in a third neighborhood shopping district, or NS-2 zone, which required two parking spaces per unit, triggering a variance. However, the map showing the third zone was never codified by the City.

Attorney Michael McDermott represented HHC One Grant LLC. Sultan Durzi represented the City but did not present an argument. McDermott argued the case should not go forward because Rosati lacked standing. He also said he had offered to reschedule the hearing and that Rosati received the Zoom link.

"He stood by his affidavit that he may not be able to appear and said that if he didn't, it would proceed," McDermott said of Rosati. The last communication between them was on Nov. 19.

McDermott said all parties agreed that Rosati is not a direct abutter, an abutter to an abutter, or directly across the street from 11 Dana Ave. Rosati lives across Hyde Park Avenue on the other side of Dana Avenue.

McDermott also contended that Rosati "filed the appeal not to oppose the

project but to advocate for affordable housing." He said that the project is in the Cleary Square NS-2 district "where accessory parking is an allowed use" and complied with the requirement of one parking space per unit.

Rosati lacked standing both as an individual and as an HPNA member and didn't prove that "he is a person aggrieved as required by the statute." Therefore, Rosati would bear the burden of proof that he is suffering "in a manner that is special and different from the rest of the neighborhood."

McDermott added that HPNA could not file the case on its own behalf because it is not incorporated.

Squires-Lee said that, if she were persuaded to dismiss the case on lack of standing, the arguments about its merit would be moot, but that she would hear them in case they became relevant.

McDermott said the BPDA, ISD and ZBA all determined it was an as-of-right project requiring no zoning relief. He explained that a table for primary vehicular uses in Article 69 illustrates uses such as a parking garage "with the condition that it is below ground or on the second floor."

"I see," she said. "You can't have primary use parking on the first floor."

Former HPNA President Jim Kirker asked if he could

speak. Squires-Lee explained that if they were in a courtroom, he would not have that right unless he was the attorney, but she would allow it. Kirker explained that HPNA members never argued that accessory parking wasn't allowed. However, he referred to a footnote in the code that accessory parking "should be subject to the same restrictions as the use to which it is an accessory." His argument is that parking is not allowed on the first floor, "which was never addressed by the ZBA."

Squires-Lee said that if she deemed that the case had standing, she would examine all of the tables in the code to determine what applied.

At the end of the hearing, HPNA member Craig Martin asked to speak. He argued that it "was mischaracterized that [Rosati] chose not to be here."

"He has a grave health condition," Martin said. "He cannot be here."

The judge said she would put that on the record, but noted Rosati was willing to proceed on the papers.

In an interview with The Bulletin, Kirker said he was happy that the judge was willing to let him present information that the ZBA did not.

"It was good to present a little bit of our side of the case to someone who did not have a vested interest," he said.

less transition. We also heard concerns from high school leaders on how students were doing in the middle schools, and we knew there was no research to show that either a K-6, 7-12 or a K-8, 9-12 configuration worked better. What we did know was that the middle schools were struggling the most."

O'Neill said they would like to have most schools either be K-6, 7-12 or K-8, 9-12, with a few exceptions.

"What we would do is

phase out the middle schools," he said. "But that doesn't mean we don't need the buildings, and the students are still ours."

Member Rafaela Polanco Garcia said she was concerned about what the buildings for the Irving and Timilty would be used for (the Jackson Mann is likely being rebuilt completely as it's currently falling apart). Cassellius said the school buildings will be used as much as possible.

"We need these buildings," she said. "We absolutely need these buildings. It's almost like a chess board; we needed to close these buildings to get to the pathway configuration – the School Committee had made that decision prior to my arrival – and now we can move in and start renovating these buildings. We also will have the benefit of being able to move elementary schools into these buildings or merging schools. So I just want to be very clear, we need the space right now to be able to enact our vision for more buildings and newer buildings."

"I'm looking to have preschool in every school, so that will help enrollment, get our families early and young and build our relationships with them," she said.

Members Robinson, O'Neill, Coleman, Ermani DeAraujo and Quoc Tran voted to approve the school closures. Members Lorena Lopera and Garcia abstained from the vote.

vehicular entrance on Allston Street. There will be 11 parking spaces as well as 24 bicycle spaces on the lowest floor, which will be “completely buried” on the Summit Avenue side. Each floor has a mix of unit sizes. There also will be a small roof deck for tenants.

The plan also includes a pocket park at the building’s main entry point of about 1,400 square feet. The first three floors have a mostly brick façade designed to match the neighborhood’s architecture. Gray paneling will comprise most of the rest of the structure and will be used entirely on the fourth floor.

“This neighborhood is like Ph.D.-plus when it comes to architecture,” Campbell said. He asked the architect to explain the vertical paneling and the fenestration (windows).

“We want to have a mix of some modern kind of detailing,” Griffin noted. Materials for the paneling haven’t been selected yet but will be a mix of fiber cement siding, which will accentuate the windows.

During the question-and-answer period, concerns were raised about the condominiums being sublet. LaCasse explained that there will be an owner-occupancy deed restriction of 75 percent of the units in the master deed.

Jocelyn Sylvester said that the area experiences “a lot of low-velocity crashes” because it is hard to see around that corner. Cars also park on either side of the street. She noted that de-

livery vans, which usually park at the corner, would further obstruct the view.

She requested a dedicated space for delivery areas. Zakim called it “a significant change” in the design. The development team would have to “shave off some frontage,” Campbell said to accommodate that.

Griffin said the sidewalk would remain at the existing width of five feet. He looked at putting a drop-off area on Allston Street, but the area was too steep.

Thomas Leonard complimented the team for offering homeownership opportunities, which most developments do not, calling it “a big win.” He also said he was happy to see parking after looking at the 4198 Washington St. project in Roslindale, which had no parking and was denied at the Zoning Board of Appeal (ZBA).

Complaints from others arose about it looking less like neighborhood condominiums and more like a private modern building.

Eva Webster said that the design did not fit into the context of the neighborhood and more resembled Commonwealth Avenue. She said the design should “set the tone” for future developments.

“I bristle when I hear anyone on the development team refer to this 20-foot setback as a park,” she added. “This is a setback, and it’s a nice setback, and it’s one element of the project that I welcome.”

“If you want to sell condos

to quality buyers who will pay you top dollars, you really need to have a buffer zone between people’s windows and the road traffic,” she continued. “And a five-foot setback is not enough.”

“I hear you absolutely on the neighborhood,” Zakim responded, noting the team will look at pictures that residents sent of architecture they preferred. “That sort of influenced every revision we made from the beginning.”

Resident Paula Alexander echoed those recommendations, saying the “building would stick out like a sore thumb.” She also explained that the utility lines could overwhelm the abutting homeowners.

Griffin said he would look into the utility line issues, and Zakim said that was a good point. Zakim said he used to live on this block, while Flynn lived in the current building. Zakim stressed that they “want to be good neighbors.”

“This is really where the proposal is at this point based on the feedback from the folks on this call and others,” Zakim said, noting all the design changes thus far.

“We heard from some folks who are really passionate about their neighborhood,” Campbell said. “And it doesn’t go unnoticed.”

eration (BPSOF) also stated that the family had been injured.

“This incident resulted in injuries to both our member and their family members,” the statement read. “We would like to extend our gratitude to the members of the Boston Fire, Boston EMS and our brothers and sisters in blue who came to the aid of one of our own in their time in need.”

A GoFundMe page was set up the following Sunday with the stated goal of raising \$10,000 for the family’s medical expenses. As of the date of publication, 942 members of the community stepped up and have raised \$105,795.

According to family friend and creator of the fundraiser, Casey Buckley, the family is now home and resting as comfortable as possible after the accident. The family released a statement through a spokesperson: “The Tobin family is deeply grateful for the first responders, doctors and nurses who helped their family. At this time they’re asking for privacy but appreciate everyone’s support.”

According to the GoFundMe, many of the donations were relatively small, ranging from about \$25 to \$100 on average, with one anonymous donation coming in at \$5,000 being the largest.

At the time of publication, no charges have been filed.

Egleston Branch Library, not a full neighborhood meeting."

But the Zoom password wasn't available to some who wanted to call in, including apparently some of the Friends, and attendance was low; only 12 were on the call.

In addition, the Zoom link conflicted with a branch library program on cartoons, featuring Popeye, according to Branch Librarian Guy Harris.

"But I guess you can't have two zooms on the same link," he said as he joined the public meeting instead.

Consequently, Leonard said he might schedule another community meeting but the selection of one option needed to be made in January for inclusion in the city's capital budget.

Director of neighborhood services at the BPL Patricia Foley said that the architects, Ann Beha Associates, worked on the plans from June 2020 until October 2021.

The Final Report of the Egleston Branch Library was released on Dec. 16 and is available at the BPL Egleston Square Branch Programming Study page.

Leonard said that the options are a renovation of the existing 6,900-square-foot library, and two variations of a new building with housing or a standalone library.

"The main question for the chosen plan is 'is this right?'" he said.

"One new but not unexpected neighborhood request is for more greenspace," Leonard said. "We may not be the Parks Department but we heard the desire for more greenspace."

Leonard described the four options and called the meeting a "feedback session." Options one and two are variations on a five- or six-story triangular shaped residential building above a platform with ground-level library. The second option has more greenspace and faces St. Mary of the Angels Church. Options three and four are varieties of a standalone library of one or two story.

Both of these are for a 17,000-or 19,000-square-foot library that Leonard said was double the size of the present building and "more than we need which is about 14,000 to 15,000 square feet."

"The two-story, multi-story is a big challenge," Leonard said. "It's more spacious but more expensive to run with more staff. One idea might be a mezzanine as a compromise."

Branch librarian Harris liked the stand-alone li-

brary; at previous meetings he was skeptical of a library with housing.

"I like the two-story," he said. "It can work. It would require more staff and a thoughtful design."

"The architects' job is to give us options," Leonard said. "There will be a lot of briefings with the new mayor, the new administration. We'll have to bring them up to speed, they may have different ideas.

"Right now the proposals are just gray boxes," he said. "Do the uses all fit? There is a definite desire for a community room with 100 seats. Then there's the central service desk, children's area, teens, the adult library stacks, staff work spaces and green space."

Alluding to the new Columbus Ave busway, Leonard acknowledged the obvious. "There's changes in the street now and book delivery spaces are part of the architects' plans. Book delivery is often a few times a day."

"The timeline depends on the options. If housing is an option it will take two years longer to build. Funding to undertake the affordable housing option in a single site is complicated."

Housing will also require a certain height and density given the finances required to make truly affordable work, Leonard added. He also said that a stand-alone library would take two to three years to build, housing over a library three to five years.

Between now until the end of January an option will be selected and the budget submitted in April; in October 2020 a new stand alone library budget was \$12.1 million.

"I don't know of it's in the budget for this fiscal year. If the plan includes housing we'll have to sit down with DND," Leonard said.

The Boston City Council will vote on the budget by June 30.

Newly-elected District 7 City Councilor Tania Fernandes Anderson was recently chosen to chair the Ways and Means Committee which will analyze the city budget in 2022. As approved by voters in November, the council can now change any budget line item.

Whatever the option Egleston Square resident Jacob Bor wants it to be impressive. "The library is not just a place to pick up a book," he said. "It's a monument to our collective aspirations. I want to feel proud if it. I want it to say 'IT IS A LIBRARY.'"
