## City Council considers purchasing liquor licenses from businesses

Last week, the Boston City Council met for a hearing to explore how it might help save a number of Boston businesses by purchasing their liquor licenses and leasing them back to them, allowing the owners to leverage the equity of those licenses to continue operating during the COVID-19 pandemic.

The idea is that the city would buy restaurants more time to operate, as it has been estimated that the city may lose 40 percent of

its restaurants for good once all restrictions are lifted. The city has also started streamlining the process for outdoor seating applications to allow for more customers while continuing to social distance.

The license would be held by the city and could sell later if the restaurant does eventually decide to close. The city would have free reign over those licenses, and would not need state approval to sell them. Boston is the only municipality in the Commonwealth

## Parkway holds peaceful BLM Vigil

The Parkway community held a peaceful vigil on the Holy Name Rotary on Jun. 1 from 5 p.m. to 5:30 p.m. An estimated 2,000 people attended the vigil, which stretched down Centre Street and the West Roxbury Parkway. The event also attracted multiple news crews and news helicopters.

Demonstrations have occurred across the country and

the globe in light of the death of George Floyd, an African American man who died when a Minneapolis police officer used lethal force while arresting him. Demonstrators also demanded justice in the killings of Breonna Taylor in Louisville, Kentucky, and Ahmaud Arbery in Glynn County, Georgia.

Residents of the Parkway decided to hold their own event in solidarity with the Black Lives Matter (BLM) movement. It was organized by community members Tonya Tedesco, Travis

Marshall, Nora Vincent, Patty Neal, and the group Progressive West Roxbury/Roslindale. The “Silent Vigil for Black Lives” event was shared via social media.

“Join us in a silent vigil in support of #BlackLivesMatter. Families with children are welcome. Please wear a mask, practice physical distancing and bring your own sign. We will stand for 30 minutes. We must make it clear to our

## NepRWA annual meeting reviews goals and accomplishments

The Neponset River Watershed Association (NepRWA) held its annual meeting on May 27. The meeting went ahead virtually rather than in person due to COVID-19. The disease and procedures to fight it have also caused a delay in the process of the Environmental Protection Agency (EPA) designating the Lower Neponset (Hyde Park, Mattapan, Milton, and Dorchester) as a Superfund site. Kerry Snyder, NepRWA’s Advocacy Director, said she hopes it will be approved by this fall. A Superfund site designation would mean federal funding to clean up the river, and would eventually lead to the removal of the Tilonson and Hollingsworth Dam on the Hyde Park/Milton line that many residents have been advocating for.

The dam presently cannot be removed because it is holding back so much legacy industrial pollution, including PCBs.

NepRWA members said they also plan on partnering with the EPA to create a Report Card for the Neponset River, similar to what already exists for the Mystic and for the Charles. This Report Card would grade the health of various sections of the river, based on water quality results.

This spring’s river cleanup was unfortunately canceled due to COVID-19. Kelly DiStefano, NepRWA’s Environmental Science Fellow, reported last fall’s cleanup went well, with 20 shopping carts, a mattress, and a wedding cake topper removed. They hope that the fall cleanup can continue as scheduled, including with the Mother Brook sites they had hoped to do in the spring.

While NepRWA is not currently working on stormwater management in Boston, the group does have representatives from the Boston Water and Sewer Commission, and Executive Director Ian Cooke notes that because Boston is downstream from the other Neponset communities, the stormwater management improvements in those towns will also have an effect in Boston.

NepRWA is focused on how climate change will affect the Neponset, and what preventative strategies can be put in place. Both flooding and drought are problems, and with flooding, there are both coastal and inland issues. Ian Cooke spoke on how both Milton and Canton have experienced severe flooding of the Neponset in recent years. Road crossings can

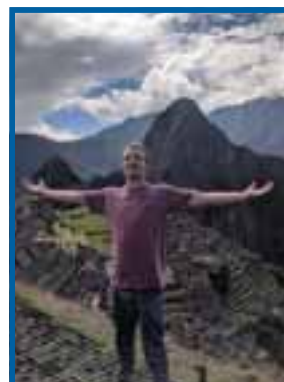

# For the hard of hearing, masks impair ability to communicate

In only three months, COVID-19 has had a life-altering societal impact on the way we work, socialize and relate to one another. But for one community in particular – people who are hard of hearing, elders or deaf – wearing a mask to prevent the coronavirus is more than an annoyance but also a hindrance to hear and effectively communicate.

“In my experience at the office, having the masks has been a complication for patients who rely on visual cues to communicate well,” said Dr. Adrienne Ulrich, a doctor of audiology and the owner of Parkway Hearing in West Roxbury. “Specifically, folks with hearing loss are at an added disadvantage because they rely on visual cues even if they’re not lip reading per se.”

Although paper and cloth masks appear thin, Ulrich explained that they impair sound quality, particularly for patients with some hearing loss.

“That covering is making understanding of speech more difficult because it has an attenuation of about 10 to 12 decibels,” she said. “So that takes someone with a mild hearing loss into a moderate range, or a moderate loss into a severe range. So it can be pretty significant and impactful.”

A third issue Ulrich has noticed, and all three of the patients interviewed experienced, is that the more cosmetically appealing hearing aids, which are worn behind the ear, can be dislodged by the masks as well as by glasses. Some patients now wear three devices behind their ears.

“We’ve had a few mishaps where something comes off and now the hearing aid goes flying,” Ulrich explained, which causes a great deal of distress to her patients. “That’s a huge complication, on top of everything else.”

Martin Laird of Brookline first sought out hearing aids online after he said his wife complained of his not being able to hear her. However, they were not effective, and there was no way of receiving care for them from the company.

“They only worked for a short period of time,” said the West Roxbury native. “So they kept sending me sets. I had four

sets that didn’t work.”

Laird met Ulrich, who gave him a set of hearing aids to test out, “which was huge.” Upon working with her, they discovered that one ear canal was smaller than the other.

“I am in the real estate business,” Laird said. “I have to be able to communicate, and I have to be able to understand exactly what the other person is saying. I have to be clear and concise and make sure there is no misunderstanding about properties.”

Using the mask, he added, has made communicating “very, very difficult.”

“I don’t wear hearing aids constantly,” he said. “It depends on the situation, so I have to be intuitive. I’m a good lip reader. All the facial expressions and little cues are so important.

“When you have the mask on, all those cues are hidden,” he continued. “And the mask itself is very frustrating. Sadly but true, I will just keep at a safe social distance because I think the mask impedes the whole communication process.”

He added that he does use them for initial meetings and open houses. But once a comfort level is established with a client, he works with the person to make sure that everyone feels safe at a comfortable distance. He also meets them outdoors.

Laird suggested developing clear masks that provide the same level of safety as masks currently in use. Ulrich noted that the clear masks available now “are hard to come by and don’t offer the same protection.”

Myrna Finn of Jamaica Plain said using the mask has been “a great issue” for her.

“It’s very busy behind my ears,” Finn said. She uses sunglasses when she goes outside,

plus the hearing aid, and now the mask.

When she was in her car, she took off her mask, only to lose her hearing aid.

“The hearing aid goes flying in the space between the bucket seats,” she said. “I try to be conscientious when I take off my mask, but it doesn’t always work.”

Another problem Finn encounters is when other people wear masks, she explained, because she can’t hear them at all.

“I just can’t hear,” she said. “I ask them to speak louder, and it’s very muffled for me. That’s a big problem for me.

“Mercifully, I don’t communicate that often with people with masks,” Finn continued. “But if I had to, I would be skunked. I would lose everything. The thing about non-verbal communication and reading the face is that we read non-verbal cues all the time. With that mask taking up two-thirds of your face, you’re just relying on the eyes. And you sort of can’t see them because you’re six feet away.”

Like Laird, Finn tends to stand six to eight feet away from people when outside and removes her mask when she has difficulty.

“You miss two-thirds to three-quarters of communication when you have the mask on,” Finn said. “And then I’ve panicked when I’ve lost the hearing aid a few times.”

Susan Cousino, also of Jamaica Plain, has been wearing hearing aids for a little more than a year when her hearing loss came on suddenly. She connected with Ulrich through a mailer and now considers herself part of her “lovefest.”

Cousino had biked from her home to her office, went to a job

site and traveled back to work for a Zoom meeting recently when she discovered she only had one hearing aid. She was afraid she would have to retrace her steps or worse – that the hearing aid had been crushed when she put the mask on and off.

“I got a call while I was in my office, and then it went to Bluetooth,” she said. “I knew my hearing aid had to be in the office, so I called Parkway Hearing and found out it had to be within three meters.”

She searched for three hours and found it on a cart where she had been watering the plants.

“It’s the mask,” she said. “I was also alone, so I had no need to hear anybody. And I panicked because they are very expensive and are not covered by insurance.”

All four conversation participants urged people to be patient when asked to repeat what has been said, because they may never understand their chal-

lenges. They don’t see the situation being resolved until a vaccine is developed, which could take up to a year and a half.

“You never know the full story of people and what they’re dealing with,” Laird added. “You can’t assume.”

“And everything has become so cosmetically appealing that it’s not something at first purview that someone would have a visual for,” Ulrich added. “Hearing loss is often considered a hidden disability, and one that a lot of people don’t seek treatment for right away. If we’re dealing with people who may have something that is being untreated or undiagnosed, and we are further exacerbating the problem with the masks, it’s certainly something that we need to have some consideration for and have some tolerance for.”

## Between a Rock and a Hard Place: Burger King and COVID-19

*To the Editor:*

On May 14, 2020, in spite of overwhelming opposition from five area neighborhood associations, area schools, elected officials, and the support of 560 resident petition signatures, 133 letters, and cogent testimony during the licensing hearing, the Boston Licensing Board, (along with the Mayor's approval), in a 2-1 vote - approved a Victualler License for a new Burger King to operate from 6am - 12am, in Hyde Park.

Only one neighborhood group, (who ironically, were the only group directed by the Mayor's office to be engaged in the initial zoning process), supported this development. Interestingly, there are dissenting voices within this group that are angered by its leadership's decision; a decision made without a vote!

Despite our best efforts to oppose this Burger King, that is situated directly in the heart of our neighborhood and directly across the street from newly built Boston Prep Charter School, the Licensing Board dismissed our evidence-based objections and would appear to also deviate from its own criteria for approving such businesses. This deviation is also consistent with the flawed community engagement effort prescribed by the Mayor's Office during the zoning process that left out the vast majority of the impacted residents and school administrators. With this being said, it comes as no surprise that the Mayor's Office gave its support to the developer and the BK operator during the licensing hearing, even if it meant utter disregard of the public health concerns acknowledged by the surrounding community of the BK.

In support of our opposition, Hyde Park City Councilor Arroyo's office, Councilors Wu's and Essaibi George's office requested a delay in the Board's deci-

sion. They agreed with the community's public health concerns and acknowledged the existence of seven (7) other fast food establishments, including another Burger King and McDonald's within a 1.2-mile radius of the newly-constructed Burger King - that in essence, exceed the Licensing Board's "saturation threshold." We call on Mayor Walsh to not just verbalize, but to demonstrate his commitment to "eliminating the injustices that make some groups more vulnerable to poor health" and stand by his statement, "[w]e will always prioritize the health and security of ALL of our residents."

Industrial fast-food restaurants are health determinants that bring no economic value to communities other than the known comorbidities that perpetuates chronic health conditions. These existing comorbidities are a result of the prevalence of unhealthy nutrition options in our community. And opening a BK (with a 10-yr. lease) in our community only increases access to another establishment that will only advance these chronic health conditions in our community. COVID-19 is disproportionately ravaging communities of color. And Hyde Park - a community with 49 percent residents of color, is one of the highest impacted areas in the Commonwealth. In a recent address to City Council, Councilor Arroyo stated: "racism has an independent influence on all social determinants of health in Boston...Justice here requires acknowledging that these systems and processes are responsible for the racial inequities that they create and that they worsen." We call on all well-meaning Bostonians and City officials to support the impacted community of Hyde Park and do whatever it takes to bring value-add establishments instead of Burger King!

neighbors and friends that we believe #BlackLivesMatter. Our children are watching," the event stated on Facebook. Tedesco began planning the event the Friday before. She said she only expected about 15 people to attend.

Tedesco chose West Roxbury to hold the event because it's her neighborhood and she believes it is the "responsibility of white people to root out racism, and the rest of the city needs to see white people standing up for racial justice." In West Roxbury, 77.7 percent of the population is white, while 10.91 percent of the population is black or African American. In the city of Boston as a whole, 44.4 percent of the population is white and 22.4 percent of the population is black or African American.

The day before the vigil, a protest regarding police brutality was held in Downtown Boston. It remained peaceful for a majority of the day, but became combative by nightfall, with 53 arrests and nine injured officers.

About 12 hours prior to the event, a rumor circled social media, claiming the West Roxbury vigil was going to be infiltrated by the group "Antifa." A photo of the event poster was shown next to a tweet from a twitter account claiming to belong to a national "Antifa" organization and pushing violent rhetoric related to ongoing protests. However, it was later revealed that this tweet was sent

by an account linked to a white supremacist group, apparently attempting to invoke fear. This misinformation was shared hundreds of times on Facebook and Twitter, causing people to call for the event to be canceled. Many community members claimed that Antifa would show up and riot, so neighbors called 311, asking for the event to be canceled. Businesses on Centre Street, such as CVS, the Corrib Pub and 7/11, closed early and boarded up their windows in anticipation of violence.

Despite the fear and concerns, Tedesco never planned on canceling the event. The vigil started at 5:00 p.m., surrounded by police officers in protective gear carrying batons. Police officers were also bussed in from other stations and municipalities.

"I thought the police presence was overbearing and unnecessary," Tedesco remarked.

Many people driving by honked and cheered in support of the BLM movement. However, one older woman yelled out of her car, "F\*ck you! What about the poor cops?!"

Many community members who attended the event were proud to take part in the vigil. One West Roxbury community member, Emily Elizabeth, said she moved to the area from Minneapolis, and was devastated by the police violence and rioting in her hometown.

"I went to the vigil to stand

in solidarity with my home, for black lives, and to bring awareness to this predominantly white neighborhood that they are not so different and are not so insulated from the place where all of this started," she remarked. Elizabeth also stated that all lives matter when black lives matter and white silence is violence.

Elizabeth said there were fewer people at the vigil than she expected.

"I was expecting lines down the parkway, but was disappointed to see that the scene was concentrated to the rotary. I am sure that many of my neighbors were relieved by this, but I was hoping for a peaceful protest with enough social distancing that we could extend and branch a bit more into the neighborhood."

While the misinformation circling on social media kept many community members away from the vigil, Elizabeth said it drove her desire to attend.

"I knew this would be a peaceful vigil and wanted to be part of the group that would make it happen. Not to prove anyone wrong, but to demonstrate that a lot of what has been shared on the news has focused heavily on negativity. I was also at the Boston Common's Black Lives Matter Rally on Sunday night. It was an incredibly peaceful and moving event right until someone started setting off fireworks. That was when I decided to leave," she remarked. "I wanted the people of West Roxbury to know that they should not be afraid to stand up for what is right."

"I felt it was necessary to be there because West Roxbury has been my home for 27 years," Elvin said. "My family always told me to fight for what I believe in. There were a lot more people there than I thought, but honestly West Roxbury surprises me a lot. There are a lot of good, self-aware people in West Roxbury who just want to live and spread kindness, and I saw that at the vigil."

Many families with young children attended the vigil. One black child held up a sign reading "When I grow up, I want to be: ALIVE." Another child of color held up a sign that said "Please stop killing us." A

group of students took a knee while holding a sign that read: "I am not black, but I see you. I am not black, but I hear you. I am not black, but I will fight with you. #BlackLivesMatter."

After the peaceful vigil was over at 5:30 p.m., many people who were not at the event complained on Facebook that the police presence was a "waste of their tax money".

"The decision to spend that much money in response to a silent vigil was not mine. We should be deeply reevaluating the amount of taxpayer dollars we are spending to create a militarized police force, while our schools are crumbling and our public health officials don't have the resources they need in a pandemic. It's budget season in Boston. People should call their Councilors," Tedesco stated.

declared essential services during the COVID-19 pandemic response in Massachusetts, so Roslindale will move forward with its time-honored tradition. It will also be a prime location for residents to pick up fruits and vegetables with SNAP, CHIP or EBT benefits, as many shops that do accept them do not have fresh produce. The setup for this market is taking into account social distancing, Forrest said, and those guidelines will be enforced.

“You have to enter on one side of the park on Poplar Street and exit on Washington Street where Cummins Highway is,” she said. “We’re also going to have to ask that everybody wear their mask and stays six feet apart. All our vendors will be at least 10 feet apart, which also means we’ll have far fewer vendors than in years past.”

Forrest said they have had to cut their vendor list in half, from 30 to 15. Specialty vendors are not considered essential either, and they will not be able to sell their wares this year, unless they can be prepackaged elsewhere before coming to the market. Everything will be grab and go. Other regulations for the market this year include no

touching of any food items while shopping – vendors must handle food first. The first 30 minutes of the market will be for elderly and at-risk customers starting at 9 a.m., and attendees will be required to use hand sanitizer or wash their hands upon arrival at stations provided in the park. Customers are also asked to shop for essential food items only.

Forrest said staff will also be monitoring how many people are in the park at any given time, as they can only legally allow a certain number.

“So we don’t really know if there’s going to be a long wait or if this market will be popular,” she said. “We’ve never done anything like this before, it’s an experiment, but we’ll adapt based on what we will have learned upon opening.”

Forrest said if the line is too long when you get there, consider venturing out and supporting many of the local businesses still trying to survive in the Square.

But it’s not all bad. Forrest said she’s happy to report that they have not lost any sponsors this time around, and while they won’t be sponsoring their usual activities, live music and children’s entertainment, the market will still be going to

help residents.

“This year their money is going towards things like a hand-washing station, hand sanitizer, and masks for our volunteers with the Roslindale Main Streets Logo,” she said. “As well as a whole host of other supplies we never thought we would need. We’ve got a dedicated volunteer corp that is going to be helping every Saturday, and they’re all Roslindale residents and we’re all trying to help keep it going. However it’s not going to be the same market we love and look forward to every summer. It’s going to be more like an outdoor grocery store honestly.”

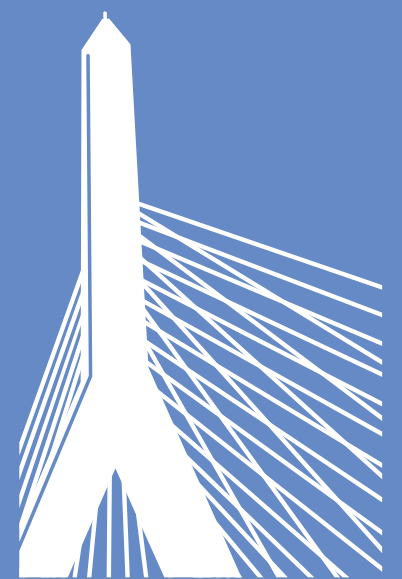
Forrest added that they’ve learned many other markets are not able to open this year, including Davis Square in Somerville.

“We expect this will further inform us of the importance of food access, because this market is going to be essential for people who use SNAP and CHIP benefits,” she said. “There are discounts for people who use those programs at farmers markets, so we might have more folks using that resource than usual.”

of Massachusetts where the number of liquor licenses does not increase automatically with the population. Instead, the Massachusetts Legislature has to vote for any license number increase.

Boston Licensing Board member Kathleen Joyce joined the hearing, and said the Board has not been sitting on its hands during this crisis.

“We’re willing to pivot from the sometimes protracted processes to review and approve things as quickly as possible,” she said. “We know that when restaurants are able to reopen, they will still be hamstrung by capacity restrictions due to social distancing and other public health concerns. Since the start of the public health emergency, the Licensing Board has continued to hold virtual public hearings on a weekly basis, and we have been able to administratively issue (Common Victualer) licenses at a previously-licensed location and we are hearing new items on a weekly basis. Business has not stopped.”

But Joyce said while the idea of the city buying licenses is well-intentioned, there may be pitfalls the council had not previously considered. Firstly, the cost of buying these licenses, some of which are valued at half a million dollars (pre COVID,

now about \$150,000), could be significant.

“It could have significant unintended consequences, including impacting how the city can support and assist our small businesses holding a liquor license,” she said. “It would create significant legal liability for the city, and we would put an administrative burden on the city’s office due to the legal requirements for holding a liquor license. While there’s nothing in the law that prohibits the City of Boston from holding a liquor license, the city would have to go through the same transfer process of any other applicant.”

She said that would include a public hearing, full financial disclosure, and would need to be approved by the Licensing Board and the state Alcoholic Beverages Control Commission (ABCC),” she said.

Joyce said there are also practical issues with the City of Boston holding a liquor license. The closest thing she said there is to a lease on a liquor license would be what’s called a management agreement, and with the city being the license holder and issuer, that structure could present problems.

“I’m not sure how this would work with the city being the licensee and the restaurant as an

operator, because under the current structure, the manager would have to be the one making the decisions and it would also require the approval of the city for these decisions,” she said. “Just thinking this through on the most basic level on what a typical management agreement would look like, the employees would actually be working for the city, the licensee, and not the operator. It would be the city that would be responsible for payroll, taxes, unemployment and social security.

“The license must exist at a specific address, a liquor license cannot just be sat on or pocketed and put on a shelf,” she said. “It has to be attached to a specific location. In order for a license to be purchased and transferred, it must be approved to go to that particular location. The city would enter into these management agreements with

each operator. These are contractual agreements, and are subject to scrutiny at the local and state levels.”

She added that any person within city government that would have a direct or indirect interest in the business associated with that license would need to disclose that information to the ABCC.

Hearing Sponsor and District 1 City Councilor Lydia Edwards said she still felt the idea is still worth vetting through the city council and to see if the council can have any impact on changing the current liquor license system.

“I don’t know anybody except for licensing brokers who look at the current system and say it’s good,” she said. “That does not have anything to do with the Licensing Board, I believe they inherited this system... We have been trying to reform it in different ways, but at the end of the day the fundamental issue I think a lot of

people have with it is that this is something that can be owned instead of a permission given out to operate a business.”


Edwards said the city could consider other ways to give businesses permission to continue to operate while not obtaining ownership of a license.

“I am looking at a bunch of restaurants on Main Street and some of them are going to close and all they have is this asset,” she said. “I firmly believe if the City of Boston doesn’t do something, someone else will. The market is what’s supposed to determine the prices. In many cases the market will be basically eliminating mom and pop stores throughout the City of Boston. I’m not comfortable letting the market just do that.”

single-stream recycling containers because they gum up the recycling process. It's disappointing on long walks during this pandemic to see the amount of plastic bags deposited into the large, blue bins; this is done by well intentioned homeowners who do not understand that plastic bags have to be recycled at special repositories for them, and the closest one to me during these times is at a Lowe's store in Dedham.

The good news during this pandemic—if such can ever be said—is that there has been less car usage, meaning the motorists' carbon footprints have been diminished. On the other hand, our staying at home has increased electric consumption because of dramatically increased computer, light, and television usage.

May the people sick with COVID-19 recover, and may our planet recover from these months of neglect.

be severely damaged during flooding events, which is something that needs to be fixed before climate change becomes worse.

Another issue facing the group is trout movement. The Neponset river is home to Greater Boston's largest concentration of wild trout, but unfortunately, there are many human made barriers to their ability to swim freely. Chris Hirsch, NepRWA Environmental Scientist, said that he evaluated 100 culverts, and a quarter of them are barriers to trout. NepRWA is working with federal and local government to restore Traphole Brook in Norwood and Walpole, which will include removing the one remaining dam and enlarging an undersized culvert, to make the brook more habitable to trout. Members are also now in a formal partnership with Greater Boston Trout Unlimited, which is assisting with surveying culverts, as well as a partnership with Embrace a Stream to collect data about trout and their habits. Their plans to track temperatures of the river to determine trout habitability will also aid with understanding potential climate change issues.

This year's Riverfest, scheduled for June 20, is unfortunately cancelled due to COVID-19. Outreach director Nancy Fyler hopes to be able to reach more Boston Public Schools students this fall to teach them about where their water comes from if school is back in person.
