Highland NA considering return due to 1905 Centre St.

About 30 West Roxbury residents and former members of the dormant Highland Neighborhood Association (HNA) met on Sunday, Feb. 21, for an informal meeting regarding the proposed 21-unit condominium development at 1905-1911 Centre St.

The Boston Planning and Development Agency (BPDA) will be hosting an Article 80 Small Project Review public meeting on March 8 at 6 p.m. For more information on the project, to comment on the project or to sign up for the meeting go to Bostonplans.org/projects/development-projects/1905-1911-centre-street.

The meeting on Sunday was headed by Joe Impellizeri and Vincent Finn and while the status of the HNA was not solidified, residents seemed eager to start it back up again to

contend with this development. Finn, who lives close by, explained the history behind the current development plans, which started in 2019. Finn explained that residents are wary of the development not only because of the height and density – the refrain most residents consider in opposing residential development – but also because of how the two existing buildings on the property are considered.

The buildings are a former bank and a dilapidated residential house. Finn said there was a great deal of concern last year when work crews apparently went in and were removing asbestos from the building in a manner that was disconcerting to residents. The owner of the development, CAD Developers, has hired O’Neil and Associates Senior Director Chris Tracy to represent them. Tracy said last year that the asbestos removal “followed the letter of the law.” However, residents

were still concerned.

Finn said he approached the workers during the demolition phase of the project at the residential property.

“We asked ‘are you going to rehab the building or something,’ and they all promptly left,” Finn said. “In January, a group of neighbors met with our local (City) councilor Matt O’Malley and outlined our concerns and tried to figure out what was happening. From what I remember, I don’t think anything came of that meeting. There’s no major result. And so the whole thing remained mostly dormant in 2020.”

Residents discussed what issues they had with the property during the meeting. The biggest concerns were density and traffic. Many residents feel that not only is West Roxbury overbuilt but that there is just not enough park-

14 Meehan Street conversion debated by SNA

The Stonybrook neighborhood could almost be considered a gated community, enclosed as it is by the Arborway Yard, Franklin Park, Washington Street, automobile repair shops and Hatoff’s gas station, while the interior is a checkerboard of one-way streets.

The Stonybrook Neighborhood Association (SNA) appears to consider it that way as it guards it from outside changes, both big and small, from a 46-unit residence to the color of windows.

The latest was on the Feb. 8 agenda as 14 Meehan St. made a second appearance. Scott Dabney, who bought the building in 2016, would like to change the second floor unit from an artist studio to an apartment.

He brought his attorney Daniel Toscano to defend this and 90 minutes were spent debating it.

Big or small, there is a subcommittee assigned to it and Sue Zobel of 16 Meehan St. chaired this one.

Toscano explained that there would be four changes to the brick building that used to be a stable: a second floor residential unit, a roof deck for the exclusive use of the third-floor tenant, a fire escape and accessible ramp from the front yard to the first floor office space that Dabney already occupies.

The one forbidden zoning use is the change of occupancy to a living unit and one association member suggested it be turned into an artist live-work unit as at the zoning approved 10 Stonley Rd.

Burger King licensing case goes to court

A coalition of concerned Hyde Park residents took their case against the issuance of a common victualer license to Burger King at 892 River St. by the City of Boston’s Licensing Board to Suffolk Superior Court in a virtual hearing on Friday, Feb. 19, citing public health concerns.

Helena Tonge, as the president of the Belnel Family Neighborhood Association (BFNA), presented the community’s case before Hon. Anthony Campo. He is the same judge who presided over the preliminary injunction against the opening of the Burger King at the Shops at Riverwood Plaza at a hearing on Aug. 19 of last year.

The appeal was denied two days later. Campo also was the judge at the first preliminary injunction hearing on July 2, where he found that the City did not present a complete administrative record.

Other plaintiffs in the case included Ledum Nordee from the Roseberry Ruskindale Road Neighborhood Association (RRRD); Vivien Morris, chairperson of the Edgewater Drive Neighborhood Association (EDNA); and Marcia Kimm Jackson, co-chair of the West Fairmont Hill Community Group (WFHCG).

Edward Cheng represented Northeast Foods as well as the intervening party, CRE Finn Riverwood, the owner of the Shops at Riverwood. Robert Arcangeli was the counsel for the Bos-

ton Licensing Board. Tonge spoke on behalf of the community during the one-hour hearing, where Campo took the matter under advisement.

“This was an ordinary, properly-conducted decision by the Board of Licensing to issue the common victualler’s license for the operation of a Burger King,” Cheng said. “The plaintiffs decided to bring this petition per cert because they didn’t like the outcome. The fact that the plaintiffs disagree with the board’s decision doesn’t mean that the board did anything wrong.”

Cheng said the case should be denied because the Licensing Board made a regulatory rather than a judicial decision. He also said they “lack standing as a matter of black-letter law,”

which he repeated throughout the hearing. The third reason he gave was that the plaintiffs themselves were not directly harmed by the Burger King. He added that, even if the procedure was “quasi-judicial,” which he claimed it was not, the board made no procedural errors.

Tonge countered that it is the way in which the Licensing Board conducted the hearing that is being disputed. There were 190 pages containing emails that were submitted before 10 a.m. the day of the Licensing Board hearing, the time up until which they were to be accepted. However, these documents were not included in the file, she said, and were not part of the board’s decision-making process.

As far as her right to chal-

lenge the decision in court, Tonge said that this is the procedure outlined by the City’s website.

“On the City of Boston’s website, if you intend to appeal any decision that the board has made, this is the directive that they provide to make the appeal,” she said. “There is no internal appeals process in the City of Boston.”

“The mere fact that the website directs people to bring a circ action – I mean, that’s directed to the entities with standing,” Cheng said. “The website isn’t a black-letter law, Your Honor.”

Tonge then asked how “no person could ever challenge a Licensing Board decision, however flawed.”

Campo directed the hearing toward what the plaintiffs considered to be “particularized injury.” Tonge said the Burger King was targeted toward her community that is 70 percent people of color. In the 190 pages of documents was testimony from Morris, who is a registered dietician and public health professional as well as the founder of the Mattapan Food and Fitness Coalition. During the previous hearing, she pointed out that the restaurant is directly across from the Boston Preparatory Charter School and within walking distance of four others. She also cited data from

the Boston Public Health Commission that show that unhealthy food options are a health issue for Boston’s youth, particularly those of color, as well as for adults in communities of color.

“We are clearly identifying with what the Boston Public Health Commission states as communities of color,” Tonge said, “as specifically targeted by fast food restaurants and convenience stores that have led to the higher rates of type two diabetes, obesity, etc. “I am part of that community of color.”

“Therefore the Boston Public Health Commission is stating that this is a direct harm to these specific communities,” she continued, saying that to think otherwise would be “egregious.”

Cheng said that Tonge is a member of a community and not subjected to direct harm, which would not confer standing to the case.

Tonge brought up a similar case involving a Popeye’s denied in Dorchester by the Licensing Board when similar arguments were presented. The decision was made based on a community outcry and an “unhealthy menu.”

“I think what [the Licensing Board is] saying is they have discretion to do so either way, as a political body would,” Campo said. “Regulatory boards are a political creation.”

No decision was reached at the time of publication.

Young Democrats host candidate forum for District 6 City Council Race

The group Greater Boston Young Democrats hosted a virtual candidate forum for the District 6 City Council Race on February 23. There are currently two candidates running, Mary Tamer of West Roxbury and Kendra Hicks of Jamaica Plain. Tamer is the Research Director for SchoolFacts Boston, a Dorchester organization which provides information about Boston schools, and Hicks is a director at Resist, a social justice organization based in Jamaica Plain.

Education was a key issue at the forum with a myriad of issues

within the Boston education system discussed. Both candidates agreed that the Boston Public Schools' (BPS) handling of remote learning has been poor, and that there will be long term impacts due to the inherent social inequities of online learning. Hicks, who has a non-verbal, autistic son, acknowledged the difficulties that disabled children have had, but also said that "our school buildings aren't safe."

Both spoke about issues with internet access. Tamer said that it has been known for seven years that families in certain areas have had issues with home internet speeds. Hicks said she supports internet being a public

utility, and both noted that BPS' building stock needs significant improvement, with some buildings being over a century old. Poor ventilation has been seen as a major hurdle for school re-opening.

Tamer, who is a Boston Latin School (BLS) alumna and parent of BLS alumni, said she would avoid being involved in any further plans to change the exam school assignment process. She said she thinks it should be left to educators and community groups. Hicks talked about her experience as a low income student at the Curley, where she was un-

aware of the existence of the exam schools until a friend said she would not be returning to the school the following year. She supports putting the test aside for this year and working on a more equitable process for following years.

Currently, the BPS school committee has seven members who are appointed by the mayor for four-year terms, and one student representative who is appointed for a one-year term. Tamer, a former appointed school committee member, says she does not support a return to an elected school committee. She notes that when Boston did have an elected school committee, it had strong issues with racial bias. She also added that school committee members had staff, and that the overall budget for the school committee for labor costs was about a million dollars. She said she supports a hybrid model, with some elected and some appointed members.

Hicks, however, said she does support a return to an elected school committee.

"This is not a hard question," she said when asked.

Hicks argued that this is not the 1970s, and Bostonians deserve a voice. She also pointed out that every elected official has the potential to be racist, but added she would work with District 1 City Councilor (North End, East Boston, Charlestown) Lydia Edwards to work toward an elected committee. She also said she would want the student representative to have a vote and to receive the stipend the other members receive.

Hicks said she would not take money from charter school proponents or from other special interest groups, such as police unions or those promoting fossil fuels. Tamer said she "doesn't know what an education privatizer is," when asked if she would pledge to not take campaign donations from them. She was, however, Director of Strategic Projects for the Boston Charter Alliance from 2015 to 2017.

Economic issues were

also a big concern. Hicks said that "restaurants and small business owners need a bail-out" and that existing city aid for business owners has been much harder to access for those who are not native English speakers. Tamer said business owners "don't feel that the city has been there." Hicks says she wants a living wage ordinance for subcontractors.

They both agreed Boston has issues with affordable housing.

"We need to demand a more transparent housing process," Tamer said.

Hicks said, "Boston does not have a cohesive plan for development." Hicks said she also wants to expand rent subsidies for low-income renters. Hicks said that due to COVID-19, the economic need "has grown exponentially."

Policing continues to be a large campaign issue in every race. Hicks says "our communities are over-policed," and she wants more transparency in police budgeting. Tamer said she wants the police department to more specifically target people of color to encourage them to become police officers.

Current City Councilor Matt O'Malley has made the environment one of his key concerns, and so Tamer said she wants a deadline for when all city cars will be electric. She said is also a strong proponent of more street trees to increase the city's canopy. Both Tamer and Hicks agreed polluting buildings are an issue. Tamer said all new buildings should be LEED-certified, and Hicks says current buildings should have an energy assessment every five years.

Both Tamer and Hicks agreed that West Roxbury and Jamaica Plain have more in common than people think, and that the neighborhoods are grounded in similar values.



Neither Toscano nor Dabney responded to this idea.

Patty Yehle lives at 11 Meehan St. and she said she is an artist.

"I'm opposed to this change," she said. "It was already reviewed and denied in 2009. Why come back?"

"It's a beautiful desirable place for an artist. A live work space for a non-noisy, non-messy artist use."

Zobel opposed the change of occupancy.

"This is a dense neighborhood," she said. "You're pushing the lot for more than it can bear."

Association steering committee chair Trevyn Langford suggested a reason for the change.

"It's a cash grab," he said. "Artist use to resident use is a cash grab. He makes more money."

The biggest issue was increased parking, specifically the use of Meehan Street for parking. Meehan Street covers the Stony Brook culvert that is under Boston Water and Sewer Commission jurisdiction. There's also a fire hydrant in front.

Toscano requested at a sub-committee meeting to find out if Boston Water and Sewer would allow parking on their

right of way and he reported back to say they refused.

"I talked to my contacts at Boston Water and Sewer," he said, "and they said they don't allow parking on top of their culverts."

"If other people next door park there, well that's their issue."

Toscano was asked who he talked with, but he said that was confidential.

An association steering committee member asked for copies of the emails to and from Boston Water and Sewer but Toscano declined.

"I won't share my communications," he said. "This is confidential to my contacts. SNA asked me to talk with Boston Water and Sewer and I did."

Mary owns unit one at 16A Meehan St. but doesn't live there. She was very concerned about trees being lost and the closeness of the property line. Toscano said all trees would be protected and his client would be happy to put up a fence.

Jennifer Uhrhane questioned the size of the roof deck.

"It's almost as big as our apartment," she said.

Zobel didn't see the need for a roof deck; it was too private.

"It doesn't give people a chance to interact with each other," she said.

Langford called for time and asked that Toscano and Dabney leave the call so the association could discuss their presentation, "as was customary as a community group."

Toscano was visibly surprised.

"You don't follow the open meeting laws?" he asked. "As a community group you don't follow the open meeting laws? I can't sit back and listen?"

Toscano and Dabney left the call.

Uhrhane said later that the open meeting laws only apply to government agencies. Mary, who lives at 45 Burnett St. said she was uneasy.

"Scott was asked to leave the meeting when he is part of SNA as a resident?" she asked. "I'm uncomfortable about asking him to leave."

Jon McCurdy was not uncomfortable with that.

"Not sharing information with Boston Water and Sewer is a bit sneaky," he said. "I don't trust this group but that's just me."

"We have no idea he even contacted them [Boston Water and Sewer]. He has no reason to tell us the truth."

Yehle agreed.

"He killed two trees, destroyed the lawn. He doesn't care about us. Dabney is an

absentee landlord."

Yehle alleged that Dabney operated an Airbnb at 14 Meehan St.

"It was a fiasco," she said. "Everyone knew it was illegal."

Langford called for a vote. Sixteen were opposed and three abstained.

Langford appeared satisfied that so many had participated and spoke out against the project.

"It was a long and intense process," he said as Yehle applauded and callers thanked Zobel for her efforts.

The drawbridge was pulled up, but steering committee member Paige Sparks cautioned the celebrants that it was not over yet.

"There's the JP zoning committee on Feb. 17 and the ZBA meeting in March," she said.

The drawbridge was lowered down on Feb. 17 when the JP zoning committee voted 11 to 2 to approve.

Zoning committee chair Dave Baron was puzzled.

"For a one-unit to a two, we've gotten a lot of letters," he said, "It's a two-family house now, it's cited as a two-family and it's zoned as residential."

Toscano explained that as a result of the concerns raised on Feb. 8, the roof deck had been reduced 100 feet and the accessible ramp removed.

"By reducing the square

footage of the real estate office on the ground floor we can eliminate the handicap ramp," he said.

None of this satisfied the neighbors.

Karina Ridgley lives on the ground floor condominium at 16A Meehan St. one of a pair of three-unit condos built in 2010. She said the ramp would block her sunlight and the parked cars would shine headlights into her unit.

Toscano repeated that a privacy fence would be built. Yehle repeated her opposition to a residential apartment because Jamaica Plain was losing live-work artist spaces. After 45 minutes, Baron called for a vote.

"They made the roof deck smaller and removed the handicap ramp. Did they do something wrong with these changes?" he asked. "I'm going to vote to approve. It's only adding a second unit of housing. That's consistent with the residential neighborhood."

Ten members agreed.

The committee also voted unanimously earlier to approve a similar matter: the conversion of an unused attic space into a two bedroom, two bathroom apartment with a new stairway built out of a closet at 11 Danforth St. The downstairs neighbors and abutters approved and the discussion was over in 13 minutes.

demic to the Mary Mulvey Jacobson Families In Need, the Roslindale Food Pantry, the West Roxbury Food Pantry, the Jason Roberts Challenger League and many others," he said. "For the Jason Roberts we were actually able to pull off the annual softball game last year in September and, I don't remember off the top of my head, but it was at least \$1,000 for Jason Roberts, which is fantastic considering it was during a pandemic."

Brennan said they have also helped out at the Parkway YMCA, the Catholic Memorial Forensics team and other local organizations.

"We don't really turn people away, if they come to us we try to

make a donation, you know what I mean?" he said.

Brennan said the idea for the raffle was well-received by his fellow Kiwanians.

"They really liked it and said they had no idea why they didn't think of it first," he said with a laugh. "I made it simple; people can just buy a chance through Venmo. If someone sees the flier or this article they can just open Venmo on their phone and enter as many times as they want. Every \$20 gives them an entry. It's convenient and easy, rather than collecting cash and checks or what have you."

Brennan said charities all over the world are hurting right

now because their primary fundraising efforts are based on hosting large events with lots of people coming together to support a cause. Kiwanis has been no different. But he said he felt they could do something about it.

"We have a mission to help children, but there's a lot of people who can't pay their bills or put food on the table and we want to help those people and we want to donate to those types of causes and it's way more important during the pandemic to support our causes and these causes because more places need the funds now more than ever."

ing for residents in the neighborhood, especially around the Centre Street Corridor (i.e. the fight over a couple of parking spaces during the recent Road Diet debates).

Finn's main point was that he felt the time between the public meeting on March 8 and the end of the comment period at March 15 was too close.

"We have a window from Feb. 2 to March 15 and then they'll all be taken to the planning project manager on March 15, and I just don't see how that works if they're going to have a meeting on March 8," Finn said.

Resident and West Roxbury Neighborhood Council (WRNC) Zoning Subcommittee Chair Tony Sarufim said there is a process by which residents can ask the BPDA to extend the comment period. Sarufim also said he has been speaking with CAD representatives and they have confirmed that CAD will be presenting to the WRNC on the fourth Tuesday of March, which is March 23, hence the need for an extended comment period.

Several residents were dismayed at the fact that both Boston Mayor Marty Walsh and District 6 City Councilor Matt O'Malley are leaving the city, this spring and fall respectively. Several residents voiced their concern that because of this they will not be able or willing to help ease residents' concerns around this project. Sarufim said he does not believe that about O'Malley.

"Did we call him? Did he say no?" he said. "I think he'll still be effective. We still have a say and he will carry our voice."

Residents were also concerned about the overall height of the building and felt that it was not in keeping with the neighborhood. Tracy, CAD's representative mentioned earlier, spoke with The Bulletin the day after the meeting and confirmed what's on the Small Project Review Application (available for view on the BPDA's web page for this project): that this project is an as-of-right building.

"The height does conform yes," he said.

Tracy added that they are not planning on extending the comment period, however he did not say the development team would oppose it either.

"If BPDA had asked us to do something like that, then yeah, we're definitely open to it, but it's their process," said the former BPDA project manager. "I'm not going to dictate how they're going to run it. Obviously we want to be good neighbors and do the right thing here and work with everybody and make sure we're inclusive of everybody's thoughts in the process for sure."

Tracy also said he and the development team are aware of residents' concerns regarding the project. However, he wanted to remind everyone that this project is being submitted as-of-right, and he pointed to a letter from the city's Inspectional Services Department (ISD) on page 26 of the Small Project Review Application agreeing with that assessment.

"While the development team understands there is some concern from folks around change and potential impacts, we respectfully ask them to be aware that the proposal is completely as of right - meaning there is no variance, special permit or exception from the rules being sought," he said. "The proposal conforms with and follows the guidelines of the Centre Street zoning. The zoning code guides the density and number of units allowed here and the proposal was meticulously planned to conform with that code. The development team looks forward to continuing to work with the community through the BPDA process and through construction."


