## Keith House saga continues

Last month, the Inspectional Services Department (ISD) released documents to Boston City Councilor Kendra Hicks regarding the demolition of the building at 1911 Centre St. in West Roxbury, also known as the Keith House.

CAD Builders LLC purchased 1905-1911 Centre St. (which included the Keith House and a former bank) and submitted a Small Project Review Application with the BPDA in Feb. 2021. The proposed project consists of the demolition of the structures occupying 1905-1911 Centre St. and the construction of a four-story building with 21 residential units, ground floor

commercial space, and off-street vehicle parking.

Many local residents were unhappy with this project plan, and advocated for the Keith House becoming a designated landmark. The Keith House, located at 1911 Centre Street, was built around 1839 and was the home of William Keith (1810-1888), West Roxbury's second U.S. postmaster. Keith lived at the property and also used the building to conduct U.S. Postal Service business. The property owner's attorney argued that the Keith House was well beyond repair. Two days after a Boston Landmarks Commission (BLC) meeting regarding the Keith House, the building at 1911 Centre St. was torn down. Many residents were upset by the action due to the fact that the Keith

House's possible landmark designation was still in an open comment period with the BLC. A stop work order was issued the next day for the property, well after the point at which it had been leveled.

A few weeks later, on Aug. 31, City Councilor Kendra Lara spoke to the Boston City Council, seeking answers as to why the house was demolished during the comment period with the BLC. Lara filed a 17F - which means the Mayor was requested to "obtain and deliver to the City Council information relative to the Boston Inspectional Services Department and Boston Planning and Development Agency."

Lara received documents from the ISD, including a

## West Fairmount Hill addresses crime and safety

Hyde Park's West Fairmount Hill Community Group (WFHCG) held a special meeting (via Zoom) on Tuesday, Nov. 15 regarding crime and safety in the neighborhood.

The meeting, which drew more than 30 local residents, followed the format of a question and answer session with representatives from the District E-18 station of the Boston Police Department (BPD), the Massachusetts State Police (MSP), the Department of Conservation & Recreation (DCR), and the Boston Housing Authority (BHA).

As prefaced by Marcia Kimm-Jackson, president of the WFHCG, its goal was to build collaboration between the West Fairmount Hill community and the City and State entities responsible for protecting and maintaining the overlapping jurisdictions in that area.

## Dale St. mobilizes residents against development

Despite the frigid temperature, more than 60 residents from southwest Boston gathered on Wednesday, Nov. 9 at Roslindale's Weider Park with Dale Street Neighborhood Watch leaders to discuss how to mobilize to stop the potential development of a 1.01-acre parcel at the end of the street.

Roslindale residents Kim O'Connell and Beth Columbo have been running the Dale Street Neighborhood Watch, previously called the Dale Street Crime Watch, for decades. This is their latest effort in their more than 30-year quest to protect this pri-

vately-owned Roslindale parcel from development. The land is nestled between Weider Park and Sherrin Woods on the Roslindale-Hyde Park border, and it is the last privately-owned property within the boundaries of the Sherrin Woods Urban Wild.

“This is a really, really important issue for our community, and it has been for many years,” Columbo said. She and O’Connell joined forces when they first learned of a development proposal there about three decades earlier.

Developer James Guerrier has proposed building 20 affordable condominiums on this parcel. However, he will need to obtain variances and a sewer easement and approval from the MBTA and Amtrak because of the proximity to the train track.

Under the Walsh administration, the City had committed \$350,000 for the purchase of that lot. Columbo said they were waiting for a new appraisal of the property from the City when she and O’Connell learned from the developer

that there is a purchase and sale agreement for the land contingent upon the approval of variances.

O’Connell also noted that the Boston Redevelopment Authority (BRA) put in place an IPOD, or Interim Planning Overlay District, in 2007 that codified the effort to conserve this land.

“The zoning states that this particular piece of land should be turned over to the City or that the state should buy it and that it should not be developed,” she explained. “The City is not honoring the wishes of the community that were stated in the IPOD.”

State Representative Rob Consalvo was the only public official present at the meeting. He has been working to protect this land from development since the time he served as an aide to his predecessor, state Rep. Angelo Scaccia in the 1990s, as well as during his tenure as the District 5 City Councillor.

“My position on this was crystal clear in writing in The Bulletin,” Consalvo said, ref-

erencing two articles in the Oct. 27 edition. “As your city councilor from 2002 to 2013, I supported the community on making sure that this parcel of land stays public open space in perpetuity.

“Let me be clear,” he continued. “My position has not changed. I stand with this community, and I will do everything I can to make sure that that lot remains public open space - as it should be and as this community requested - moving forward. It makes complete sense to me, and it’s the right thing to do.”

He also reminded those present that no papers have been signed, and the process is in its infant stages. Also, he said three consecutive mayoral administrations – Walsh, Janey and Wu – have honored the City’s commitment of \$350,000 toward the conservation of this land.

The preservation effort has garnered the support of the Hyde Park Neighborhood Association (HPNA), the West Roxbury Civic and Improvement Association and the

Southwest Boston Civic Association. So far, O’Connell said she and Columbo have gathered 500 signatures to urge that the land be purchased with government funding.

Other issues O’Connell raised are that Stony Brook, which runs through the property, would have to be uncapped during construction, shifting water flow that would impact Sherrin Woods. Dale Street already experiences flooding during heavy rain. This is compounded by the presence of underground springs.

Kerry Castor, the president of the WRCIA, called the area “a hidden little treasure.” She said she is organizing a meeting with the West Roxbury chapter of conservation group Mothers Out Front to join the effort and urged people to reach out to their elected officials.

Castor also had a message for them: “Stop campaigning and tweeting. Get out in the neighborhoods and do your job.”

Jordan Frias, chief of staff for current District 5 City Councillor Ricardo Arroyo, was present at the meeting and said he was “there to listen and learn.” Also in attendance were Paul Sullivan and Tricia Kalayjian from City Councillor

At-Large Michael Flaherty’s office.

Pat Alvarez, the vice president of the Southwest Boston Community Development Corporation (SWBCDC), organized the Green Team to maintain the Sherrin Woods Urban Wild. She said preserving this parcel is critical and aligns with the Boston’s Green New Deal.

“The City has poured I don’t know how many hundreds of thousands of dollars into restoring Sherrin Woods,” Alvarez said, noting that at one point \$600,000 was spent.

“There’s not one legitimate reason to build here,” she added. “And there’s a million reasons not to.”

After the meeting, one person who spoke out in favor of the development was Roslindale resident Alan Wright, a board member of the West Village Neighborhood Association (WVNA). He noted that there is a critical need for affordable housing and that this effort shows “NIMBY attitudes” from the groups involved.

“I just want people to rethink how privileged they are to have houses,” he said, noting that the condos would attract young professionals who would contribute to the area and would likely utilize public transportation. “They want to keep needy people out.”

“This parcel of land has been abused for hundreds of years, and there is still construction debris there,” Wright continued. He added that “the trees there are old and frail,” and that the parcel is covered with invasive species. He described it as a “highly trashed area,” with litter ranging from McDonald’s bags to needles to poop bags from dog walkers he has seen.

# New addition for Brooke School

The Brooke Charter School has its flagship buildings on American Legion Highway, and like this boulevard which connects Hyde Park with Roslindale and Dorchester, the school has attracted students citywide since it was founded in Roslindale in 2002.

Now the Brooke plans an addition to its 150 American Legion Hwy. building. The proposed three-and-a-half-story addition to the rear of the brick school building was approved by the Boston State Hospital Citizens Advisory Committee on June 23, 2022.

Boston Planning and Development Agency (BPDA) senior project manager Sarah Black hosted a virtual public meeting about the planned addition on Nov. 10, attended by 13 callers including State Rep. Russell Holmes.

This was a notice of project change hearing that would amend the Planned Development Area of the 42.5 acre build out of the former Boston State Hospital land by Lena New Boston, approved by the BPDA and Zoning Board of Appeals (ZBA) in January and February 2006.

Change has been the oper-

ating word for Lena New Boston.

In 2003, Lena Park CDC, a leader since 1991 in the long-stalled redevelopment of the closed Boston State Hospital, formed a partnership with New Boston Development to build out the property after previously designated developers had failed.

But for reasons never fully explained, Lena Park CDC abruptly closed in June 2009, and 150 American Legion Hwy. and its attached gymnasium were locked and remained vacant for years.

After what seemed to be tense negotiations between the CAC and the Lena Park Board - and after being considered as a church, 150 American Legion was sold to the Brooke Charter School as an elementary school.

After renovations designed by Arrowstreet Architects the school open in 2012. As part of the Olmsted Green development, the reorganized Lena New Boston built out the gymnasium building with ground floor offices, breakout rooms

Questions and concerns broke into two categories: the recently increasing gun violence in the neighborhood's Fairmount public housing development, and the safety and upkeep of Martini Shell Park, located along Truman Parkway at the base of West Fairmount Hill.

The BHA development takes up a significant portion in the heart of the West Fairmount Hill neighborhood, and those commenting during the meeting expressed concern, fear, and frustration at the increasing frequency of the gun violence emanating from it. A submitted question asked what was needed from the community to help re-

move guns from its streets and to increase criminal prosecution of offenders.

Responding to this, Capt. Joseph Gillespie, commander of E-18, noted the importance of cooperating with investigations. "I know some people are reluctant sometimes, for fear of retribution or retaliation, but we need the information." He added that help from elected officials was also needed to enforce laws that are already on the books. "If there's no deterrence, these incidents are going to keep occurring. We've seen some really bad people get arrested and they're out, either that day or the next day, to commit crimes."

Gillespie also referred to the nearly 40 dedicated BPD patrols that have thus far been assigned to that area since the beginning of the month.

BHA Administrator Kate Bennett also clarified that "the vast majority of these incidents don't involve our residents," although no confirmation was provided by anyone regarding exactly what has been bringing the perpetrators into that particular community.

She also stated that, when there is evidence of resident involvement in a crime, "there is aggressive follow-up by both the BHA and the BPD." Addressing further deterrence, she said that the BHA has been meeting with residents, and that installed

surveillance cameras will be operative by the end of this week.

It was also clarified during the meeting that the BHA's very small police force of nine officers for the city's 60 different public housing developments serves as BPD support, rather than as a primary force, and also acts as a liaison between the BHA and the BPD.

Additionally, William Dickinson – Mayor Wu's senior advisor on faith based initiative and public safety – proposed the idea of community walks as a method of deterrence.

Regarding Martini Shell Park, topics raised included limiting access to its parking lot during off hours to deter loitering and illegal activities, installing emergency call boxes and additional lighting on its area paths, and increasing the electrical capacity of the Martini Shell itself, which is one of only two performance venues of its kind in the city.

Related to this, the State Police – which has jurisdiction over Truman Parkway (although the BPD overlaps) and the park –

were encouraged to increase their community presence, which was well received by Lt. Gregory Keane, commander of the Blue Hills Barracks Station H-7, and Lt. Kevin Baker of the MSP Colonel's Office.

It was also recommended that residents call both the BPD and the State Police regarding law enforcement matters in that overlapping area of jurisdiction.

In closing, Kimm-Jackson emphasized individual accountability. "Our leaders need our voices to substantiate, to validate, to push for things. If nobody's asking for it, they can't ask for it because they feel like it. We have to be the impetus... I encourage you, if you want to be part of the solution, to raise your hand to see what you can do to do that."



and multi-purpose rooms for Lena Park CDC and the Brooke School gym on the upper story.

The revived Lena Park CDC opened with a new director on Oct. 3, 2014. This was the community benefit for Olmsted East, a 14.5-acre, 102-unit rental housing development dedicated in June 2010.

At the BPDA meeting, Black introduced Katie Ferrier, principal architect with Arrowstreet, designers of the addition.

Also on the call was Mark Loring, chief operations officer of the Brooke Charter School.

Ferrier explained that the addition was required to move the 8th grade class from the Brooke High School.

The \$41 million high school built on land adjacent to Olmsted East was also designed by Arrowstreet and opened in 2018.

This was another change; the 2006 PDA called for this site to be built as Heritage House, a museum and community center for the history and study of the development of mental health practices for which the state hospital was well-known.

Ferrier explained that the new addition was also required for additional programming that is now at the Brooke Roslindale building on Cummins Highway. She added

that the Lena Park building would not be affected by the new addition: the gym would remain and the lower floor would still be the Lena Park CDC rooms. Ferrier said that one small playground had already been relocated from the rear of 150 American Legion to a nearby space along Austin Street.

The other recreational change would be the temporary use of the basketball courts for a construction trailer, equipment and material storage; the courts would be restored and returned to school and community use after completion of the addition.

The new addition would have four classrooms and offices and break out rooms on each floor and a new cafeteria on the ground floor: there would also be a new entrance to Austin Street.

Resident Takiesha Gray asked about the timeline.

Ferrier said the project would go out to bid “next month and construction should begin in April of 2023.”

Gray asked about the budget.

Evan Warner, project manager of STV Construction Inc., said that the cost is \$12 million. “We have the same contractor [Consigli] and construction manager as the high school, and the same team as the high

school,” he said.

Gray asked about the impact on the students during construction. “There’s been a lot of concern by Brooke school staff about not losing any school time and minimizing the impact on students,” Warner said.

“That’s part of the bid documents,” Warner said, “to adhere to a certain amount of constraint with the construction and the school.”

Warner said one plan is to have a screen separating the school classrooms and the construction; also “dedicated travel on stairways through the building to separate the construction from the students.”

In what seemed to surprise Sarah Black of the BPDA, the meeting lasted about 29 minutes.

Black reminded callers that the comment period ended on December 2.

**MHC reviews project wins**

The Mount Hope Canterbury Neighborhood Association (MHC) at its two-hour monthly meeting on Nov. 10 at the Home for Little Wanderers in Roslindale announced two big wins on local development projects that recently began construction in a scaled-back form due to community advocacy.

MHC co-chair Lisa Beatman said that the apartment development project for 106 units at 289 Walk Hill St. has commenced. The original proposal was for 160 home-ownership condominiums, she

noted.

"There was a lot of community involvement," she said, "and we did manage to get it scaled down at least some."

A building permit was granted by the city on Sept. 9, according to the Boston Planning and Development Agency (BPDA) website. The Residences at Walk Hill LLC plan to construct 106 rental units in a three- and four-story building with a gross floor area of 94,418 square feet. It will include off-street parking for 126 vehicles.

A community benefits package of \$510,000 also was included in the plans, which allocated \$50,000 for the Slow

Streets program and a commitment for another \$50,000 for a bike share program, according to the website. There will be a \$410,000 payment made as part of the city's Inclusionary Development Policy (IDP), presumably for off-site affordable housing units.

Beatman also said that the ScrubaDub car wash, located at 565-569 American Legion Hwy., began its renovation project recently.

"It does seem like one of the two curb cuts is smaller," she said, noting the original proposal called for two 30-

building permit from Aug. 9 issued by Deputy Building Commissioner Marc Joseph, a report of all exterior demolition and raze work type permits issued over the past three years, and ISD documents, emails, and text messages related to the Stop Work Order.

"Commissioner Sean Lydon issued a temporary Stop Work Order for the work on Friday, August 12, 2022 to allow ISD staff to confirm that all internal procedures were followed and that all required documentation had been submitted in connection with the application for the demolition permit. Upon completing this review on August 17, 2022, ISD lifted the Stop Work Order at 1905 Center St. West Roxbury and allowed the

demolition work to resume," stated Edward Coburn of the ISD.

About a month after the demolition of the Keith House, the brutalist bank structure at 1905 Centre St. was also demolished.

On Oct. 19, Lara and members of her staff met with local advocates, the BPDA and ISD to determine what broke down in the landmark process.

"As of now, we [Lara's office] have not decided on doing a hearing. If we did so, due to the legislative calendar it would have to be next year before we even file for it," explained Lee Nave Jr, Lara's Chief of Staff. "Our office has had a couple meetings with local nonprofit developers, one of which is the Jamaica Plain

Neighborhood Development Corporation. The idea was to see if they'd be interested in buying the land from the developer. Our rationale is, due to the public outcry and the way the developer has handled the situation they'd be more likely to sell the land. We've also reached out to the city and looked at the possibility of a land swap." A land swap is when the city would swap the current land owned by the developer for a publicly-owned parcel that has not been developed on. There are thousands of such parcels around the city of Boston.




foot-wide curb cuts. “They had proposed these excessively wide curb cuts, but we lobbied hard.”

Beatman noted that the city’s policy is that a one-way curb cut can be no more than 12 feet, while a two-way curb cut cannot exceed 24 feet.

“Their reasoning was that it was better than it was before,” Beatman said. “That’s like nails on a chalkboard.”

The Boston Conservation Commission had held a hearing on the proposed remodeling and vehicle queue realignment on July 7, which MHC co-chair Rick Yoder called “a mixed bag.”

“One of the improvements to ScrubaDub, which I think is a real improvement,” he said, “is that now there are going to be three lanes for a holding tank basically for cars.” Previously, double parking and long lines would tie up traffic.

There will also be automatic payment systems with associated gates, according to the notice of intent submitted to the Conservation Commission, that also are expected to improve traffic flow.

A concern Yoder expressed is that the Conservation Commission approved the project’s encroaching into the 25-foot buffer zone of Canterbury Brook. The project’s notice of intent stated that there would be a 5,312-square-foot alter-

ation of the riverfront area, with 12,470 feet within the 100-foot buffer zone.

Yoder said he was concerned about fuel and chemicals potentially entering the waterway as well as stormwater management.

“I raised the question of what’s going to happen after the filtering gets clogged,” he said. “They just ignored it.”

He said that the neighborhood is sometimes viewed as “a dumping ground” by city officials.

“Sometimes it just takes organized residents to push back and make officials pay attention,” Beatman added. “This is why our group and our pocket neighborhoods, with even a handful of letters and testifying at hearings, can make a big difference.”

In other news, state Rep. Russell Holmes spoke before the audience of a dozen people about the results of the state election on Nov. 8. The main ballot question he discussed was Question 1, which was referred to as the millionaire’s tax.

He noted that Question 1 was the only one of the four ballot questions that involved a constitutional amendment. Before the question reached the ballot, it had to be approved by both the House and Senate in two constitutional conventions “It passed [the constitu-

tional convention] the first time,” Holmes said. “But the Supreme Judicial Court said, ‘Your language is not tight enough.’”

Question 1 passed by a narrow margin of 52 percent of the vote, but that wasn’t confirmed until the afternoon after the election, according to a Boston Globe article.

The tax will be implemented in July. It will affect people who have a capital gain of greater than \$1 million, but Holmes explained that there is a \$250,000 tax exclusion. It also will apply for people or businesses that earn more than \$1 million a year.

The money will go towards funding transportation and education improvements, including the MBTA, Holmes explained.

Regarding the recent redistricting process by the Boston City Council, Beatman announced that the MHC neighborhood will no longer be included in District 4, whose city councilor is Brian Worrell, for the next city election cycle in November 2023. The neighborhood will now become part of District 5, which is represented by City Councilor Ricardo Arroyo.

Beatman noted that Worrell lobbied to keep this area in District 4. She said she had a conversation with him expressing her concern that “the neighborhood isn’t considered a lame duck for the next year.”
