The first Roslindale Village Main Streets (RVMS) Winter Farmers Market started the year off with fresh vegetables, baked goods, beeswax and more on Saturday at the Sons of Italy Hall on Birch Street.

Farmers Market Manager Steve Marcelin said this was his second year managing the winter market, and he said it was fantastic to see the community come out in the cold and rain to support the market.

"It's going great, it's never dull you know?" he said. "You always get new vendors every year and you think about it in a new way.

What I'm really interested in this year is still having our old vendors come back, like Apex Orchards, and also welcoming new vendors that we never had in Rozzi before, like Gamma's Apothecary, and Cultural Tea Leaf. It's all food that I haven't tasted personally, which is exciting, and I'm guessing it's also food that the Roslindale community hasn't tasted either."

Marcelin said that it was a healthy turnout for the smaller market. Though the numbers don't usually come close to the Summer Market, he said the Winter Market still packs a punch.

Janey named Boston City Council President First Latina Councilor sworn in

The Boston City Council met at Faneuil Hall and later at its regular chambers for a historic swearing in ceremony and first meeting of the decade.

This year's inauguration featured several firsts, including the first election of a Hispanic woman – At-Large City Councilor Julia Mejia – since

its inception more than 100 years ago. It was also the first time ever that a majority of women and people of color sat as Boston City Councilors.

Boston Mayor Marty Walsh led the proceedings at Faneuil Hall and later commented at City Hall, while the councilors themselves presided over the meeting.

"To all the newly-elected councilors, congratulations," Walsh said. "It's a proud mo-

ment for all of you as we enter into a new decade here with this council. You represent new ideas and new ways of getting things done and it's important to move this great city forward. Collaboration is going to be at the heart of all our work. We need to continue to collaborate. When you see what's happening in Washington D.C., you see a complete

Boston's Latin Quarter celebrates Three Kings Day

The Connolly Branch of the Boston Public Library in Jamaica Plain invited community members to help them celebrate Three Kings Day (Dia de los 3 Reyes Magos). The event took place on Saturday, Jan. 4 and included decorating crowns, book readings about Three Kings Day, the singing of traditional Latin American holiday songs, and dancing. Over 200 children and adults attended the celebration.

Three Kings Day, also known as "Feast of the Epiphany" or "Epiphany" is a Christian holiday celebrated by many children in Latin America and Spain. This holiday marks the biblical adoration of baby

Jesus by the three kings, also referred to as the Three Wise Men (Magi). Three Kings Day is traditionally held on Jan. 6, or the twelfth day of Christmas. Popular traditional Epiphany customs include singing, blessing one's house, consuming king cake and other holiday desserts, winter swimming, removing Christmas decorations, and attending church services.

The Three Kings Day celebration was hosted by the Hyde Square Task Force (HSTF). The event kicked off with a performance by members of the Ritmo en Accion dance team. The dancers performed Homenaje a la Rumba, which was choreographed by

Mayor Walsh announces reappointments to Boston School Committee

Mayor Martin J. Walsh today announced the reappointments of Alexandra Oliver-Dávila and Lorna Rivera to the Boston School Committee, the governing body of the Boston Public Schools (BPS). Oliver-Dávila currently serves as the Executive Director of Sociedad Latina, Inc., and has been an active member of the School Committee since her appointment in 2016. In 2019, she served as vice chairperson of the Committee, and co-chair of the Superintendent Search Committee. Dr. Rivera is the Director of the Mauricio Gastón Institute for Latino Community Development & Public Policy, and an Associate Professor of Women's & Gender Studies at the University of Massachusetts-Boston. She has been an active member since her appointment in 2019. Oliver-Dávila and Dr. Rivera are both parents of current BPS students.

"I am proud to reappoint both Alexandra and Lorna to the Boston School Committee, both tremendous leaders who put the best interest of our students and schools first," said Mayor Walsh. "I want to thank both of them for their dedicated service, and I look forward to our continued work as we ensure every single student in Boston can reach their full potential."

The seven-member Boston School Committee is responsible for defining the vision, mission and goals of the Boston Public Schools; establishing and monitoring the annual operating budget; hiring, managing and evaluating the Superintendent; and set-

ting and reviewing district policies and practices to support student achievement.

"We are thrilled to welcome two dedicated colleagues back to the Boston School Committee," said Boston School Committee Chairperson Michael Loconto. "I look forward to continuing to work with Dr. Rivera and Vice-Chairperson Oliver-Dávila to further develop and strengthen the district's strategic vision, improving educational outcomes for all BPS students."

As Executive Director of Sociedad Latina, Oliver-Dávila works to increase opportunities in education, workforce development, civic engagement and arts and culture for Boston's Latino youth and families. During her time at Sociedad Latina, Oliver-Dávila helped create partnerships between the organization and the Colleges of the Fenway, Museum of Fine Arts and Longwood medical area hospitals. She has also provided collaborative leadership in other organizations such as the Greater Boston Latino Network and Boston Youth Service Providers Network. Other organizations she is involved with include: Beth Israel Deaconess Medical Center, Boston After School & Beyond, Boston Children's Hospital, Dana-Farber Cancer Institute, and the National Coalition of Schools Educating Boys of Color (COSEBOC), among others.

Oliver-Dávila currently resides in Roslindale. She is a graduate of Emmanuel College, where she earned a B.A. in Political Science and Tufts University, where she earned a Master of Public Policy.

"Working alongside my colleagues on the Boston School Committee to support student achievement is a responsibility I take very seriously," said Oliver-Dávila. "I am incredibly excited to continue investigating ways to implement critical youth voice in policy decisions and leverage community partnerships for the betterment of this district and the entire City of Boston."

Currently, Dr. Rivera is work-

ing on the Latinx Student Success Initiative, a partnership with Bunker Hill Community College, to improve retention and graduation rates for Latinx college students. Dr. Rivera also works with the Talented & Gifted (TAG) and Proyecto Alerta afterschool programs that serve Latinx bilingual students in the Boston Public Schools. She has extensive community service and co-founded a national nonprofit, WE LEARN, dedicated to advancing women's literacy. Dr. Rivera serves on the Advisory Boards of the Center to Support Immigrant Organizing and the Latino Education Institute, and on the Board of Directors for the Hyde Square Task Force, an arts-based youth development organization serving Afro-Latinx youth in Boston.

Dr. Rivera has a Bachelor of Science in Elementary Education from DePaul University, state of Illinois licensure in Language Arts & Social Studies grades K-9, and a Masters and Doctorate in Sociology from Northeastern University. Between 1994 and 2001 she taught G.E.D. classes and also was the director of the Adult Learners Program at Project Hope in Dorchester. She lives in Roslindale.

"As a BPS parent, I am profoundly committed to the important charge of this committee, working to close opportunity and achievement gaps for our youth," said Dr. Rivera. "I am very grateful for this opportunity to remain on the Boston School Committee and continue leading the ELL Task Force, advocating for English learners and all students and families of the Boston Public Schools."

The seven members of the School Committee are Boston residents appointed by the Mayor of Boston to serve four-year staggered terms. Mayor Walsh made these appointments based on a list of candidates recommended by a 13-member Citizens Nominating Panel composed of parents, teachers, principals, and representatives of business and higher education.

Parkway needs food pantry volunteers

It's that time of year again. The holidays are over, but the need for food and volunteers isn't just for the November and December months. In West Roxbury and Roslindale, the need is constant.

At Rose's Food Pantry in West Roxbury, the group's four programs are in a constant need of volunteers. And Director Darra Slagle said they can use the help of anybody for many reasons.

"One of my biggest concerns is I want to avoid volunteer burnout," she said. "We have the greatest group of volunteers right now, they're so enthusiastic and they come all the time, but because we're growing so much I don't want anybody to burn out. I want them to feel invigorated after they leave, and not feel depleted, so we're always looking for volunteers to help with our burgeoning program."

Slagle said the biggest time they need help is on Tuesday afternoons and evening.

"It tends to be when the kids are in school and most working folks are working, and so we definitely have a need on Tuesdays," she said. "We pick volunteers of all

ages, nationalities, creeds, whatever, we check off every box when it comes to our volunteers. If people can't stand for long hours we have jobs for them. We don't let disabilities get in the way because we have jobs for everybody."

Perhaps most importantly, Slagle said they need a volunteer to help finding volunteers.

"I'm putting in so many hours just as the director, I could use someone else who could help out recruiting volunteers for sure," she said. "If somebody is interested in volunteering for Rose's Bounty, no matter what their wheelhouse is we're willing to take them on as volunteer because we have so many different aspects for programs and if somebody wants to do writing or anything with social media we're happy to entertain that notion."

Slagle added that the Parkway community has already been very generous with their time and effort, but more is always needed.

"We can't do anything without the community. I have to say I am so proud to be a member of the West Roxbury and Roslindale community, because the people are awesome, we have so many great volunteers, we

have so many great businesses that chip in I can't say enough to say how proud I am that this is truly a community organization," she said.

Slagle said they have four programs, which includes the bimonthly food pantry distribution. She said currently they serve on average about 250 families a month. Another program they have is preparing food boxes for veterans at the VA hospital, which currently serves about 50 vets a month. They also have a food backpack program at the Chittick School in Hyde Park that serves almost 50 kids a month as well. She said their adult day care food program also serves about 30 residents for 49 weeks of the year.

BPDA discusses 32 home ownership units at 100-110 Lincoln St.

The Boston Planning and Development Agency hosted a public meeting regarding the proposed 32 homeownership units on 100-110 Lincoln St. in Brighton on Tuesday night. The proposal would be approximately 43,180 sq. feet, five stories tall and include four Inclusionary Development Policy (IDP) units, 27 garage parking spaces and 54 bicycle parking spaces. Variances for the project include floor area ratio, parking, height, and rear yard setback.

The public meeting at the Brighton Marine Health Center had a low turnout, with only about 10 residents and community members in attendance. This was possibly due to the fact that Mayor Walsh's 2020 "State of the City" was happening at the same time.

Project Manager John Campbell of the BPDA opened the meeting and said the idea was to get feedback from the community.

Attorney John Pulgini gave an overview of the proposed project. The 100-110 Lincoln St. site is currently used as a storage facility. The site is on the corner of Lincoln St. and S. Waverly St. and faces the Mass Pike. The proposal is transit oriented, located within three blocks of the Boston Landing Commuter Rail Station. The project is also served by the 86 and 64 MBTA buses. It is a 12 minute walk to the new Boston Landing Commuter Rail Station, a nine minute walk to Star Market, a 19 minute walk to Allston Village, and a 21 minute walk to Brighton Center. The total development cost is estimated to be \$9.5 million.

Architect Shane Losi of Choo & Company, Inc. pre-

sented the building design during the public meeting. The proposed building will be built on the property line. Part of the building will be one story high, while the rest of the building will be five stories high.

"The sidewalks will be about 9 feet wide all around the building; on Waverly [street] and Lincoln [street]. We're giving back about a foot and a half of sidewalk to make the sidewalks wider so we can have street trees and have a wide sidewalk area," Losi explained during his presentation. "On the existing site plan, there are curb cuts along Lincoln [street]. We're closing all these curb cuts to bring additional parking on the street." The sidewalks will include greenery, such as trees and planters.

Losi explained that the exterior will include brick and fiber cement. A few residents raised concerns regarding the design of the building - one Brighton community member mentioned that the design was "kind of blah". Another meeting attendee remarked that they would like to see bigger windows on the building.

"To me, it looks like a hospital. It doesn't have that 'family feel' to it," stated one neighbor.

After the presentation, Pulgini and Losi opened the meeting to questions, comments and concerns from meeting attendees. One concern raised by community members was affordability. In addition to the above four units being designated affordable, the developer will contribute approximately \$52,174 towards the creation of additional affordable units. But meeting attendees stated that they would like to see more income restricted housing.

"Will there be a community

space for meetings in the building?" asked one meeting attendee. Pulgini stated that they have "not thought about it yet", but they will consider it. Many neighbors agreed that they would like to see space in the building reserved for public meetings as a community benefit.

Another major concern was the lack of green space. Losi explained that the proposal includes roof decks, but no open green space. Community members stated that they would like the proposal to include more "permeable land" since the area can be "prone to flooding".

"Does it [the proposal] include visitor parking?" asked another meeting attendee. Losi responded that the proposal does not currently include parking for visitors. Community members remarked that they should include visitor parking due to the fact that there is very limited on street parking in the area.

"There needs to be green space, it needs to be set back more, and it needs to have bigger windows. This [building] looks like a rental [property], not a homeownership building. I'm happy that it's homeownership and not rentals, but this needs to be a place where people will be proud to live," commented one community member. Losi and Pulgini remarked that they will keep community members and neighbors updated on the project as they make design changes to the proposal.

Angie Egea. After the dance, band members Gilberto Rivera and Rumbanama joined the stage and performed for attendees. While listening to the traditional Latin music, children decorated crowns, danced and read books about Three Kings Day.

“For us, this event is about uplifting the cultural aspect of the neighborhood. This neighborhood is known as Boston’s Latin Quarter, so it has a long history of a presence of Latinx population here, mostly from the Carribean,” explained Celina Miranda, who has been the Executive Director of HSTF for three and a half years. “So, how do we continue to make sure that the Afro-Latinx aspects of the neighborhood remain? This is one key celebration for countries in the Carribean, like the Dominican Republic and Puerto Rico.”

Miranda also explained that this event has grown more and more popular over the years. “It [the Three Kings Day celebration] has been getting larger and larger every year. This year surpasses last year [in terms of attendance].” She also remarked that one of the most important aspects of this celebration is preserving the cultural aspects of the Epiphany here in the United States. “I love seeing the diversity - the racial and ethnic diversity - in the people that come to

this event. It helps us to build bridges across differences and helps people come together,” stated Miranda. “I also love the very traditional music we are playing here today.”

HSTF was founded in 1991 to address the growing violence, economic, and social challenges facing the Hyde/Jackson Square neighborhood of Jamaica Plain, also known as Boston’s Latin Quarter. HSTF’s mission is to “amplify the power, creativity, and voices of youth, connecting them to Afro-Latin culture and heritage so they can create a diverse, vibrant Latin Quarter and build a just, equitable Boston.”

“This has been an activity we [the HSTF] have done for about 25 years now to keep the Latin American tradition going. It [the Three Kings Day celebration] always receives a very positive reception in the neighborhood,” stated Ken Tangvik, the Director of Organizing and Engagement for the HSTF. “Recently, this neighborhood became a Massachusetts Cultural District, so its nice that all of our efforts - creating cultural events, training youth, and arts - has brought us this recognition.”

Tangvik explained that for the past 25 years, this event has included music, dance, and literature. “We feel very strongly about giving books away,” he remarked. “Instead of giving away typical gifts or

presents, we give out free, good quality children’s books about Three Kings Day and its traditions. We give out books for all different ages.” The children’s books and novels were written by Hispanic authors and included award winning titles such as *Me llama Celia: The Life of Celia Cruz* and *Dreams From Many Rivers: A Hispanic History of the United States Told in Poems*.

The Dia de los 3 Reyes Magos event is a part of HSTF’s annual series of free community events, called *Viva el Latin Quarter*. “Our events aim to celebrate and uplift Afro-Latin arts and culture and provide opportunities for neighbors to connect all while bringing vibrancy to Boston’s Latin Quarter. Signature Viva el Latin Quarter events include a summer series in July and August, a series of events during Latino Heritage Month, and a Halloween Festival,” remarked Miranda. “We want to make sure we bring events to the Latin Quarter.”

Washington Street corridor sees 19 new developments in 2019

Twenty-two new residential buildings—both rental and ownership—were either completed, under construction or planned during 2019 in Jamaica Plain.

All but three are on the Washington Street corridor that remains the new housing frontier of Jamaica Plain.

Jay Walsh, a consultant with several developers, explained the obvious in November.

“The neighborhood is being reborn,” he said.

The neighborhood is also being rebranded.

Tempo, The Vita, Velo, and MetroMark replaced the seemingly pedestrian Stonybrook, 3521 -3529 Washington Street, The Residences at Forest Hills and Forest Hills Commons; the first three didn’t exist five years ago.

What started it all in many ways was 3200 Washington Street—which changed owners but not its name. The \$35 million, two, five and six story buildings of 76 luxury apartments (18 affordable) got underway in 2014, survived furious opposition in 2015 and began leasing in August, 2019. New owner Berkeley Investments hosted a reception opening on October 18, advertised as “contemporary living in Jamaica Plain.” RODE were the architects.

The Vita (“Live like you mean it”) began as 3521-3529 Washington Street. It is part of a 3.5-acre old factory site that was first proposed to the JP neighborhood council in April 2011 and over the next six years changed development teams and archi-

itects.

There are three buildings: a four-story, self-storage building on McBride Street built by SSG opened a year ago; a four-story, 44-unit luxury block tucked into a back street called 45 on Burnett that will open in 2020 built by New Boston Ventures.

Also opening in 2020 is the Vita itself, a six story, 82-unit (12 affordable at 80 percent to 100 percent ami) luxury condominium building with the most dramatic corner facade in Jamaica Plain, four, cantilevered glass balconies. Finegold-Alexander is the new architect.

Marketing of The Vita – now owned by Back Bay Development- began in January 2019. As of December 16 units were available beginning at \$545,000.

The ground floor will have a Planet Fitness, The Co-Operative Bank, Pure Dental, Third Cliff Bakery and Beth Israel Deaconess Health Care.

On the other side of the Casey Arborway, two new developments will be completed in 2020 totaling 330 units costing \$141 million.

A+O Flats (“Arboretum-Orange Line”) at 95 Hyde Park Avenue is almost completed with landscaping and sidewalks but not occupied.

It is a five-story, 78-unit, fully affordable rental building developed by The Community Builders and designed by the Architectural Team and Stephen Chung.

Forty units will be made available to those earning 30 percent-60 percent ami using low income housing tax credit financing.

Criterion Development proposed The Residence at Forest Hills on a former parking lot in July 2016, and it has progressed smoothly with planned completion in 2020.

Designed and built concurrently with the completion of the Casey Arborway, The Residences -now called Velo- is 252-units in three, six-story buildings grouped around a courtyard that covers the Stony Brook culvert.

Designed by Icon Architects, the flagship building has a majestic curve that follows the turn of Washington Street and the parkway.

Velo includes 50 percent affordable units at 50 percent to 70 percent -the highest affordable number of any privately financed development in Jamaica Plain.

Including land, the development cost is \$113 million.

The anvil of angst in 2019 was the crossroads of Washington and Green streets which within a decade will be unrecognizable.

Five new developments totaling 314 units are proposed or approved on this corner totaling an estimated \$160 million, but bound to be higher given frequently lengthy community review and increasing costs of labor and materials.

1. Boston Community Ventures should begin demolition of its property at 3353 Washington St. in preparation for its 45-unit, five and six-story condominium building designed by Deborah Katz of Interface Design Studio. Bids are being sought and the architect is making construction drawings.

2. JPNDC will soon close on its acquisition of 3375 Washington Street from City Realty that it will raze and develop into housing. The two tenants El Embajador Restaurant and De Chain garage –both the object of City Life demonstrations in 2017 - will be relocated.

3. After long and tempestuous community opposition, City Realty received zoning board approval on July 9 for its proposed four-story, 23-unit apartment building at 197-201 Green Street. Designed by Paula Claridge and Ermeline Moliere of EMBARC Architects. Demolition is pending for 2020.

4. Since February 2019, Primary Development Group has been going through the community grinder for its proposed 47-unit, five story, terraced apartment building on the site of JP Auto Glass at 3326 Washington Street. This opened up for the first time a clash with the historic preservation community that sought to preserve the existing 1850 schoolhouse on the site. While unsuccessful, this provided an opening for others to oppose the development on various grounds and BPDA and zoning dates yet to be scheduled yet.

5. Pine Street and The Community Builders received BPDA approval on November 14, 2019 for the largest supportive housing development in Boston for the formerly homeless at 3368 Washington Street designed by RODE Architects. The six-story building will include 140 studio apartments for formerly homeless with in-house supportive services and 221 fully affordable rental units. The subject of three contentious BPDA public meetings, the development was either strongly opposed or weakly supported by most residents. A priority of Mayor Walsh, part of the funding for the \$82 million development will be \$10 million in linkage payment from the enormous One Congress Street luxury-housing tower. A zoning date has not been scheduled.

Urban Edge held a ribbon cutting on Sept 16, 2019 for Walker Apartments, an \$18.5 million, 49-unit fully affordable rental units in two buildings at 67 and 80 Walnut Park.

On December 12, Urban Edge received BPDA approval for 1599 Columbus Avenue, a six-story, 65-unit income restricted apartment house near Jackson Square.

Work is now well underway for the new \$23.5 million Egleston Square firehouse; groundbreaking took place on Sept 16.

in Roslindale really love their market, they're really committed, but we try to cater to everybody, no matter what," he said. "It doesn't matter what financial background you're coming from, what you're into, if you're vegan or whatever, there's something here for you."

Beverly Bees manager Brian Deeley was manning the station for his beeswax candle stand that he and his wife Anita run. Deeley said the beekeeping and wax extraction he leaves mostly to his wife, as his full-time job is to go to buildings and safely remove and relocate beehives that might be harmful to bees and humans.

"We're both different kinds of beekeepers," he said. "My wife Anita is actually a pretty famous beekeeper. She goes around and gives talks and things, and she's one of the preeminent experts on bee diseases, which is kind of depressing, but she's the best at identifying them. I take hives out of buildings. So, if you get bees in your house and you call an exterminator the exterminator is going to say 'these are endangered, I can't touch them'. So, they call me."

"My wife dragged me into it, it's her company, but we started local at the Beverly Farmers Market, which is a little smaller. We then kind of branched out. Now Roslindale, winter and summer, is one of our best markets," he said.

Deeley said the molding process

itself is pretty quick and easy for him, but the wax production can take the bees a good deal of time.

"I get a frame of bees out of a hive, shake them off, the honey gets spun and put into a jar as raw honey and the wax gets melted and filtered and then melted and filtered again to get this nice color we have here. It is then put in a mold," he said.

Deeley added that yes, he still feels stings from the bees even after years of keeping and relocating them.

Resident and local artist Wendi Gray immortalized the scene at the opening of the market. She said she does hundreds of paintings every year of Roslindale, and loves capturing her community on canvas.

"I paint Roslindale every day," she said. "I moved here about a year-and-a-half ago. I've had some showings in the Square, I've had some stuff online, people commission me to do stuff too and I do a lot of the events."

Gray said her main focus is to document as much of everyday life of Roslindale as she can. To see some of her art, go to instagram.com/graywendi/

Resident Henry Ladd said he comes to the winter market every year.

"It's good coffee, good produce and it's good seeing friends in the community," he said. "I think it's great to connect with your local

food chain and get food that's local, seasonal and fresh."

Resident Amy Todeschini said she also comes every year, and said it is a great market with a lot of variety.

"There seems to be more vendors here than usual, which is cool and I really like it," she said. "I think the fact they can sustain it too is a really good sign for Roslindale."

Resident Lisa Ramsey said any time she can help a local organization rather than a big box store or large online retailer, she's there for it.

"I come out for these guys right here, Neighborhood Farm," she said. "This is why I come. I haven't seen who else is here yet. I'll walk around when I'm done, but I'm always here first. I love it here, it really makes a big difference. I hate giving corporations money. The less money I can give them the more money I can give to the local community and then the better I feel."

breakdown of collaboration that's been going on for 25 years now. We can't let that happen here in the City of Boston."

Newly-elected District 9 City Councilor Liz Breadon led the proceedings at City Hall, before At-Large City Councilor Michelle Wu introduced a motion to elect District 7 City Councilor Kim Janey as City Council President.

"I am honored to make a motion at the start of this new decade and new term for justice, equity and opportunity for all, and I rise to proudly nominate our good colleague from Roxbury, Councilor Kim Janey," she said.

The nomination was seconded by newly-elected District 5 City Councilor Ricardo Arroyo, and was passed 12 to 0 with District 3 City Councilor Frank Baker voting "present." Janey, followed District 4 City Councilor Andrea Campbell's lead as the first African American to serve as Council President, said her thanks to the council and to Campbell specifically.

"I am so humbled and grateful, thank you for your support and thank you for putting your faith in me as your president of the Boston City Council," she said.

Janey said she wanted to work to make a more inclusive and equitable Boston for all residents.

"We will continue to prioritize equity and inclusion during my tenure," she said. "Representation matters, and this body is now more representative of the city we all love and chose to serve. As the daughter of Roxbury, I am especially proud to lead the council. My district has a rich history and amazing cultural assets, but it is also ground zero for many of the inequities in our city. Despite unprecedented economic prosperity, we have an enormous wealth gap. We're in the middle of a construction boom and Boston's property value is at an historic 164 billion dollars, but we're experiencing a housing affordability crisis. Our educational system receives national acclaim, but our schools are increasingly segregated and racial disparities persist. While we have the best hospitals in the country, the opioid epidemic has devastated families and communities. The climate change crisis needs urgent action before it's too late and car congestion is bringing the flow of traffic to a grinding halt."

Janey said while the city is

facing serious problems, the accomplishments the council has been able to make over the past few years give her hope and optimism.

"In neighborhoods all across our city, families are finding it increasingly difficult to make ends meet, and sadly, some of our neighborhoods experience the trauma of gun violence all too often," she said. "While these challenges seem overwhelming, I am encouraged and I am hopeful, because of the good work that we have already done on the council, working with each other and in partnership with the Mayor and in partnership with residents in our neighborhoods."

Janey pointed to some of the work the council has done so far, including the short-term rental ordinance restricting what had become unlimited hotels in the city, affordable housing, open space and historic preservation projects passed through the Community Preservation Act and the recently-passed Wetlands Protection Ordinance. But she said there is still a lot to do.

"In this new term, we must continue to prioritize equity, transparency and accountability," she said.

Janey said her first item of action will be to create a new committee on the Council to tackle issues associated with the Payment in Lieu of Taxes

programs for the City's nonprofits. The PILOT program was first agreed to by a majority of the city's large nonprofits, like Harvard and the Massachusetts General Hospital, to pay in cash or in kind 25 percent of what they would have to pay if they paid taxes. This was first instituted in 2011 and few of the city's top-earning or endowed nonprofits have consistently paid close to what they agreed to. Janey said she hopes to rectify that situation.

"Let's find new ways to tackle old problems, like free MBTA buses, to increase ridership and improve traffic flow in the city," she said. "That one's for you (State Rep.) Russell (Holmes)."
