# St. John Chrysostom welcoming comedians for fundraiser April 7

St. John Chrysostom is hosting a comedy night fundraiser on April 7 to raise money for the church's expenses at the Irish Social Club.

While it hasn't really been an annual event, chair of the steering committee for the St. John Chrysostom Church Mary Martell said they only really hold it when the church really needs it.

"It's really just raising money for the church for everything from heat light and power to the cost of running the parish," she said.

This year, the event will host three local comedians, including veteran of the Boston scene Tony V. Former District 6 City Councilor John Tobin said he's booked Tony V for a long time, and has booked West Roxbury comedians Harrison Stebbins and Jessica Casciano at his Laugh Boston locations many times.

Martell said they originally started the event with former Boston Mayor Thomas Menino when the parish needed a new parking lot.

"Tom Menino used to be a parishioner and his wife is still a parishioner. He really helped us start," she said.

Tobin said Menino approached him back then to book the acts for the show, in his own political fashion.

"Menino called me up here at Northeastern and he said 'what you doing this Sunday?'" he said. "He would always ask that, which meant you're going to be doing something and he's going to tell you what it is. He and Angela and a bunch of his parishioners would meet for breakfast on Washington Street after one of the early masses and he said to come down there, we're going to tell you about something we want to do."

Tobin said the then-mayor used that time to ask Tobin to help out.

"I get in and he says, 'John here has agreed to run a comedy show for us,'" he said laughing. "They had to raise I think \$30,000 to fix the parking lot. He said to me 'you're going to find the venue and book the comedians and we're going to sell the tickets. It's going to be a great night.'"

Tobin said they held it first at Roxbury Latin's theater and it was a huge success.

"I think we raised north of \$40,000 for one night with the mayor and Mrs. Menino behind it, it was extraordinary," he said.

Martell said she was excited for Tony V, who has worked in various famous films over the years including *The Town* and has been mainstay in the Boston comedy scene since the late 1970s early 1980s.

"How do I describe him?" she said. "He's really sort of a kind soul, he just can really light up a room with his comedy and he also because he's a native Bostonian, he's been in the market for a long time so we got lucky... I think he'll have a lot of fun with the group. I hope that because we have the comics we'll be able to draw a younger crowd, as our parish is a little on the older side, so we're hoping he'll bring in some other folks who want to have a seat and listen to him."

Tobin said he admires Tony V quite a bit as well.

"I've been friends with Tony forever. The guy has been around for a long time but he's probably one of the most respected comedians from the Boston comedy scene and he's really respected by younger comedians," he said. "I remember this Montreal Comedian of the year Just for Laughs award show and Bill

## It Is I


There's a movement afoot to boot out the word "whom" from English because it is too formal, prompting some to wonder if Hemingway might want to reconsider the wording of the title of his book about ringing bells.

Undoubtedly, Hemingway never considered the word "whomst" for his title. There has never been a word "whomst;" it's a slang way of upgrading "whom" to an elite, formal status.

Which bring me to reflect on my close friend David VonEuw, who(m) many, including myself, still miss so very much after his death a couple of years ago. As a product of Roxbury's Mission High School, he would answer the telephone and respond to a caller's query if indeed that was David on the other end by declaring, "It is I."

And he was correct. His English was impeccable. David wasn't trying to be high-falutin'; he was just following grammar rules before they were tinkered with. Remember the scene in the movie "Norma Rae" in which one of Sally Field's children corrects her over the telephone when she opens with a "It's me?"

The linking verb "is" takes a nominative case in David's and Norma Rae's sentence. The word "it" is an expletive, not an expletive as in the substitution for a profane word introduced extensively to the American na-

tion with the transcription of President Richard Nixon's tapes. The only other expletive in English is "there" as in the sentence, "There are two pints in a quart." "There" and "it" can also be used as an adverb and pronoun, respectively.

The use of "It is I" is akin to "Woe is I." The usage in both cases now sounds too formal, and it probably is. It's less formal and more relaxed to say, "It is me" and "Woe is me." But most versions of the Bible do not want to tamper with Jesus's grammar (after translation) and they present Him using the very formal, "It is I" when calming His frightened apostles and disciples.

At first glance and consider-

# Hyde Square Task Force gearing up for Raices performances

The Hyde Square Task Force (HSTF) is hosting three shows of student-led performances in theater, dance and music coming up this April called Raices.

Set for April 25-28, the shows will feature original pieces from students of the program. Director of Arts and Education Programs Brenda Rodriguez-Andujar said all performances will center around the Sacred Ceiba Tree, commonly known as the Tree of Life.

“So our young people over the course of the fall were doing research on folk tales from Latin America and the Caribbean, and what they were looking for was common themes in the folk tales,” she said. “What they saw in many of the stories, whether it was Central America, South America or the Caribbean, was the Ceiba Tree. It was a really important factor, the Tree of Life, it just kept coming up and it didn’t matter what country it was from and it was just a very important part of Latin American culture.”

Rodriguez-Andujar said they

set to work researching the Ceiba tree stories.

“Each one of the three disciplines, theater, music and dance, are going to be sharing their interpretation of these folk tales around the tree,” she said.

Rodriguez-Andujar said this is important for the kids to know and recreate the stories of their ancestors, to know who they were and what that can tell the young performers about themselves.

“They’re answering the ques-

tions of who they are,” she said. “Raices is the Spanish word for roots, so this is also digging into many of the cultural roots that many of our young people share... This is them learning about their history and stories that their ancestors have shared and communicated over the course of generations,” she said. “We have young people who were asking their family about the Ceiba tree



## Sign of the times for OPEN River group

The OPEN River (Opportunities for Enjoyment of the Neponset) River Planning Committee discussed signage possibilities for the River Street side of the Neponset River at its meeting Monday night, March 27, at the Finard Community Room at 912 River St.

A draft was released to the committee by the Massachusetts Department of Public Health ear-

lier that day for the committee’s review and feedback before a final sign would be considered for approval. The committee, as well as the larger Neponset Valley Greenway Coalition, have been advocating for multilingual signs along the Neponset River to prevent fishing and swimming in the contaminated waters for about 15 years, according to meeting chair, Vivien Morris.

Morris is the chair of the Mattapan Food and Fitness Coalition and coordinator of the

Edgewater Drive Neighborhood Association. She is also active in other community organizations, including the Neponset River Greenway Coalition.

Because the draft is under consideration, The Bulletin was not given access to the picture of the sign, which contained several proposed icons.

However, these icons were discussed, including not catching a

type of fish called white sucker. "White sucker kind of seems like a specific," said Chris Hirsch, an environmental planner with the Neponset River Watershed Association. "People don't go around asking to eat white sucker. There could be misunderstandings."

Pat Alvarez of the Southwest Boston Community Development Corporation (SWBCDC) suggested saying something about a catch and release policy, but she was not sure if an icon would properly convey the message.

"People in my community don't even know what a 'catch and release' policy means," Morris explained. "They fish to eat."

"This isn't the Cape," added Theo Collins, a staff scientist with the Charles River Watershed Association. He is a Rita Barron Fellow.

Bombarding residents with 12

symbols with things they should not do is confusing, Hirsch said. Then these symbols have to be notated in English, Spanish and Haitian Creole.

Instead, he suggested a "friendlier approach," a two-pronged strategy showing what was and would not be allowed, and why.

"We need to show that there cannot be fishing of any type, swimming and wading," he said. "There is contamination and E. coli. But there can be walking along the shore and canoeing. The goal is to have them embrace the river."

The ultimate goal for the River Street side of the Neponset River is for it to be used for recreational activities like the Truman Parkway side not that far away. But, on the stretch that runs from the old paper mill where the mini-mall now stands, up to Mattapan Square, 15

years of advocacy efforts have gone ignored until recently, members explained.

"You can see where it is located," Morris said.

"There is no attention paid to the West Street side to the Edgewater Drive side," added Alvarez. "That says something."

Once the final draft of the sign is approved by the committee after the comments are approved by the state DPH, the committee needs to determine where the signs need to be placed. The members tossed around some potential ideas.

"We need to place them at West Street, of course," Hirsch said. "Then there is the Kennedy Playground, the Ryan Playground, Paul's Bridge and the T&H Dam."

When confusion came up over exactly where to place signs, Hirsch suggested creating a GPS

application with neighborhood visuals.

"We could add in local landmarks, like gas stations and restaurants," added Collins.

"Most people know by what they see in their community," Morris said. "Even if you have a map, you need a little guidance, a little handholding."

The Townsend Hollingsworth Dam is an area of major concern. The outcome of the meeting was that OPEN River will make requests of The Department of Conservation and Recreation (DCR) and the Department of Public Health (DPH) to fence of the dam to keep people away.

"I feel it might be a DCR issue, because it is their property," Hirsch said. "DCR owns the property, but the signs are a DPH responsibility. The dam is ready to collapse."

Also, the group said the DCR will hold a celebration with Gov. Charlie Baker on Thursday, April 19 during school vacation week at 1:30 p.m. with the group. It will take place at Ryan Playground in Mattapan.

Other upcoming events include the DCR Cleanup Day on Park Serve Day with the Neponset River Association (NEPRA) at several locations. For more information, go to [www.neponset.org/cleanup](http://www.neponset.org/cleanup).

- here they are learning more about themselves, but at the same time they opening doors to learn about other people's backgrounds, it's just a way of sharing with one another."

Rodriguez-Andujar added that the kids have really worked hard all winter on the show to make it the best it can be for April.

Each performance is going to have all three pieces woven in through a wonderful story that will be shared using all three pieces and it's going to be very engaging and entertaining but also very educational, which is what we're all about."

Community Development and Events Coordinator Sarah Brugge said they will also be hosting Bailemos, a dance fundraiser for Saturday, May 12 from 5 p.m. to 8

p.m. She said it was just a way for them to raise some funds and spirits in the community.

Brugge said they will have experts on hand for those who want to learn some new moves and a social dance session for those who just want to let it all out on the dance floor.

"We have some really amazing dance instructors for salsa, Cuban movement and bachata that will be followed by social dancing so people can just listen to great music and dance," she said.





ation, the elite status of the nominative case here is obligatory. But as Bible reading takes on more substance at this sacred time of year with the advent of Easter, perhaps a rendition of the Bible should come out with the informal set-up: people might find some passages less intimidating and understandable.

And I just can't imagine the singing of the spiritual "It's me, O Lord, standing in the need of prayer" with the pronoun being changed.

If all this grammar seems to be nitpicking, you'll have to criticize the Sisters of St. Joseph, who when teaching English to us in a Boston grade school embraced poetry, short stories, spelling, sentence diagramming, and grammar, the last of which seemed to have been the most emphasized. I just don't know how they accomplished teaching all these components to what is now labeled English/Language Arts. And I know, for sure, that they would not have edited the words of Dan Schutte's touching hymn, "Here I Am, Lord."

Here I am, Lord. Is it I [emphasis mine] Lord?

I have you heard you calling in the night  
I will go, Lord, if you lead me  
I will hold your people in my heart

I, who made the stars of night  
I will make their darkness bright

Who will bear my light to them?

Whom [emphasis mine] shall I send?

said league organizer Bill Higgins.

The league takes children with disabilities and impairments and selects a volunteer for them to work with so that they can both play a game of baseball. This year's opening day is scheduled for April 24 at 5:40 p.m. at the Jason Roberts Field at the Ohrenberger School in West Roxbury. Higgins said they have kids from all over the city come to play, but they always need more help.

"I've been going out and getting sponsors to help out with the cost of running the league for the upkeep of the field, the upkeep is totally our responsibility," he said. "We've

been able to do it with tremendous sponsors from the city, we're able to have what some people think is the best field in the city."

The field itself was put together by the league and helped by then Boston Mayor Thomas Menino. Higgins said they made sure that children of any and all abilities would be able to use it.

"When he built it, he built it so wheelchairs could fit in the dugout; they're wide, and the baselines are wide, too, so wheelchair children can go," he said. "He started it with the help of the sponsors. We've been able to keep it nice, I'm very proud of that field."

Hubbard first started the

league decades ago for his nephew Jason Roberts, who was killed in a drunk driving incident in 1996. Roberts was also impaired, and Hubbard said he wanted to work with children like his nephew so they could enjoy baseball the way he had.

"Opening Day, and to be fair every day we play is always an amazing time," he said. "When I was involved in the Parkway Little League for a period of time I really enjoyed that too, but when I got involved with the Challenger program and

saw how much joy it brought to a child when they hit the ball, even when it's just 15 feet or something, they throw the bat and run down to first with a huge smile on their face. That's what this league is all about. We want to bring some joy and a sense of accomplishment to the children."

Hubbard said they are also always in need of gloves and bats. They give each child a glove and a bat every year, and they don't always get returned. The opening day festivities will include hot dogs and hamburgers and local youth to sing the national an-


