FHNA discusses welcoming JP@Home

The Fairmount Hill Neighborhood Association (FHNA) welcomed senior support organization JP@Home to give a presentation at its monthly meeting on Wednesday, April 24 at the Boston Police Academy.

Elsa Bengel, a founding member and Village to Village Volunteer of the Year, stressed that the current name is a misnomer, because the group is looking for ways to spread its wings into surrounding communities, especially Hyde Park.

"We are looking to change the name and are open to suggestions," she said. "We just didn't think Southwest Boston@Home sounded right."

The mission of the organization, which has partnered with elderly service nonprofit Ethos, is to provide social, educational and support services for people over age 65 regardless of their incomes.

Hyde Park resident Pat Alvarez said she learned about the program last fall at a meeting.

"I've been to their Soup Group, where they rotate houses and share dinner," she said. "But they also share information about all kinds of things."

She added that it is a wonderful experience for seniors who are facing the challenges of living alone.

John Wicker, the other founding member, is no stranger to Hyde Park. He is the husband of Barbara Wicker, the longtime librarian of the Hyde Park branch, who has since retired.

Bengel explained that Beacon Hill Village was the first organization of its type in the country when it started 16 years ago. Now there are 300 across the country, including JP@Home.

"We had tried to partner with them, but when they said no, we thought it would be great to start our own in JP," Engel said.

JP@Home is unique because it has combined with Ethos to provide social service expertise that the agency usually offers to low-income elderly clients to help them age in place.

"And then there's the rest of us," Engel said. "We can get physical therapy, but that's about it."

Engel and Wicker want to bring the social dynamic to Hyde Park, Roslindale and West Roxbury that they have offered in Jamaica Plain for almost five years.

The group, which currently has 150 members, has social activities like going to restaurants, tai chi and a writing group.

Hyde Park resident honored as first female recruiter for National Guard

Find yourself at a community meeting and you might run into a familiar face, Patricia Odom.

Easy with a smile, a story or a helping hand, Odom's demeanor doesn't necessarily lend itself to a military mind, but as it turns out, she spent several years serving as the first female black recruiter of the United States National Guard in Massachusetts.

"I was in the Army about a good six years," she said. "I remember coming out in '85."

Odom said it was a personal tragedy that motivated her to join up, and she said it was good to get a fresh start.

"I actually went in because I had just Patricia Odom

Barbara Baxter's Memorial Garden dedicated Longtime Hyde Park activist fondly remembered

On Saturday, May 4, the Barbara Baxter Memorial Garden was officially dedicated at the Francis D. Martini Memorial Shell Park (1015 Truman Pkwy.) in Hyde Park.

The ceremony – which took place just over a year after the longtime community activist died – drew a crowd of about 100 people on an overcast afternoon.

Those in attendance included members of Baxter's family, friends, a number of neighborhood activists, and several elected officials.

State Representative Angelo Scaccia made the dedication standing with the blooming memorial garden and inscribed stone behind him and facing the gathered audience.

Scaccia had also given the eulogy at Baxter's funeral the prior spring, and his two addresses served as bookends for the effort made to bring the garden into existence.

Baxter's death – which happened a couple of days after the official kickoff celebration for Hyde Park's 150th anniversary year - sent shock waves through the community and, almost immediately, the idea for a memorial garden at Mar-

tini Shell Park was hatched by fellow activists Martha McDonough and Rita Walsh, Baxter's two closest friends.

The idea began to take shape with assistance from different sources - including Scaccia's office, volunteers, and donations - and the footprint for the garden was laid down late last summer. Flower bulbs were planted in its bed and along the bank of the Neponset last fall.

"We dedicate this memorial to a fantastic woman," Scaccia said of Baxter during his remarks, as McDonough and Walsh stood beside him, their idea now officially made real.

Scaccia then invited those in the audience to share their own remembrances of Barbara.

A number of people chose to speak, and in so doing revealed different aspects of Baxter's life – aspects likely unfamiliar to those who only knew her in one particular capacity.

For those in the crowd who came to know Baxter as a Hyde Park activist, Valerie Burns of the Neponset Greenway Council speaking of her enthusiasm when heading out to a community project on cold, rainy days was already well known:

"Barbara would be there, really, with the kind of energy

that made us all really believe that the day was going to be terrific. And it always turned out

As was District E-18 Commander Joseph Gillespie's comment that Baxter "was the most dedicated, selfless community person I've ever met in all of the districts I've worked

And the fact that Father Ron Coyne – pastor of the Blue Hills Collaborative, which covers Hyde Park – knew Baxter was unsurprising, as well.

But the fact that he had first gotten to know her when she

was, for him, the face of the Department of Youth Services (DYS) when he was visiting teenagers there many years before he took his current post may have been a surprise for most of those present.

Just as Pastor Beth Wyman's commentary on Baxter's lifelong and deep commitment to the Hyde Park Presbyterian Church may have shed more light on just who Barbara was.

Shortly after Baxter's death, Wyman spoke of her different roles in the Church: serving as a Session member, establishing

the Baby Basics program that provides baby diapers to mothers in financial need, supporting the Church tutoring program, fund raising, and just "holding court" on Sundays as members of the congregation would stop by the church office to say hello as Baxter - a treasurer - helped to count the day's collection money.

"She really liked to see the Church involved in the community," Wyman said of Baxter that day. "That's what really mattered to her because her

Editorial

CLEAN AND GREEN

Let us now praise muddy men.

Last week, the Bulletin reported on how members of the Neponset River Watershed Association, Keep Hyde Park Beautiful and other residents joined forces to help clean the banks of the Neponset River.

Such displays of neighborhood pride are not entirely uncommon, but they are no less commendable.

We quote from the story itself: "A few dozen residents spread out along the river and Truman Highway and collected dozens of bags of trash that included the usual suspects; bottles, cans and plastic, and some other not so usual items, like car doors, TVs and toilet seats."

It adds: "Resident Edward Berry said he comes out with KHPB for most of the group's cleanup activities, and he said it's an ongoing battle to makethe group's namesake a reality. "Every little bit helps, even though it does seem like a monumental task sometimes," Berry said. "No matter how much you pick up, it's always back there in a couple of months, but we just want to keep the waterway clear."

That quote encapsulates why all this is so important and commendable an effort. Hard work may, as they say, its own reward, but this is inevitably-thwarted work. Pull the trash away, more will eventually take its place.

There is, at least, a temporary result. One can also hope that, slowly but surely, a message of deterrence is sent to those polluters.

Too often, talk of climate damage and pollution is met with a dumb shrug: "What can I possibly do about it." That is wrong-headed thinking. The truth is we can heal Mother Nature. Elbow grease is the magic formula.

Bit by bit, average people have been at the ground floor of environmental remissions. Waterways, big and small, do recover. Depleted forests do regrow. Air quality does improve. It is no miracle. Just the result of labor and dedication.

The folks who stepped up to aid the Neponset River deserve any and all praise they receive. What they did is indicative of how we reclaim our neighborhoods from the overwhelming drag of pollution and illegal dumping.

"The Neponset is just such an untapped resource," said resident Scott Kriscenski. "If we could just clean it up it would be a boon to the neighborhood. If you go just a few hundred yards that away in Milton and look at it, it's pristine, there's a bunch of wild-life and it's just beautiful, here and come close to any roadway, it's just littered with everything, there' no regard for nature."

When is a drop-off not a drop-off?


semi-public agency that was recently disclosed as having paid 300 of its employees more than \$100,000 annually—tries to relieve vehicular congestion at Logan, it has relegated Uber and Lyft drop-offs to inconvenient central parking. The good news is that luggage handling will be available there. Thus a family with young ones in tow will have baggage help reaching their airline. Hopefully, passengers with legitimate disabilities will be dropped off at curbside, saving them from having to navigate walking to their airlines.

As a former cab driver for a few months a number of years ago—Town Taxi, I'm proud to say—I have a loyalty to taxi drivers. Therefore, it is with no small amount of pleasure that I am aware of cabs still having access to curbside drop-offs, unlike Uber and

As MassPort—the same Lyft. But I'm perplexed about limousines having the same, if not more than, the "privileges" offered to cabs.

Limos are allowed where only taxis can venture. This seems to favor the very rich who can afford such transportation to East Boston's primary destination. Thus highly paid athletes, entertainers, and politicians who arrange to be transported by limos do not have to suffer what a family of four heading to Disney has to endure with their central parking disembarking.

True, not every group heading to Logan in a limo is from the upper tax brackets: sometimes people heading to vacation want to start off in an elegant style by hiring a limo and toasting their upcoming getaway with champagne. But for the most part parties heading to Logan in limos are privileged: why should their pas-

Dorchester . However, I lived nearly the Dudley Station retail district where you had many stores to shop with so many products for sale.

Shoppers traveled into Downtown Boston for larger items. However, a lot changed over the decades. Dudley, Uphams Corner and Fields Corner are never coming back to the way it was in 1959 or 1970 and this reality must be recognized by community leaders who are looking for some false renaissance that most likely will never return.

We all shop differently today. Many younger folks shop online. Rarely do they go shopping at brick and mortar stores. Even the malls, which killed downtown business areas, are failing in this current state of shopping we live in.

I recently read that many in folks my neighborhood are sounding the alarm that 8 storefronts have shuttered their doors up by Dudley Station in under a year. Advocates are signaling the alarm that an 'economic crisis' is at hand and must be taken seriously.

When the City of Boston took over the site of Ferdinand's Furniture store and leased most of the space in the building as the new Boston School Department HQs, it was hoped by local politicians and community leaders that this move would restore life to this once business center of commerce. It hasn't and probably never will do the trick.

"When you're in a crisis, you don't know where to go," Wicker said. "This group and the support of Ethos provide a safety net."

Members choose the social activities, according to Wicker.

Dues of \$25 pays for a program coordinator at Ethos to answer specific questions and link members to services.

"It's not just about medical stuff," Wicker said. "It's about shoveling snow, gardening and getting help at the house. Anything to help someone age in place."

David Johnson, a Hyde Park resident, spoke about a group he started called the Friends of Truman Parkway.

"I moved from Quincy three years ago," he said. "I love it, but it is not maintained."

Johnson "rode up and down Truman Parkway," describing litter and conditions where it was not accessible. He detailed his findings in a report, which he presented to the Department of Conservation and Recreation.

"The state allocated 1.5 million to put up speed signs and

make some improvements," Johnson said. "But once (cars) come up Fairmount Ave., they belt up towards Mattapan."

He encouraged FHNA to "band together" with his association.

Chair Joe Smith encouraged this, and also mentioned the efforts of Keep Hyde Park Beautiful in environmental education and combatting litter.

Smith announced a number of upcoming community events, the most important being the dedication of a community garden in memory of community and environmental activist Barbara Baxter, who passed away a year ago last week.

Baxter's two closest friends and helpers, Martha McDonough and Rita Walsh, described Baxter and the garden planted in her honor. The ceremony took place on Saturday, May 4 at the Martini Shell at 1015 Truman Parkway



The Hyde Park Neighborhood Association (HPNA) met on Thursday, May 2 with attendees showing keen interest in any follow-upfrom Mayor Marty Walsh after his visit to the April 4 meeting.

During that meeting, Walsh promised to look into the specifics raised over the 11 Dana Ave. project. Many in the community are angry over what they believe is the improper zoning of the development and the mayor said he would check with the Boston Planning and Development Agency (BPDA) and get back to HPNA President Jim Kirker.

"The mayor did not get back to me,"said Kirker. "I sent him an email, thanking him for coming. I told him I thought it was very successful." Kirker went on to describe the Dana Ave. building as literally not having a first floor and that the design needed to be reevaluated. "What's going on, in my opinion and others' opinions, I call it a gerrymandering...this is a gerrymandered building. They are doing it to skirt their responsibilities to put in affordable housing in this building." Kirker added that the building needs variances which they should not get. "I wrote another email to the mayor about 10 days after that asking if I could get a response before this meeting. I did not get a response", said Kirker. "That's where that stands as far as what I have done."

Craig Martin said that he spoke to the mayor at the coffee hour hosted by the city in Hyde Park on Wednesday, May 1. Martin said he arranged it so he "bumped" into the mayor and reminded him that a month ago he said he would report back to the HPNA on his findings. Martin said the mayor's chief of staff is supposed to get back to the group with information. "So, this is an on-going thing," added Kirker.

Concern continued over the city's development process as George Perry also asked to speak and expressed his dissatisfaction with the zoning organizations in Boston. "The Board of Appeals in Boston is a corrupt organization. The



BPDA is rogue. Don't trust them. The Board of Appeals should not pass another variance." Perry argued that Hyde Park was being torn apart. Joe Smith from the Fairmont Hill Neighborhood Association agreed that a lot of what is going on in zoning is outrageous and that Hyde Park was lucky to have Craig representing it.

Other business at the meeting included the results of the election of officers for the HPNA. "You can say that everyone who was unopposed was re-elected," Kirker joked, indicating that incumbent officers will retain their current positions for another year: Jim Kirker as president, Ralph Costellesso as vice president, and Denise Dodds as secretary. Val Mayo is the new treasurer.

Under new business, Elliot Beale, the owner of Only One Jamaican Restaurant in Dorchester and Brockton spoke to the group about his plans to open a third restaurant in Hyde Park at 1345 Hyde Park Avenue. "Since 2003 we've been operating take-out, breakfast, lunch, and dinner," he said, referring to his Dorchester site."In 2017, we went on to Brockton, operating in a second location."Beale said that a restaurant in Hyde Park was something he wanted to do, though it is hard with two other restaurants, but his son, Rick Beale, is "young and ready" so he wants to move forward. There will be 49 seats in the proposedfamily restaurant that will serve lunch and dinner.

Beale noted that he asked to speak at the meeting so he could tell the community first. The mayor's appearance at the last meeting precluded him from announcing it earlier. He originally hoped to open in early June, but the city is saying six weeks, so the grand opening might be delayed to late June.

Smith advised, "The city is very slow on getting the approvals together, regarding a liquor license." The audience applauded the opening of a new restaurant. Some offered to advocate on Beale's behalf if there are any delays. "If the city tries to stiff you, come to this group," said Perry.

Smith spoke about the Keep Hyde Park Beautiful initiative.He asked for volunteers to help plant flowers in the community."This is a terrific way to meet people. They are all like-minded. If you are interested, look online, and we can always use the help. I encourage you to join us if you

Smith went on to say he is also hoping to help organize a District 5 candidates' night. He will coordinate this with other neighborhood associations and the public library. More information will be forthcoming.

To the Doctor: I recently purchased a 2018 Toyota RAV4, and am very pleased with it. But one issue I have is that the headlights don't do a good job lighting up the road ahead. Personally, I think part of the problem could be the body design with the headlights placed too far back. I'm thinking that I have three options: adjust the headlights to a lower point; install an LED headlight kit with brighter bulbs; or install fog lights. What would you advise?

From the Doctor: I get a lot of complaints from drivers who are not satisfied with their headlight illumination. There are a couple of options that are not very expensive. You can buy LED or Sylvania high-output replacement lights. There are also small additional driving lights that can be mounted on the front fascia. If your vehicle has fog lights, or a cutout for fog lights, this can make a great mounting area. If equipped, you can sometimes replace the fog lightbulbs with the LED style. Whatever you choose, the bulb you purchase should be a direct plug in, not the older style LED that requires additional wiring. LED bulbs are very bright in color and very cool in temperature. In some cases they are so cool the snow will not melt off the lenses.

To the Doctor: I currently own a full-size pickup truck with 4WD, but I am looking to downsize to a compact truck. Is AWD comparable to 4WD? I like the 4WD for driving in snow. Would AWD react the same in snow and slippery ice-covered roads?

From the Doctor: AWD systems do not require any driver input. Some AWD systems have a button to lock in the AWD system while others do not. Some AWD systems have a center differential that splits the traction from front to rear and others have smart AWD that will send power to wheels with the most traction. I have three AWD vehicles with no problems. The AWD systems of today do not wear the tires as much as older systems and the gas mileage difference is minimal.

And with that, Vance made an educated guess based on that Rainbow Girl experience:

"I think she just kept going." Others commented on their own relationships with Baxter.



lost my husband," she said. "We had just had our son, and we got married July of '74, our son was born in July of '75 and I went in at June of 76'. It was my way of getting out of Boston. It was like, I've just gone through such tragedy and the only thing I want to do now is get out of Boston and start a new life."

Odom said she trained with the regular U.S. Army in Columbia, South Carolina in January of 1977. She said she came back home and felt like going full-time.

"I really liked the military life, and it just so happened that someone in the recruiting office saw me and said, 'you know you're just coming home, and you should think about us, we have a full-time army position available and you should apply."

But as one might expect, she didn't have the job right off the

"And so I went for the interview, and it was probably about 15 high ranking people in the room, all men, and I walked in well-dressed with my uniform on and heels - the whole nine yards – and the first thing that came out of their mouths was 'a lady?" she said. "You need to be home having babies, this is not a job for you.' I said hire me, I guarantee you I know what I'm doing."

After about a month, they hired her. She said she shipped out to Indiana for training and then the next thing she knew she was heading out to high schools and colleges to recruit young soldiers.

"I was jumping out of helicopters and doing all sorts of things to impress students," she said, adding that it wasn't a parachute jump, the helicopter would almost land and she would jump out. "You go to recruit students anywhere where there's a big area to constantly talk to get people to join the military. So the helicopter would fly into the school and there I'd be and kids would be like, 'wow that's impressive!""

These tours constituted the majority of her outreach to students.

"You got to remember during that time they did not have social media or the internet or cell phones and all of that so a lot of things they had to do to bring people in would try to get people's attention," she said.

Odom said a lot of times she got some push back from schools, but not because she was a woman, but because of the anti-military sentiment of the time after the Kent State Shooting.

"They were like 'we don't want that here' and I would have to convince them that it wasn't like that," she said. "And so, after six months on the job, they thought I was the best person for the job they could have ever hired."

Odom said she had been featured in newspapers and the Stars and Stripes – the U.S. Armed Forces Newspaper – as one of the nation's top recruit-

"One thing I did was I was honest about the military, and that was very important," she said. "Some people would lie about the military, they'd tell people you can do this or that and you really can't. You have to take an exam to get in and that will inform your career path while you're in the military. I would tell them the truth and explain to them the benefits. If you qualify, these will be your benefits, but not only that they would see how I had grown in the military, my looks and achievements and people would say 'I want to be like

her."

She said she regularly filled her eight person a month quota, and during that time she received a lot of rewards, certificates and trophies. She said she later got remarried and decided to leave the Army to raise her family, but not after attaining the rank of an E-7 Sergeant First Class.

She said last week, the State of Massachusetts sent her a certificate of recognition of that

"That's how I was brought up, you do something right or you don't do it all," she said.

However, mistakes happen, even in the military, and the certificate she originally received said she had only attained the rank of an E-6 Staff Sergeant. She said she had to send the State of Massachusetts her discharge papers to prove her actual rank at the time of her discharge.

"When I saw this, I was like 'oh no, they're going to have to do this over," she said. "If you've never been in the military I'll tell you, rank means a lot. It means money, it means authority and it's who you are..."I earned that rank and I worked very hard, it's very hard to get rank in the military and to go in at Sergeant status? That's not easy. I worked very hard for Sergeant First Class, and you have to respect people and get respect to do that. That's what the military is all about, respect. You're in a leadership position, and so therefore, I asked them to redo the whole thing."

Odom said she then went to work in the Boston Public School system as a teacher and is now retired from that as well. She said her military experience definitely gave her an air of authority and helped her in her classes. She's now a community activist and organizer, working with several community organizations throughout Hyde Park, most especially the East River Street Neighborhood

solutely make it an annual event."

Luna said the funds would be used to procure new computer/mobile applications for the kids to use when they're away from school to hone up on their skills.

"One of the learning activities they do is an online application for reading and math programs," she said. "All of our kids, grade K through 8 will have access to that."

Race Director Macy Donaway, who runs a race timing company with her husband on the weekends, said they've helped coordinate hundreds of races thorughout New England, but being Hyde Parkers themselves, she said they felt it was weird that their neighborhood didn't have anything, until now. She said neighborhood organizer Pat Tierney connected them with the Roosevelt Friends Group.

"We always wanted to do something in Hyde Park, and she sent them our way," she

Donaway said they are still waiting on several donations, but as of the date of publication they have raised more than \$3,000 from the event for those learning applications for the kids.

"It should be close to \$4,000 with those donations coming in," she said.

Donaway said the area of Hyde Park presented a unique challenge in setting up the race. She said they wanted it to be local, but also accessible. She said in order to do that they had to work with the Massachusetts State Police, the Massachusetts Department of Conservation and Recreation and the Boston Police Department. She added that the BPD District E-18 officers helped out especially.

"Sgt. Dan MacDonald understood the value of the 5k race and had been involved in races elsewhere, and he was instrumental in getting the police detail donated for the race as part of the BPD Community Service Initiative," she said. "Just to see that they valued the event and wanted to have something in Hyde Park and were willing to do that was really outstanding. We were really lucky to have Sgt. MacDonald."

Residents from all over the area came out, and not just parents either. Resident Anthony Haley, and chef at Bacaro, said he came out because he believed in the school and his community.

"So people who work at the restaurant had a team and I thought I'd support the community," he said. "We're really tightly-knit here,

everybody's coming together and I thought it would be a good one. I mean it's the first one ever. The race was good and the weather kept me cool when we were going too."

Residents Kevin James and Jua Robinson said they have kids going to the school and they wanted to make sure they did what they could to improve their experience.

"I mean, we made it through so it was definitely a good race," said Robinson.

District 5 City Council Candidate Maria Esdale Farrell (and current education adviser for current District 5 City Councilor Tim McCarthy) said the school creates a community around itself. She said she came to support the race even through her kids aged out of the school.

'You know how once you're a Marine you're always a Marine? Well once you're a part of the Roosevelt, you're always a part of the Roosevelt," she said. "I don't even have kids there anymore but it's been like 13 years here and it means everything to be part of that community."

Residents John and Karen

May Sarno said they took their time on the course, and were happy to support the local school.

Many local businesses have sprung up in the street-level areas of this restored building and in the surrounding area, but many have failed and many more still face the same demise. Small business was once the anchor of this retail district and there is still hope it can survive there. I am sure the high-cost leases are probably not helping matters when little folks in business have such a narrow line of profit. You can't stay in business if you're losing money.

A local developer has suggested building something called Teachers Place, a development priced for working families, city workers and such, and this sounds good. It would be built upon the parcel of land that once held the old Boston Police B-2 station. Bringing in folks to live nearby can only help with bringing back the prospects of restoring the Dudley Area to some of its past glory. It would be a good step.

The problem for Roxbury remains that City Hall doesn't seem to know what to do about creating a long term vision. There is a Roxbury Master plan but, to date, it seems just a piece of paper with words printed on it.

Rev. Theodore Hesburgh, president emeritus of the University of Notre Dame said, "A vision without resources is a hallucination." I'm thinking the Roxbury Master plan might qualify as a hallucina-

If we wish to rebuild neighborhood centers of commerce and rebuild Downtown Crossing, we need a vision and the will to do something about the status quo.

More meetings aren't the answer. More will from City Hall is needed. That only happens when citizens demand real action and not more pieces of paper with nothing on it but the same old same old things.

Communities should be about finding ways to say "yes" to the needs of their residents, perhaps especially with regard to public education – and never more so than now. The challenge of meeting significant community need is rarely riskfree, yet this is a case in which any potential risks are, I believe, substantially outweighed by the benefits.






