## Property on Sprague Pond considered – if owner will sell

The Boston City Council's Committee on Environment, Resiliency and Parks met on Friday, Dec. 3 to accept a state Parkland Acquisitions and Renovations for Communities (PARC) grant of up to \$387,164 to help fund the acquisition of two parcels on the western shore of Readville's Sprague Pond.

The only caveat is that the parcels are privately-owned, with the owner already having completed several steps in the development process to build three condos on the property.

Committee Chair and District 6 City Councilor Matt O'Malley presided over the hearing on the property, located at 0-4 Lakeside Ave. The grant money would be used to purchase the land and declare it a permanently protected park.

It would be named the Sprague Pond Shoreline Reserve.

In October, Sprague Pond was officially designated by the Department of Environmental Protection (DEP) as a "great pond." This means that it contains more than 10 acres of land in its natural state.

The grant money was awarded by the state's Executive Office of Energy and Environmental Affairs Division of Conservation Services, Parkland Acquisitions and Renovations.

District 5 City Councilor Ricardo Arroyo joined the hearing briefly to express his support for the land acquisition via the grant money.

"These two parcels have historical significance," he explained, noting they

## Shootings, residents' doors unlocked causing problems

The Southwest Boston Civic Association (SWBCA) met on Dec. 1 in a virtual format and discussed incidents of crime with representatives from the Boston Police Department (BPD).

The discussions focused on the two districts that comprise the neighborhood association. Those districts cover West Roxbury and Roslindale (E-5) and Hyde Park, Roslindale and a bit of Mattapan (E-18). Crimes they discussed took place over the past two months.

Starting with the bad news, District E-18 Community Service Officer Paul Broderick said there were several shootings in the district over the last month. Broderick started with the shooting first reported on Oct. 10 at 6 Ayles Rd. around 3 p.m.

"There was a radio call for a person shot and the victim was found on the


ground with gunshot wounds," he said. "He was deceased. Homicide is investigating this. This was a targeted shooting."

The next reported targeted shooting Broderick discussed was on Nov. 22 at the intersection of Maple Avenue and Walnut Street around 10 p.m. The victim was apparently found shot in the abdomen, driven to the hospital and later died. Homicide detectives are now investigating the incident.

Broderick also reported a non-targeted, apparently accidental shooting to the neighborhood first reported on Nov. 10. He said the shooting took place on 217 Wood Ave. at around 10:30 p.m. He said the victim was shot randomly after the assailant approached him and asked him a question. When the victim didn't

## Wayfinding signage coming to Egleston Square

Egleston Square became a crossroads in 1898 when Columbus Avenue was extended from Northampton Street to Walnut Avenue.

This was built with center street-car tracks and catenary poles for electric cars and in November 1909 those surface cars connected to the Boston elevated (Orange line) station and Egleston Square became a transit




# A plea from Matthew

The title does not mean St. Matthew, who is referenced a lot at this time of year, as in "Now when Jesus was born in Bethlehem of Judea, in the days of King Herod, behold Magi came from the East ..." This is Matthew White, who for many of us is The Recycle Guy. Driving one of the large yellow but sometimes white compactor trucks for Capitol Waste, he arises around 3:30 AM on most weekday mornings to do his long route throughout West Roxbury, Hyde Park, and other parts of the city, elevating the 96-gallon blue toters into his truck.

With his ever-present sunglasses on and his baseball cap worn backwards, he takes pride in contributing so much to our city (by saving on landfill volume) and by carrying so much back to be recycled. Many times the hydraulic extenders on both side of the expensive truck are not working, meaning that he has to jump out of the driver's seat to position the large, blue totems on the mechanical lift.

Here's comes the bad news: some people throw ANYTHING into the recycle bin—all violating the directions on the totter. Such deposits have been done by careless, if not malicious, residents. But what he needs help with these days preceding Christmas concerns well-intentioned people who place styrofoam into the blue totems. Such people are under the misconception that just because their television, video game, and so many other items delivered by UPS, Amazon, FedEx, post office, and DHL arrived in card-

board boxes with styrofoam bracing the contents against bumping, that the said Styrofoam must be "good." Wrong. Styrofoam, whether in the form of peanuts or rectangular prisms, is mentioned first on the lid of the totem as not being recyclable. So don't increase the volume on his trucks by not taking the time to remove the Styrofoam and breaking down the cardboard; plus, it has to be removed on the conveyor belts at the recycling facility in Charlestown.

Speaking of gumming up the works, don't throw plastic bags into the recycle bin: they are to be excluded but can be recycled at Roche Brothers and Loew's, among other places, where plastic bags are placed to be taken away to be recycled.

Here's hoping that all the people working on recycling have a Merry Christmas, one devoid of styrofoam.

transfer station.

The elevated is gone but that surface transportation route on Columbus Avenue serves three of Boston's busiest bus routes: the Number 22, 29 and 44.

And as of Dec. 1 the Number 29 bus will be free for the next two years.

Just as electrified elevated trains were cutting-edge transportation in 1909, so is the state's first bus-only lane that opened with enthusiastic fanfare on Nov. 4, 2021 through Egleston Square from Walnut Avenue to Centre Street and Jackson Square and the replacement Orange line.

Carolyn Royce of the Egleston Square Neighborhood Association (ESNA) joined then-mayor Kim Janey and MBTA general manager Steve Poftak at the ceremony.

"This is a very important gain for Egleston Square," she said. "It's innovative, it's new, it's exciting and it's brought some welcome public investment to Egleston Square."

The busway with four new center lane bus shelters gets riders through Egleston Square; the next phase of investment is planned to improve how residents get around in Egleston Square.

As William Moose of the Boston Transportation Department (BTD) —who was the city's project manager on the busway—described it in a November 2020 virtual public meeting, the next phase of investment would be the Egleston Square wayfinder directional sign program.

That wayfinding program is getting underway and Laura Moule of BTD came to the November 1, 2021 ESNA meeting to explain that with the busway completed, a survey for the program would begin.

It would be the first signage program of a business district in Jamaica Plain.

The wayfinding signs would be funded through the Egleston Square infrastructure budget through which the busway was built.

BTD defines Egleston Square as bounded by Boylston

High School, but the Peace Garden has been fenced off since Nov. 14 and is up for sale.

Also among the questions residents will have a chance to answer is the connection from Franklin Park to the Southwest Corridor Park which is considered important to the BTD wayfinding program.

That connection should be accessible for both walkers and bicyclists.

School Street is the obvious route since it lines up with an original park entrance and El Parquecito de la Hermanadad playground.

Columbus Avenue at the Walnut Avenue park entrance steps is the most direct route since it lines up with Atherton Street that runs straight to the SWC Park.

The survey will allow residents to determine the best route for the neighborhood.

The planning and design process for the signage is being done by Kittleson Associates and Mary Saunders is the project manager.

The signs will include destinations with a logo, directional arrows and the length of time to get there by foot or on a bike.

According to Moose, the sign approval and fabrication will be completed at the end of winter 2022 and be installed that summer.

Among the destinations will certainly be the three new bus stations within the center of Egleston Square at Walnut Avenue, Weld Avenue and Bray Street.

These have electric signs that list the routes and arrival time of each bus.

The busway opened for operation on Oct. 30 and Andrew McFarland of the MBTA said at the Nov 1 ESNA meeting that he was encouraged.

"We're working pretty closely with the city on this," he said. "From a bus operator's standpoint we've gotten positive comments. This is the first time that the T has done this in the system. It's doing pretty well."

# Transcript Tab calls print quits

The West Roxbury Roslindale Transcript, which had a few years ago combined with the Allston Brighton Tab, announced recently that it has suspended its print edition of the dual paper since Dec. 1.

According to a 1970 historical publication by Richard Davis, the paper started publishing in Roslindale in 1930. Davis' Recollections of Roslindale stated the paper was a joint venture between he and the wealthy then-owner of the Dedham

Transcript, Charles M. Cox.

"He wanted to start a paper in Roslindale," the essay read. "He came down to see my father, and asked him if he'd be interested. My father said no, he wasn't interested, but he said: 'My son, you see him, I know he'd be interested,' and my father pointed to me up in the store. When Mr. Cox approached me, I grabbed at the opportunity. I was going to Northeastern University, but I said I'd be very glad to work with him. So he gave me a job, and they gave me so much an inch for whatever I'd

do."

While the Transcript Tab won't be ending its digital services, the last print edition left the printing shop on Dec. 1. A release from the paper states that this decision will help them to deliver more local news.

The Bulletin Newspapers will continue to report on these four neighborhoods every week. According to Dan Kennedy's Media Nation blog, more and more Massachusetts papers owned by Gannett (and its subsidiary Gatehouse) are shutting their print operations.

### LETTERS LACKING IN REALITY

The letters to the editor in the December 2 issue of The Bulletin could not have been in sharper contrast over the issue of parking spaces in proposed developments. On the one hand writer Robert Orthman decried the ZBA decision to deny a permit to the proposed development of 4198 Washington Street in Roslindale Square based on a lack of parking, and on the other hand inveterate writer Sal Giarratani decried the approval of any developments that do not have "sufficient parking" spaces. The latter thinking can best be described as lacking in any relation to reality on several crucial points.

First, rising housing prices are primarily

the result of short supply, which is exacerbated by the incessant demand that more parking spaces be provided. Second, it is astounding that there exists a perception that everyone owns or wants to own a car. In fact, a great number of people do not own - in particular those of lower income, the very people hurt most by high housing prices. It is past time to end the 20th Century notion that everyone should be driving a car. Indeed, our survival on this planet is directly dependent on reducing our addiction to carbon dioxide spewing and congestion creating private transportation machines.

are part of the land where the Massachusetts 54th Regiment, the first Black volunteer regiment to serve in the Civil War, had been encamped.

Rep. Rob Consalvo of Hyde Park also supported the effort. He and state Sen. Mike Rush previously coauthored a letter in support for the state designation as a great pond.

"This is a hugely important issue for Readville and Hyde Park," he said. "And that great pond designation brings so many protections to Sprague Pond."

"This land around Sprague Pond is under threat of development by a private owner who wants to build units of housing on it," Consalvo acknowledged. "While we support housing across the district, this particular piece is so important to protect through this grant because of the historical nature of Sprague Pond and the land surrounding it."

Aldo Ghirin, the senior planner for the city's Parks and Recreation Department, said that this land acquisition has been a "long-term goal of the city," citing a 2011 strategic plan for Hyde Park completed by the Boston Redevelopment Authority (BRA), now known as the Boston Planning and Development Authority (BPDA), that referenced "a Sprague Pond waterfront park."

"It has the potential to be a nationally significant historic, cultural and archaeological resource area," Ghirin said.

City funds through Community Preservation Act (CPA) revenues will also be allocated for the purchase, he added. He explained that he needed to get authorization for the funding before speaking to the owner, upon the advice of the city's counsel.

City archaeologist Joseph Bagley said this land was the former home of the Massachusetts Tribe at Ponkapoag. He flagged the land as an archaeologically sensitive site of historical significance both for Indigenous people and because of Camp Meigs, where the 54th Regiment was encamped.

Bagley explained he had no authority to perform an archaeological survey on the property currently because it is private. However, he said he would "take it on as a community archaeological project" if acquired.

"We really need to do this," O'Malley said. "It's really heartening to see the work of the city and the state coming together. This can be an incredible destination and place of learning and place of remembrance."

But there was not unanimous enthusiasm for this proposal. Belnle Family Neighborhood Association (BNFA) President Helena Tonge expressed concern that the property owner had already received approval for development of the three condos from the BPDA, the Zoning Board of Appeals (ZBA), and the Boston Conservation Commission, which was not referenced at the hearing.

"What I've noticed over a period of time in my position and as a resident is there's no cross-conversations with these departments when critical deci-

sions are being made," she said.

Tonge also questioned why, considering the frequent mentioning of the 54th Regiment and the Massachusetts Tribe, that these groups were not part of this conversation about the land acquisition.

Proposed space for the 54th Regiment reenactors has been discussed for location in The Pryde, the LGBTQ-friendly elder housing development that is being built on the site of the former Rogers Middle School, rather than on the site of Camp Meigs, she noted.

"There are descendants here that are living, breathing entities," she stressed. "Who gets to tell the story? Who gets to decide what goes into spaces and how those spaces are designed and discussed?"

Frank O'Brien, a community environmental activist, agreed that Tonge raised good points.

"The goal is to have a willing seller at the end of the day, and this grant helps accomplish that," he said.

Darius Gregory of Gregory Investment Group, the property owner, was the last to testify. He spoke of O'Brien's conservation effort here in less than glowing terms.

"He may be a champion to some," Gregory said of O'Brien. "But in my case, for lack of a better word, he is somewhat of a nuisance because of what he's done to prevent this development from moving forward."

Gregory added that he and his partner "have spent hundreds of thousands of dollars" going through the approval procedures prior to construction. He said he would be willing to sell it "if they are willing to agree on terms."

"To date, I don't see how they are going to fill the gap that needs to be filled," he said.

O'Malley said that the procurement process will be transparent. He hoped that the City Council would approve the measure at an upcoming meeting.

answer, the assailant shot him.

Broderick also detailed several other thefts including package thefts, a marijuana bust and a few vandalism reports. Broderick said in overall crime, the district is down 18 percent.

Broderick also detailed several other incidents including, but not limited to, a fight at the bus stop involving students of Boston Prep, the tasing of a resident at a gas station on Hyde Park Avenue, a robbery of a cell phone and motor vehicle from a woman at Braywood Road, a breaking and entry theft of a wall air conditioning unit from the construction site at 11 Dana Ave., a stolen Lexus off of Hyde Park Avenue, and another motor vehicle stolen while it was left running outside.

This lead into the E-5 crime report from Community Service Officer Ed Roach. First and foremost, on Nov. 27 an intoxicated 27-year-old male found his way into the bedroom of a young girl on Gloria Road. The girl was sleeping in her parents' room that night, but after they had breakfast she found someone in her room she was not expecting.

"This just shows you the importance of locking things, not just cars but also your houses," he said. "The family was downstairs in the morning and the girl comes back and said 'There's a man sleeping in my room.' The night before, the daughter had slept in the parents room and had proceeded to go into her room that morning, and while

they were sleeping someone came in, obviously intoxicated because they thought they were in the house of a girl he knew, and it was a 21-year-old male. The police came and he was arrested, but that shows the importance of at least keeping your house locked when you're sleeping and at your most vulnerable."

Roach also detailed several motor vehicle break-ins which occurred almost exclusively in vehicles that were left unlocked.

There was an uptick in larcenies from vehicles, especially in West Roxbury," Roach said. "There were 13 in West Roxbury, as opposed to eight in Roslindale. I believe every

single one in West Roxbury was unlocked and I think everyone but one in Roslindale was unlocked and people leave things like expensive cameras and laptops and decent amounts of cash – I don't know why these people are doing it – but that's a continuing problem we never seem to get over, people never willing to lock their vehicles. If people locked their vehicles, these 20-plus incidents might have been only a couple."

Roach said also that there was an incident at Eagle Street on Nov. 14 where the victim reported they were out shopping and saw a notification on their Ring doorbell. They came home to find the intruder in the house. The victim asked what he was doing there, and he said he was helping her husband

paint the house. He fled out the door.

"The crazy part is the police responded and then the guy came back with his wife and daughter," Roach said. "The wife (of the suspect) brought her husband back to the scene of the crime so he could be arrested."

Roach said the Drug Unit made an arrest at Stonybrook Commons, where they per-

formed a search warrant.

"They made two arrests and seized over 250 grams of fentanyl, which is over a half a pound," he said. "Fatality involving fentanyl is in the micrograms, so that shows how much that is. In total there were 10 other arrests from the drug unit, and it was pretty much spread out. There were four in Roslindale and six in West Roxbury."



"We actually received more than that but of those received only 81 were eligible," she said. "I just want to thank the public. A lot of folks took time out of their busy schedules to apply for a position to serve the community. This is an incredibly important role for the City of Boston and I want to thank all those who put forth their names."

Those being submitted include Mona Connolly Casper of South Boston, Maria Dolorico of the South End, Anne Hernandez of Roslindale, Luis Lopez of East Boston, Zachary Lown of Roslindale, Carrie Mays of Dorchester, Tara Register of Roxbury, Chanda Smart of Roxbury and Benjamin Thompson of Dorchester.

Campbell did say the re-

sponsibility of appointing three of the nine nominees lies with the mayor, but they are asking Wu to consider further action once the selection is made.

when she chooses three of these persons to nominate, she should let the council know what her decision-making involved," she said. "So we can report that back to folks who were not selected so they can stay engaged in the process and, if seats do become available, they can reapply and be reconsidered to fill in if someone is ineligible."

The OPAT is designed to be a separate review entity for the Boston Police Department (BPD), and since the passing of its associated ordinance earlier this year, it will have to form two oversight bodies, one to deal with internal affairs complaints and the other, CRB, which will deal with civilian complaints against the police. The CRB will have the power to refer incidents to the OPAT for investigation, conduct their own investigations, make determinations in regard to complaints set against the BPD, review relevant complaints, review any incident where a Black person, indigenous person or person of color is fired from their job or disciplined at the BPD, investigate allegations of disparate treatment of workers or officers of the BPD, and make recommendations to the Police Commissioner regarding complaints brought to the Board.

District 6 City Councilor Matt O'Malley said there was not a mandated process in the ordinance on how the council was supposed to select its appointees, but he said he is happy with how it turned out. He said the council tried to put conduct as transparent a selection process as possible, and he believed the number of applicants showed that.

"Not only did we have an online portal, but we made sure that language access was at the forefront by making sure the application was translated into Chinese, Cape Verdean Creole, Haitian Creole, Spanish and Vietnamese. We had a very open process, and I know that all of us here reached out to our networks to try to make sure we had more folks involved. The result was not only 80-plus candidates, but 80-plus really qualified candidates. The hardest part was trying to winnow that down to nine."
