## St. Theresa's, St. John's to commence collaborative Father John Carroll to retire

St. John Chrysostom Parish and St. Theresa of Avila Parish will be entering into a collaborative starting Sept. 1. Fr. John Carroll, who is currently the Pastor of St. John's, will be retiring, after having served the Archdiocese of Boston since 1984 and being a member of the Franciscan T.O.R. community for 17 years before that. He will be celebrating his farewell Mass on August 30th, at 10 a.m. in the church yard, with a reception following.

Fr. John Connolly, who is currently the Pastor of St. Theresa's, will also be serving as the Pastor of St. John's. He previously served as the Administrator for St. John's from 2013-2015. He has currently served at St. Theresa's for as long as he previously served at St. John's, which he takes as a "sign from the Lord of His particular Blessing" for this new collaborative. Fr. Carroll says that St. John Chrysostom has undergone difficulties due to COVID-19 and has had to take out multiple loans. He says that the collaborative will make the two parishes "become stronger."

"I can't put into words what it has been like for me here. I have had some great times with you, two trips to Europe, and our seasonal bus trips," Carroll said in a recent letter to the Parish. "The many prayerful and religious services for the different seasons of the church and of course I just liked decorating any prayerful space over the years. There were many structural and cosmetic things done to enhance our parish. We got a parking lot, fixed the frame outside of the pastoral center, replaced windows, and

## Preliminary Injunction against Burger King opening denied

The preliminary injunction against the opening of the Burger King at the Shops at Riverwood Plaza was denied in a decision on Friday, Aug. 21, after two previous hearing continuances and a postponement. It came before Suffolk Superior Court virtually in a hearing over Zoom on Wed., Aug. 19, with 25 people in attendance.

After more than an hour of arguments, the Hon. Anthony Campo decided to take the matter under advisement before issuing the decision.

Plaintiff Helena Tonge, the president of the Belnel Family Neighborhood Association

(BFNA), announced the decision in an email on Monday evening, Aug. 24:

"At this time, we do not have the written decision of the judge and will share when received," the email stated. "On behalf of the community at large, we will continue to address and weed out the travesty of environmental injustice that targets and plagues communities of color - our LIVES depend on it!"

The battle over Burger King has been a whopper for the community since January. Arguments have been made that the franchise would bring a needed restaurant to a commu-

## Committee votes to support Pine St Housing

Agreeing with Sarah Horsley that Monty Gold's lawsuit against Pine Street was "very un-JPlike." The JP housing committee voted at its Aug. 18 virtual meeting to send a letter urging that the suit "be resolved as soon as possible" and reiterated its "strong support for the project itself."

However, it was not clear to whom the letter should be sent, as a letter to the editor to The Gazette and The Bulletin, to Boston Planning and Development Agency (BPDA) director Brian Golden, or both.

The housing committee also heard the first public presentation by partners Jamaica Plain Neighborhood Development Corporation (JPDNC) and New Atlantic Development for its proposed five story, 39-unit senior housing at 3171 Washington St -- directly opposite the Pine St Inn housing.

Jamaica Plain Neighborhood Council member Car Carolyn Royce opened the meeting by asking for comments on the lawsuit against the Pine Street Inn/Community Builders proposed six-story, 225 fully income-restricted housing development/

# Parkway Rallies to Save the USPS

West Roxbury and Roslindale community members gathered at the West Roxbury and Roslindale Post Offices on Saturday, Aug. 22 in support of saving the Post Office. The rallies were hosted by Progressive West Roxbury/Roslindale and were part of the national movement #SaveUSPS.

The US Postal Service (USPS) is currently one of the hottest political issues in the fall campaign season. There are allegations from officials and postal workers that the Trump administration is depriving the USPS of needed funding ahead of the election for political reasons, and Donald Trump himself has stated publicly that increased voter participation from mail-in voting would hurt his re-election chances. The USPS was hit hard by the pandemic, and democratic politicians are alleging cost-saving measures implemented by Louis DeJoy, the new postmaster general, have led to severe service delays and the removal of many mailboxes throughout the nation, including Boston.

The postal service is considered a vital public service that has been a critical part of our nation's infrastructure since the 1600s. The USPS

employs over 600,000 people in seven different unions and employs nearly 100,000 military members and veterans. Forty-eight percent of the world's mail is handled by the USPS and is the most cost-efficient way to send letters and packages. The elderly, small businesses, rural areas, and people of color would be impacted the most if the USPS were to shut down. The USPS is considered a lifeline for many remote communities, including indigenous and rural farming communities. It is also the cheapest way many people receive their prescriptions/medications.

Around 20 to 30 Parkway community members gathered at the West Roxbury and Roslindale post offices, hold-

ing signs in support of saving the USPS. Participants wore masks and socially distanced down Centre Street (except for when they took the group photo). One rally attendee held a sign that read "Let's Go Postal on DeJoy!" Another sign stated, "Don't Delay The Mail! Our Vote Must Prevail."

**COLUMBUS AVENUE  
BUSWAY PLANNING  
DISJOINTED**

*To the Editor:*

A recent virtual meeting about the City's proposed center busway on Columbus Avenue at Egleston Square revealed how disjointed the City's "planning" process is. Despite two City planning documents, JP/Rox plan and GoBoston 2030 transportation plan, that called for Columbus Avenue upgrades to improve bus, bike and pedestrian conditions, the City is planning to eliminate two auto travel lanes on Columbus Avenue between Walnut Street and Jackson Square and force cyclists to share a narrow lane with autos and trucks. This plan violates the City's Complete

Streets policy that calls for all transportation modes to be accommodated. This plan makes conditions for cyclists worse than today. At the meeting City officials erroneously stated the busway plan is consistent with previous plans.

Improvements to help buses through this area are needed. So are safety improvements for bikes. The City in 2019 developed a plan for right-side bus lanes that would have "made major improvements for both bus passengers and general traffic." The right-side bus lane report showed huge peak-hour travel time savings in the north-

bound direction: as much as 81% for bus riders. Southbound was almost as big in the evening and still significant in the morning for bus riders; improved travel times for buses, improved pedestrian conditions, and accommodated cyclists. This plan was never shared with stakeholders or the public. All of the improvements proposed with the center busway—better pedestrian crossings, seating, signage, trash cans, etc.—could be implemented with right-side bus lanes.

The City's so-called planning process with the public consisted of essentially telling

people that it's building the center busway plan and asking what color trash cans do you want. It is unconscionable that the City would not discuss the right-side bus lane plan with the public to help it evaluate an alternative that would truly provide a Complete Street.

After reading the editorial (There is no going back to normal) in the Boston Bulletin about how the new school year will begin during the ongoing COVID-19 virus threat, I am so happy to not have school age children, and that my grandkids are both preschoolers.

Normal stopped last mid-March when the whole world seemed to go into mass panic, schools shutting down and politicians putting our economy into suspended animation. Businesses closed, people couldn't go to work, everything just seemed to stop in mid-sentence.

I am not too sure that any real learning took place once remote learning took hold, as best it could. By June, with remote learning ended, all students were just pushed ahead and I wondered how many of those students were actually ready for their next grade level coming up next month.

I have been a substitute teacher in the Quincy Public Schools since the 2013-2014 school year. This year, Quincy will offer Grades K-3 hybrid learning with both in-school and remote learning. learning. Different schools are trying their best to do what is good for students and staff. What else can any of us do?

The goal is to get back to normal as much as possible but it is unlikely we shall ever return to what was normal prior to the beginning of last March. The whole world was turned upside down and it may take a while longer to upright our ship of life.

The bottom line is to make sure our children stay safe and healthy. That is the job of us adults. Hopefully, someday we'll look back and laugh at this period of our life, but right now no one is laughing.

The JPNC would like to highlight:

\* \* This project will be 100% affordable and will serve populations in particular need: low- and moderate-income families and formerly homeless individuals. The development will include 62 affordable family size units and 140 supportive housing units that provide on-site health, counseling, and other services. Supportive housing is a proven approach to helping our unhoused neighbors get back on their feet.

\* \* \* The project is a model of transit-oriented development. The building is located two blocks from the Green Street MBTA station and provides covered bicycle parking. The majority of the building residents will not own cars.

\* \* \* The project will provide jobs to local residents. The development will adhere to Boston Resident Jobs Policy, or exceed its requirements.

\* Equally important, The Community Builders and Pine Street Inn held an extensive,

nity starved for places to dine. But opponents charge that the cost to the children at the nearby schools – many of whom are on free or reduced lunch and children of color – is too great. They also referenced a study by the Boston Public Health Commission (BPHC) that shows the increasing correlation between fast food and conditions like obesity, diabetes and heart disease.

Tonge and five neighborhood associations originally sought a preliminary injunction on Thursday, July 2. They sued the City of Boston, specifically the Boston Licensing Board, which granted the common victualers license for the Burger King to open in a 2-1 vote on May 14.

Campo presided over both the July 2 and Aug. 19 hearings.

Attorney representing Helena Tonge Kerby Roberson challenged Northeast Foods LLC, the second largest Burger King franchisee in the nation, and the Boston Licensing Board. Edward Cheng represented Northeast Foods as well as the intervening party, CRE Finn Riverwood, the owner of the Shops at Riverwood. Robert Arcangeli was the counsel for the Boston Licensing Board.

Roberson said the Licensing Board did not consider all of the documentation presented before it in order to make a complete decision. He referenced emails that could be submitted up until the 10 a.m. deadline of the Licensing Board hearing.

Archangeli confirmed that there were 10 emails received by the Licensing Board at approximately 3:30 a.m. on the morning of its hearing, May 14. He said he could not take a position on whether or not they were considered.

“Within those 10 emails themselves there were 190 pages of attachments,” he said. “And that is on top of, I believe, an additional 50-plus pages that was part of the original administrative record, Your Honor.”

Roberson charged that “the Board has abused its discretion by not considering the totality of the evidence.” He also said the hearing should not have been held during the pandemic, when people did not have an opportunity to participate.

“The Board has to demonstrate a rational basis for its decision, according to case law,” Campo said. “Are you saying it wasn’t rationally based, and if so how?”

Roberson said there was evidence that was not included in the decision, including the lack of a current traffic study, and the impact of the drive-through franchise on the neighborhood.

He also brought up the health impact of the fast food restaurant and the hundreds of child labor law violations against the Burger King franchisee, Northeast Foods, LLC., throughout New England.

“This is a regulatory board,” Campo said. “This is not an adjudicatory process. This court has to give due deference to its

proceedings. How is this court to substitute its opinion or its thought for the decision-making of the regulatory board?”

Roberson said it is the court’s responsibility to look at the situation in its totality, noting that the decision was made “at the height of the pandemic while the state was in lockdown.”

He added that the Burger King will affect “generations of people” in a community that has been the hardest hit by COVID-19, according to City statistics during the height of the outbreak. It is also one that has an increasingly diverse population and growing percentage of immigrants.

“Once the license is granted, there’s no going back,” Roberson said of the Burger King. It will be open from 6 a.m. until midnight. He added that the drive-through was not initially proposed on River St., which is one lane each way.

Archangeli stressed that the Licensing Board acted rationally because it goes by the number of licenses in a community and then takes into account public support or opposition as an ancillary factor.

“I do believe the board pointed out the public needs standard and defined it on the record,” he said.

“Clearly it is a sad day to hear that a Burger King in a Black neighborhood is a public need,” Roberson responded.

two-year community process and were quite responsive to feedback, including reducing the building height by one full story due to community concerns.

We hope that Mr. Gold will withdraw the lawsuit so that this desperately needed housing can be built as soon as possible. In a pandemic and an economic crisis that has devastated communities of color and working-class communities in particular, this project can offer hope and home for our neighbors.

painted all the rooms, and put shades in and got rid of those dated drapes. The property looks good and our air conditioning is such a gift.”

St. John's and St. Theresa's had already been linked as part of the Archdiocese's evangelization plan Disciples in Mission, which was started by Seán Cardinal O'Malley, OFM Cap., in 2012. This is not a merger, and the two parishes will maintain a separate identity, including separate finances, although there will be one parish council. Fr. Connolly said in his letter to the two communities that neither at the Archdiocesan level nor at the parish level is it anticipated that this will lead to a merger or closure of either parish.

Fr. Paul Soper, who is the Archdiocese Secretary for Evangelization and Discipleship as well as the Director of Pastoral Planning, said that “the point of a parish is to introduce people to Jesus”, and he hopes that this collaborative will allow both parishes to have “a renewed moment to focus on their core mission,” especially by helping parishioners to witness to others to start “telling other people about their relationship with the Lord.” He wants them to write a “plan for evangelization together”. Fr. Soper also notes that the collaborative of St. Anne's in Readville, Most Precious Blood in Hyde Park, and

St. Pius X in Milton, which has existed since 2014, has been working well. Fr. Connolly hopes that this collaborative will help the two parishes grow the Catholic community in West Roxbury, along with West Roxbury's other Catholic parish, Holy Name.

St. Theresa's Parochial Vicar, Fr. Richard Bradford, will also be retiring. He has been at St. Theresa's for 22 years. He will celebrate Mass at St. Theresa's on an as needed basis while he continues to serve at the Congregation of St. Athanasius in Brookline, where he is currently Chaplain. His Mass of Thanksgiving will be at a date to be determined.

Fr. Charles Higgins, who is presently the Pastor for St. Albert the Great Parish and St. Francis Xavier Parish in Weymouth, will be St. Theresa's new Parochial Vicar, and will also join Fr. Connolly in celebrating Mass at St. John's, effective September 1st.

Schedules for Mass, confession, and catechism classes are to be determined. Confession was not held at St. John's this week but it is expected to resume next week on Wednesday from 1-2 p.m. (The Sacrament of Reconciliation is also offered in West Roxbury at Holy Name on Monday from 4-5 p.m. and St. Theresa's on Tuesday from 6:30-7:30 p.m.).

## Catering to my blind spots

It was Channel 4's Bob Lobel, who, having retired much before his time, occasionally spiced up his sports segment of the evening news by lamenting “Why can't we have guys like that?” Lobel might have been talking about players in cities other than Boston—some baseball player who hit for the cycle, a hockey player who scored four goals, a basketball player who achieved a triple double two games in a row, or a running back who scored four touchdowns.

I'm tempted to paraphrase Lobel's rhetorical question with a “Why can't our schools produce a girl like this?” Perhaps we already do and the accomplishments have not been deemed newsworthy, even in these pandemic and Black Lives Matter times when teenagers accomplish so much.

You might think that I'm referencing Greta Thunberg, the 17-year-old Swede who has made such a mark for herself by bringing environmental concerns to the forefront before tens of millions of people, including the august members of the United Nations. But I'm actually thinking of Alaina Gassler, then a 14-year-old not from one of the BPS exam schools or from a suburban campus with state-of-the-art science laboratories. Alaina, from rural Pennsylvania, came up with a great invention

that has great appeal to me.

Almost a year ago The New York Times reported that she had seen her mother becoming frustrated with blind spots when driving. Probably tired of hearing Mom grouse about the issue, the middle school girl designed a system that uses a webcam to show anything that might be hidden from a driver's sight.

A panel of scientists, engineers, and educators was so impressed that last year they gave her the \$25,000 top prize at the annual Broadcom MASTERS (Math, Applied Science, Technology, and Engineering for Rising Stars) annual competition.

Drawing almost 2400 applicants nationwide, the competition was sponsored by the non-profit Broadcom Foundation

and the Society for Science and the Public. Gassler defeated 29 other middle school students in the science and engineering category.

Her project sought to remove blind spots created by vehicles' pillars that support a car's frame and hold windshields in place. She used a projector, webcam, and reflective fabric: the webcam was attached to the outside of a car's A-pillar on the outside, with a projector mounted underneath the car's roof to project the image onto the pillar or blind spot. The reflective fabric on is on the mount so that the image can be seen only by the driver. She realizes that the science project can be improved by using LCD screens instead of the projector to let the driver adjust the brightness and orientation of the vehicle in the blind spot.

In light of the Federal Communication Commission's and Federal Trade Commission's inability to stop the barrage of spam and unsolicited-sales telephone calls plaguing us—my phone is supposed to be registered on the Do Not Call Registry—it would be nice if she can only apply herself to devise something to halt these daily intrusions to modern life. Calling the well-advertised DNC phone number 1-866-231-2255 simply does not work.

Royce said she had obtained a copy of the lawsuit and reminded the meeting callers that Gold was not against the supportive and income restricted housing but the parking ratio.

Gold has asked the court to demand that the ZBA annul its decision to approve the housing development which would prevent Pine St/TCB from getting a building permit and require it to repeat the zoning process.

Horsley said that Pine St housing is “more important than ever” given the pandemic’s impact on homeless and low-income families.

“There must be a better way to address traffic and parking,” Horsley said.

Marie Turley of Union Avenue was more critical of the BPDA for not coordinating traffic and parking in that area of multiple approved housing developments.

But more than that she did not want Union Avenue’s fingerprints on the lawsuit.

“I want to add a point of clarification,” she said. “Attached to the lawsuit is a Sept. 12 letter from Union Avenue with our concerns, but we’re satisfied with Pine Street. There’s another IAG meeting scheduled that should mitigate this process. It’s the next step.”

According to the BPDA that step has not been scheduled.

Moreover, the Sept. 12 Union Avenue letter remains a BPDA public record that Union Avenue did not revise between Sept. 12, 2019 and the March 12, 2020 zoning board of appeals approval.

Zack DeClerk is on the 3368 Washington St. IAG.

“This [Pine St housing] cannot be a casualty of larger issues of development,” he said. “This is a very fragile project. Funding sources are limited. More neighbors are sleeping outside. It’s a huge need. We can’t lose this. The first option is to drop the lawsuit. There’s enough energy here to force that option.”

As if on cue, at noon on Aug 20 City Life/Vida Urbana set up an on-line petition: “Monty Gold, Drop the lawsuit against Boston’s largest project to house [the] homeless.”

The next day Gold responded to a message from a Woodbourne neighbor who signed the petition.

“I had no desire to pursue [the appeal], however all is not what it seems,” he wrote.

In other news, Samantha Montano of JPNDC described its proposed senior housing at 3371-3375 Washington St. that immediately abuts Turtle Swamp Brewery. She said this was only an introduction; an Article 80 Small Project Review had not been filed with the

BPDA. JPNDC bought the property from City Realty on Jan. 7, 2020 for \$2.155 million. It includes El Embajador Restaurant and De Chain Auto Service.

Montano said De Chain is relocating and a new restaurant space will be built out in the new building for El Embajador “if they want to return.”

Montano said the housing would be for seniors who want to “age in place.”

“Seniors are our fastest growing demographic in the city,” she said. “There will be supportive services like at the Julia Martin house.”

Montano said there would be 39 one-bedroom units with one live-in manager’s apartment. All apartments will be affordable below 60 percent area median income (AMI) with 25 percent dedicated for incomes at or below 30 percent AMI.

Brian Goldson of New Atlantic Development explained that there have been “a lot of community meetings.”

“We want people to understand why we would have to have 40 units,” he said. “Forty units is necessary to make it economically viable. It’s the minimum number of units to create a vibrant community with supportive services.”

He said the units would be

designed as compact living with “higher floor-to-floor heights.”

Designed by Utile Architects with Ingrid Blangstom principal architect, it will be a five-story masonry building.

“We want durable, high-quality materials,” Goldson said.

He added there will be a green wall on the front façade of living plants “[that] will add a lot of interest” plus an interior courtyard and setbacks between stories facing Washington Street. But there was a new wrinkle.

“We can’t get access from Green Street,” he said. “We’ve been working with our title attorney and the abutter’s attorney [Boston Community Ventures] and we can’t get any legally-shared easement from them.”

BCV owns 3353 Washington St. and is approved to build a six-story, 44-unit residence that is currently on hold until March 2022.

In addition the city will not allow a curb cut on Washington Street.

“So we’ll only have a dedicated short-term parking space and an ambulance space,” Goldson said.

“At the March [Union Ave] meeting at El Embajador you didn’t have access from Green Street?” she asked. “Nobody from Union Avenue is aware of this. This is significant for Union Avenue.”

Goldson said that New At-

lantic Development would file for city funding on Sept. 28 and added that it would concurrently file for zoning variances.

Goldson promised a “robust conversation with the community” in the meantime. But he didn’t know what that would be like.

“The city’s outreach process is a big question,” Goldson said.

According to the BPDA’s COVID-19 response guidelines, it is still working on how to resume “public engagement that is broadly accessible and equitable,” and future meetings will be announced.

However public meetings are done, Turley wants more of them with Union Avenue. She particularly wants the Green St access issue clarified.

“We look forward to robust conversations,” she said. “Nobody opposes senior housing, but we want high end architecture.”

Bill Madsen Hardy of New Atlantic development reminded call-ins that “this is a long time before construction begins. Two years at best.”

"I came out to rally today because we have to support the post office and the mail. We're in the middle of a pandemic and people want to mail their votes. I've seen people come by me right now taking their ballots to the mail. A lot of people are planning to do this and I think a lot of people should do it - and they're trying to scare people into not voting," stated Anne Fleche, a rally attendee and WR community member. "I watched some of DeJoy's testimony on Friday and he says everything's fine. But if that's what we're supposed to think, then he and the president need to get on the same page, because that's not what Trump is saying."

Rachel Poliner of Progressive WR/Roslindale organized the rallies. "I've been getting questions for weeks, what can we do, what can we do, what can we do [about the attack on the USPS]? And so much of it feels over our heads, you know? Something like this is big - it's national. The Congress has to act," Poliner said. "And so what can individuals do at the moment? This weekend, we can add pressure so that when the House holds hearings this week, they feel the momentum and they feel the anger and rage across the country about having this basic system disrupted."

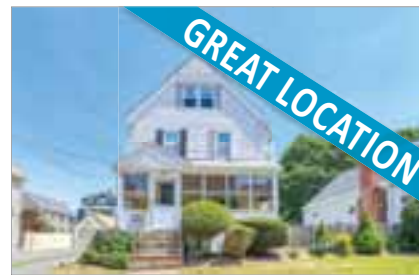
