LANA tackling wetlands sale

The Longfellow Area Neighborhood Association (LANA) met virtually on Monday, July 13 to discuss several issues around the neighborhood, with the most impactful of those being the work the group has been doing to secure the Roslindale Wetlands.

The wetlands, located inside an area outlined by Weld Street and Walter Street, have been an issue of contention for some time. LANA member Kathleen McCabe said the group has been fighting development on the wetland for decades, most recently in 2005 and specifically on the 104-108 Walter St. parcel.

McCabe said that most of the land encompassed in the 108 Walter St. parcel is now protected wetlands, but a section of it is not. She said the Wetlands Task Force working group within LANA has been working on the issue since its formation, but has really stepped up the pace since the fall.

"It really picked up when the (Community Preservation Act representatives) CPA came to do some outreach, and we started thinking about whether CPA funds could be used for the city to acquire these parcels, so we could be proactive and avoid another fight with a developer," she said. "The priority is to protect the wetlands. The 104 Walter and 108 Walter properties are owned by the same development company, Feeney Brothers."

She said 104 is zoned for two-family housing, and she said the Wetlands Task Force felt 104, combined with a small portion of land from 108's street-facing side, could be a great opportunity to build four units of affordable homeownership units.

"But then a 'For Sale' sign went up

on the property in mid June," she said. "Feeney Brothers has had a couple of offers and the threat of a private sale and then over-development is very real, along with the permanent loss of 108 Walter, adversely affecting the wetlands and incurring the loss of some of the loop trail."

McCabe said they are working with partner groups, like the Southwest Boston Community Development Corporation, as well as advocating that the city apply for a land grant for additional funds, to be able to purchase the property.

"LANA has also filed a letter of intent to file for CPA funds for this coming round," she said.

McCabe added that the Massachusetts Audubon Society has agreed to place and hold a conservation restriction on the property should the city buy it for conservation purposes, which would allow the Society to be able to hold the property as conservation land in perpetuity, barring an act of the State Legislature.

On that front, McCabe also said they have received letters of support from State Sen. Michael Rush, State Rep. Edward Coppinger, District 5 City Councilor Ricardo Arroyo and District 6 City Councilor Matt O'Malley. She said LANA's September meeting will be more focused on filing for CPA funds.

In other news, the owner of Henry's Market, Devyani Patel, came before the association to request a recommendation for the market's upcoming application for an all-alcohol license. She said since the pandemic and the opening of several casinos in the local area, her primary business of lottery, beer and wine and cigarettes has fallen off.

"It's really tough to survive here and I'm trying to serve my customers who are buying beer and wine and have asked many times for liquor. It would be more

convenient for them to have one-stop shopping," she said.

Residents Carter Wilke and David Wean said they were opposed to the license because of Henry's actually applying for an all-alcohol license years previously. The compromise was the beer and wine license the shop currently has.

"Liquor stores next to a park have a really bad track record, and people felt that a lot of us volunteers for LANA would be spending a lot of time picking up empty bottles and nips around the park," Wilke said. "I am still very much opposed to this for that reason."

Wilke added he originally voted in favor of the beer and wine, but now regrets that decision, because the windows of the store have been taken over for alcohol," he said. "A business that makes its profit from other people's addictions is not something I want to support."

Patel pointed out that new liquor licenses are not currently allowed to sell one-serving liquor containers, and the smallest she would have in stock would be quarter pints.

"I'm still opposed to this because it's really just expanding something we're not trying to promote in our neighborhood," Wean said.

Member Jonna Iacono said she felt tobacco and alcohol regulation is a state issue, and she doesn't want to see the neighborhood's corner store go under.

"Henry's is probably one of the most integrated spaces in Roslindale; it's the glue that holds our neighborhood together," she said. "If this business is in the process of failing because they can't have a full liquor license, which we know haven't been fairly distributed to minority-owned businesses in the city,

Pot dispensary wants to add recreational

A lot has changed since Dec 11, 2018 - including its name - when The MassPatient Foundation, now called Apothca, received zoning approval for the first medical marijuana dispensary in Boston at 54 Hyde Park Ave. in Forest Hills.

Apothca returned to give a progress report on July 2, 2020, this time in another change, on Zoom.

Joseph Lekach, president and CEO speaking from Florida, opened the virtual meeting attended by only The Bulletin and a resident named Margaret P., who joined the broadcast 30 minutes later.

Lekach said he had sent out notices of the meeting via registered letter to residents living within 500 feet of 54 Hyde Park Ave.

This included the six condos at 38 Hyde Park Ave. that were still under construction in December 2018.

"We want to tell the community of JP of the progress of the medical marijuana dispensary," Lekach said, "including the potential of adult-use sales at the same location."

"This has taken a little bit of time," he admitted. "It's been a long process. It took a year to get our change of occupancy. We applied to move the license from Holyoke to 54 Hyde Park Ave. in January 2019 and it was approved in January 2020."

And in that time, the marijuana business changed in Jamaica Plain. In June 2017 when it made its earliest presentations to Forest Hills groups, Apothca

Workshops address fireworks problem

At-Large City Councilor Julia Mejia hosted a series of public outreach workshops and meetings last week to help the city address the ongoing problem of excessive fireworks usage in its neighborhoods.

Mejia's agenda put forth four ideas for residents to discuss and figure out if it would be feasible and advisable to implement in the neighborhoods. First, she introduced a fireworks buyback program, which would allow residents who have purchased fireworks to be able to turn them in for gift cards or cash. Second, the creation of a fireworks festival for which residents' fireworks could be launched by a permitted professional in a large setting. Third, to create a public awareness campaign to show how fireworks impact residents (and pets) throughout the city and how they can create or bring back trauma. Last, she said she wanted to see how calling 311 could be used to help identify and possibly curb the use of fireworks in hot spot areas.

Mejia added that lobbying the state legislature and Gov.

Charlie Baker to intercede on Boston's behalf with other states where fireworks are legal and try to create a stoppage process is worthwhile.

"The governor needs to call the governors of other states and say 'you can't sell to people who don't live in your state,'" she said. "There needs to be accountability, but no one's having that conversation."

During one of the breakout sessions, resident Sandra Singer said she would like to see more police enforcement and possibly setting up traps, like a speeding trap, where police go to a known hot spot and wait for firework offenders to set up, and added she would want to have dogs trained to be able to sniff fireworks, as they do for cadavers and explosives. However, another resident said in her neighborhood that would definitely not be something she would invite.

"I would really like to understand how policing and sending bomb-sniffing dogs is always the solution for people," she said. "I don't know where you all live, but I know what neighborhood I

Tricky consumer math: cui bono?

In ancient times an insightful Cicero enjoyed posing the terse question to his fellow Romans, "Cui bono?" When he heard someone orating, he was probing, "For whose benefit?" There's no doubt—it can be proven mathematically—whom a local drugstore chain's cash-register policy benefits, and it's not you or I.

Read on about the trickery, which is elaborated on a few paragraphs down.

Having always enjoyed teaching discount/percentages to middle school students, I was never able to fool too many with the following question: If you buy 3 of the same items at the same price, is it better to have the discount imposed on the total price or on each individual item when it was rung up on the cash register? For instance, for an item whose list price is \$10 before a 30% discount is imposed, is it more profitable for the consumer to pay \$7 (\$10-30%) three times for a total of \$21 or to have the 30% taken off the total regular price of \$30?

To try to trick those who obtained the correct answer (it doesn't matter: both ways come out to be \$21 sale price total), I would begin a second query with an emphatic, "BUT if the prices are different, is it to the consumer's benefit to have the discount imposed at the end after the total regular price is calculated? For instance, if a consumer purchases single items with list prices of \$20, \$30, and \$40 and a 10% discount targets all 3 purchases, is it better to have the percent applied to the \$90 total or to impose the discount on each charge individually? The answer, of course, is the same: the consumer should pay only \$81 either way.

But a huge drugstore chain here in the Boston area does play with percents that work to its benefit, and the chain is in no hurry to amend the policy because of the difference in

money involved.

Let's say an item—in this case, non-taxable—costs \$10. The consumer has a 40%-off coupon as well as a \$3 cash coupon. The chain's cash register processes the \$3-off cash coupon first—to make the cost only \$7—then applies the 40% off. Thus \$2.80 is subtracted from \$7 resulting in the final charge to be \$4.20.

If the consumer wants the 40% off coupon applied first, too bad says the cash register. It won't subtract \$4 (\$10-40%) from \$10 even if the cashier rings up the cash coupon first and the percent coupon second. In this scenario, 40% off the \$10 item results in a sale price of \$6, from which \$3 is subtracted, with the final cost \$3.

OK, OK, the consumer loses out on only \$1.20, not even enough to buy a package of Good and Plenty (which may be the most ingenious name ever bestowed on a candy: they taste good and there's plenty of 'em). But multiply this by tens of thousands of transactions during the day with many consumers thinking that the price still comes out to be the same. Maybe you already realized the difference, but too many don't.

Is it unethical? Of course not, but the chain's policy takes advantage of people's innumeracy for its own benefit.

Sometimes even for a good communicator it may be difficult to describe a situation you have experienced. It's not just because you don't know which words to use, but rather what you believe more so than what you just might have witnessed. For me, probably like most of you, the last three-plus months have been horrific. We haven't read or heard about what we know is the best about our country, community, and people. It's been about a scary medical emergency, self-serving violence marrying legitimate political protests, media hype and the related thirst for ratings. None of this infighting serves the interests of our country or our own true personal interests. As a matter of fact, all this artificial heated rhetoric on both political sides has only undermined America's national reputation and security interests. What American workers and military servicemen have achieved over the years through courage and self sacrifice, the national media has inaccurately and even recklessly handed over to our nation's enemies on a platter. They have distorted the moral values that we stand for as a nation and substituted them for opportunistic narrow ideological opinions.

Well today I got a true perspective of how an average American family feels about the challenges that we all face every day and how we as average families of Americans must deal with them. It wasn't at the opening of a Hollywood movie starring future Academy Award winners, but instead at the wake and funeral of one of the Boston area's most respected families. It took place at Richie Gormley's Funeral Home in West Roxbury and moved to one of America's most renowned churches, Holy Name Parish. It is a church with a

reputation as prominent as the one my family was honored almost every day for five years to attend, St Peter's Basilica in Rome. We were not with a saint like Pope John Paul II, but with Pastor Rev. George Evans and a group of parishioners just as dedicated and committed as far as I am concerned. They reminded me of my own community at Gate of Heaven and St. Brigid in South Boston, which I'm proud to call my parishes, or any other Catholic churches for that matter.

The beautiful funeral Mass was celebrated for Patrick A. Timilty, and the sincerity of his life could not have been portrayed more beautifully than by his brother Greg Timilty. I only wish that my long time sincere friend and their father, former State Senator Joe Timilty, could have been sitting next to labor legend Tommy McIntyre of the Bricklayers Union and me.

After the funeral Mass, my wife Kathy and my son Ray walked with me across Centre Street to catch the T bus to Forest Hills Station to head back home. But just then a West Roxbury friend of the Timiltys, who attended the Mass, recognized us waiting for the bus to Forest Hills and graciously offered us a ride back to Southie. We didn't want to inconvenience Lou Murray, Board Chairman of Catholic Radio 1060 AM, but he was so kind, and it was so helpful to our tired old bones.

What a great morning in the West Roxbury neighborhood, talking to the Timilty family, neighbors at Roche Brothers supermarket and attending Mass at Holy Name.

Pat Timilty, your Mom Elaine Benson Timilty, whose father Billy Benson was my baseball coach in the Boston Senior Park League, and of course your dad Joe, had to be

proud of your courage in overcoming your challenges in life. You and your wife raising two beautiful children, Olivia and Patrick, who sat in the front row of the church Friday, must have been as proud of you as we all were. God Bless you and families like yours and what they mean to America. We'll be back at Gate of Heaven and St Brigid Church on Sunday to be with the same kind of beautiful families who are loyal to God and community. But now in South Boston we will be with another dedicated new priest, Fr. Chris Boyle, whose Dad Artie Boyle, is also a great friend of Our Lady of Medjugorje Shrine, along with Jimmy Kelly from Crystal Travel Agency and me.

Before going home to Southie, one of the ladies working in Roche Brothers stopped me in the market to tell me about another good political friend from West Roxbury who had just passed away, former State Rep. Frank Coppinger. I said a prayer for Frank in church and said to my son Eddie, "The people of West Roxbury have certainly sent some of the best public officials to the State House over the years that we have ever had."

We learned the values of God, Country and Family at an early age from our parents, our faith and yes, our neighbors.

live in and the thought of having more police in this neighborhood so that they can have more interactions with black people and shoot somebody is not appealing to me. I would just hope that people would understand that police are not an answer to every problem that we have. I keep hearing maybe the States can hide in the bushes and jump out, I mean you're putting other people's lives in danger over this stuff and I can't not say anything about it."

Resident Katheryn Willmore said she would like to see the state interact with places that sell fireworks and set up some kind of screen so that Massachusetts residents would not be able to purchase fireworks at all.

"Couldn't the state require ID with an address, and if they're from Massachusetts, don't sell it them?" she said.

Lauren Thompson said she believes the federal government, in the form of the Bureau of Alcohol, Tobacco and Firearms, should be involved in stopping the spread of illegal fireworks from state to state.

Residents Sophia and Kinsley said they do not believe a buyback program could work, considering the expense of driving to another state and how much these fireworks are selling for these days. They said a public outreach campaign should be the focus, since many setting off these incendiary devices may not be aware of the harm they can cause those who have experienced trauma or residents' pets or themselves. They pointed out that fireworks contain high levels of arsenic and other heavy metals that can be detrimental to people with respiratory conditions like asthma, which can specifically impact communities of color and the environment.

Mejia said she would be taking feedback from these sessions would be sent to the recently-created Fireworks Task Force. Residents with ideas can also email Mejia's point person on this issue at brady.baca@boston.gov.

well I'm all for it."

Member Joseph DiMasi said he was in favor of the license, as it would make it more convenient for him.

"Litter is a problem all over Boston," he said. "We have Home Market, Silva's, and there are plenty of corner stores that sell lottery and cigarettes, but we want to make sure our neighborhood stores do stay in business and it would be sad to see them go."

The LANA Board took a nonbinding poll on the issue, which came down to a tie at 12-12, and the Board voted to send a letter of non-opposition to the Boston Licensing Board. That letter is contingent on alcohol being displayed behind the counter, the license not being immediately sold and that Patel would agree to work on the display windows with LANA.

was the only cannabis concern in JP.

But then Core Empowerment received zoning approval on March 12, 2019 for a 6,000 square foot recreational marijuana shop at 410A Centre St. next to Whole Foods and Apothca had to change its business model.

Deep into the meeting and under questioning by The Bulletin, Lekach was frank.

"We would be at a significant disadvantage if we were only medical marijuana," he said. "It would be at a loss. Adult use [recreational use] makes the economics work. Medical marijuana can't be 100 percent of our focus."

The Apothca dispensary is also much smaller at 1,500 square feet.

Lekach told The Bulletin the next day that at their Lynn dispensary, medical marijuana is 15 percent of the sales; adult use makes up 85 percent.

Core Empowerment is slated to open in September 2020, but this has not been confirmed; Core did not reply to messages.

Lekach said he expects to begin operation of the medical marijuana dispensary in January 2021.

"We will file for a building permit in July and plan on building out the ground floor space in October," he said.

The adult use process will be

the same as the medical use.

"All the roads start today," Lekach said. "Neighborhood council, zoning board, new host agreement, cannabis control commission approval. Another two years." Apothca will meet with the JP Neighborhood Council on July 28.

Lekach said they would apply for an adult license to the city in September and the state application in December 2020.

Apothca has been paying rent on the vacant space at 54 Hyde Park Ave. to the landlord Logan Miller since May 2019; it made option payments starting in May 2017 prior to the full lease. The landlord - who also owns and operates JP Cross Fit next door - testified in favor of the medical marijuana dispensary at both the June 27 and Sept. 26, 2017 neighborhood council meetings. On Sept. 26, a skeptical council voted not to oppose the license request.

Dan Quaile of Lincoln Architects, who has not yet completed building permit drawings, is designing the space. Lekach said there will be a physical barrier between medical and adult sales.

Access will be tightly controlled with a sally port entrance, security cameras and an alarm system designed by Wayne Alarm.

"We want to fit in seamlessly

with the local community," Lekach said.

Lekach said that Apothca's business model has also understood the economic impact of COVID-19.

"We will have a 10 percent financial discount for all patients, not only for those who have a demonstrated financial hardship," Lekach said.

He said that after Pure Oasis in Grove Hall was looted of \$100,000 worth of cannabis on May 31, Apothca was the only marijuana manufacturer to contribute to the store.

"We gave them \$25,000 worth of product," Lekach said.

Cannabis operation and cultivation will be done at the 26-acre former Bayer pharmaceutical factory in Fitchburg.

As he did three years ago at the neighborhood council, Lekach explained that Apothca would run a tight ship.

"It will be a cutting edge, seed-to-sale inventory tracking system to prevent diversion," he said. "There will be tight security measure with surveillance cameras."

Patients must show doctor's proof of their debilitating medical condition, Lekach said. "They must apply for a valid registration use, a certificate submitted by a physician directly to the Cannabis Control Commission."

said Charlie Adams, regional vice president of Pennrose, Inc. Pennrose and LGBTQ Senior Housing Inc., the development partner, were notified by Secretary of State William Galvin's office and the United States Department of the Interior that they had received Part One approval.

"Even though the world has generally slowed down COVID-19, we have not," Adams said.

Part Two involves presenting the updated plans to both entities, and Adams said he "has received positive feedback" on the preliminary version.

The City has been involved in the process throughout, and Boston Mayor Martin J. Walsh this week expressed his support of the project.

"Boston wouldn't be the great City that it is without the contributions of the generations who came before us," Walsh said. "This new senior housing development in Hyde Park shows our commitment not just to housing residents of Boston as they age but also highlights the inclusiveness of the City by creating safe and stable housing for those in the LGBTQ community."

As an update, over the past six months, Adams said there has been a complete building survey. There was an environmental study conducted to determine the amount of asbestos,

lead and PCPs.

"We also did a lot of work on the brick and did a masonry inspection," he noted. "We want to be able to preserve and repair the brick so that it will last another hundred years."

The environmental team found "a huge amount of ledge underneath the site, so that presented some major challenges," according to Adams. "And the more we dug, the more we found. You can actually see where some rock formations are poking up among the grass."

Parking was a concern brought up during the process. Adams conceded that, while those who find it an issue might not want to reside there, the City has been supportive of working with the team to improve the streetscape.

"As part of the redevelopment plan, the developer is proposing to replace all sidewalks on all sides of the building," said Alexander Sturke, a spokesperson for the Department of Neighborhood Development (DND). "On Harvard Ave. this will actually allow for the street to be wider and accommodate street parking on both sides of the street."

"There are so many walkable destinations on the main streets," Adams added. "On Fairmount Ave., you have the theater and dining."

Preserving the historic character of the school, which was

the first home of Hyde Park High School before it became the Rogers is important.

"One thing to note is that, when we bid on the project, there was no survey of the building," Adams said. The team knew only about one of the structure's three wings.

Now the team has been able to delve into the building's his-

tory and architecture. One find has been the cinema room at the far corner of the building's upper floor, a mystery to many former students at the "Jolly Rogers" because it was never explained.

"Unfortunately, the cinema room is not accessible," Adams explained, noting the old staircase. However, he

said the old chairs are still there. An idea was to make that a screening room for residents.

"I'm really excited that the main original entrance will be used as the main entrance," he added. "We've done some work with a historian, and this is where the horse-drawn carriages would come up."

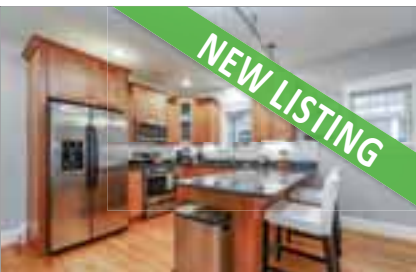
