WRNC hesitant about 100 Charles project

On July 25, at 7 p.m., the West Roxbury Neighborhood Council (WRNC) met with neighbors, a representative from the mayor's office and a group working on the new housing complex on 100 Charles Park Rd.

WRNC Zoning Committee Chair Tony Saroufim managed the overall discussion of the development.

Jeffery R. Drago, an attorney partner for Drago + Toscano LLP

and the architect Dennis Greenwood then presented the new complex to the WRNC, with the owner present.

Plans include knocking down the UNO Pizzeria headquarters that is now at that location and has stood unoccupied for many years.

The project consists of two five-story residential buildings with 121 dwelling units and 85 parking spaces underneath the complex. The total lot size is 46,656 square feet, but the project itself is 123,905 square feet. As per the city's Inclusionary Development Policy

(IDP) there will be 16 subsidized affordable units.

The buildings would include two gyms, one in each building, individual front lawn pieces, bike parking in front of the building as well as blue bike access, a common roof deck, and an open pedestrian plaza between the two buildings.

Right now there is no sidewalk at this location, but with the new apartments would come a 7.5-foot sidewalk all around the circumfer-

D5 Candidates face off again

The latest District 5 City Council candidate forum was held virtually on Tuesday, July 18, during which all four candidates fielded prepared questions presented by moderators representing the eight community groups sponsoring the event.

District 5 includes Hyde Park and portions of Roslindale and Mattapan and, during the hour-and-a-half forum, 150 residents tuned in to watch and listen to what the candidates had to say.

Each one stated their positions on various issues, and shared what they intend to do if they are elected, and incumbent Ricardo Arroyo

outlined what he has done on the City Council since January 2020. Because of the absence of candidate back-and-forth, and the lack of follow-up and open floor questions, their statements went unchecked, creating a relatively low stress environment, considering the crowded field and high stakes.

Hyde Park resident Ricardo Arroyo (www.votearroyo.com) accounted for the highest volume of content as he rattled through his responses, highlighting issues he has advocated for since taking office. His overarching goals include racial equity and affordable housing, and he also made note of the citywide proposals and policies for

Partnership would bring major changes to White Stadium

The White Stadium at Franklin Park, dedicated by Mayor James M. Curley on Sept. 28, 1949, is apparently very important to current Boston Mayor Michelle Wu.

In the wake of the announcement in early July that the city would lease a portion of White Stadium to a private women's soccer team, Boston Unity Soccer Partners, Wu opened a virtual public meeting about the plans on July 13.

Attended by more than 250

callers, the two-and-a-half-hour Zoom was hosted by Brianna Millor, Chief of Community Engagement.

"I want to turn this over to the leader of our city who cares about its youth," Millor said.

"White Stadium is a really exciting opportunity for Boston," Wu said. "We want to offer every opportunity to let kids play, to let them grow."

"We've been working on this for a long time," she said.

"The legal parameters are set [the stadium is owned by the George Robert White fund]. The city maintains complete

ownership," Wu said, "I want to be very clear, White Stadium is not being sold. It will still be Boston Public Schools (BPS) property. It's very exciting talking to you about a very exciting idea for the women's soccer league."

On April 26, 2023 BPS issued an RFP for "the revitalization of White Stadium as the centerpiece for BPS athletes and a hub for the community."

The RFP - due on June 26 - was for a 10-year lease with an

ence of the building.

The dimensions of the project place the plan under the Boston Planning and Development Agency's (BPDA) Article 80 Large Project Review process, which means they have to go through more BPDA community review to get this passed. There has already been one BPDA community meeting earlier in the spring.

"This sub-district is a community commercial district," Drago stated. "But there have been a number of residential developments in and around this site."

Right now the multifamily residential structure needs to apply for zoning relief. The required floor area ratio is 2.0, the proposed is 2.66. The maximum height allowed is 45 ft while the proposed height is 54 feet and 6 inches. For usable open space none is required but they are proposing 19,654 square feet of open space.

Throughout the conversation, parking availability was a huge concern for WRNC members.

The proposal calls for 85 parking spots below the building with a drop off location for Ubers and Lyfts, but no sidewalk parking and no visitor parking. Residents will only be granted a parking spot if they pay for it.

"Right now I am against this building," Saroufim said, "unless there are more parking options. I work with the soccer teams at Millennium Park and with the cars driving through so quickly it is not safe for the children."

Drago explained that right now the ratio required by the BPDA for parking spots is .5 spots to every one unit. He said they struggle to even get 1 spot for 1 unit because of the city's efforts to promote other modes of transportation.

This brought up concerns because of the fact that this location

is not near any public transportation and traffic on the VFW Parkway is already very congested.

"Someone is going to build something there eventually," Drago said. "We just thought that housing would be the best option when it comes to the traffic concern. Residential buildings are less of a parking issue than commercial ones."

Two residents of apartments in that area attended the meeting and voiced their concerns. They were against this building being built because of the height. According to them, the apartments proposed for construction would be blocking many of the rooms' views of the current apartments.

"I am usually an open-minded individual," Saroufim said. "But I am not buying that we will have enough parking. Eventually people will be parking on the street. We have reached 1,400 kids who have signed up for Parkway soccer," Saroufim said. "And there are barely enough parking spots."

Another member stated that having more bike spots than units and less parking spots than residents is wishful thinking and that in a perfect world where people are actually biking this would work, but this location is just not downtown Boston- West Roxbury is not Downtown Boston.

"There are so many factors involved in this, and I do not want to make a mistake," Saroufim said. "I don't think you want us to send you a letter right now against it, because with some improvement the next time you come I think we can eventually give you a letter of support."

No vote was taken at this meeting. The proposal still needs to go through the BPDA and the Boston Zoning Board of Appeals for approval. It is currently in review.

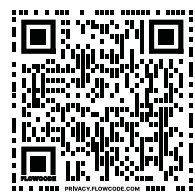

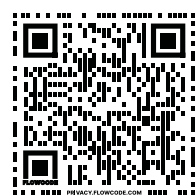

Friends of Blakemore need your help

The plans are ready, the artists are set, and now the only thing needed to complete the mural for the Blakemore Bridge is more funding.

The Friends of the Blakemore Bridge first started its campaign to beautify the bridge connecting Hyde Park Avenue to Roslindale over the MBTA Tracks a few years ago. Organizers Meri Bond and Rosy Hosking started by applying for and receiving a Love Your Block grant in the amount of \$3,000.

The bridge is rusted and adorned with graffiti. Hosking said she first got involved after seeing a call to action on Facebook that Bond put out. Hosking said it's been amazing to see the local community come together on this.

"Meri responded with interest and then someone I know saw that the Love Your Block grants were available. I reached out to Meri about it and said we should apply for the grant," Hosking said. "We decided to meet in person and it turns out we live right down the street from each other."

The grant funding required a 501C3 nonprofit organization to apply, and until they got a recommendation from Boston Director of Civic Organizing Henry Santana to reach out to the Arts & Business Council of Greater Boston Inc., they couldn't access the money.

Hosking said you can show up on July 30 for a community painting session. Shoot Hosking an email at rosy_hosking@yahoo.co.uk to sign up, or you can just show up the day of from 12 p.m. to 6 p.m.

"That's the artists' job (painting the design) and they don't want us sticking our noses in, but what we can do is prime the panels," she said. "We'll just get 10 gallons of paint together and just

paint the panels."

The group has put together a budget of \$13,000 to both beautify the bridge and make it safer for all modes of travel by adding updated lighting and signage. The city has already installed two street lights and has employed the Boston Graffiti Busters to help keep the graffiti in check.

Hosking and Bond have enlisted the support of graffiti artists in their bid to beautify the bridge. Artists Andres Duarte and Jonathan Lopez-Willen will be lending their talents to the project. Hosking said they will be able to pay each of them \$1,500 from the Love Your Block Grant, but said that's basically only enough for the materials needed for the project.

"Our artists have said they're willing to paint with the amount we've raised so far, but to pay them what they're worth and honor their work we need to keep fundraising," she said. "If we can't reach the goal then we can only give them less and not do other things we want to do to the bridge, like put in trash cans, tree trimming and more lighting. There are different ways we want to build community around this like having a block party on the bridge as well. We've applied for a permit for Labor Day Weekend but haven't received it yet. If we don't, then we'll just do it on a neighboring street."

Hosking said the artists have experience in this type of work some of which you may have seen around the neighborhood.

"Duarte did the phone box artwork on Belgrade and also did a mural for the Philbrick School. He and his partner Anna reached out because Anna's kid goes to the Philbrick and passes over the Blakemore Bridge every day," she said. "We then reached out to Artists for Humanity to see if

July 29: a day of irony

There are many examples of ironies in life. There's the doctor who becomes ill; there's the tailor whose pants rip; there's the mechanic whose car breaks down. And then there is the irony about the 47 deaths of sailors on the U.S.S. Callaghan.

Note that the ship in question is spelled with a "G"; the other way of spelling "Callahan" is without the "G". [The second spelling used to name a long-standing clothing store on Centre Street in Jamaica Plain near the Monument.]

And the U.S.S. Callaghan is not named after Father O'Callahan, the Catholic chaplain who received the Medal of Honor for tending to his shipmates for 3 days when the U.S.S. Franklin was severely damaged by two huge bombs, killing 1,000 sailors.

Here's where the irony of the U.S.S. Callaghan comes in, sadly on July 29, 1945. The destroyer had previously supported the invasions of Tinian, Guam, Saipan, Mindanao, Luzon, Palau, Iwo Jima, and Okinawa. And the ship survived all these without too many scratches. But just after midnight, it was to be sunk by a kamikaze bomber a mere two hours before it was scheduled to be relieved of duty to return to the U.S. for a much needed overhaul. The toll could have been much worse, as a tragic 47 sailors perished with the ship sinking in fewer than two hours. Nearby destroyers and small LCS (Landing Craft Support)

ships assigned to the same picket duty off Okinawa rescued the rest of the crew. The Callaghan was the last destroyer sunk in the war, about two weeks before a truce was signed on August 15. [The formal surrender was signed on September 2.] If only the Callaghan had been allowed to leave its assigned post 120 minutes earlier.

So, this July 29, if there's any irony characterizing your life—say you're on the beach reading a book about rain, and the dark clouds start forming, or you purposely leave the Band-aids at home, thinking that nobody will step on a sharp sea shell and it does happen, or you run out of gas three hundred feet from a gas station—think about the irony of 78 years ago when a host of sailors were counting the hours—nay, minutes—before their ship was scheduled to come home and disaster struck. That's irony in the first degree with a capital "I".

option of 10 more years for the west grandstand and adjacent fenced-in area. The rent was set at a minimum of \$400,000 a year. The sole respondent was Boston Unity Soccer Partners (BUSP) CEO Jennifer Epstein. The Epstein family co-owns the Boston Celtics and owns the Abbey Group real estate corporation.

BUSP proposes to invest \$30 million to renovate the existing west grandstand, improve the infield and environs and add the Grove to the fenced-in area south of the field. BUSP will contribute funds for a roof over the east grandstand, which will be renovated by the City of Boston.

The west grandstand will be leased for 365 days and the east grandstand leased for soccer game days between October and March, about 20 days.

A separate corporation, The Grove Operating Company LLC, will lease The Grove for 365 days.

BUSP has retained STANTEC, architects who will renovate the east grandstand, and design The Grove and west grandstand canopy. Chris Bridle is the lead architect, and on the call he said the Grove and canopy would respect Frederick Law Olmsted's park design. The canopy would resemble a leaf, he said.

The west grandstand will be under BPS management and redevelopment coordinator Evan Brinkman, the Public Facilities Department assistant director of design.

Barely discussed at the virtual meeting but described and illustrated in the BUSP proposal was that the BPS plans three new buildings tacked on to the east grandstand and absorbing parkland facing the Walnut Avenue entrance.

A two-story, 70-foot-high gymnasium and indoor athletic building, a long two-story, 60-foot building wrapping around the White Stadium grandstand wall that will include a new entrance, grandstand terrace and box seats and a smaller one-story building for locker rooms and offices.

According to the mayor's office in a reply to The Bulletin, the city has budgeted \$10.5 million for a programming study and design of the east grandstand.

"When design is complete the city will appropriate additional funds for construction costs. It's too early to project what the total cost will be," the city stated.

Don Irish, Chief of Operations, who along with Millor represented the city on the July 13 Zoom, reminded participants that only 14 percent of the stadium is part of the lease and that "the city will make a significant investment."

Irish emphasized the bad conditions of the stadium.

"It's not up to code for the BPS athletes," Irish said.

Part of that 14 percent is the 62,500-square-foot The Grove, which seems to be the money maker of the BUSP lease. It would act as a public event and amusement space that BUSP said would generate \$10 million a year for vendors.

The BUSP proposal calls The Grove "A destination in itself... creating a lasting economic engine." The Grove is 1.5 acres and Bridle explained that "it's in keeping with Franklin Park and the Franklin Park Action Plan.

"The design of public parks is never finished," he added. "They must adapt to changing conditions."

As Bridle explained, it would be called Tent Village and would move outside the stadium walls; an earth berm would block it from the Playstead through which a walk would connect to a canopy bridge thrown over to the

original Olmsted-designed Playstead Overlook.

The Grove would have a separate entrance outside the stadium and, within the Tent Village, would be a curvilinear platform for beer garden, food concessions, equipment rental, ice skating rink and performance stage.

The proverbial 800-pound gorilla on the Zoom was traffic and parking. Brian Beisel, from Howard Stein Hudson, explained in detail with colored diagrams on the screen share an elaborate program of pre-paid, off-site parking with shuttle buses linked to Orange line stops.

"There will be a full-time community relations officer, an executive management position before, during and after events to handle the shuttle service," Beisel said.

BUSPS anticipates the new stadium will be open and ready for the 2026 soccer season.

Following the presentations by Irish, Epstein and Bridle the chat box lit up with dozens of comments coordinated by Morgan McDaniel, deputy chief of operations.

"There's lot about parking," she said.

Twelve callers testified, including District 8 City Councilor Tania Fernandes Anderson, who reminded people that the stadium was in her district.

She liked the plan, but wanted "more transparency" and requested that the next meeting be in-person.

Millor introduced Juan Fernando Lopera, Chief of Diversity, Equity and Inclusion at Beth Israel Lahey. He said he was from Colombia, went to Brighton High School and took the school bus to play at the stadium.

He said he was "very excited" about the plans and wanted to invest in the proposal.

Epstein put up on the screen share a list of 31 groups and individuals BUSP had consulted; they met twice with the Franklin Park Coalition in December 2022, six months before the RFP was released.

Michael Coppinger is a board member of the FPC and said he lives on Walnut Avenue.

"My great concern is the disconnect between the BPS and Boston Unity," he said. "I'm not in favor of buildings moving outside the walls of the stadium."

Jana Pickard-Richardson from Montebello Road agreed.

"How much more land will be taken?" she asked. "Franklin Park is like Swiss cheese, all these spaces carved out for different users."

A caller named Pollard who said he lived at 495 Walnut Ave. said he was worried about traffic and parking.

"It will just add to 25 years of failure in Franklin Park," he said.

Courtney Leonard said she was from The Boston Tech Academy and had concerns about who will use the stadium.

"White Stadium is 800 years overdue for renovation," she said, "urban disinvestment. I want to know how the women's athletic league will impact Black and Brown folks. The [Franklin Park] golf course is not for us. This is a great idea, but how are we going to keep it for Black and Brown students?"

Epstein wrapped up her presentation.

"Sports bring communities together," she said. "It's really meaningful for us to offer world class professional athletics right here in this neighborhood."

The most impacted neighborhood for professional women's athletics will be Egleston Square and BUSP is scheduled to meet with the Egleston Square Neighborhood Association on Aug. 7.

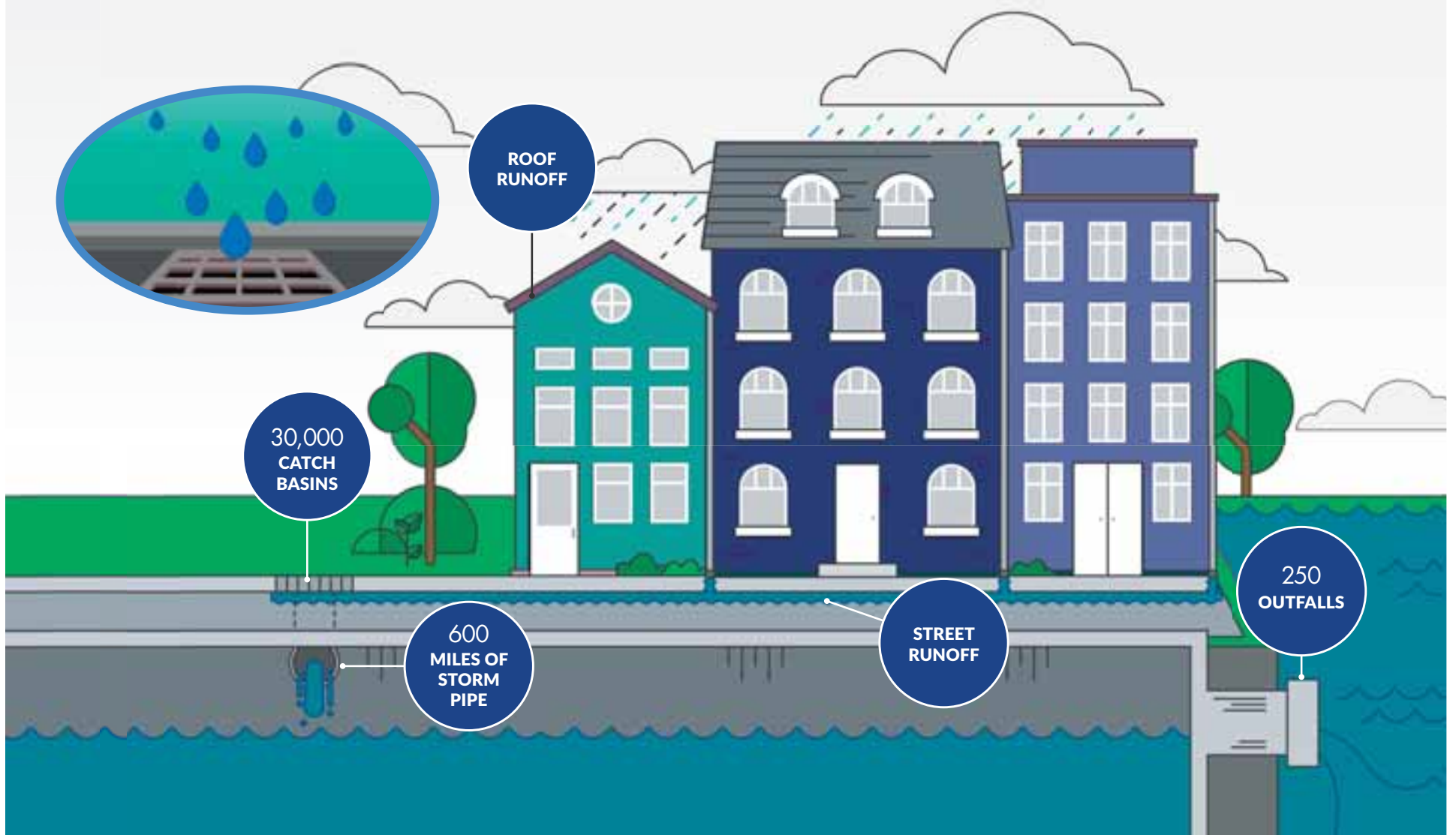
What is stormwater?

And how does it become a source of pollution?

Stormwater runoff is water from rain or snowmelt that does not soak into the ground. As stormwater flows over hard (impervious) surfaces, it collects trash, sediment, and pollutants like motor oil and fertilizer. Impervious surfaces like roofs, patios, roadways, parking lots, and sidewalks prevent water from absorbing into the ground. Stormwater is not treated, so these surfaces allow more pollutants to enter local waterways. The image below shows a Boston cityscape and the features of our stormwater system.

Next year, the Boston Water and Sewer Commission will launch an expanded stormwater program that meets an elevated need for investment in stormwater infrastructure and green solutions. The program will include the creation of a proposed separate stormwater charge and credits/grants for customers who work to reduce stormwater runoff from their property.

they could recommend a graffiti artist for the other side so that it reflects the community who uses the bridge. We know for a fact that there are graffiti artists who use the bridge because there's graffiti on it so we thought we could lean into that."

Hosking said the actual art will reflect the results of a survey of residents asking for ideas of what they want to see on the bridge. Then they reached out to the MBTA and a host of other entities for approval of the design.

"Part of the reason nothing happened is because there are so many jurisdictions all having a stake on the bridge. It turns out art is dealt with by the MBTA but we still had to get a waiver from Amtrak that they wouldn't need flaggers for the trains for what we wanted to do."

The Friends have secured a

fund donation from neighbor Joseph Danz of Boston Exterior Remodeling who will match all donated funding up to \$5,000, and also a donation of \$500 from the adjacent Top Liquors business.

"We started really grassroots by putting the request out on Facebook and we've already raised \$1,000" Hosking said. "Our next step is to reach out all the businesses locally and ask if they can contribute."

Both Hosking and Bond said the support they've received from the Arts & Business Council of Greater Boston Inc. has been invaluable and the project could not have gotten to where it is today without their help. Pryde loses federal funding

The LGBTQ+-friendly Pryde Senior Living development in Hyde Park took a blow last week when the House Appropriations Committee removed the project and many others like it from the 2024 Transportation, Housing and Urban Development spending bill.

The announcement came last week, on July 18, when the U.S. House announced amendments to the spending bill that cut \$850,000 in funding for the project.

But that's not stopping the development, according to the Pryde's website:

"Know this: The Pryde will open in Spring 2024," the website stated. "We will finish the work of creating a safe, affirming and fabulous housing community for low income and economically vulnerable older adults that embraces and welcomes our beloved LGBTQ elders and allies. We will make history together."

The Pryde's owner, LGBTQ Senior Housing Inc., put out a statement last week as well.

"Despite overwhelming community support and meeting all of the criteria for Community Project Funding and despite approval by the subcommittee, the Republican majority in the Appropriations Committee approved an amendment to strike funding for The Pryde, along with the William Way Community Center and the LGBT Center of

Greater Reading in Pennsylvania," the group stated.

LGBTQ Senior Housing Executive Director Gretchen Van Ness reiterated the company's dedication to the project.

"We will not be stopped," she said in a statement. "For the hundreds of low-income and economically-vulnerable LGBTQ older adults and others who are waiting – many in unsafe circumstances – for the opportunity to apply for housing at The Pryde, please know that the work continues and we will soon make history when we open our doors to our first residents."

District 5 City Councilor Ricardo Arroyo introduced and got passed a resolution in the Boston City Council condemning the funding removal, which totaled \$3.2 million for LGBTQ+ housing projects.

"That money would have helped convert a former Boston Public School, the Rogers in Hyde Park, into 74 units of high quality, service-enriched units of high quality housing for our seniors," he said. "This is a furtherance of attacks on LGBTQ+ communities. I just want to give some background on this, we are in July of 2023 and in July of 2022, the Pryde was physically attacked with graffiti all over it. Death threats, and threats of arson. The community came together then and it will come together now."

which he has held – or holds – leadership roles, including the tree canopy ordinance, the municipal food waste ban, and the elimination of the sale of nip bottles.

Roslindale resident Enrique Pepén (pepenforboston.com) – who had served as the City's executive director of the Office of Neighborhood Services prior to entering the race – noted his career focus on the City's community services while emphasizing civic education. Speaking of public transportation in the district, he said that he would advocate for the 32 and 34 bus routes to become part of the fare-free program.

Hyde Park resident and Boston police officer Jose Ruiz (www.ruizforcouncil.com) focused on straightforward communication with residents regarding district concerns. While he was in agreement with his opponents on most issues, he did go against them regarding the reallocation of police funding to prevention and social supports; and on moving traffic details from police to civilian flaggers. He is against both pro-

posals.

Jean-Claude Sanon (www.sanon4boston.com) – who has lived in, started businesses in, and provided constituent services in Mattapan, Hyde Park, and Roslindale since his arrival in the city in the 1970s – emphasized protecting, encouraging, and amplifying the district's diversity, and effective goal-oriented engagement with community organizations. He was the only candidate not in favor of ranked choice voting in municipal elections.

For the most part, the candidates held similar positions, and – with the general exception of Arroyo, who typically cited legislation that he either was involved with or supported – they spoke in relatively broad terms about how to achieve them. All were in favor of adding affordable housing (Pepén and Ruiz both noted that they had grown up in public housing), and all confirmed their support of rent control and/or rent stabilization.

Education was mentioned repeatedly throughout the forum, not just in terms of the school system, but for the city population at large. In terms of the latter, it was touched on as a key to achieving success for the city's Green New Deal, climate sustainability, and District 5 residents understanding their rights and privileges regarding City services.

Regarding the schools themselves, both Pepén and Arroyo suggested ways to work with them to build successful post-high school lives, with the former proposing cooperation with labor unions to give students an opportunity to pursue vocational careers, and the latter speaking of investing in the BPS to increase students' financial awareness.

Education also played a part in the candidates' comments on gun control, with Pepén, Ruiz, and Sanon all highlighting it as part of the solution, and Pepén and Sanon touching on the BPD's commu-

nity and school involvement as part of that process. Ruiz also addressed gun laws not being enforced in the courts, and a lack of manufacturer accountability as key components of the problem. Arroyo spoke of his efforts to add youth jobs, as well as his advocacy of mental health services and of a BPD unit dedicated to non-fatal shootings as a way of reducing future fatal ones.

Regarding public transportation, both Arroyo and Sanon cited commissioned studies of Hyde Park Avenue as part of alleviating its congestion. Ruiz, on the other hand, stated that transportation studies were "money poorly spent," suggesting instead that the focus be turned toward conditioning commuters to use public transit and bicycles.

Regarding the other Yes/No questions, all responded in the affirmative to taking a leadership role in the City purchasing Crane Ledge Woods (the focus of a recent District 5 BPDA application that drew the attention of the city) for full conservation purposes.

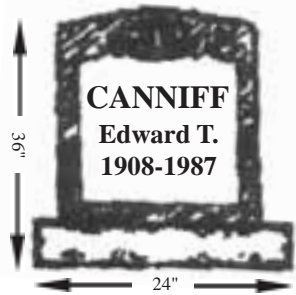
Regarding whether or not they supported non-citizens with legal status being allowed to vote in municipal elections, Ruiz was undecided, and the other three were in favor.

After the forum had ended, more than 50 attendees lingered virtually. Some asked questions, most of which concerned District 5 matters unaddressed in the tightly controlled environment. Three, then two candidates remained onscreen, silently listening.

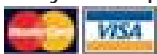
