On Sept. 26, more than 100 concerned Roslindale residents and business owners piled into the Roslindale Community Center to talk about the Municipal parking lot at Taft Hill Center in Roslindale Square. The community meeting focused on the possibility of building affordable units above the parking lot.

The plan is in its very early

stages and no specific proposal for housing was presented, but the idea is to take the 43,000 square feet of 90 parking spaces and place a residential building above it.

The Department of Neighborhood Development asked residents for their opinion on what can make Roslindale more affordable and a better place to live.

"I thought this meeting was

## At-large Candidates talk Roxbury Prep, road diet

The Bellevue Hill Improvement Association Inc. (BHIA) met on Monday, Sept. 30 to discuss with At-Large City Council Candidates their positions on the Roxbury Prep High School proposal and the proposed road diet on Centre Street.

The road diet drew the most conversation from residents and officials. While all seven present or represented candidates (Julia Mejia was not there but was represented, and Incumbent Althea Garrison did not attend) said they were in favor of improving road safety. They also said that all stakeholders should be listened to and understood, especially the business community. At-Large City Councilors Michael Flaherty, Anissa Essaibi-George and

Michelle Wu all attended, along with challengers David Halbert, Erin Murphy and Alejandra St. Guillen.

Many businesses have come out against the road diet on Centre, but At-Large City Councilor Michael Flaherty pointed out that in South Boston at least, it has worked on L Street.

"In South Boston folks would rather give up their car than their parking spaces," he said. "I fought against it and it was implemented anyway and we've seen major and significant improvements on Day Boulevard as well as onto L street... That said, I believe whether or not it worked in my neighborhood, it may or may not work in this neighborhood."

Flaherty echoed the sentiment of many of the candi-

About 40 residents came out last week on Thursday, Sept. 26 for an abutters meeting at 1318 River St. concerning a 32-unit proposal on the site.

Residents packed into the garage at the former site of Junior's Automotive, which has since packed up and moved all its operations to Middleboro. Development Attorney John Pulgini represented

HPTrax LLC. during the meeting and said the 32-unit, 19-parking space mixed use proposal would have less net traffic than the auto shop that was there before.

Pulgini said a good deal of traffic facing Hyde Parkers now is mainly commuter traffic, since Hyde Park is becoming a transportation destination, basically a place people come to park and take public transportation into the city.

"That's what they call commuter traffic," he said. "The issue is not residential development, residential development is the least impactful you can do for traffic. So the traffic from this building would be less than the traffic when it existed as an automotive shop."

Pulgini also said the marketing for this building will be geared towards young professionals looking to commute to Downtown and

# Vinny Michael Ryan Fundraiser raises funds for cancer research

On Sept. 28, about 70 people gathered at West Roxbury Knights of Columbus to celebrate the life of the late Vinny Michael Ryan. Last Saturday would have been Ryan's 60th birthday. He passed away from pancreatic cancer last year.

The event was meant to not only pay tribute to his life, but to also raise money for research to cure pancreatic cancer.

"We're very very happy" said Vinny's mother Catherine M. Ryan, who was more than happy to talk about her son. "He was our oldest son, passed away on June 1 from pancreatic cancer. He lived with us, he was a bachelor, and had a lot of friends".

She further explained that celebrating his life seemed important to the family and getting everyone involved to help others just seemed like a good fit.

"So what we wanted to do was something like this for pancreatic cancer... he was very brave," she said.

Longtime friend Paul Carson said he worked a good deal with Vinny.

"I had the privilege of working with Vinny out of Hyde Park High. We had a great time, we

became great friends, and one of the best guys I've met," he said.

Carson describes Vinny as someone who was "a sports enthusiast. A Red Sox crazy fan... He introduced me to friends in West Roxbury."

More than a friend, Carson tells how much Vinny loved the community. "He did a lot with the kids. He was involved with CYO (Catholic Youth Organization), he worked at CM (Catholic Memorial) before he ended up being a custodian."

"He would've turned 60 this year so they went a little bigger to celebrate" said Vinny's nephew Greg Kamelos who also shared a few words regarding Vinny's impact on others. "His dedication and sense of humor to those who were around hi will be remembered most. He was always interested in making sure everyone was taken care of and it was never a dull moment". Kamelos said Vinny's impact on the community was extensive.

"I know he was involved in the school system at Hyde Park High. He was just a name that most people knew, so it was tough when he passed," he said.

Vinny's sister Patricia Kanelos explained the importance of the event, at least for her.

"It's very important because it's a fundraiser to cure pancreatic cancer which my brother died of. They're really doing a lot of research on other cancers, and they really need to up the ante on pancreatic cancer."

She explained how people can detect early stages by a "urine test that's in the works for early detection. The significance of that is when my brother was diagnosed it was in his liver, pancreas, and bone, so there was nothing we could do. It was too late."

Other than as a fundraiser, Patricia explained that the event also does more than raise awareness; it gets the family back together.

"It's a nice get together because the friends that he had were family... We try to keep in touch with everybody."

# New BPDA Planner for Jamaica Plain

Kristina Ricco has been with the BPDA three years and been the JP Planner for six months, replacing Marie Mercurio.

Ricco sat down with The Bulletin on Sept. 25 to discuss her work and her philosophy. She was joined by Molly McGlynn, BPDA assistant communications director.

"Marie Mercurio. That's some tough shoes to fill," Ricco said. "I have to make myself known to civic groups and associations and people."

That will require coordination; Ricco also directs PLAN East Boston, a neighborhood facing similar economic and demographic pressures like the Washington Street corridor in Jamaica Plain.

Ricco graduated with a masters degree in urban planning and architecture from Columbia University in 2013 and then joined the major Boston architects Child- Bertman - Tseckares(CBT). There she was involved in large-scale master planning for BU and the New England Aquarium.

Ricco may think she has big shoes to fill, but she really has big shoes to follow and that's Plan JP/Rox.

"JP/Rox is so young," she said. "It's only been 18 months. We're still trying to work on how

to fully implement the goals, how to apply them to the design review."

The promised change in the zoning code within the JP/Rox boundaries has been slow in coming, according to many who participated; Ricco challenged that.

"The process took a long time," Ricco said. She joined the BPDA in May 2017, two months after the Plan was approved by the BPDA.

"It's fundamentally a regulatory process," she said. "A complex process. That's why it takes so long. BPDA is one of many stakeholders as the formal regulatory body. There's also the community and elected officials."

Ricco sees Plan JP/Rox as a classic compromise.

"Everyone is a little bit happy," she said, smiling.

Glancing at a diagram of the



# When bad things happen to good people

When President of the Boston City Council Michelle Wu experienced a jolting snafu by Boston Public Schools regarding a non-assignment for her very young son, there were many of us who whispered, “Been there, done (experienced) that.” Maybe that feeling within some of us was elevated to the status of actual schadenfreude. Of course, the head of the Boston City Council experienced a quick remedy, possibly due to her significant political status: an opening was quickly found at her nearby Charles Sumner School for the Roslindale family.

Not too many assignment stories can match that of a South Boston High School teacher who lives a Mookie Betts’ throw from the William Ohrenberger School. The School Department wanted to send his young ‘uns to a distant BPS school; every year they were denied the short hop-skip-and-a-jump walk to the Ohrenberger. Rather than take their chances with the vagaries of the buses, the mother drove them at no small cost to a suburban parochial school for years, but this has a happy ending in that both children were admitted to an exam school.

My family experienced a similar, anguish-producing feeling in the late 70’s when our kindergarteners were sent to the distant David Ellis School. Some years they were the only non-mi-

nority students in their classes—sort of a reverse James Meredith at Ol’ Miss—but without the violence and protests. The cause of angst was not their surroundings: it was the physical act of busing in which the well-intentioned bus drivers would either be late and/or get lost and not listen to our tad-precocious daughters telling him how to get to our house.

On the first day of kindergarten the bus was three hours late returning our oldest, a four-year-old to our house. Our other daughters had one or two others in their class from our section of the city—small comfort in the days before cell phones and GPS could help confused bus drivers.

The waste of money by the City to send our kindergarten daughters to a distant Walnut Av-

enue school—probably dictated by someone in the assignment unit with no kids in the BPS—was no small amount. There was at the end of the bus ride two wonderful kindergarten teachers and wonderful classmates.

School bus tardiness is still an issue after all these decades, as revelations occur that 1 in 5 buses are late. It’s not necessarily the bus drivers’ faults: following a trash truck on a narrow thoroughfare (thinks Perkins Street in Jamaica Plain) or being detoured around a construction/accident/watermain break site just cannot be helped. The BPS’ hiring a consultant for a short time at a whopping \$50,000 is not going to resolve the lateness issue if MIT couldn’t solve the routing problems in the recent past.

The city still has not learned that busing small fry to distant locations is not a win-win situation. Time spent on bouncing buses is not productive for them, as it might be for older students who can read on buses. Perhaps the councilor will try to persuade BPS to allow for closer school-house destinations, as was the solution in her case. While Michelle Wu’s dilemma did not involve busing per se, at least there is now one city councilor who understands the difficulty of soliciting information from Boston Public Schools, whose employees are categorized as “public servants.”

Bike lanes aren’t really about bicycles. Bike lanes are a tool for social change. To the average person what that really means is that the pointed headed intellectuals don’t like you and the way you live. You breeding-oriented people with your families, youth hockey players, your regional and local Catholic schools are taxing the environment with your cars. Little joyful errands will become a painful reminder of the Walsh administration, while Marty is retired in some sunny place with the rest of the shady people. Drop-

ping your child at the school you fought so hard to get into will take twice the time. Think it through, you’ll need to budget 60-90 minutes instead of 30 minutes for the quick Saturday morning run to the local hardware store, bank, cleaners and donut shop because there are 50% less parking spaces. Gentrification in a middle-class town means changing the people who live here. You say you won’t, but you will. You’ll tire of the nonsense and traffic on your side streets and sell out like the people of Charlestown, Southie, and Brighton. Our vibrant businesses, youth sport leagues, parishes, and schools will suffer the same fate as other neighborhoods in other cities who have surrendered to this delusional thinking of bike lanes.

Lastly, an element of bike lanes that Matt O’Malley won’t tell you about is the fundamental legal change that social planners have planned for you it is called “default liability”. It is now the law in Europe where this bike lane craze emanates from. In Denmark and Holland, the bicyclists pull their bikes right in front of cars. Part of the reason these bikers are so bold is that in those countries and much of Europe is that the automobile driver is automatically at fault in a collision with a bicycle. Imagine getting a 7-year surcharge on your auto in-



# RTW gives uplifting performance of Godspell

Riverside Theatre Works founder Marietta Phinney first started her dream theater company “down by the riverside” with a performance of *Godspell* at St. Anne’s Church 33 years ago. She was teaching music and drama at St. Anne’s School when some aspiring young actors and actresses took to the altar, including Osmani Rodriguez, Kelly Terranova, and a boy named Tim McCarthy, who would play Jesus.

On Sat., Sept. 28, several original actors returned to the St. Anne’s for a revival of the 1971 classic musical in a benefit performance for the 100th anniversary of St. Anne’s Church before a standing room only crowd of more than 300 people. This time, McCarthy, now the District Five City Councilor for his hometown, remained in the audience, watching 16-year-old phenom Luke Palmer take the lead.

The cast of 11 members, ranging in age from 16 to 50, mesmerized the audience with a mix of up-tempo rhythmic numbers and more mellow interludes that chronicled the life of Jesus as detailed in the gospel of Matthew. Each character has at least one personal reflection, using a biblical figure to express a gospel reflection of love, hope, forgiveness, kindness or faith.

Kelli Neville gave an angelic rendition of the 70s classic, “Day by Day,” holding Palmer’s hand in demonstration of her character’s faith. The crowd swayed and clapped in unison with the beat, one of several spontaneous outbursts throughout the two-hour performance.

Sabatino, who played Judas in the original production, called this night “a full circle moment.”

“My family was raised in this church, which made it even more special,” she said. “I am now blessed with an amazing husband and four beautiful children. It made the performance even more rich.”

Talent continues to run in the genes. Her daughter, Mikayla, also part of the RTW family, currently is pursuing her acting dream in New York.

Rodriguez has been working in film and commercial productions recently. He starred in the independent Catholic award-winning film, “A Blood Throne.” He will appear in an upcoming commercial with Elizabeth Banks, star of “The

Hunger Games.”

“How grateful and blessed I am to be a part of this wonderful production of ‘Godspell’ again with my dear friends 33 years later,” Rodriguez said. I was able to play the same part and sing the same song, ‘Light of the World, which represents so much of what this theater and its founder, Marietta Phinney, is all about, shining a light of love and peace to the world. And now Marietta is passing the torch on to P.J., continuing to let it shine.

He added that it was special reuniting with the old cast members and forging relationships with the new ones as they embark on their theatrical journeys.

“I must say that I was honored to sing ‘Amazing Grace,’ which was sung originally by the late and amazing Steve Ruggieri,” he continued. “He was a mentor to me.”

“Riverside Theatre Works is a wonderful gem in the city that does so much for the community,” he said.

“It was just a rush of emotion,” Kelli Neville said. “After all of the rehearsals, to actually put it in front of an audience made a huge difference.” “I was just filled with all of that energy from the audience,” added her sister, Kaitlin. “I was just feeding off of all that energy.”

Both sisters, who live in Milton, agreed that it was a great experience to perform with a talented and diverse cast with people of all ages.

Palmer has been “close to 20 productions” between RTW and his scholastic career, he said. A junior at Milton High School, he has been performing since grade five.

“It’s been such an honor to work with such a talented team,” he said. “I’m not sure yet if I will choose performing arts as a major in college, but I really enjoy acting.”

“It was like going back in time,” added Russell, who is now a doctor specializing in geriatric care. “It was just like old home week.”

“I’m so proud of them,” Phinney said. “We tour all over the place. This was a little more difficult because it was a different setting. But we are a family.”

Mayor Martin J. Walsh this weekend joined residents, community advocates and business owners to announce the permanent transformation of Birch Street in Roslindale Village into a car-free, pedestrian-only space where residents can enjoy food, music and activities. The architectural firm, Merritt Chase, was selected for the design and implementation of the project that is scheduled to be completed in the Summer of 2020.

“This project will make Roslindale Village even more vibrant, and we look forward to simi-

larly transforming more street space at locations throughout our neighborhoods,” said Mayor Walsh.

In a collaborative effort between the City of Boston, Roslindale Village Main Streets, A Better City, and neighborhood business owners, the pedestrian-only concept was initially piloted during a six-day pop-up plaza series in May 2019. Through in-person surveys, Merritt Chase and neighborhood volunteers gathered feedback from the community, directly informing the final design of the permanent Birch Street Plaza in alignment with the city's new tactical realm guidelines.

“The pedestrianization of Birch Street will give residents and visitors a safe and appealing place to sit, interact, and relax as they visit the neighborhood. It will help strengthen Roslindale's social fabric, be a source of pride, and no doubt grow into a space which will host more events, such as the Fall Festival and Holiday Market,” said Adam Shutes, owner of the Boston Cheese Cellar in Roslindale Village.

As part of Go Boston 2030, the tactical realm guidelines focus on making “tactical” placemaking more accessible for all our neighborhoods, creating more nimble and standardized processes for the

creation of plazas, parklets, outdoor cafes, and street murals along Boston's streets and sidewalks. These new processes for tactical public realm improvements add to the City's toolkit for public space development and management and will continue to evolve in the coming years in collaboration with the Boston Transportation Department, Public Works Department, Mayor's Office of New Urban Mechanics, Arts and Culture, and other city agencies.

Projects that are either underway, or completed to improve the City's public realm include the Tontine Crescent Plaza in Downtown Crossing, the Phillips Square Plaza in Chinatown, parklets in various neighborhoods, and new street murals in Dorchester, North Allston and Roslindale. Through the Age-Friendly Bench Program, 89 new benches have been installed across the City, with a particular focus on raising the availability of resting locations for older adults.

dates, and some residents pointed out that L Street was not a main thoroughfare like Centre Street, but Flaherty said there are residents pushing for a further road diet in South Boston.

“I was pleasantly surprised and I’m now supportive of the road diet and how it’s provided safety improvements in my community,” he said. His representative Paul Sullivan said after Flaherty left that there have been calls for a road diet on East Broadway.

Essaibi-George said the city should take immediate steps regardless of what happens with the road diet to improve Centre Street with repainted crosswalks and lit pedestrian crossings. All other present candidates said they supported the proposal for a road diet, and Murphy said she was sitting down to have coffee at the Recreo shop in West Roxbury when Marilyn Wentworth was struck and killed while trying to cross the street. The incident has been the catalyst for the proposed road diet and improvements to Centre Street.

The BHIA voted to oppose the Centre Street Road Diet as well as the proposed Roxbury Prep School at 361

Belgrade. The Roxbury Prep High School has been a controversial project since its inception, and only St. Guillen came out in support of the High School.

“I see the issue of Roxbury Prep as an equity issue,” she said. “We have students of color across the city split up and I have talked to people in favor of the proposal and those in opposition and sat for a long time to talk about the issues like traffic, safety and the issues of community and I feel like a lot of those issues have been addressed.”

Challenger Halbert said he’s not necessarily against the school, but he said he wants a concrete assurance that the school will hold up its end of the deal, and for that he suggested the school put up some collateral.

“If the school wants to be there and it’s pushing forward on this, then I think we should say ‘hey, have the charter school but have it on a set of mutually-agreed-to values,” he said, asking that if the school goes in, have Roxbury Prep put its Charter up for collateral to ensure cooperation with residents. “I think if we raise the stakes it makes everyone a better actor.”

West Roxbury Neighborhood Council Member Stephen Smith asked the panel of candidates about the West Roxbury Education Complex on the VFW, its closure and what the future plans for the building might be. Essaibi-George, who also chairs the Education Committee in the City Council, said she has been working with BuildBPS and the Boston Public Schools District on the issue.

“I have made it very clear to the district and the school department that that campus needs to remain a high school,

this side of the city is missing one and for me that’s city property and city land and it needs to remain a BPS school,” she said.

Essaibi-George said she expects to discuss the issue with the BPS in a month or two to find out where the district stands on any plans to demolish, redesign and rebuild the school.

“But that process is still many years away,” she said.

In other developments regarding the Roxbury Prep School, BHIA member Paul Nevins gave an update on his citizen-led action to stop the

school. He said that under the Massachusetts General Laws 30a section 10 provision 10, which states that 10 or more residents may intervene as of right in a public hearing process like the Zoning Board of Appeals and would be permitted to present evidence as part of the proceedings. He said they have informed the Boston Planning and Development Agency and the Boston Zoning Board of Appeals of his and others’ intention to intervene. He said if the ZBA refuse to hear the intervention, they are prepared to go to court to settle the issue.



cannot afford to live in South Boston. He said the appeal of the project would be its close proximity to the Hyde Park Commuter Rail Station, but residents pointed out that train runs only three times in the morning and evening, and in the morning, by the time it gets to Hyde Park from Franklin, it's already full.

Hyde Park representative for Boston Mayor Marty Walsh's Office of Neighborhood Services Bryan Flynn said commuter rail problems have been a sticking point with the T and his office. He added one thing the city has been working on has been that of Zone Fare pricing, which because of Hyde Park's distance to Downtown, puts the Commuter Rail price of a ticket to South Station at \$6.50 for Hyde Park Station and \$7 for Readville, which Flynn said he pays every day.

"Readville has been a part of Boston since 1912, and we pay the same rates as people in the suburbs," he said.

Another resident said she had a problem with the design of the building.

"I've seen this exact design in so many places, is there any other offer for the design?" she asked.

Residents said they were against the density and the height of the project, which comes in at five stories – four for residential living and one for parking and about 1,000 square feet of com-

mercial space.

Pulgini said the commercial space would more than likely be a non chain coffee shop, but some residents said they were skeptical that a coffee shop would survive.

"You must have some kind of magic wand if you think retail is going to come into the first floor because there are so many empty spaces up here that the Hyde Park Main Streets and the Hyde Park Board of Trade have been trying to fill and they can't fill," she said.

Pulgini said he used to be the president of the Hyde Park Board of Trade, and said bringing in more residents within walking distance of businesses would help alleviate strain on local businesses.

"Everybody in this room knows the Fairmount Grille closed," he said, to murmurs of agreement from the crowd. "It's devastating to me, it really is.... But my point is this, the rest of the city is gaining restaurants, but we're losing restaurants."

Pulgini said the current design would call for the Boston Planning and Development Agency's Article 80 Small Project Review process, and would call for Community Benefits, which he said could be contributions to help with street design.

Residents were still not convinced, however, as the intersection of River Street, Business Street and Gordon Avenue regu-

larly backs up because of too much traffic and the rail bridge, but residents said they did not feel 19 parking spaces would be enough.

"We live in Boston, and our public transportation stinks," one resident said. "It's not realistic for most people not to have a car, like if you have a family or children, it's just not a realistic expectation."

Residents were also concerned that the developer did not live in Hyde Park and hails from Sharon, Massachusetts.

Fairmount Neighborhood Association President Joe Smith said he was involved in the rezoning of Hyde Park a few years ago and he's not happy that despite reworking all the rules for developers, there are still projects like this one coming in with numerous requests for zoning variances.

"It is crazy suggesting they want to put forward 10 variances," he said. "You're talking about a substantial departure from the rules and regulations."

Pulgini pointed out that the original auto business was located in a three-family zoning district and would have required a lot more variances than 10.

More meetings on this proposal are expected in the coming months, but this project has not yet been submitted to the BPDA's process or has been put before a local neighborhood association.

Green Street-Washington Street crossroads showing four approved developments totaling 350 units. Ricco answered the question about density, which is on most people's minds, with a question of her own.

"How many units is enough?" She asked. "Can we put a cap on the number of units? Should we?"

"Plan JP/Rox is facing the challenges of housing need," Ricco said.

Ricco is not unmindful of the problems that causes for people who already live here.

"I know from firsthand experience the pressures of trying to find an affordable house to buy," she said. "People think those of us in the BPDA earn a good salary and can afford the housing. But that's not always true."

Turning to the fast changing light industrial Stonybrook neighborhood corner of Brookley, Stedman and Stonley, at the edge of Forest Hills, the question there was about street patterns. One residential building is nearly completed, and two new buildings are either planned or approved, all totaling 94 units.

The latest, 50 Stedman, just received \$6.5 million in financing, yet it's on a narrow street without sidewalks.

"Part of design review is the production of infrastructure," said Ricco. "It's part of the community benefits, the public realm and the IPD."

"Streets, sidewalks, are all reviewed by the BPDA with the BTD and the Public Improvement Commission," Ricco said. "The city's costs are substantial; it does a lot of capital infrastructure. But we require private developers to build the sidewalks, street trees. The people will get it built faster."

Ricco said that it's the nonprofit housing quarter like JPND, Urban Edge and The Community Builders that are fulfilling the spirit of Plan JP/Rox with more creativity and more affordability.

"It's an important learning process for us," she said. "The private developers build small with less units. This is their real life interpretation of the Plan and the affordability requirements."

"But the highest and best use ideal are the large projects like Pine Street/TCB. They're fulfilling the city's goals of increased affordability."

Ricco admitted this requires city and state subsidies, but said she thought that the mix of housing with light industry, such as at 121 Brookside Ave. and Carlisle Engineering, can work.

"Marie built on a genuine contact with the community," Kristina Ricco said. "My phone and my door will always be open." That phone is 617-918-4238.

# Roxbury Latin Seniors Help Bury Boston's Unclaimed Citizens

Eternally resting atop a small hill in Fairview Cemetery in Hyde Park, Mayor Thomas Menino watches over the most destitute of Boston's deceased citizens. Menino's gravesite overlooks the City Poor Lot, a section of Fairview owned by the City of Boston and reserved for the burial of its indigent and unclaimed denizens. On September 17, a man by the name of Dennis Kelly joined those buried in this small patch of land. Mr. Kelly passed away on August 19 at the age of 66; no friends or family came forward to claim his body, and so he was to be buried in a simple casket, in a grave that would remain unmarked. Sadly, this is the reality for so many in our City. Government-owned land like the lot at Fairview Cemetery is scarce, and what does exist is rapidly filling.

Typically, Mr. Kelly would be buried with no one to bear witness, honor his life, or say goodbye. Instead, members of Roxbury Latin's senior class carried his casket to its gravesite and read aloud a series of poems and prayers to give Mr. Kelly in death something he lacked near the end of life: company. The boys were there as part of the Class I service program, Ave Atque Vale. The phrase, which translates to "Hail and Farewell," comes from the closing line of Catullus's poem addressed to his deceased brother. Roxbury Latin's Assistant Headmaster Mike Pojman began the Ave Atque Vale program at RL six years ago, having seen it done at his own alma mater, Saint Ignatius High School in Cleveland, Ohio.

Ave Atque Vale partners with the Robert J. Lawler & Crosby Funeral Home in West Roxbury. Bob Lawler, whose brother and nephew attended Roxbury Latin, is flooded each year with burials

for those with no family and no resources. Since Mike and Bob teamed up to begin this program, Roxbury Latin boys have served as pallbearers and witnesses at nearly 100 funerals. "We're not here to change the world," Mike says. "But everyone deserves a dignified burial. It's the right thing to do."

Mr. Pojman believes that so much about this Roxbury Latin tradition is valuable for the boys. "We are thanked for many things," he explains. "We get affirmation all over the place. This is a small thing, done for somebody who has no capacity to say thank you. And there's something important in that." To stand together as witnesses for someone they do not know, quietly reflecting on an ultimate reality of life, also has a unifying effect, he believes. "I think boys feel a certain closeness in this experience," he says. "There are so few times in their busy lives, after all, when the boys can pause and stand together in silence."

On September 17, six Roxbury Latin seniors carried Mr. Kelly's casket to the hearse, processed behind him to the funeral, and presented six readings before he was lowered into his grave. They ended with this:

*We pray, Lord, that when it is our time to depart this world, we will be surrounded by those who love us. Sadly, Mr. Kelly was not so blessed. He died alone with no family to comfort him. But today, we are his family; today we are his sons. We are honored to stand together before him now, to commemorate his life and to remember him in death, as we commend his soul to his eternal rest.*

*Frater, in perpetuum ave atque vale; requiescat in pace, Amen.*

a great display of folks who care about their neighborhood and want to have a conversation on what is possible for the future" said Director of Housing Innovation Lab Taylor Cain.

She said the main thing residents wanted to talk about was affordability, but they didn't agree on quite how to get there.

"I think there were a range of opinions on the degree of affordability, what that means, the breakdown in terms of the mix of units that we could potentially explore on a site like this. I think there were a number of conversations on affordability in different ways."

When asked about the point of the meeting, Cain replied, "Honestly, the point was to start a conversation," Cain said and added that, "This is the first of many conversations about what this could look like in Roslindale as it relates to the municipal parking lot. And so we definitely didn't come in with a proposal or something that we wanted to do. It was really coming in with an idea and having that conversation with folks on what that idea could look like here."

"A lot of people came out, and a lot of people feel very strongly," said Roslindale resident Caron Kirchoff when asked about the meeting. She said she noticed that "the two

major issues that seem to be expressed were the desire for affordable housing and a concern about parking."

Kirchoff became optimistic on what is to come. "People in Roslindale want to keep the business district vibrant and I think there's a way for us to do that, and have enough parking, and achieve affordable housing."

Resident and business owner Ben Warner said he wants to see more affordable housing in the area, however he said his reasoning may not have been totally altruistic.

"I'm certainly in favor of affordable housing. I run a business here but can't afford to live here" he said. "I would say a good chunk of my customers are from Roslindale. But the other businesses, they are not. They're getting a lot of people from outside so the parking is super necessary."

He added, "Since I run a business it's important to me that my customers can park. My business is right near the parking lot so my customers use it."

"It's really hard to hear people in constant conflict in this city over development issues," said City Councilor candidate Maria Esdale Farrell after the meeting. "I do worry sometimes about the stakeholders whose voices are not

heard or respected. Our business district, and those owners, they have a lot of voices that should be valued. The people who just bought in that area need to be valued."

Farrell further expressed her opinion on development in the community. "I think there needs to be better overall planning when it comes to our city. Not just keep plopping development after development on any available lot."
