WRMS Discusses Centre Street

West Roxbury Main Streets (WRMS) hosted a technical assistance panel from the Urban Land Institute (ULI) Boston/New England. The presentation took place on June 11th at the Theodore Parker Church. ULI Boston evaluated West Roxbury's economic and development outlook along Centre Street, and the scope of the study included street design, retail and housing mix, zoning, placemaking, wayfinding, and other factors for West Roxbury to consider in future planning and development.

The ULI Boston/New England study seeks to answer the following questions:

Which sections of Centre Street are the most critical areas to focus on in terms of making significant and impactful change? What types of changes are recommended in those sections and why are these areas most likely to be successful? Which properties are the most important to focus on? Are there specific uses that panelists feel are lacking that should be focused on?

The presentation given on June 11th showed preliminary findings, and a final, physical report will be provided in the upcoming months after a further study. Nyal McDonough of ULI opened the presentation by explaining that he "lived on Stratford Street at one point in time" and is "familiar with Centre Street and the chal-

Rotary honors Darra Slagle, Rose's Bounty

The West Roxbury Roslindale Rotary Club honored Rose's Bounty Director Darra Slagle on Friday, June 7 during its annual Paul Harris Awards Dinner at the Stratford Street Church.

The church is also the location of the food pantry, and while Slagle said she was appreciative of the honor, she made sure everyone knew it was a gigantic team effort.

"It's very difficult for me because I don't like to be singled out, this is such a group effort," she said. "It's really a community effort. I have so many people who volunteer - I shouldn't even say I - we have 100-plus regular volunteers and they come in at different times for all the different programs. I have

two gals running the veterans program, two gals running the backpack program making sure they're filled with nutritious food, it's such a collaborative effort I feel almost undeserving because there are so many people involved."

And they are all needed, as food insecurity becomes more and more rampant in the city as a whole and in the Parkway in particular.

"We had a record number of people coming in just last week. We had over 100 families on Saturday come into the food pantry and we had over 100 on Tuesday," she said. "Tuesday is usually fewer people. It's unfortunate, but I'm so happy we have the means to get people food. I feel very, very blessed. I have to say too, if it wasn't for my husband Lampros Minos, I wouldn't be able to put in the hours that I have to do

this. I want to thank him too."

Stratford Street Church's Rev. Abigail Henrich is also a member of the Rotary, and said the consensus in picking Slagle was very strong among the board, and she has seen Slagle's work in the community first hand.

"There was 20,000 pounds of food unloaded today, tons of fresh fruit and vegetables. Because of this we're able to do the elder and veterans delivery programs," she said. "So there's about 20,000 pounds of food that comes in every month, and then every week we might get 5,000 more pounds of fresh meat, dairy things like that."

The pantry began three years ago when the West Roxbury Food Pantry closed down, and the group

lenges it poses.”

Jim Hefferman, of Navern Partners, LLC, discussed Centre Street’s assets and opportunities as well as its challenges. He discussed the fact that Centre Street is the center of West Roxbury and has nodes of activities.

“It reflects West Roxbury’s community pride and engagement,” he stated. He also discussed Centre Street’s multiple transportation options, such as the commuter rail and MBTA buses.

“Centre Street is a very car-focused street,” Hefferman remarked. “That is a real safety concern for pedestrians and cyclists. There are long waits at the intersections for pedestrians.”

He noted that the street design “does not serve pedestrians, cyclists, and retail shoppers.” Hefferman believes Centre Street should conduct a “parking utilization study”.

He noted that there is “underutilized parking”, and believes the commuter rail stations should provide free parking to people who want to use the businesses on the weekend. He explained two hour parking may be too long on Centre Street, and businesses may benefit from having 30 minute parking instead.

Alykhan Mohamed, an urban planner, discussed possible ideas that could improve safety for all users on Centre Street. For vehicular traffic, Mohamed suggested dedicated turn lanes. For pedestrian/retail shoppers’ traffic, he recommended more stop lights, more crosswalks, and signs with flashing lights. For cyclists, Mohamed proposed a dedicated bike lane and a physical buffer from vehicles.

After the presentation, WRMS and ULI Boston opened up the floor for questions and comments from the public. Marty Keogh, a West Roxbury resident and member of the West Roxbury Civic Improvement Association stated, “Everyone here in this room knows we have a problem on Centre Street.”

Keogh recommended more stop lights, more signs with flashing lights, more police presence and Smart Lights for Centre Street. He also voiced his concern with reducing lanes on Centre Street (also known as a “traffic diet”). Keogh believes that would send a lot of Centre Street traffic onto side streets, where they would speed and potentially hurt another pedestrian or children.

“If they want to take the deaths off Centre and put

them on my street they’re out of their mind. It’s been dangerous our entire lives, it’s never going to be safe,” Keogh said in an earlier interview.

Another meeting attendee voiced her concern about the traffic at Holy Name rotary, and believes people need to be slower getting on to the rotary and getting off.

Many of the meeting attendees were small business owners on Centre Street. A lot of the people in the room had not heard about the meeting until the morning before. “There needs to be more community engagement,” stated one community member.

This meeting should not be confused with the June 20th meeting, in which City of Boston officials will present a proposal on the redesign of Centre Street. The community is encouraged to attend that important event, which will take place at 6:30pm at the Holy Name gym.

Editorial

TRAGEDIES

Details are still hazy and incomplete as to what happened to Red Sox All-Star David Ortiz in the Dominican Republic and why.

There are plenty of rumors as to why the beloved slugger was shot in the back, but precious little in the way of hard facts. It really shouldn't be that surprising. Pieces of any criminal puzzle take time to click into place.

A few things strike us in the immediate aftermath.

First and foremost, heroes can let us down. It was predictable, but naïve, to see many folks online refusing to put any credence in some of the more scandalous rumors surrounding the shooting. They were not just skeptical, which would be a reasonable response, they were unmoving in their refusal to believe even a shred of the emerging stories.

The reality is that two things can be true: Ortiz can be a good man, and a man whose flaws and deeds came back to haunt him. No one is perfect, especially not sports stars. He is no less deserving of our prayers and concern.

The other observation we had is quite a bit broader in scope, and perhaps more alarming in a societal sense: we are all still quick to believe and share inaccurate reporting and fake news.

In the immediate aftermath of the shooting there were understandable, but no less inaccurate, reports of the extent of his injuries (a bullet passed cleanly through his leg); rationales for the attack (a robbery), and even horrible reporting in social media as to where the shooting took place; Venezuela, opined one baseball "source").

As we veer ever closer to another presidential election, one marked by increased scrutiny of online disseminators, the fact remains that we are still making the same mistakes with media consumption. We still believe and spread bad intel. There is still a rush to "be first" and enjoy some false sense of pride in "educating" our friends and peers.

Speed is the bane of reporting and distribution alike.

It is hard to get too worked up. The Ortiz news was shocking and most reactions understandable. Reaching for the "share" button was reflexive.

The problem is that, days later, many still believe those initial fictions that immediately emerged. As a flipside to the same coin, even vetted news is being dismissed because it doesn't fit a mental image of a man they only know from TV.

Our collective sense of truth in media still needs a reset. We never seem to learn.

When my brother-in-law Frank as a young boy noticed that flags were suddenly hanging outside along his mid-western street on his birthday, he assumed that the Bedford Falls-like community in which he lived was toasting his natal day with this display of Americana. Unremarkable to say, it was also Flag Day. He did not understand the tradition of June 14.

In "Fiddler on the Roof" the audience hears much of the importance of tradition, as the play and the movie both open with Tevye and others singing about it robustly. With so many of us, both very young and very old, tradition plays such an important role in our lives. With youngsters all one has to say, "This is the way we did it last year/month/week" and a tradition has been established.

Here in Boston there are large traditions, such as the Fourth of July Concert with its cannons for the "1812 Overture," performed before hundreds of thousands as well as a national television audience, lesser traditions such as the Little League parades involving a section of the city, and smaller traditions involving a neighborhood, such as the reading of the Declaration of Independence at the opening of Buchanan Road's Independence Day block party.

A wonderful, close-to-Boston tradition was recently revealed to me by a city resident who plays Saturday morning softball with suburbanites in distant Wayland. Their softball diamonds—they face each other with an overlapping center field—are situated kitty-corner on a square town block, on one side of which is a funeral home.

Whenever the casket is being transferred from the funeral home to a hearse for the procession to a church or cemetery, one of the observant players bellows, "Funeral!" At this time all play stops on both diamonds, players respectfully doff their hats, and hopefully silently pray for the deceased and his/her survivors as the funeral cortege slowly wends its way around the block.

The tradition of men doffing of their hats, standing respectfully still, and abstaining from any activity when a funeral passes is not new. Construction workers doing street repairs used to have the monopoly on this custom. Some classrooms in parochial schools used to pay similar homage to a passing funeral.

In these days of hurry-up for everything, it's delightful to hear of this tradition that undoubtedly slows down a softball game, as its players struggle to meet after-game appointments. Perhaps this respectful tradition could be emulated by youth coaches of all sports.

Theodore Parker hosts a cappella concert

The Theodore Parker Church (TPC) hosted Windborne - a political and intercultural a cappella - in concert on Friday, May 31. The a cappella quartet performed in TPC's Parish Hall, which was completely filled with church and community members.

The Windborne quartet - which is made up of vocalists Lynn Mahoney Rowan, Will Thomas Rowan, Lauren Breunig, and Jeremy Carter Gordon - has been called "some of the finest singers of protest and folk music that I have ever heard..." by folk music journal Sing Out!. The group shifts effortlessly between different styles of traditional music, hail-

ing from all parts of the world including Bulgaria, Quebec, France, and Appalachia.

"I saw them perform at the New England Regional Folk Alliance, and I was quite impressed," explained Carol Allen, who does bookings for the TPC. "We discussed dates they could perform, and now they're here in concert!"

"Lynn, Will and I started singing together for fun in high school," New England native Lauren Breunig explained. "Jeremy joined in 2013, and that's when Windborne really started. Singing has been a full time job over the past year."

During their concert at the TPC, Windborne performed songs from their project Song on the Times: Social Action

Songbook & Album. The illustrated songbook and album takes music from working class movements for people's rights in the US and UK over 400 years, and is sung for today's struggles. "Some of the lyrics are very old, but they have the same message today," explained Breunig. "We've also updated some of the lyrics." These topics include workers rights, climate change, and racial justice.

Windborne believes that as artists, it is important to make music that bring people's attention to struggles and poverty. They opened the a cappella concert by singing "The Diggers' Song", a 17th century English ballad which was a protest song for land rights. Many people in the audience clapped their hand and stomped their feet along with the beat. The group also per-

formed "Bread and Roses", a political slogan, poem, and song associated with the textile strike in Lawrence, MA in 1912.

Windborne members Will and Lynn performed a song they wrote in 2006 after seeing the Al Gore documentary An Inconvenient Truth. The song, titled Slave to Time, is a call to action and an apology to future generations. "The phrase 'do not be a slave to time' speaks to how easy it is to assume that someone else will deal with the problem, or that we will deal with it later. It is a call to action beyond climate change, it speaks to all social struggle," explained Lynn Rowan.

The group went viral two years ago when a video of them singing outside Trump Tower in protest was shared thousands of times on Facebook. The lyrics discussed the "low folk rising up" and "the tyrants in their towers of gold shall hear the people's cries". "It was about a week before Trump's inauguration," explained Jeremy Carter Gordon. (You can watch the video at <https://www.youtube.com/watch?v=aE3s2IwgcAE>).

In 2014, Windborne was one of ten groups in the nation chosen to be US cultural ambassadors, traveling to Angola, Turkmenistan, and Central Asia. The group also engaged in a lot of community events while in these countries.

This is the church's last Music on Centre concert of the Winter/Spring 2019 season. "This was our most ambitious year so far for Music on Centre," stated Allen. The TPC's Music on Centre has hosted two other concerts during the winter and spring of 2019. In January, they hosted singer-songwriter Joe Jencks and Balkan musician Samodivi. In April, Music on Centre hosted the folk group the Heather Pierson Trio and singer Mike Laureanno. All shows benefit the TPC and its work.

Neighborhoods join together to share ideas for Livable Streets

Residents from Roslindale to Roxbury joined forces on Thursday, May 30 at the Lena Park Community Center at 150 American Legion Hwy. in Dorchester to express their views on how they would like to see their major transportation arteries improved to transportation advocacy nonprofit group Livable Streets.

More than 30 people at-

tended the forum, which focused on what residents from Roslindale, Hyde Park, Mattapan, Dorchester and Roxbury would like to see on American Legion Hwy., Cummins Hwy., Blue Hill Ave. and Morton St. for cars, pedestrians, bikers and bus routes and stops.

Kristiana Lachiusa, the community engagement coordinator of Livable Streets, moderated the forum, where she had posted maps of the

streets beforehand. Attendees circled areas where they felt were the most dangerous. During a 90-minute slide presentation, they commented on what they would like to see improved and how their daily lives are impacted now.

"The goals of these planning sessions are to offer opportunities for the communities to be empowered; to advocate for the changes they

need, and to provide the know-how of who to talk to," Lachiusa said.

She added that these forums provide the "resources and tools" for people who don't know which roads belong to the city or state, and from which department or legislator where they should seek resources.

People also had the chance to connect across neighborhoods and realize that they encountered the same problems - feeling endangered in crosswalks, worrying about their children and thinking about bike lanes and bus-only lanes.

The first topic of discussion was American Legion Hwy., which stretches from Roslindale to Dorchester. There are no plans in the works as yet, but plenty of feedback.

"All of these accidents are right out here," said one resident, pointing outside. "We need them to keep crashing into the wall."

Rick Yoder, the co-chair of the Mount Hope Canterbury Neighborhood Association (MHC), spoke of the other end of American Legion in Roslindale, near the ScrubaDub car wash at Walk Hill St.

"There is an 81-foot curb cut," Yoder said. "You never know when the cars are going to come in, and where the exit and entry and exit are."

"When you are walking, you almost have to do a spin in, out and around to watch for traffic," explained fellow

MHC co-chair Lisa Beatman. "It's a very dangerous area. Traffic is coming from three directions, and it's near a K-8 school."

Yoder added that there have been a couple of fatal accidents on Walk Hill, and "a couple of rollovers on American Legion."

"The intersection needs to be redesigned, and traffic needs to slow down," he noted.

Beatman commented that the name of the street should be changed from Highway to Parkway, which would be more in keeping with its original intention with greenery through an urban neighborhood.

"When people see the word 'highway,' they automatically think speeding is okay," she said.

Another huge problem is the 14 bus line, which runs infrequently, stops early at night, and doesn't run at all on Sunday.

Gwendolyn Farrell of Hyde Park recommended speed check signs on American Legion, as well as Blue Hill Ave., the most widely traversed road.

"Also, if they make the roads a little bit narrower, they could add a dedicated bus lane or bike lane and also slow down traffic," Lachiusa said.

Some residents questioned narrowing an already dangerous Blue Hill Ave. One resident suggested putting the bus in the middle in the road with a platform in the middle, simi-

lar to the subway.

Blue Hill Ave. and Warren St. have one of the highest crash rates, and the 28 bus is the most widely used bus routes with more than 45,000 passengers along that roadway per day, Lachiusa said.

"If you are biking, forget about it," she added.

The audience suggested traffic calming measures, including speed bumps, raised crosswalks more traffic lights and other means from Blue Hill Ave. to Columbia Rd.

Others suggested a dedicated bike lane and making more frequent bus trips so that people would use cars less frequently.

Lachiusa stressed that this is the first of several community meetings, and that it is meant to empower people.

"I thought there was a good turnout and good conversation," she said. "Talking about street improvements can be challenging and divisive, and there often aren't right answers. The larger the group of people with similar goals, the more likely they will be to make the changes they want to see."

Arealus Pough, community engagement manager at the Lena Park CDC, agreed.

"I was very impressed with the turnout and that people from all of the neighborhoods were working together toward the common goal of making our streets safer for everyone," he said.

has been able to expand its programs from just food distribution in one location to delivery services for veterans and seniors, as well as the backpack program at the Chittick Elementary School in Hyde Park, which provides fresh meals to youngsters outside of school-provided lunches.

"The response in the community has been incredible, everyone is so supportive of us and everything we do," she said.

Rotarian District Governor for 2020-21 and former Chapter President Terry Curran said the Rotarians use the distribution days as service days for their club, allowing them to meet up in a social atmosphere rather than a dry meeting.

"It's part of our commitment to the neighborhood to be volunteering," she said. "We absolutely love it; we all do different things. You may think that in West Roxbury that there's not food insecurity, but there is, even with friends I have. People are aging and things getting tighter, the elderly are the people really coming through on Tuesday because they experience food insecurity and they don't want to tell anybody about it. They do a great job here."

Curran added that no matter the situation, Slagle always made sure everyone coming to them for food assistance was helped in whatever way they needed.

"She just has a way about her that everybody feels comfortable when they come in," she said.

Lord Mayor of West Roxbury Richie Gormley reaffirmed that the work at the pantry is amazing and that Slagle is a most deserving recipient.


"Anything to help, I'm always here to support," he said. "It's a great organization."

Current West Roxbury Roslindale Rotary President Dominic Rebelo said the Rotary Board decided on Slagle quickly for the Paul Harris Award.

"It was such an easy thing," he said. "Darra was challenging because we actually wanted to do this for her last year, but she's very humble, and so she didn't want to accept last year."

Rebelo said the three years of volunteering at the pantry woke him up to some of the real issues facing residents.

"In working with Rose's Bounty I've been really struck by a lot of the people who come for services here. It illustrates that the issue of food insecurity exists and is sort of hiding in plain sight," he said. "I'm glad Rose's Bounty has been a wedge to help out."

Ave. in Roslindale will remain under review, and will not be brought before the BPDA Board of Directors for a vote at their monthly meeting this Thursday, June 13,” said Aisling Kerr, the BPDA Project Manager for the proposal. “BPDA staff remains committed to continued facilitation of the ongoing dialogue between the Roxbury Preparatory Charter High School and the communities of Roslindale and West Roxbury.”

The 562 student school has been the subject of a lot of debate among residents for more than two years. Residents against the school contend that it will cause increased traffic in an area that is already heavily-congested, especially along the West Roxbury Parkway. The proposal’s development team has released a traffic study including nearby proposed and approved developments in the neighborhood. That study found the small increase in traffic from the school would be negligible. Opponents also contend the area is too small for a high school.

Bellevue Hill Neighborhood Improvement Association Chair Ginny Gass said she and her group were concerned about a

hasty approval from the city on the project when they recently found building/demolition permits fixed to the Clay Auto building, dated May 17, and filed by Suffolk Construction.

She had said she and her group planned to talk to Boston Mayor Marty Walsh about this at the Tuesday Coffee Hour with the Mayor at Billings Field, but the event was rained out.

“In the meantime, we continue to oppose the project,” she said. “We plan to attend the Roslindale coffee hour scheduled for Thursday, June 13, at Roslindale Square.”

The development team and the school administration sent out a press release after the end of the extended comment period for the project, and pointed out that 85 percent of the comments the BPDA received were in support of the project. More than 1,000 comments were submitted to the BPDA, during 80 days of the public comment period, which is much longer than normal for the BPDA.

“We are so encouraged by the tremendous number of comments in support of our high school project. It’s a testament to the work we’ve done to inform

the community about our school,” said Kate Armstrong, the Associate Chief Operating Officer at Roxbury Prep. “We are committed to being a good neighbor, answering questions and solving problems, just as we do now at our current locations.”

The school also stated they have a petition of support in which 842 residents of Roslindale and West Roxbury signed, with a total of 2,349 signatures from Boston residents.

One resident of Roslindale sent a post card to the BPDA, writing in on it, “Rox Prep saves lives!”

The Greater Belgrade Avenue Neighborhood Association expressed opposition to the project in its current form.

Some opponents are saying that the currently unused Rogers Middle School would be a good location, but the City’s Department of Neighborhood Development has floated the idea of affordable senior housing at that location.


Other residents expressed the idea that since the West Roxbury High School has to close down for repairs and renovation anyway, why not give the building to Roxbury Prep. The Boston School District flatly refused this idea.

City looking to move Animal Control to Parks Department

The Boston City Council Committee on Government Operations held a hearing recently at the request of the Boston Parks Department to move the Animal Care and Control (ACC) Commission under the purview of the Parks Department.

The ACC is currently run through the Inspectional Services Department (ISD), which got it from Property Management in 2014. The currently-proposed move would have to go through a City Council ordinance.

Boston Parks and Recreation Commissioner Chris Cook said it makes sense for Parks to bring ACC under its umbrella, as many of the calls for animal control occur on Parks property.

“We do see a lot of the wildlife interactions taking place on our land, so we do think we are the right agency to actually absorb the city entity,” he said. “For a lot of regulatory reasons, a lot of the conflicts, whether it’s off-leash dogs or wildlife such as geese and coyotes, they actually occur on our properties and so it runs into the existing city ordinances and rules regulating parks and open spaces.”

Cook added that ISD’s mission is specific to private prop-

erty and a narrow scope, while the Parks Department has a bit more flexibility, and would be a better fit for the ACC.

“We do think there would be an opportunity to capitalize on the learning environment of the Parks and Recreation Department through all of its outreach programs, and we could actually get people to understand the rules and regulations behind Animal Care and Control,” he said. “We think that it not only makes sense from a regulatory perspective, but we really think it makes sense from an educational perspective to absorb ACC into the Parks and Recreation Department.”

Cook added because of park interactions with animals, the department already interacts with the ACC and ISD on a daily basis.

“And the majority of their time is actually spent typically on our properties or on Public Works Department city streets,” he said.

Cook said the changes to the city ordinances governing the ACC, which are Ordinances Chapters VI, VII, XVI and XVIII, would be pretty straightforward.

“A lot of the language you see just strikes ‘ISD’ and inserts ‘Parks and Recreation,’” he said. “And then I just do want to flag that with the trans-

fer of ACC, the revolving fund associated with ACC would also be transferred to the Parks and Recreation Department and that would go through all of the auspices and oversight of the City Council that all revolving funds in the city go through.”

The change would also affect which agency issues dog licenses. Under the current system, those licenses are issued by ISD. In the new system, they would be issued by ACC under the Parks and Recreation Department. All offices and titles would be transferred under the Parks as well. There would not be any layoffs or

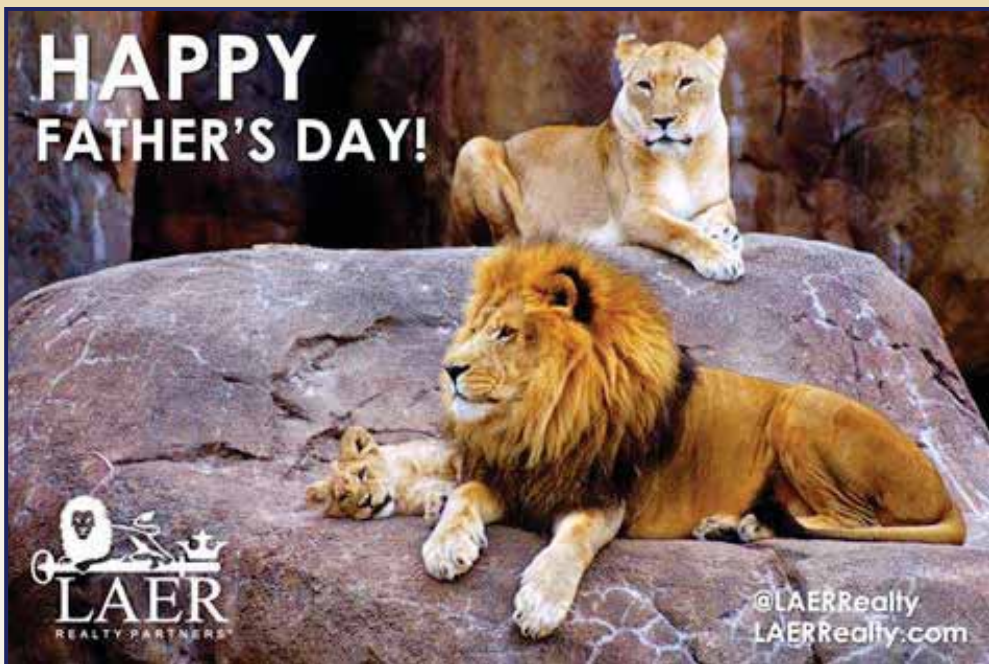
changes in position leadership. The city currently requires that all dogs six months of age or older (human years) must be registered and licensed every year by the ACC.

The impetus behind the change comes from complaints from residents of South Boston that they would have to reach out to two different agencies – ISD and Parks – to have a meeting on enforcement of leash laws in the park.

“Now we think we could deploy them citywide in a way that makes sense that is driven by the 311 calls,” he said. “The other important aspect of it, the Parks and Recreation Depart-

ment has so many more resources as far as outreach in terms of getting educational materials into the hands of residents, whether its our Coffee Hours or our three or four hundred different programs we run through our arts and culture programs, it’s just easier to have some of those ACC officers on hand to educate the public on things they could do while engaging wildlife.”

Cook added that pest and rat control will remain under the ISD jurisdiction. The Boston City Council will vote on this change at the June 5 meeting that took place after the Bulletin’s deadline.

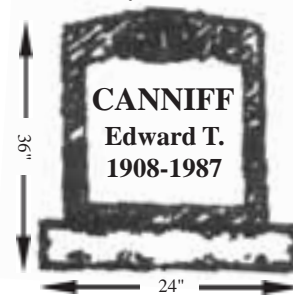
