## MHC talks retail cannabis control

The Mount Hope Canterbury Neighborhood Association (MHC) met last Thursday, April 11, and discussed several issues facing the American Legion Highway corridors, specifically that of a proposed retail cannabis shop.

The retail dispensary, slated for 717 American Legion Hwy. and the current location of the City Farm Florist and Greenhouse, raised a bit of neighborhood ire at the last MHC meeting, and residents were still concerned about how the plan will move forward. The proposal comes from Silverline Therapeutics and was represented by former Boston City Councilor Mike Ross. MHC member Lisa Beatman said she has her own concerns about the proposal,

but that as a neighborhood organization, there are only three areas at which they can have an impact or try to stop the project.

She said zoning regulations, traffic concerns and hours of operation would be the areas they could most affect, if the neighborhood was so inclined. Several residents said they wanted the shop proposal to be removed from the neighborhood, as they saw it as another example of retail that no other neighborhood wants being dumped in the American Legion Corridor.

“We have proposals across the entire City of Boston; they’re everywhere and the response from the zoning board is that ‘we don’t want it in our neighborhood,’ doesn’t fly,” said District 4 City Councilor and City Council President

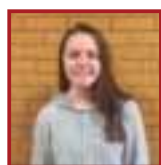

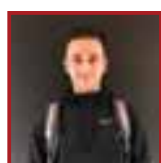

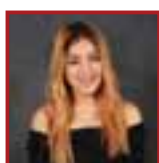

# New fire station coming to Egleston Square

Egleston Square gets a new fire station about every 70 years; the first one was built about 1880 at Washington St and Atherton Street where the city parking lot is.

The Boston Fire Department discussed plans for the third fire station to house Engine 42/Rescue 2 at a community meeting on April 3.

The meeting was hosted by Deputy Chief for Facilities Reynold Maign, with Chief Joseph Mayo, Fire Dept Facilities; District 9 Fire Chief Robert Dowling, Fire Dept. Public Information director Brian Alkins and Scott Dupre of The Public Facilities Department.

The new, three-story, three-bay firehouse will be built on the site of the second fire station at Columbus and Bragdon Street that opened on Dec. 19, 1952; it was built on land taken from the Dimock Health Center.

Maign told the audience that the existing firehouse will be razed beginning in July. The new station will have the same number of fire apparatus and firefighters.

Maign said that there will

be a public art component to the new building, which is being managed by the Boston Art Commission.

In fact, the first time the public heard about the new fire station was in a press release from the mayors' office of Arts and Culture in August 2018 announcing that \$300,000 had been allocated for a "site-specific, impactful, focal design feature for the first new fire station in Boston in over 30 years."

The Fire Department could give no information to The Bulletin at that time about the new station. The Bulletin got a tip about a temporary fire station building on March 6.

Designed by the architectural firm of Dore and



Whittier of Newburyport, the new Engine 42/Rescue 2 is part of the Imagine Boston Capital Plan released by Mayor Walsh on April 28, 2018 which called for a new fire station in Egleston Square. The design was far enough along so that the BFD could release it to the public on April 3.

The total cost is \$25.3 million. Jason Harris of Dore & Whittier described the new building as being highly energy efficient with a sensitive ventilation system that would thoroughly clear the air of pollutants carried in after fires on trucks, apparatus, jackets and coats.

Chief Dowling of District **Fire Station**

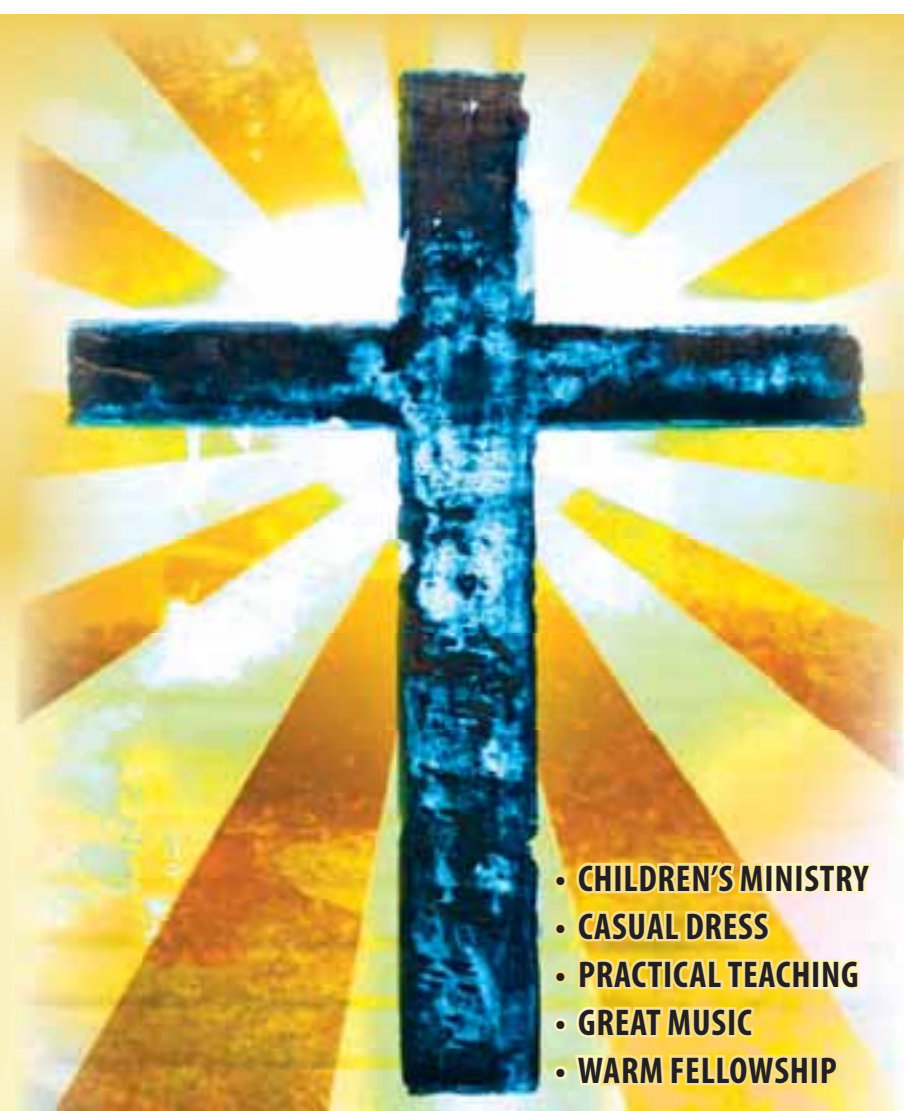

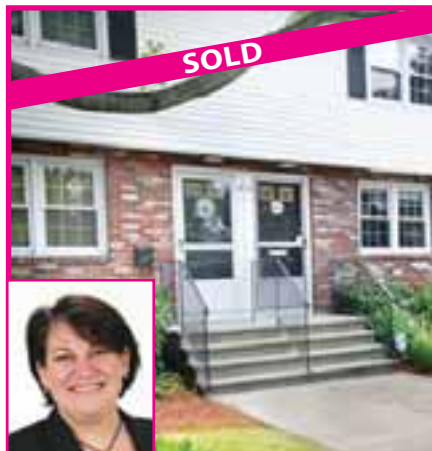

He added that he is a “health nut” and would like to see a place for yoga mats and exercise equipment such as an elliptical machine or even a bar to do chin-ups. An area for children would also be beneficial.

“I can remember a slide, a swing and a teeter-totter,” Haynes said. “But now there’s nothing.”

Haynes noted that the Factory Hill Park is “kind of secluded,” which is why it may not receive as much attention as other larger parks.

Lisa Consalvo, chief of staff to state Rep. Angelo Scaccia, explained that the Factory Park is a state-owned park.

“The DCR (Department of Conservation and Recreation) runs it,” she said. “You would have to put a request for funding in the state budget.”

Consalvo added that this is the perfect time for the group to initiate the process to get the request in for next year’s budget.

“If you do want a playground, that’s fine,” she said. “But you will have to have maintenance.”

Also, there are two MDC sites nearby: the Badjko Memorial Ice Rink on Turtle

Pond Parkway and Camp Meigs Memorial Park in Readville.

A DCR surveyor would have to review the park to note the feasibility of equipment in different areas of the park, Consalvo said.

“For example, you couldn’t have a slide too close to a hill because it would be a safety hazard,” she said.

“If they could just refinish the benches, that would be a start,” Linda Rose O’Connor said. “Even if they could put out a chess board, that would be something.”

Members said they did not think parking would be a concern because the park would mainly draw pedestrians from the neighborhood.

They also noted that activity in the park would deter crime and drug use.

Consalvo said that the group should draft a short letter stating that it would like to request state funding for a study for a park, the history of why it was good for the neighborhood and the reasons it would benefit their community with renovations.

“Then we can start the process,” she said.

Member Abrigal Forrester said he had tried to jump-start

this process a year ago with Sen. Mike Rush.

“I had a conversation with DCR and Mike Rush last year and took them on a tour,” he said. “The challenge is that it’s a state park, and that we are sort of in a no man’s land.”

He questioned if there was a way the state could hand the park over to the city as an option.

Forrester also mentioned that he had discussed the project with a company called OG Design last year, that was willing to do the project pro bono. However, he was unsuccessful getting Factory Hill on the list of their projects.

“It’s a tragedy when children have to play out in the street when there’s a beautiful park right there,” Forrester said.

Consalvo said this would be good time to advocate for funding under the Community Preservation Act.

“There are grant opportunities as well,” Maria Esdale Farrell from City Councilor Tim McCarthy’s office said. “You could apply for the money for a park bench, a free library or a community garden.”

She also announced two local cleanups that are look-

ing for volunteers.

On May 11, there will be a major cleanup effort in Hyde Park as part of the citywide “Love Your Block” campaign.

“You can contact Bryan Flynn and say that Factory Hill would like to be a site,” Farrell said.

Flynn can be reached at bryan.flynn@boston.gov. The sign-up deadline is April 26.

The second is the semi-annual cleanup of the Neponset River on Saturday, April 27 from 9 a.m. to noon, Farrell added. Truman Parkway and Doyle Playground are the main sites.

Farrell also announced that she will be running to replace her boss, who will be leaving office when his term expires.

“I am a life-long Hyde Parker who has raised six kids here,” she said. “I am very familiar with your neighborhood because I used to hang around on Thompson St. when I was young. Plus I have been deeply involved in the

Channing School.”

She noted that her family also grew up in Hyde Park, and that her work with McCarthy has given her a deep understanding of the diverse needs of not only her area, but of Mattapan and Roslindale.

“I understand the ever changing family and neighborhood needs for these diverse communities,” she said. “Fulfilling these needs is my undying passion.”

Farrell said that she has been reaching out to Mattapan residents after the shooting on April 6.

“I have been working with a group of Mattapan residents who want to gather city resources and support to bring attention to the violence, especially after the shooting”, she said. “I am meeting with them at Brothers on Friday, April 12 at 8 a.m.”

The next FHNW meeting will be held on Wednesday, May 8 at 6:30 at the Factory Hill Park on Town St.

# Brighton residents want pot shops in right spots

Brighton residents gathered at the Brighton Elks Lodge on April 11 to deliberate over the proposed cannabis establishment slated for 354 Chestnut Hill Avenue. Jonathan Lau, proprietor of the Vape Shop and his legal counsel, Christopher Ray, represented the venture. Edward McGuire, chief of staff for mayor Walsh's civic engagement cabinet moderated the meeting.

Lau has owned the electronic cigarette store called the Vape Shop at 6 Tremont St. for

four years. He plans to open the second shop in Brighton. Lau backed his cause by citing a March 7 report released by the Cannabis Control Commission (CCC) and the Disadvantaged Business Enterprise (DBE) illustrating the lack of diversity in the state's emerging marijuana boom.

"The marijuana industry, especially in Massachusetts right now, has been quoted at 87 percent white owners. I think Latinos are at 6.7 percent and Asians are at 2.6 percent," Lau said. "These numbers are very

Andrea Campbell. “You would need a legitimate reason why it’s not a good fit for the neighborhood.”

Resident Joe Russo pointed out he felt the neighborhood would not use the facility, and took a straw poll from residents gathered to ascertain that. But State Rep. Russell Holmes pointed out the specific neighborhood did in fact vote affirmative for legalization of marijuana. Resident Christine Russo said she was concerned about the 70 employees Silverline proposed.

“Where are they going to park?” she asked.

“So I would say your sample size here are the folks who are most active, but the best way to know if your neighborhood wanted this or not is to look at your ward and precinct,” he said. “It was a close vote, and I think the reason there is so much contention often is because even statewide the vote went 1.76 million for and 1.58 million against.”

He pointed out Ward 18 Precinct 7 voted 51.1 percent 48.9 percent against. Resident DeMon Bills said he felt the neighborhood may have lost

this fight already.

“Of course there’s going to be traffic issues and all these things, but it’s coming and if we want to push no on this proposal and yes for the one over the gummies and stuff (612 Hyde Park Ave.), I want to pick a side and say this is what I’m going to stand for, but we don’t know what either of these options looks like yet,” he said. “I don’t really see us winning that kind of fight, every one of these places has a political connections, and we have lost that... They have Andrea Cabral, Tito Jackson, Mike Ross, they all have political connections and we can’t win there, it’s frightening but we will have to face it.”

MHC member Lisa Beatman said they could try to turn the community benefits requirement of 3 percent of all sales going to the local municipality to the neighborhood’s advantage.

“That would be money this neighborhood could use for things we know the city is never going to do for us, like a second park or whatever we can think about,” she said.

Holmes also gave an update on 289 Walk Hill St. The

project was approved by the Zoning Board of Appeals about two years ago and has recently received a building permit extension from the ZBA (as permits last two years). He said the ZBA required a commitment to at least knock down the existing buildings, which should be happening soon.

“They’re going to get their demo(lition) permits and knock down those buildings, clean the site and get it seeded so when we get to that corner it will finally be attractive,” he said.

Holmes said the former developer, Charles Gill, has sold his portion of the development to Nabil Boghos, but has also put a lien against the development.

Resident Margo Leonard informed the MHC that her proposal for a butterfly garden at the corner of Mount Hope Street and Hyde Park Avenue is a go. She said the planting is scheduled for June 1, and she’s accepting ideas for art and beautification.

“I’m thinking of getting local kids to decorate a trellis with children’s artwork,” she said.

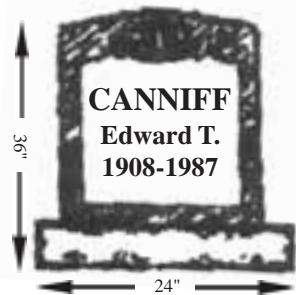

9 said that opening and closing three wide bays takes up a lot of energy.

Harris explained that the new station would be a very tight interior space using every inch that will manage hot and cold air.

The bays will be longer to accommodate additional trucks if required. The building will have an efficient use of space for full training areas including stairwells and the roof.

The building will be pushed back on the site with additional parking. Maign explained that now Rescue 2 has to go to Moon Island in Quincy, eight miles away, for training; now they will be able to train right in the station, vastly reducing emergency response times.

The three-story building will be built of brick, metal panels and a second floor glass wall of windows facing Columbus Avenue.

The last new fire station in Boston was Engine 38 in Jamaica Plain that moved to its new building opposite Blanchards in 1984; it took over the old Papa Gino's location.

The old brick firehouse next to the post office remained open and operational during construction.

Engine 42 doesn't have

that option.

The Fire Dept. will erect a temporary, prefabricated building on the Atherton Street side of the 125 Amory Street BHA housing campus.

Dupre of PFD explained that the site is a now a visitor parking lot. A curb cut to Atherton Street will be made that will match the cut required for two new buildings planned for the campus by Amory Partners, Urban Edge and The Community Builders, now in the financing stages.

The location of the temporary fire station will be close to the Orange Line fence on the space to be built as a drive and parking for the new buildings.

The city will lease at a cost of \$1 million a double-wide trailer for the Engine 42 truck and the fire chief's SUV. The temporary building will have a bunk-room, day-room, break-room, kitchen and showers for six firefighters.

Dupre said that the temporary building will be a "quiet building" with a minimum of lights and sirens when the fire truck goes out.

"We're working on permits for the temporary structures now," Dupre said. "We'll begin construction on them at the end of this month through July. The new fire station will be demolished in July.

"Everything will face Atherton Street," he said. "The truck and chief's car will be side by side. We will not encroach on BHA property."

"We've met with the residents of 125 Amory Street about the temporary building," he said. "There will be a 15 foot buffer between the temporary building and the BHA. There will be no access through BHA property."

"We've met with the BHA and Amory Partners over the last 15 months," Dupre said. "We've worked out an agreement about how much land will be required over a 16-18 month period. We plan to open the new fire station in the fall of 2010."

As has been reported in The Bulletin, the 125 Amory St. BHA campus is now owned by Amory Partners and representatives from that partnership, Urban Edge, JPND and The Community Builders, were at the meeting.

The Boston Housing Authority continues its relationship with the residents. Rochelly Bartolotta, the BHA Project Manager for Real Estate helped explain and translate for the many residents at the meeting.

No further community meetings are planned, according to Alkins.

low for a diverse place as Boston."

Attendees of the meeting were largely pro-marijuana and in favor of improving diversity in the business. But the concern was the site was close to a local pool and Boston College(BC).

"We have almost 15,000 students (at BC) and most of them are between the ages of 18-25," said Former commissioner of the Boston Police Department and Director of Public Safety at BC William Evans. "Everything you read about this shows that's where kids' brains are developing, and we've had a large increase in mental illness in that particular age. So I worry about the impact of THC on these young kids, on their mental health."

Ray highlighted his clients' plans to make the site more secure, including thickened windows, new cameras, on-site security, and 24/7 CCTV monitoring.

"We are sensitive to the operations of the community center and the pool nearby and our proposal is to limit our hours during days of peak activity for that pool" Ray said. "We plan to mimic what a couple of other dispensaries, both in Massachusetts and elsewhere have done, which is to rely mainly on an appointment-based system. This has the advantage of letting us control the hours very carefully."

Other residents pointed to contradictions with the presentation. In the slideshow, Lau and Ray proposed modifying business hours in conjunction with the hours of the pool, but verbally said they'd rely heavily on an appointment system. Lau also said he employs 66 percent veterans and 33 percent disabled veterans but when asked to break those statistics down he revealed that he oversees a staff total of three.

Anabela Gomes, zoning chairwoman of the Brighton-Allston Improvement Association commented that Lau and Ray had yet to confirm the store's capacity limit.

"Now for the location, it's 900 sq. ft., you should know exactly the capacity you can hold in that building and where they're going to wait and where they're going to purchase the product," Gomes said. "You said there may be 100 people outside, well what about the sushi shop next door that almost shares the same entranceway?"

Evans closed the meeting by focusing on the students he's tasked with protecting on campus.

"(Vaping) is getting more young people addicted to cigarettes than it's getting them off of it," Evans said. "As far as BC goes and my position, I'm worried about the location because it's so close to my student population."

The residents encouraged Lau and Ray to improve on their presentation and try again at another meeting.

to be because they were not written down as they were sung in the fields or in churches where hymnals might not be available or attendees might be illiterate—this moving hymn seems to be mainstream now. The haunting melody and repetitive questioning continue up to the victorious “Were you there when He rose up from the dead?”


The other very appropriate hymn for Good Friday, regrettably, has not passed muster with a number of churches in spite of its beauty and majestic message. “The Old Rugged Cross” probably has its roots in Southern Baptist churches, but if “Amazing Grace” and “How Great Thou Art” have crossed important denominational thresholds, so too should George Bennard’s “The Old Rugged Cross.” Composed 107 years ago, it ends with the sobering resolution, “I will cling to the old rugged Cross/ And exchange it some day for a crown.”

One hymn most of us will not hear in churches on Easter Sunday is, “Alleluia! Alleluia! Let the Holy Anthem Rise.” It’s viewed as too waltzy, as if there is anything inherently objectionable to 3/4 time. Any objection to its inclusion should be based on word content—and the lyrics to this rousing anthem form no basis for prohibition: indeed its message is powerful.

The singing of “I Know My Redeemer Lives” seems to be more widespread in churches of different denominations these days, and right that it should be, because of the startling admission contained in the title. All of which leads—in your scribe’s humble opinion—to the ne plus ultra of Easter music, “Jesus Christ Is Risen Today.” Some congregations relish this triumphant hymn so much that in the weeks following Easter they omit the first verse about “risen today” and start with the second stanza.

May these and many other hymns continue to stir and sustain us in these turbulent days.

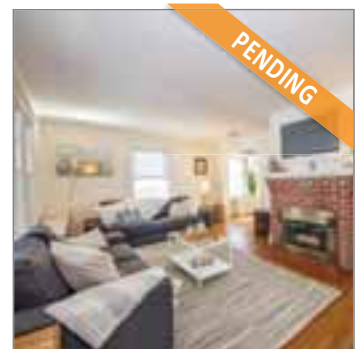
